

Dear Rabbi Silver:

I was very happy indeed to learn from Mr. Meyer Mintz whom I delegated to call on you in Cleveland early this week, of the splendid reception which you accorded him, and of the sympathetic manner in which you received his message from our entire Keren Hayosed committee.

I am sure that Mr. Mintz described to you in detail the plan which we have formulated for this year's Keren Hayosed endeavor in Newark, and impressed upon you the thought that if this plan is successfully carried out it will have a most marked effect upon Keren Hayosed activities throughout the country.


Our local leaders have come to the realization that since the Keren Hayosed work is a more or less permanent work, requiring the best thought, energy, and the money of all thinking and feeling Jews, regularly and periodically, it would be most desirable if an effort were made by us once for all to sell this thought to the entire community in such a manner that each contributor would pledge himself to automatically repeat his contribution annually.

We are determined to secure at least 500 people from Newark who will pledge annually from \$100.00 up. We feel that if we are successful in this we will raise the sum of \$100,000.00. We made a splendid beginning the other night at a little dinner meeting of a few people at which several \$1,000 contributions were made, and at which everyone present contributed at least \$100.00.

Dear Rabbi Silver:

I received today a letter from Mr. Mintz, our Regional Director in the State of New Jersey, concerning the conference he had with you with reference to the Newark Campaign. I have also a copy of a letter sent by Mr. Hollander to you. Since I have been in close touch with the Newark situation, having been there only last week in connection with a preliminary meeting, I think I ought to give you full information with regard to the situation.

First, let me say that I am happy to learn from Mr. Mintz' letter that you would "most likely agree to come to Newark", because I consider Newark one of our most important points. The Newark Jewish community has developed magnificently of late, and can become a power of strength to our Movement.

I liked immensely also the fact that you wished to have some assurance that if you make the effort to go to Newark, maximum results will be obtained. I quite agree with the position which you take, for the following reasons:

Newark, for several years, gave very little to Palestine. Last year we got connections with Mr. Michael Hollander, and Dr. Weizmann was there, with the result that \$50,000 was secured in cash. They were to have had a 1924 Campaign last Spring, but it was postponed to the Fall, because the leaders of the community were interested in the great drive for the Jewish hospital, which, as you probably know, brought in close to two million dollars. Mr. Michael Hollander was Chairman of the Drive, and contributed twenty thousand dollars. Mr. Felix Fuld contributed a quarter of a million dollars, and the rest of the community gave in proportion. We did not agree to the postponement of the Drive, however, until a promise was given that Mr. Hollander would head our Drive in the Fall, for \$100,000. Now, it seems that they are expecting to have a Community Chest Drive in November, and it is therefore important that our Campaign should take place very soon.

(Rabbi A. H. Silver -- 2)

They have worked out a plan by which they are to enroll the people as annual holders. They began by getting together a group of fifty men, whom I addressed last week. The idea was put to them and accepted, that they should contribute each \$100 or more and help get 500 others to do likewise. The meeting was quite successful from the organization standpoint, and good spirit prevailed. Unfortunately, the contributions are considerably lower than what they should be even when consideration is given to the fact that these are supposed to be annual contributions. Mr. Michael Hollander himself gave last year \$3,000. It was understood that he would give at least as much this year. At this meeting he announced his contribution as \$1,000. Many of the wealthy people there took advantage of the \$100 or more proposition, to give \$100 a piece. The result was that some people who had given considerably more last year also reduced their contributions. The old Zionists who have been giving \$500 and \$300 seem to have been demoralized and reduced their contributions considerably. Another illustration, Mr. Fuld gave last year \$500. I understand from Mr. Hollander that he was going to give \$1,000. The same from Mr. Bamberger. Even on the basis of annual contributions all these men ought to give at least \$5,000 a year. In other words, it is quite possible that the plan would be successful from the point of view of organization, and the 500 contributors would be secured, but there is no guarantee as to that. What does seem to be certain is that the level of contributions is deliberately being lowered.

Please do not misunderstand me. These men are all desirous of helping us, but do not appreciate the magnitude of the task and the urgency of the need.

If you go there, and by all means you should, the results ought to be splendid. I believe we will have an opportunity also to interest some of these people in a much larger way; but they must appreciate the effort which you are making, and act accordingly.

Another illustration; Recently Mr. Hollander was on a trip to Canada. One of the local institutions was in financial difficulties. A telegram was sent to him stating the need for a loan or advance of \$100,000. Mr. Hollander telegraphed back to advance the \$100,000 for him. Such people, under such circumstances, ought easily be able to guarantee us the \$100,000 in full, and a great deal more.

I sincerely trust that you will see your way clear to accepting the invitation, and we are sure that you will be able to obtain wonderful results

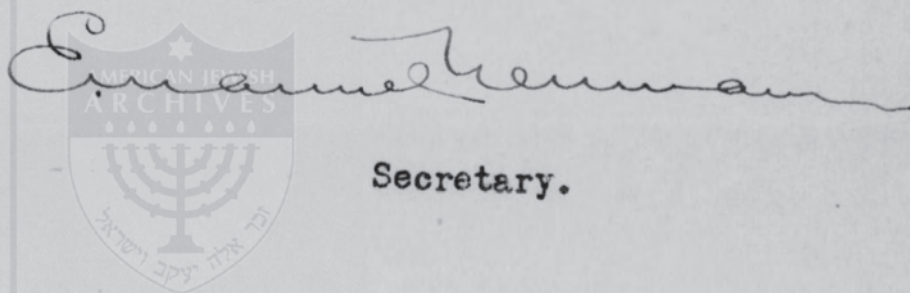

Dear Rabbi Silver:-

I was very happy indeed to receive your telegram informing me of your willingness to come to Newark October 28th. The delay in acknowledging your important message was due to two things, first the fact I have been out of town for several days and second that something extremely important for Keren Heyesod has happened in Newark during the past few days which necessitated delay in my answer to you.

You will be interested to know that for the past year and a half we have been trying to bring into the Keren Heyesod work every element of Newark Jewry. However, we did not fully succeed until yesterday when we were finally assured by Messrs. Louis Bamberger and Felix Fuld that they were with us unqualifiedly in this great work. I am sure that you have met both these gentlemen and know something about their standing, not only in Newark but the entire State of New Jersey, therefore realize what a great victory for our cause their acceptance of it is.

However, after they assured me of their willingness to co-operate in the Keren Heyesod, and after a full discussion of our plans for the campaign to be launched on October 28th, both gentlemen advised a postponement of the campaign until early January for two reasons, first because the Community Chest of this city is to launch their campaign November 7th and is really beginning its active solicitation within a few days, which means that these gentlemen and a great many others whom we require as workers, will be taken up with the Chest work, and second, that there is not sufficient time between now and the 28th to prepare properly for your coming and for a satisfactory launching of the campaign.

Our Committee has seen fit to accept the recommendation of Messrs. Fuld and Bamberger and have decided to postpone the campaign until the middle of January. They have requested me to communicate this information to you and to urge you to give us a date in January to suit your convenience when, I am certain, we shall be thoroughly prepared to respond to your call with \$100,000.00.

Might I add that at this time and in combination with the Keren Heyesod appeal, we shall also appeal for our share of the Emergency Fund being raised by Messrs. Marshall and Wise for the Jewish Refugees in the various ports of embarkation. I feel that announcement of this fact at the proper time will provide us with effective dramatic element that will impel people to give.

My dear Rabbi Silver:

This decision is not mere paper action, as at the meeting were present the leaders representing the various groups of the city.

Scranton has been one of our best cities but as a result of an unfortunate occurrence last year it became necessary to reconsolidate our forces. Once that reconsolidation is complete, we shall have no difficulty in Scranton. For that reason it was suggested that to insure the overwhelming success of the Drive, you be asked to be the principal and only speaker, and I am writing this letter to ascertain whether you would be willing to make this sacrifice for the sake of Palestine.

I can assure you that you will be met by an unusual gathering, as a large number of people will come from the nearby towns to hear you. I am purposely writing to you so early so that you may be able to make proper arrangements. The Scranton Committee will be too happy only to leave the choice of the date and the day to you, as they will accommodate themselves to your convenience. I wish to assure you that I would not make this request were it not for the absolute conviction that your presence will spell unusual success.


Dear Rabbi Silver:-





Dear Rabbi Silver:

Since my last conference with you in New York, I have had further occasion to consider the matter of the regional director for Ohio.

Our correspondence with Mr. Simon has given us the impression that he was not in a position to devote himself to the supervision of the Cleveland office as he had in the past, and in view of the many campaigns throughout the state long deferred, we have hastened to find a candidate for the regional directorship.

About a week ago an excellent candidate appeared in the person of Mr. Boruch Zuckerman whom of course you know. Mr. Zuckerman has been for years the general manager of the People's Relief Committee, also a member of the Joint Distribution Committee, and has had generally a wide experience in campaign work in particular, and Jewish communal work in general. His devotion to the Cause is of course beyond question, and so, too, I think is his intelligence and ability. He is also an energetic and hard worker and appreciates the importance of those qualities which are so necessary to the success of this work -- promptness, exactitude, follow-up, etc. The People's Relief has finally wound up its activities, and Mr. Zuckerman is about to become an active partner in a business in which he has until now had a certain share. We have been negotiating with him for some time, and Mr. Rothenberg and I are inclined to think that he would be

a valuable asset for our Organization. There remains, of course, the question of his personal views and his relation to various groups. For, Mr. Zuckerman, has, as you know, started out by being a very staunch radical Poale Zionist and rather revolutionary in his attitude towards the powers that be. In the course of his work in behalf of the Relief, while his enthusiasm has not been in the slightest weakened or dimmed, he has learned to work with others of a different mind. In fact, he has learned to appreciate the more bourgeois elements and their virtues to such an extent, that he has been criticized severely in his own party as "running after notables", and inclining too much to the right. He is no longer a member of the Central Committee of the Poale Zion, and I think for all practical purposes, one can describe him now as a general Zionist with radical democratic sympathies. I pointed out to him the fact that while no one would be concerned, particularly about his personal views, the groups with which we work are largely the "balibativim", so that it would naturally be expected that he would by his acts give no offense to the people with whom he will have to work. I think he understands that thoroughly and we can rely upon his good sense and his eagerness to attain success to guide his steps aright.

We have not taken this matter up formally with our Administrative Committee as yet, but there is no time to be lost because unless we make arrangements with Mr. Zuckerman within a week or ten days, he will be tied up with the printing business and will not be available. As it is, if we decide to engage him, he can begin work almost immediately. Incidentally I might say that he is going to send his family to settle in Palestine within a few months, in the hope of following them there eventually.

Mr. Simon came in from Cleveland yesterday and told me how sorry he was that he had not been able to see you on Monday as he had planned. Mr. Simon advises us that he has discussed this matter with Mr. Rocker who is favorably disposed toward Mr. Zuckerman.

I will of course discuss this with you in detail on Tuesday.

Dear Rabbi Silver:

I am writing you to Boston so as to lose no time, but I am also sending a copy addressed to you in Cleveland.

I am writing with reference to Zuckerman and the Cleveland campaign. I have received a letter from Mr. Efros reporting on a conference that he had with you together with Mr. Simon. We quite understand your position in the matter; viz, that Mr. Zuckerman would not be the proper person to influence the American or Americanized element of Cleveland Jewry. It seems to us, however, in the first place that our main support for the time being has no doubt been the Russian Jewish balabatim; and in the second place, there are the cities outside of Cleveland that have been neglect both with regard to propaganda, to campaigns and other Zionist activities; e.g., Akron, Canton, Youngstown, Columbus, Dayton, etc. It seems that both Mr. Efros and Mr. Simon still feel that there is need for a permanent regional director to look after the work all year round. In the third place, the question of the Cleveland Campaign must be considered. I understand that you have suggested that Mr. Leoser should be asked to assume the chairmanship again. Mr. Leoser is a very estimable gentleman, no doubt; but I think that everybody who knows the situation in Cleveland feels that the campaign in Cleveland can be a success only under one condition -- that you assume the largest measure of responsibility for the campaign, whether in the capacity of actual chairman for the drive or in any other capacity that you may choose. But however may be the formal arrangement, we all feel that we must lean heavily upon you. I don't have to labor the point. Both as the Vice-Chairman of the Z. O. A. and as the

leading figure in Cleveland, there is no escaping from that conclusion, and I should like to be in a position to assure our friends that you will assume that responsibility. I am the more concerned about the matter since our forces in Cleveland are, as you know, limited. The Executive Committee comes down practically to Mr. Efros and Mr. Simon who were personally responsible for a large part of the Keren Hayesod money raised in the past. Mr. Simon, I understand is in poor health and will be obliged to leave the city in the near future to go either to Palestine or to California. Under the circumstances we cannot content ourselves with the prospect of your merely giving the campaign your assistance. It is essential that you assume leadership. I hope you don't mind my putting it so bluntly.

With reference to Zuckerman, I would like to suggest the following: In view of the need of propaganda, organization and campaign work throughout the state, I would have Mr. Zuckerman engaged to proceed immediately with organizing the campaign in Youngstown and other smaller cities. We will be able to judge his work, and it will be possible for you and our friends in Cleveland to get a better impression of his ability to handle the situation, and we shall then be in a better position to decide definitely whether to engage him permanently for the regional directorship or not, and whether he should handle the Cleveland campaign or not. We feel that he is a valuable force and are loathe to lose him altogether. We do not wish to take any step contrary to your wishes. After mature deliberation we suggest this plan and would urge you to give it a trial. You know, my dear Silver, that we have no particular motive in urging Zuckerman upon you except our desire to see the territory well covered and a useful man drawn into our work.

I would appreciate it if you would reply to this letter as soon as possible. I know how rushed you are, but I hope you will find a few minutes to take care of this.

From all reports, I believe that you will find the situation in Boston quite encouraging.

Dear Rabbi Silver:

I have received your letter of December 10th, in reply to my letter of the 9th, with reference to the situation in Cleveland.

I am afraid you have misunderstood me, and I should not like any misunderstanding to exist between us. I could not conceive of the relation of the Keren Hayesod to you as a bureaucratic one, and certainly I do not consider that our work can be managed under a Prussian system, with 'discipline' as the keynote. If I mentioned the office you hold in the Zionist Organization, at all, it was not in order to use it as an argument why you must accept responsibility for the campaign, but as a reason operating in the minds of people why they should naturally wish to lean upon you in their own community. I think if you will reread my letter, you will see that was the intent of my words.

We know how helpful you were in the last campaign and, believe me, we appreciate it to the fullest extent; and it is only because we realize how limited are our forces in Cleveland at the present time that we felt obliged to write to you about the situation.

I hoped you might be able to assume the administrative and active direction of affairs. Indeed I still hope you will, not because you are in any way obliged to do so; but because your interest in the Movement and your earnest desire to further it are just as strong as mine, or any-one-else's in this country.

I hope to have the opportunity of seeing you again in the near future when we can discuss these matters personally.

Dear Mr. Szold:

Pursuant to the several conversations which you have had with Mr. Bernard Flexner, we are glad to indicate to you briefly the plan and purpose of the Palestine Economic Corporation, and to invite your participation therein.

The Palestine Economic Corporation has been organized under the laws of Delaware with an authorized capital of \$3,000,000, divided into 30,000 shares common stock, each having a par value of \$100, of which 25,000 shares are being offered for subscription at this time.

The Board of Directors will consist of about thirty members who will be elected from the membership of the Council. Thus far eighty-five gentlemen have agreed to come on the Council and lend the organization their assistance. The undersigned have agreed to serve on the Board if desired, and the following have likewise agreed to serve as its officers provisionally:

President	Bernard Flexner
Vice Presidents	Louis Marshall
	Herbert H. Lehman
Secretary	Joseph C. Hyman.

Arrangements are now under way, looking toward the acquisition by the Corporation of the assets in Palestine of the Reconstruction Committee of the Joint Distribution Committee, aggregating about \$450,000 on a conservative valuation, in exchange for shares of the Corporation. Similar negotiations have been taken up with the American Palestine Company, and it is to be hoped that the Palestine Cooperative Company will likewise consolidate its efforts with those of the Corporation. As the agency through which American Jews may serve the economic needs of Palestine, the Corporation hopes to coordinate both here and in Palestine the activities of those whose purposes and aims are similar to its own.

To this end, the Corporation will be ready to acquire the sound assets of the aforementioned organizations on the basis of an appraisal made, in each instance, by impartial and disinterested appraisers, and will issue its shares against such sound values determined as above; that is to say, one dollar in fully paid stock for each dollar of sound assets. No stock will be issued except for either cash or assets as stated.

The attainment of the object of the Corporation, however, will depend mainly upon the amount of fresh capital that may be raised in America, and the effectiveness with which such capital may be employed in constructive, productive work in Palestine.

The purposes of the Corporation are not philanthropic. It intends to aid only those enterprises whose management inspires confidence and gives promise of their productivity and permanent value to the country. The chief task will be to foster Palestinian undertakings through the extension of credit in various forms. It is contemplated that the business of the Corporation will be conducted on such lines that a substantial part of its capital will constitute a revolving fund. It will avoid the assumption of responsibility for the actual conduct of the business of the enterprises which it may decide to further, since it will not be practicable nor desirable that it shall provide managerial administration for such undertakings. While, in the opinion of recent observers, Palestine offers an opportunity for safe business undertakings, it does not follow that all the enterprises which the Corporation may help, are certain to prove successful. Some, although useful, productive and financially reliable, may produce neither quick nor large returns. As is the case everywhere, the result of some of the work undertaken will be disappointing, but, notwithstanding the risks always present in business, and despite the added risk inherent in the present state of Palestinian development, it is believed that a corporation of the character contemplated, will become a potent agency in the upbuilding of the country. The Corporation will employ its funds so as to stimulate a healthy growth of industry and commerce rather than attempt to realize the largest or quickest financial returns. It will be content if, by means of a conservative administration, it may keep its funds intact, accumulate sufficient reserves to enable it to provide against possible losses and other contingencies, and secure to its stockholders and investors a modest return upon their capital. The Corporation will make no promises or representations and will give no guarantees as to the outcome of its endeavors.

Applications for help have already been made by various Palestinian groups and enterprises. Such appeals will doubtless continue to be made. None of these can be considered now for the obvious reason that it is not possible for the Corporation to know what funds it will have nor when these will be available; and it is further only fair to other Palestinian groups which may seek the assistance of the Corporation, to state that nothing can be done until the Corporation is formally organized, has a definite idea of the amount of funds available for its purposes, and has caused each application for help to be thoroughly and intensely investigated on the spot by the accredited representative of the Corporation. In our opinion, commitments made in any other way or hopes held out on any other basis, will mean disappointment to the Palestinians and embarrassment to us.

We trust that the foregoing will serve as a basis upon which you may communicate with the members of your organization.

We shall be glad to go further into this matter with you at your very early convenience.

Mr. Flexner has been identified with the business of Palestine Cooperative Company since its inception as an active director. Copy of a letter received from Messrs. Flexner, Marshall, Warburg and Lehman, on behalf of Palestine Economic Corporation, is attached.

As appears from said letter, the new corporation

(a) will carry out the principles and policies of your Company, and

(b) will not issue any of its shares excepting for money, or assets fairly valued and appraised at money's worth.

It is contemplated that the new corporation will have, in addition to the assets of the Joint Distribution Committee, American Palestine Company and Palestine Cooperative Company, a substantial sum of new money in cash, at least to the amount of the net assets of Palestine Cooperative Company; and that the stockholders of Palestine Cooperative Company will receive in exchange for their shares, at least an equal number of shares in the new corporation.

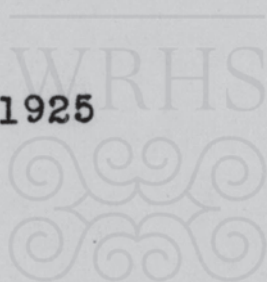

Dear Rabbi Silver:

I am sorry that I delayed until now in writing to you with reference to ^{your} projected visit to New York in connection with our Campaign.

I have gone over the ground very carefully with Mr. Zeldin, and we have come to the conclusion that, inasmuch as you would be unable to devote more than one day to the trip to New York at present, we are not warranted in insisting upon your coming at this time. The sectional campaigns are under way and there are sectional dinners which we can in some way manage to take care of with local talent. We would rather reserve you for a date a little later, when there may be need for a large city-wide affair with a speaker of outstanding reputation. I need not tell you that we all deeply appreciate your willingness to assist us, and that we will use every effort to make the future function which we hope you will attend fully worthwhile.

The other day, Mr. Archibald Silverman came in from Providence, and repeated the request which had been made several times, that you agree to open their Campaign for \$40,000 in April right after Passover. I really believe you would enjoy going to Providence, because they have a splendid group of representative men and fine workers who always deliver the goods. Perhaps we can manage to have this Providence date arranged close to the date of our big affair in New York, to which I refer.

En passant, I might tell you confidentially that last Sunday I had a visit from Mr. Billikopf and Mr. David Bressler, who evidently had been requested by Mr. Marshall to help in getting the work of the Palestine Economic Corporation started, so far as fund-raising is concerned. Mr. Billikopf and Mr. Bressler wanted us to supply them with a list of our principal contributors in New York and other ~~particulars~~, for the purpose of inviting them to a dinner at which their subscriptions would be solicited for the Corporation. We took this matter up at a meeting of our Board the other night, and the feeling was very strong that the Palestine Economic Corporation ought to go out for new contacts and new groups, particularly non-Zionists who have hitherto held aloof from every form of Palestinian work, rather than work again the groups from whom we have been getting money year in year out for the Keren Hayesod. There is considerable feeling on this subject in our circles in New York right

now, ~~and~~ I am afraid we are in for some disillusionment; and yet I somehow keep hoping that they may really be able to bring in new groups and enlarge the circle of those who are participating in the upbuilding of Palestine.



Flatbush \$752 From Quota

Section Makes Sensational Spurt and Will Probably Be First to Reach Goal

Flatbush is only \$752 shy of its \$30,000 quota, with \$12,748 in cash and \$16,500 in pledges. Max Kiss, go-getter chairman of the section, assures us that these pledges are as good as spot cash and that we can safely credit Flatbush with \$29,248.

This sudden forward spurt of Flatbush is a dramatic climax to the quiet but effective, slow but sure campaign tactics which were adopted by the section under Mr. Kiss's and his able assistants' direction. At present it appears as if Flatbush will be the first section to complete its quota.

The synagogue appeals in Flatbush during Passover were very successful, a total of \$5,350 being pledged by the various congregations. On April 21, another campaign rally was held at the Capitol Club on Beverly Road and plans discussed for completing the campaign in proper fashion. The Palestine Film was exhibited before an enthusiastic audience on April 23 at the Jewish Communal Center of Flatbush, on Avenue I. Rabbi A. M. Heller, a veteran Keren Hayesod speaker, delivered an inspiring address. A number of other functions to further stimulate the campaign have also been arranged.

Passover appeals were made in the following synagogues: Shaare Torah, Judge Bernard A. Rosenblatt and Rabbi Joseph Miller; Young Israel, Maurice Firth and Adolph Flam; Kings Highway Jewish Center, M. Lord Balfour and the Keren Hayesod Colony Nahalal

(From an Editorial in the Syracuse Post-Standard)

Interesting as have been the accounts of the new Hebrew University for whose founding ceremonies Lord Balfour journeyed to Palestine, other news from the land which is being rebuilt by the Jews deserves, and doubtless is getting, equal attention. That is particularly true in respect of reports on the development of agriculture, for they tend to upset our notions that Jews are successful only in business and do not adapt themselves to the soil.

As an example of what is being done on the land, an excerpt from a wireless dispatch from Nazareth to the New York "Times" on Lord Balfour's visit to the co-operative colony of Nahalal is enlightening. "Nahalal," the dispatch says, "was founded three and a half years ago near a vast swamp with mosquitoes infected with malarial germs. The Germans forty years previously had attempted to colonize the place, but were compelled to abandon the scheme, and the Arabs used to say that even birds could not exist there. During the first summer the Jewish colonists suffered severely, sixty per cent. having malaria, but all is changed now. There are not mosquitoes and there is no malaria, and, thanks to fourteen miles of canals, the water which formerly fed the swamps can be used for irrigation. In their short time the colonists have raised 60,000 vines, 30,000 fruit trees and 25,000 other trees in addition to building

a dairy. The seventy-five families in the settlement cultivate 2,000 acres co-operatively in the sense that all buying and selling is done collectively, but each man's holding is his own."

Lord Balfour, after hearing from the head of the colony the history of the settlement said, quoting from the same dispatch, "that it was idle to assert that Jews were townsfolk, for there was ample and conclusive proof that they could turn into agricultural communities."

Naturally the prospect of ancient Hebrew scholarship being revived and centered in a great Hebrew University seizes the imagination. But it is fortunate, as Lord Balfour pointed out in his speech of congratulations to the Jewish colonists, that the Jews have concentrated neither on the material aspect nor on the abstract consideration of learning, but on the contrary realize that those ideals must be combined, that the University of Jerusalem and the Technical Institute of Haifa on the one hand must be balanced by the great commercial and agricultural efforts such as those now under way.

Lord Balfour paid a tribute to the generosity of American Jews in the colonization of Palestine, and said they would rejoice when they "see what has been achieved here."

EASTERN PARKWAY HAS REACHED \$46,000 MARK

Morris Miller, who has been the most active figure in the Eastern Parkway campaign since Rabbi Israel Herbert Leventhal left for Palestine to attend the Hebrew University dedication, announces that \$46,000 of the \$50,000 cash quota has been raised and that \$29,000 of this is in cash.

Over \$9,000 in pledges resulted through appeals made in Eastern Parkway synagogues during Passover.

Mr. Miller also tells us that the additional \$4,000 needed can be considered as already raised among the various prospects who are still outstanding and that the section does not intend to stop when it reaches the \$50,000 mark.

The Keren Hayesod has branches in forty-five countries. The largest per capita contribution is given by the Jewish community of South Africa.

Mrs. Gottheil in Palestine Appeals for More Service

PASSOVER APPEALS IN WILLIAMSBURG \$6,000

The Williamsburg campaign committee reports that as a result of its Passover appeals, which brought in \$6,000 in pledges, the section has realized to date \$32,500 in cash and pledges. The local quota is \$50,000.

\$18,500 of the Williamsburg total is in cash, and President Max Blumberg is now spurring on his workers to collect on the old pledges as well as to solicit new contributions in order that the section should make a good showing on May 11. He hopes to get at least \$16,500 more in cash by that time.

The First Hebrew Opera

Extracts from "The Pioneer", the first Hebrew Opera ever written, the work of Professor Jacob Weinberg, were given for the first time during the Passover Holidays in Jerusalem by the Palestine Opera Company in honor of the dedication of the Hebrew University.

HARLEM SUCCESSFUL IN PASSOVER APPEALS

EXPECT \$53,000 FROM LONG ISLAND MAY 11

The participating Communities in Queens are now on the last lap of their Campaign, and are aiming to have the maximum cash and pledges to report at the Wind-up Dinner on May 11th.

The Far Rockaway Committee, headed by Dr. A. B. Cohen, Judge B. A. Rosenblatt, Dr. Norman Salit, Moe N. Berlin, Michael Salit, Maurice N. Hyman, Mrs. R. Altschul and Harry I. Wildenberg, opened its Campaign with a Dinner on April 5th, and is pointing its guns at the \$15,000 mark which it expects to have in cash at the Wind-up. The Committee expects to have an additional \$10,000 in pledges by May 11th.

The Jamaica Committee, led by Max Alpert, Harry Serkin, A. Seril, Frank Berman and A. Rappaport, is now heading for the \$8,000 mark and expects to have an additional \$2,000 in pledges. The Rockaway Park Committee expects to turn over a total of \$2,000 in cash with additional pledges of \$500.

The total expected for the five Communities by May 11th is \$53,000 of which \$36,000 is expected to be in cash. These figures by far outstrip the record in last years campaign and do not include such important communities as Arverne, where an appeal for the Fund will be conducted through the Derech Emunah Congregation on the Shevouth Holiday; Edgemere and Rockaway Beach, where the appeals will come later in the year, and Morris Park, Middle Village, Elmhurst, Winfield, Astoria, Corona, Long Island City, and some of the other smaller Communities in Queens which are now making preparations for their Drive the latter part of May.

1,000 Jewish Immigrants Admitted To Palestine In One Day

On March 14, the largest number of immigrants were admitted to Palestine thus far. On that day 700 immigrants came in on the S. S. Braga, in addition to 223 tourists. Of these 450 were landed at Jaffa and the rest at Haifa. On the same day 300 immigrants were landed at Jaffa by other vessels, making a total of 1,000 new settlers.

In the entire month of March 3,300 immigrants, the largest number ever admitted within a similar period, came into Palestine.

As contributions to the Keren Hayesod increase, so will immigration proportionately grow.

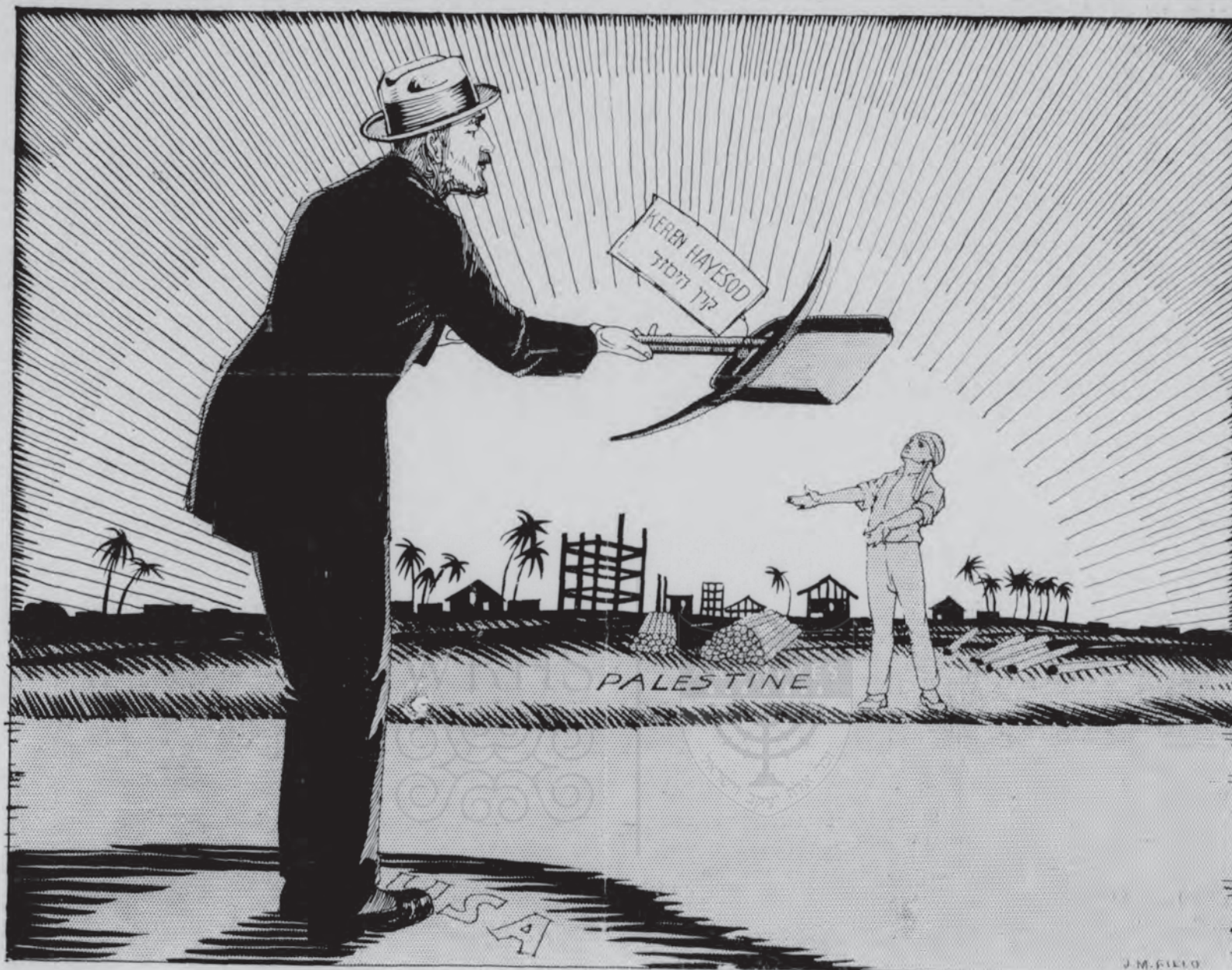

OVER 400 ATTEND BENSONHURST DINNER

SECTION LACKS \$5,000 OF ITS \$35,000 QUOTA

As predicted the Bensonhurst dinner at the Colonial Mansion on April 18th was an overwhelming success. Over four hundred representative Jews of the section were present at this gala Keren Hayesod function and heard addresses by Senator Selden P. Spencer, Louis Lipsky, Maurice Samuel, Rabbi Nachman, H.
