My dear Rabbi Silver:

The progress that has been made since my last visit, more than two years ago, is unprecedented. The J.N.F. is restoring the soil. The reclamation program is going forward at a faster tempo. A visit to Adullam that our President, Dr. Levine and I made, left us breathless.

The visit has given us new inspiration. The Medinah is being transformed. We can all take great pride in the miraculous development.

Israel is realistic. There is no escape from the political realities. The leaders are not minimizing the changing position of Israel as a result of the developments in Iraq, Jordan and Lebanon. The people here are calm. They are not half as disturbed as some of your friends in America. There is no visible evidence in Israel of fear or uncertainty. This is a great and gallant people.

Our high level discussions with the leadership here have been fruitful. We have been advised that the negotiations are coming to a head. This new plan will open new vistas for the J.N.F.

Please accept my warm and cordial greetings. I wish it were possible for you to be here and to share in the exultation that comes to those who are now in Israel.

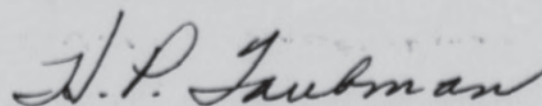
