As a leading citizen of Ohio, you can be helpful this year in making our State's role in the National Employ the Physically Handicapped Week Campaign, October 2-8, a successful one.

Our problem and the objectives of NEPH Week, now in its fifth year, is to demonstrate that it is good business to hire the handicapped. A recent U.S.Department of Labor survey revealed that the properly placed handicapped person is not only the equal of the non-handicapped from the efficiency standpoint but is his superior in terms of safety on the job.

Today, there are more than 25,000 handicapped persons in Ohio who are either actively seeking work or are in the process of rehabilitation. Finding jobs for these people is something more than a humanitarian gaol; it is essential to a sound economy.



Joe Kapell has advised me of his conference with you and Mr. L. W. Neumark regarding the matter of the inclusion of the position of Jewish Chaplain in the table of organization of the Cleveland State Hospital. On behalf of my Committee, as well as myself, I wish to express our appreciation to you for your offer to help us with this problem.


The Jewish Chaplaincy Program at the State Hospital was the result of approximately two years of study by a committee of the Federation of Jewish Women's Organizations of which I was the Chairman. This Study Committee developed after many members of our community were acquainted with the lack of a consistent program for Jewish patients at the State Hospital. We learned that historically services to patients at State Hospital were provided by the Catholic and Protestant groups. Through the years, various Jewish organizations from time to time planned religious and social programs for Jewish patients at State Hospital. It was our Study Committee's opinion that sporadic efforts were not conducive to the establishment of a proper responsibility of the Jewish community to the Jewish patients in this institution.

Our Study Committee recommended a part time Chaplaincy Program, and with the help of the Council of Jewish Women the necessary funds, \$1200 per annum, were made available for such a service. The Committee selected Rabbi William Seligman, Assistant Rabbi, Park Synagogue, as the Chairman.

As a result of our close interest in the program at State Hospital, we learned that there is a permissive clause in the State laws regarding mental institutions which permits the Director of the Hospital to include in his table of organization the position of "Chaplain", and that the State budgets for this position. Lausche Executive Mansion Columbus, Ohio My dear Governor: I should like to bring to your attention a subject which has disturbed members of the Jewish community of Cleveland and which, in their judgment, involves a matter of principle. At the Cleveland State Hospital the services of chaplains are provided for Catholic and Protestant patients, and the budget is met by the State. No such provision is made for the services of a Jewish chaplain to look after the spiritual needs of the considerable number of Jewish patients at the Cleveland State Hospital. Several years aco a request was made to include the services of a Jewish chaplain at the State Hospital. This request was not granted. The Jewish community, through the Council of Jewish Woman, then proceeded to engage the services of a part-time chaplain at its own expense which amounted to some \$1200 a year. Our community feels, however, that this form of discrimination is unjustified, and again last November took up the matter with Dr. E. H. Crawfis, Superintendent of the Cleveland State Hospital, who agreed that the time had come when the position of a Jewish chaplain should have the same status as the Catholic and Protestant chaplains now enjoy. Dr. Crawfis wrote a letter to Dr. Baker. Commissioner of the Division of Mental Hygiens, copy of which I am enclosing, in which he requested that an additional position for a Jewish chaplain be established at the Cleveland State Hospital. Dr. Baker's reply to Dr. Crawfis, dated November 16, 1950, is hereto also attached. It is clearly unsatisfactory. I believe that the natter is of such importance as to warrant carrying it beyond the office of the Commissioner of Hental Hygiene and to bring it to your attention. I received your letter of January 11th and read what you said about a disparity in the treatment accorded those who are rendering the different religious services at the State Hospital in Cleveland, Ohio.

Please be assured that the knowledge which you gave to me in your letter is the first intimation that has come to me that the course followed by the State in procuring Catholic and Protestant religious services is different from that related to the Jewish service.

If the State is defraying the expense of the Catholic and Protestant service, unquestionably, it ought to do likewise in respect to the Jewish service. I will see to it that the views which I expressed will be carried into effect.

I am in full accord with your proposal that Jewish Chaplains be employed at our state institutions where there is a sufficient Jewish population to justify the same. The budget that has been submitted for the Cleveland State Hospital includes sufficient money to establish an additional position for a Jewish Chaplain at that institution. If the Legislature follows our recommendation, funds will be available for this purpose on July 1st, 1951. At present, we are unable to establish such a position because of limited appropriations. First of all I want to tell you that I regret that I have not had the occasion of being with you as frequently as I would like.

The other day when I got through listening to General Douglas MacArthur I said to myself it was the best speech I ever heard except a number which I heard you give. The only difference in my reaction was that while your talks were better, they also expounded action with which I was in agreement.

I can not say that I agree with General MacArthur in the course which he advocates as a solution of our problem. While I believe that we may have to eventually come to his suggestions I can not see that at this time we should give up hope that we can do something through the United Nations Organization.
