Dr. Harry Lee Franklin was born in Lexington, Kentucky in 1895. He was the American consul in Berlin for twelve years, from 1926 to 1932. He has recently contributed articles to the Literary Digest, the Louisville Times and other newspapers throughout the country. He is the author of "Germany's Tobagganing Trade Balance". He has lectured widely since his return from Europe, and during the coming season he is to deliver lectures on Germany and Austria under the auspices of the League of Nations Association. He knew European correspondents of American newspapers in Germany and is familiar with the difficulties they have had in reporting news from Germany. Working with these newspaper correspondents, he learned at first hand the aims and methods of Nazis and he presents the unbiased views of a good investigator in the narrative form of the reporter.

My dear Mr. Goldhammer:

In annalyzing our expenses from June first to November first, 1934, we have averaged an expenditure of \$342.38 per month.

You will note that our October expenses were \$378.90, and that our November expenses were \$481.33. This increase for October and November indicates that we cannot accept the \$342.38 monthly average as the figure for our monthly expenses for the heavy months of November, December, January and February. We feel that \$425.00 per menth is the minimum on which we can operate. It is necessary for us to hold one or two large public meetings, and to pay speakers to appear before groups which have been propagandized by our adversaries.

We now have a great many committees at work, and this means increased cost of telephone, postage and office supplies.

Above all else, we feel that we are achieving our goal in the boycott, and this means expense both in propaganda and in maintaining our constant contacts with the stores.

Therefore, we feel that we are not safe in estimating our monthly expenses as less than \$425.00. I assure you that Miss Chadsey has watched the budget very carefully and has made every effort to keep the expenses down, and I am sure that if she can effect savings that will reduce the office expenses below \$425.00, she will do so.

ATTENTION: MISS CHADSEY Dear Miss Chadsey: When the League for Human Rights Against Naziism was formed I became a member, as I was not and am not in sympathy with the anti-Jewish actions of the Mazi Government. Since that time, however, in the actual operation of the League, it has adopted the trade boycott against Germany as one of its measures. I cannot feel that such tactics can work in any other way than those of arousing intense bitterness. The way to make progress in matters of the spirit is to do so through negotiation, conciliation and an effort to reach mutual understanding. The boycott method is the opposite of these. My dear Rabbi Silver: A friend and associate, who is at the head of a large manufacturing industry, which is a member of the American Chamber of Commerce in Berlin, has been for some time wavering in his desire to continue his company's membership in the Chamber. He is a broad-minded man - antagonistic to Hitler and Naziism. He does not directly import goods from Germany but has been trying for some years to seek a German outlet for his own products. He has made a few sales, the payments for some of which have not been prompt or satisfactory. Now he is advised that payments to a substantial amount must be in German merchandise. He has just sent a very strong letter to his German representative signifying his decision to retire from the German field and resign from the American Chamber of Commerce in Berlin. I quote from his letter-"******You don't appreciate how strong and general is the Boycott against German Goods. My sympathies are wholly with the movement. It should be continued and strengthened and made still more aggressive. Our friend, Mr. Mandelbaum, has just handed me a copy of the March edition of the Economic Bulletin, which I enclose, calling my attention to the editorial by Dr. Silver, one of the nation's outstanding scholars and community leaders, for whom I have great respect and admiration. Then read the list of American firms. on Page 4- Borgfeldt - Banner Coal - Julius Kayser - large and important concerns - then tell your friend, Julius Lippert, he's an ass. ****** I thought you would be interested in the above, which is not for publication. When with Father Coughlin last week, he mentioned your name and spoke very highly of you. He intimated that he hoped to have you with him in Cleveland. I am wondering whether he has invited you and whether you have accepted the invitation.

I am receiving abusive letters from all over the country. The Associated Press gave an erroneous report of what I said even though twenty copies of my manuscript were available on the press table. I practically gave my prepared talk verbatim. I have written a letter of protest to the head of the Associated Press, but the damage has veen done.

The Detroit Free Presson Friday morning, April 26th, in an editorial, which, which, address tenclose herein, was quite complimentary to me. Now that the whole thing is over, I am satisfied that going was the wise thing. It was not a bad thing for a rabbi to have been present before that packed meeting. I was not the only speaker on the platform who was not in sympathy with Father Coughlin's program. I was amazed at Bigelow. He is the Ohio organizer of the National Union for Social Justice.

In a private conversation with Father Coughlin, which lasted for several hours, he denied his anti-semitism. What may be in his heart, I cannot determine, but I do know that he is very anxious not to appear as an anti-semite. That being the case, I see no reason why Jews should insist that he is one. Hitler never would have invited a rabbi to speak on the platform with him, nor would Hitler ever have denied his anti-semitism. The fact that Father Coughlin is very anxious to do so is a very encouraging thing in the American scene. In his conversation with me, he definitely stated that he would right any anti-semitic movement in America as long as he is on the air, and added that he would not be a priest if he did not do so. He claims that we Jews were too sensitive, etc., etc. He is not a spiritually sensitive personality. He comes of humble Irish parentage and has all the provincialisms and parochialisms of his early environment. He is not an intellectual. When he becomes angry, he calls name , and when attacked he fights back, and apparently does not mind hitting below the belt.

Silver -2 I think that he is sincere in his desire to do something for the poor. In a way I think it a pity that the intelligentsia of America are spurning him, as they might channel his social sympathies into constructive patterns. I do not like his associates. Among them was a governor of the cotton exchange of New York, whom I am certain has no interest in social justice, and who is probably prepared to exploit Father Coughlin's popularity with the American people. When I told Father Coughlin that I could not follow him on his monetary plan, he answered that I could not be for social justice. He contends that money is the root of all evil and that only by attacking the money problem can social justice be established. He is inclined to be a fanatic. In his address, he stated that all decent people will join us. Apparently he feels that political or economic heretics are indecent. Some day I hope to have a chat and discuss the entire thing with you. In the meantance of an anxious to know whether he invited you and whether you have accepted his invitation. My dear Miss Chadsey:

Many thanks for wire and letter. I agree with you completely that it would not be worthwhile under the circumstances which you mention to have a badly attended meeting at this time, and I agree with you of course to postpone it for the Fall. But as a matter of fact I am already working out my schedule for the next season due to the American custom that most of the clubs and organizations like to fix their dates and speakers very early. I shall spend the first half of October around Wisconsin and Minnesota; the second half of the month I have to be in New York. The November and December are already occupied - so what about October the 16th and 17th, which are Wednesday and Thursday? You would do me a great favour if you kindly inquire whether the organizations you have in mind could fix up those dates because that will be the only possibility at all. The fee will be \$75 each lecture because beginning with next year I have to take care of eight persons; my father in law who is a stage director in a very good position has been informed that next year his contract will not be renewed due to my activity abroad, so that I am the only one in our whose family to be able to work, and therefore I have to arrange my next lecture tour upon a businesslike basis. Would you please let me know as soon as possible to my permanent mailing address whether those two clubs are willing to have me speak at the two dates which I suggest.

One other request which I have more to Mr. Scheuer, Mr. Morris and who else would be able to do something. Sailing back to Europe the end of this month, I am going as soon as I am there to Prague, and I am going to have a already prepared conference with the delegates of our underground people, which is going to be held near the German border (I do hope to escape the danger to be kidnaped!). I would much like to come to those extraordinary brave and courageous people not with empty hands, and I would like to have a certain amount to take care of the victims of the underground work and their families. If I can give to two hundred families \$20 each, which is 50 marks, it will be a great help; I am writing to all my friends over the United States to get this amount together before I leave, to take it with me. Would it be possible that some of your members who are interested in the active struggle in Germany to get \$150 together? If so, and I sincerely do hope so, please try it and send it to my account - The Chase National Bank West Fourteenth Street Branch, New York; there is no need to be afraid of, nobody will learn anything, I change the money in Czechoslovakia and deliver it myself. But please do it, please!

Goldhamer I understand that the budget committee has appropriated \$3,000. for the League for Human Rights Against Maziism for the current year. Sometime ago, we submitted to you a budget showing a minimum estimate of \$4,500. \$3,000. per annum will not cover salaries and it is impossible for this organization to function unless the appropriation is increased. As of May 1st, The League had accrued a deficit of \$650. The writer personally borrowed this amount and loaned it to the League in order to pay the back salary due Miss Chadsey so that she could go away on a vacation and unless funds are forthcoming to cover the deficit, it will be necessary to close the office and discontinue the work of the League. Mazi activities are not diminishing and daily reports are coming in, which need immediate attention. If the good work which hes been accomplished in maintaining the boycott by constant contact with Claveland stores, is dropped, all that has been accomplished in the past will be lost and if, therefore, it is impossible for the Welfare Federation to allocate any more funds to the League, it will be necessary for us to either discontinue or to raise funds by public subscription immediately. We feel that instead of decreasing the appropriation for the League, that it would be worthwhile for the welfare Federation to seriously consider advancing a minimum of 5,000. to this organization because every dollar over and above the 4.500. minimum can be used to investigate Mazi activities and to bring speakers to Cleveland to combat Mazi propagarda. The League has not been able to do as much of this work as it should because of the lack of funds in the past and it should not be hampered in the future if it is to continue. Under the circumstances, will you please advise us at the earliest opportunity as to whather the action of the budget committee is final or if it will be reconsidered. Sincerely yours, Elmer Scheuer.
