Addendum to my letter of November 10th

This will unquestionably be rather academic by the time it reaches you, but I would like you to know my view about Irving's participation in the Jerusalem Conference dealing with the reorganization of the American Zionist scene.

I argued against his participation in this meeting long before BG's blast against the ZOA was reported in the New York Times. I felt - and still feel - that the chances are very slim for achieving the type of reorganization of the American Zionist Council which would not endanger the interests of the ZOA. If I have been right in assuming that this Conference is likely to be a failure and that its "success" would depend on Miller's readiness to make certain compromises affecting the independence and functions of the ZOA, then why get into it in the first place?

Moreover, I have very definite reservations with respect to the manner in which this Conference has been initiated. While the chairmen of the Jewish Agency certainly have a right to issue invitations to such a meeting, I question whether the Prime Minister of Israel is entitled to do so. The initiative assumed by BG is, to say the least, disquieting.

I wish to emphasize that the above observations refer exclusively to the Conference called by BG, Locker and Goldmann, and are in no way related to the Actions Committee meeting, which is a chapter in itself. Correct me if I am wrong, but I have a hunch that your position on Irving's going to Jerusalem has been largely determined by your thoughts on matters related to the Actions Committee. I can certainly imagine that you would like to have Miller on the scene to share responsibility for actions that may have to be taken (or avoided) on behalf of the ZOA in the course of the Actions Committee sessions. It is therefore unfortunate, from my point of view, that the Conference on the future of American Zionism has been arranged to coincide with the Actions Committee meeting, as it is quite difficult to make it clear that while Miller's participation in the former meeting is inadvisable, there are some compelling reasons to warrant his presence on the scene during the Actions Committee deliberations.

I must add that I agree fully with Lipsky's contention that any conference on the reorganization of the American Zionist Council should rightly be held in the United States - although even here the chances of success would be very limited. I also agree with Lipsky that this is not a matter to be decided by the leaders of the Government of Israel. Of course, Lipsky's motivation in taking this position is considerably different from my own.

Finally, I think you should know that Silver has expressed to my very strong objections to Irving's participation in the conference.

Needless to say, I hope that my pessimistic analysis of this question will prove to be incorrect. I know what a difficult task you will have on your hands during the coming weeks and I send you, in addition to my warmest regards, my fervent wishes for success.

Dear Dr. Silver:

After our telephone conversation of today, I phoned Harry Shapiro in order to obtain precise information on the situation in the higher echelons of UJA administration.

I learned that Schwartz is primarily a "front-man," and requires the services of an overall administrator who supervises all the departments of the UJA. This function was first carried out by Mr. AN Nisselson, who resigned a few years ago. His successor was Moritz Gottlieb who died recently.

To the best of Harry's knowledge, the job is still vacant. He would most certainly like to be invited to accept this position, though, for obvious reasons, he has not and will not put himself forward as a candidate.

If, as is rumored, Schwartz will leave the UJA during the summer, this position will acquire even greater importance. The non-Zionists would obviously seek to exercise even greater control over the entire UJA setup than they now enjoy. With Harry Shapiro in ^{this} key spot, however, there will at least be a measure of protection for Zionist interests. The political changes now taking place in Israel would seem to make greater Zionist representation in the UJA mandatory.

Quite apart from these considerations, it should not be overlooked that Harry is unquestionably the best man in the UJA organization, and his record will prove it.





Editorial in the NEW LEADER of February 16, 1953

DR. SILVER EQUIVOCATES

For one whose reputation as a Jewish clergyman and Zionist leader is as eminent as Rabbi Abba Hillel Silver's, his reactions to the outbreak of anti-Semitism behind the Iron Curtain are, to say the least, peculiar.

Shortly after the Prague purge, Dr. Silver was quoted as saying that he could not "believe" that the Russian or Czech Communist regimes would indulge in anti-Semitism, and urged that we await "proof" until we condemn these "friends." (This statement was front-paged by the DAILY WORKER, which was then hard put to find a prominent American to "explain" the Prague bloodbath.)

Last week, as tens of thousands of Jews and others were fleeing an epidemic of Soviet genocidal terror, Dr. Silver said at his sixtieth birthday dinner:

"It is not too late for some authoritative statement or act on the part of the highest Soviet leadership to clarify the situation, set the record straight, relieve the minds of men of fear and suspicion..."

The dinner at which Dr. Silver spoke was held by the Zionist Organization. Yet it was Governor Dewey who uttered the words that should have come from the Rabbi:

"Zionism as such has now become a crime behind the Iron Curtain, and merely being born a Jew is now cause for hanging."

A day later, the former General Secretary of the U.S. Communist party, Earl Browder, unwittingly made the retort par excellence to Rabbi Silver in the N.Y. Post:

"I don't occupy myself with whether the charges are true or false, or whether they really constitute anti-Semitism.

"Their practical effect is to set in motion wheels for the ultimate destruction of 2,500,000 people who are identified by their origin."

We don't know whether Rabbi Silver would accept the new SOVIET

ENCYCLOPEDIA as authoritative enough "to clarify the situation," but it has done so admirably well. It announces that Jews are not a national minority because they are not a "historic, concentrated, stable community of people." If anyone accuses the U.S.S.R. of anti-Semitism, it can now retort that there is no such thing as the Jewish people. Indeed, the ENCYCLOPEDIA adds that "the Jewish question in the Soviet Union does not exist" - all that exists is, according to the official count, 3,020,000 Jews, who will now, presumably, be made to conform to official theory by disappearing. Israel - where Jews are trying to erect a "stable community" - is reactionary; and Zionists - that is, people like Dr. Silver - are "agents of American and British imperialists."

Rabbi Silver, not incidentally, remains one of sixteen individuals who have not answered a telegram we sent on January 14 to thirty-five supporters of clemency for the Rosenbergs, in which we requested a "forthright condemnation" of Soviet anti-Semitism. The other fifteen, whose names we deem it worthwhile to call to public attention, are: Nelson Algren, Morris Carnovsky, Howard da Silva, Arnaud D'Usseau, Rev. Stephen Fritchman, Dashiell Hammett, Ray Lev, Frederick J. Libby, Rev. John H. Melish, Rev. William H. Melish, Anton Refregier, Paul Robeson, Mary Church Terrell, Mary Van Kleeck and Rev. Harry F. Ward. Paraphrasing Dr. Silver's appeal to Soviet leaders, we would say that it is not too late for him to make "some authoritative statement" that will "clarify" his own attitude toward Soviet anti-Semitism.

My dear Harold:

There is a couple here who want to settle in Israel. The man is a graduate of a vocational school and has had some years of experience as a plumber. He had service also in the United States army. His wife is a graduate of a local college with a B.A. degree and has also been a teacher of Hebrew. They are prepared to go. They have corresponded with the Jewish Agency. They will have living quarters when they get there. What is troubling them is the cost of transportation, plus the freight rates for shipment of their furniture, plus the tax which they will have to pay on their belongings when they arrive. Is there any fund for Aliyah for Americans? It seems that what is involved here is some \$400 to \$500 inasmuch as they have some money themselves to pay towards transportation charges.

Dear Miss Wagner:

Thank you for sending us the tearsheet of the Jewish Agency picture which you used in your Yearbook.

I must say that I am distressed over the many errors in this piece.

Dr. Nahum Goldmann (should be spelled with two N's) was not co-chairman of the World Zionist Congress. He was President of the World Zionist Congress.

You state that the resolution adopted by the World Zionist Congress (last paragraph on page 1183) was "a decisive victory" for a bloc led by Dr. Abba Hillel Silver. The granting of a special status to the Zionist Movement advocated by Dr. Nahum Goldmann in his opening address, was the evident desire of all Zionists. No single bloc or individual should be given credit for this resolution.

There was no bloc of "American delegates," as inferred in your article. The American delegates represented various parties, each with its own views.

No single individual can be described, under the multi-party system, as "the leader of American Zionism." Such description gives the American Zionist Movement a monolithic character which it neither desires nor possesses.

The top officials for the World Zionist Movement were elected by democratic ballot. No single party prevailed at that Congress. It is a misstatement, therefore to impute that any single leader was prevented from occupying office, because of the influence of any one party.

The future of the Zionist movement, its organizational and ideological problems and its relationship to the State of Israel - these issues, which arose following the establishment of the Jewish State in 1948, remained unresolved and acute in 1951.

Zionist spokesmen had repeatedly declared that a strong Zionist movement would be indispensable to the State of Israel for an undetermined period: Israel's precarious position in the Middle East and its critical economic situation underlined the continued need for an effective World Zionist Organization. Moreover, it was pointed out, a vigorous Zionist movement is also essential for the health and vitality of Jewish life throughout the world. Nevertheless, some - including leading personalities in Israel - had questioned or opposed the continuance of the Zionists' special status in relation to the Jewish State. In the three years since Israel's establishment, the position of the World Zionist Organization, and of American Zionism in particular, had been drastically reduced.

Only a World Zionist Congress - the highest deliberative body of the movement - could provide a definitive solution to these problems. The first gathering of this kind since the birth of Israel was therefore awaited with more than the usual interest. After a number of postponements, the Twenty-third Zionist Congress was scheduled for mid-August in Jerusalem.

The various Zionist parties formulated their positions in advance of the Congress. The Zionist Organization of America, at its

national convention held in June at Atlantic City, New Jersey, unanimously reaffirmed "the fundamental conception of the world Zionist movement as the recognized and accredited body representing the Jewish people in relation to Israel." Recalling the historic role of Zionism in mobilizing the spiritual, material and moral resources of the Jewish people in behalf of the Jewish State, the convention stated that "the World Zionist Organization must continue to possess special status and retain freedom of action in its own proper spheres... The World Zionist Organization must possess constitutional independence and autonomy in the administration of its activities. The component parts of the world Zionist movement should similarly enjoy full administrative autonomy within the sphere of their competence."

This policy proved to be the chief subject of debate in Jerusalem. The advocates of a powerful and influential movement, led by Dr. Abba Hillel Silver of Cleveland, Ohio, scored a decisive victory when the Congress unanimously considered it "essential that the State of Israel, through appropriate legislative act, grant status to the World Zionist Organization as the representative of the Jewish people in all matters that relate to the organized participation of Jews the world over in the development and upbuilding of the land and rapid absorption of its newcomers."

An attempt was made at the Congress to supplant the traditional Basle Program of Zionism with a new "Jerusalem Program." This was vigorously opposed by the American delegates, who contended that the long-standing aims of Zionism still await total fulfillment. They ^{held} that, instead of substituting new aims, the Congress should define the tasks of the movement. This view

prevailed in the final vote. Zionism's tasks were listed as follows:

- A. The strengthening of the State of Israel.
- B. The ingathering of the exiles in Israel.
- C. The fostering of the unity of the Jewish people.

The Congress then outlined the work of the World Zionist Organization:

- A. The encouragement, absorption and integration of immigrants and Youth Aliyah (the youth immigration program); the stimulation of agricultural settlement and of economic development; the acquisition and development of land as the property of the people.
- B. Intensive work for chalutzut (pioneering) and hachshara (pioneer training).
- C. The effort on a large scale for the mobilization of funds for the purpose of carrying out the tasks of Zionism.
- D. The encouragement of private capital investment.
- E. The fostering of Jewish consciousness by the propagation of the Zionist idea and strengthening of the Zionist movement; the imparting of the values of Judaism, Hebrew education and ^{the} spread of the Hebrew language.
- F. The mobilization of world public opinion for Israel and Zionism.
- G. Participation in the effort to organize and intensify Jewish life on a democratic basis and the maintenance and defense of Jewish rights.

Notwithstanding its accomplishments in the sphere of world Zionist policy-making, the leadership of American Zionism did not fare well in the matter of the composition of the movement's executive bodies. The largest party at the Congress,

the Mapai, headed by Israel's Prime Minister David Ben-Gurion, refused to yield to arguments that the widest possible coalition should prevail in the new Executive; nor did it agree that the leader of American Zionism, Dr. Silver, should be invited to occupy high office in the World Zionist Organization.

Since the Congress, some doubt has been expressed as to the ability of a narrowly-composed World Zionist Executive to implement the statesmanlike policies adopted in Jerusalem, for all sections of the movement.

At the same time, American Zionists continued to demonstrate throughout 1951 their readiness to undertake and carry out all practical tasks - the campaign of the United Jewish Appeal, the Israel Bond Drive, and the development and welfare projects sponsored by the various Zionist bodies in this country - on which Israel's future depends.

Dr. Franklin J. Meine, Editor-in-Chief of the American People's Encyclopedia, has sent me the enclosed copy of a letter from J. L. Teller, Director of Information of the Jewish Agency. Teller charges that my article in the 1952 Yearbook ("Zionism, 1951"), which dealt primarily with the World Zionist Congress, contains "many errors" and "misstatements."

I have re-read the piece (a carbon copy of which is enclosed) and am convinced that it was accurate in every respect. I shall, of course, send a full reply to Dr. Meine. In that connection, I would like to have a direct quotation of Goldmann's position on the status and autonomy questions before he became chairman of the Agency's American Section. I have been unable to find it in my own files and wonder whether you might have something along these lines in Cleveland. Of course, if this involves too much trouble just forget about it.

It is somewhat amusing that Teller feels he must rush to Goldmann's defense in this way - even when Goldmann isn't being attacked.

I have made a few attempts to read the book, but can't manage to get into it. I imagine that the many memoirs, diaries and novels on the tragedy, which I have read in the past, have brought me to a saturation point. If there is no special hurry on this, I will keep the book until I manage to read it; or if you prefer, I will send it on to you.

Knowing of your deep interest in both Jewish antiquities and contemporary Israel art, I strongly recommend a visit to the current exhibition at the Metropolitan when you are next in New York. Josie and I are enthusiastic over it - not merely because of the way the art critics have been praising her father's work. The whole thing has been done with intelligence and a sense of history.

The other guests were Henry Cabot Lodge Jr., chief of the United States Mission to the United Nations; John Foster Dulles, Secretary of State; George M. Humphrey, Secretary of the Treasury, and Martin P. Durkin, Secretary of Labor.

Also Edward L. Ryerson, chairman of the board of the Inland Steel Company; Lessing J. Rosenwald, Philadelphia philanthropist; Dr. Milton S. Eisenhower, the President's brother, who is president of Pennsylvania State College; Harry A. Collier, described by the White House as a California business man; Palmer Hoyt, publisher of The Denver Post, and Rear Admiral Lewis L. Strauss, U. S. N. R., New York banker, former member of the United States Atomic Energy Commission and now an administrative assistant to the President.

The President has made it a practice to have guests at breakfast, luncheon and dinner with persons from all walks of life, officials as well as private citizens.

The word about tonight's dinner was that it was strictly "social."


