Dear Dr. Silver:

The film technicians advised me -- and I so informed Mr. Selzman -- that the 35mm print (the one shown at the New York dinner) will be sent to you by air express. However, it will not be available before Friday -which means that you should be receiving it at the Temple on Saturday.

The 16mm prints, which were ordered for yourself and Aranha, will be ready next week, and one of these will go forward to you as soon as it is available for shipment.

Will you please be good enough to instruct the person whowill be in charge of the 35mm film to return it after your dinner is over.

I have been getting the estimated costs of the fuller documentary film production which I would very much like to do, as well as of the other project which I regard as vital to preserve the historic record -- namely, the making of a duplicate negative and at least one print of all the raw film material which we are able to dig up in the UN film library (much of which is already in very bad condition). The rough estimate I have received for duplicating the four reels which I have discovered to date is \$950, with the possibility of additional sound costs of approximately \$400 (depending on the condition of the film and on whether the sound tracks would have to be duplicated in a separate operation). I am doing my utmost to have these costs revised downward, but I think it would be safe to assume that even the limited effort -- that of merely duplicating whatever footage we have found -- would cost something in the neighborhood of \$1000. 1 am sure you realize that I cannot authorize this kind of project on the basis of my own non-existent budget. Emanuel and I have been trying to get financial aid for our film activities from the American Zionist Council. but I don't have too much hope for backing of this amount.

That's the picture as of this moment.

#### Reflections on our 60th Anniversary

Sixty years may not loom large in the giant telescope of history, particularly when these are years in the life of the most history-conscious of peoples, and one is usually well-advised to eachew dogmatic conclusions from a survey of so brief a span -- all the more so when the events under review happened only yesterday. Yet, there are exceptions, and notable ones. The highest peaks in the historical landscape were thrust up suddenly, though many years, even centuries, of submerged volcanic activity may have preceded their emergence. So it was with the glory that was Greece -- an outburst of phenomenal creativity and intellectual achievement for a century or so, not remotely approximated during the many other centuries of Hellenic civilization. So it was, too, with the amazing concentration of extraordinary men among the Founding Fathers of the American Republic -- a Washington and a Jefferson and a Franklin (the list could be even longer), each of whom could have singly distinguished his time and place, joined together in the same great human endeavor.

We believe that the Zionist Revolution is likely to occupy a commensurate place in the history of the Jewish people. We believe the second of the second sec

The achievement of Jewish Statehood was, to be sure, accelerated by the greatest tragedy in all of Jewish history -- the slaughter of the six million by Hitler.

But this horrible validation of the Herzlian prognosis would in itself have failed to move the nations of the world to restore the remnants of the Jewish people to their ancient homeland -- for conscience in international affairs is weak and needs bolstering by might on the side of the right. It was Zionism alone that provided the elements which proved decisive -- the heroic <u>Vishuv</u> itself, which had been created by fifty years of Zionist pioneering and enterprise, and its powerful resistance movement which developed into the finest military force in the Middle East; the brilliant political leadership -- particularly on our own American scene and in the United Nations -- which defeated the schemes and maneuvers of the enemies and opponents of Jewish Statehood and achieved international support for Israel's establishment.

In these efforts, particularly in the political struggle of the 'forties, the role of the Zionist Organization of America and its leadership was of decisive importance. The name of Abba Hillel Silver will surely be permanently enshrined, side by side with those of David Ben Gurion and Chaim Weizmann, in the annals of the Founders of Israel.

But it is not merely of our glorious past that we think today, as we celebrate the 60th anniversary of both the World Zionist Organization and the Zionist Organization of America. Our major emphasis is on the insistent demands of the present and the horizons we seek are before us and not behind us. The "Great Debate" in our own ranks Moccowing about the future need for a Zionist is, happily, petering out. The opposition from within now seems to consist of a powerful minority of one -- the distinguished Prime Minister of Israel. But even so eminent and persuasive a figure has failed to prevail upon the movement, which is acutely aware of its special tasks and its responsiblities to the Jewish future, to disengage itself of those tasks and responsiblities. Indeed, each new assault on Mr. Ben Gurion's part appears to be winning greater adherence to the movement, so that -- and we note this with satisfaction -- former opponents of our am consistent view that Zionism must yet perform a major role in Jewish history are now to be found among the staunchest defenders of the movement.





Dear Charles:

I am sorry that you weren't able to attend the Pittsburgh conference, particularly as I wanted you to lead off the discussion. As you have probably heard, it was a great success from every point of view. There was a sizable contingent from the Cleveland Heights Temple District. Some of them met with me briefly after the conference and indicated a readiness to do some real Zionist work, especially in the political sphere. Needless to say, I tried to encourage them. One or two also sought information on the "League," being thoroughly confused, though definitely opposed to the "League" as a separate organization. (This was, no doubt, the backwash from earlier shenanigans of Ezra Shapiro, with whom, incidentally, they expressed strong disagreement.) I hope I succeeded in setting them straight on the facts.

They tended to bear out the feeling you expressed that, with the exit of Shapiro, the conditions in Cleveland may be appropriate for a full degree of Zionist unity. Not being on the scene myself, I may be drawing incorrect conclusions from the brief conversation I had in Pittsburgh. However, I decided to pass it along to you for whatever it may be worth. In any case, you will, no doubt, be consulting Dr. Silver about such matters, and I am sure that you will be guided by his judgment.

On another item -- the ZOA public meeting which you are planning for mid-May -when Claire Okonowitz relayed your message that Governor Williams was to appear in Cleveland in June, I was under the impression that this was in no way related to the Jewish community as such, and I therefore suggested that we should continue our efforts to get him for the ZOA meeting, however slim the outlook, since I felt that through personal connections we might get him to appear without a speaker's fee. However, I now note in a release from the American Committee for Israel's 10th Anniversary Celebration that a city-wide mass meeting has been called for June 4 at Severance Hall and that Dr. Silver will head the list of speakers. Is this the meeting you referred to in connection with Gov. Williams. If so, we will obviously have to drop the idea of trying to pin him down for the ZOA meeting, as a Silver-Williams program repeated in the course of two weeks in the same community would not make sense -- and would surely lead to a dispute between the 10th Anniversary Committee and the local ZOA. Please advise.

In general, I believe that the scheduling of the June 4th meeting so soon after the date set for the ZOA rally is most unfortunate. While there is, of course, an advantage in the fact that our meeting is scheduled to take place first, the situation is still likely to create confusion. Is there any hope of having the June 4th meeting deferred for a few weeks?

Assuming that we are not to proceed with Williams for the reason stated above, we will try to get one of the other personalities mentioned approvingly, such as Senator Humphrey or Senator Gore. (I assume that Claire Okonowitz has relayed the information about Gov. Freeman's unavailability due to an already-overcrowded schedule in the month of May.)

I continue to receive very enthusiastic comments concerning your own speaking engagements for the ZOA, for which all of us here are grateful to you.

Since the beginning of his career. In 1921 he was a leading member of the Branders-Mack group but was among the first of the dissenters to retorn to active Zhunist service. Silver favored the plan for the ex-tended Jossish Agency proposed in Weizmann and Marshail, which was later ratified at Zurid (1990). He entered the lists actively against the Eastish government's plan to partition Polestine, later alandoned. Silver was a consistent critic of British administration in Palestine and spake with sight and skill in condemnation of British violation of their mandatory undertakings. Together with Samuel Untermyer he organized the anti-Mazi boycoit in the United States

In addition to skill in negotiation and administration, Silver possessed a unique and unrivalled gift of oratory. On occasion his fervor and passion made lasting increasions on large addiences. His sermons and public addresses were distinguished for grace of expression and vision, for fine style and originality of thought, which often rose to losity oranizate heights, and for boldness and coverage. It set a standard for Ziomet platform unterances and Jewish pulpit oratory.

His writings includer Messianic Speculations in Ancient level (1927). The Democratic Durus e in Rwish 11 Key (1928): Keligion in a Changeng Wiston (1940) with Crisis and Jewish Sociarial (2020). I just received a copy of Dr. Silver's address before the Central Conference of American Rabbis on June 26, and -- recalling our talks over the years on the vital questions dealt with in Silver's paper -it occurred to me that you might be interested in having it translated and published as an article in Haaretz.

Do let me know whether you plan to do this, as I believe it is important that Israeli public opinion should be made aware of these views and would arrange to have the article published elsewhere if Haaretz does not plan to do so. I send it to you because I thought that the pages of Haaretz would be eminently logical for such an article, and also because I recalled your own special concern with the whole subject.

We are, of course, anxiously watching every new development in the current Middle East crisis. I believe that our activities of recent months proved to be quite useful, and I expect that the weeks ahead will bring important new tasks in the political sphere -- not that I expect anything other than more brickbats as reward for the Movement.

If another trip to the U.S. is in the offing, please let me know. I hope that next time you will be able to remain for a real visit.
