This first note to you following your return gives me the opportunity to extend a hearty "welcome home" to you and to Mrs. Silver. I trust that your trip was both interesting and enjoyable, and I hope that I shall have an opportunity of learning some of your impressions in person soon.

I assume that you have seen the various published items which I forwarded to your office during your absence. Publication of my letter to Hadoar was delayed because it seems that the Hebraists there found the translation of my comments too formidable a task. I finally had to see to the translation myself —— with an assist from Emanuel. A copy of the Hebrew text, which is scheduled to appear in the current issue, is enclosed.

With respect to the other items (the <u>Davar</u> interview etc.) -- I have assumed that if you believe they warrant clarification, you would have made or authorized appropriate comment.

Where the Z.O.A. is concerned, there isn't much to report -not that there has been any lessening of sound and fury for
their own sake. But lest you get the impression that my
life is joyless at this point, I hasten to add that there is
no end of naches at home.

My hopes regarding appropriate office arrangements for the writing of the book have not been realized yet. It would seem that Redelheim had some second thoughts on the matter after Emanuel spoke to him (no doubt along the lines of "What's in it for me?") and he has sidestepped the question every time I have raised it during the past weeks, putting off a final undertaking and arrangement until some indefinite time. (During the past few weeks I haven't been able to speak to him at all, since he hasn't been feeling well.) So I can only try to do what I can whenever I can.

Meanwhile, there has been a development on another front which could have a salutary effect on this matter as well, since it would involve a radical change of my professional circumstances. I received a call from an executive placement agency with which I had registered around the time of our last meeting. The agency wished to know whether I would be interested in a certain opening for which they are prepared to recommend me enthusiastically. The opening:

I also inquired about the advisability of bringing influence to bear on the leadership of the American Friends of the Hebrew University. I was advised to hold off for the present but that this might prove most helpful during the days to come. I am therefore giving you the background at this time, so that -- if I should take the liberty of requesting a note or call from you to the AFHU leadership -- you will have the full picture. I am under the impression that you have done a great deal -- especially recently -- in behalf of the Hebrew University, and you may, therefore, be in a position to give me a definite impression of the proposition and also perhaps to let the AFHU people have your opinion of me, assuming that you are requested to do so and that you do not regard me as utterly useless. I have no idea as yet which of the AFHU Board members are most concerned with this matter, though the agency mentioned that it was in touch with a Mr. Herbert W. Steingarten -- probably a professional executive.

Well, that's the story. You may be hearing further from me on it.

For the rest -- I had a small experience with a surgeon last week which involved a short stay in the hospital. A growth

Dear Dr. Silver:

Regarding the American Friends of the Hebrew University matter about which I wrote to you last week -- the placement agency has advised me that a high level intervention of the type I had mentioned might prove useful.

I am enclosing a list of the leaders of the American Friends of the Hebrew University, taken from a letterhead dated May, 198. I imagine that the two key people on this list are Daniel G. Ross, the President and Dr. Frederick R. Lachman, the Executive Vice President. (I see no mention of Herbert W. Steingarten, who is the person with whom the placement agency is in contact.) You will know best whether your relations with any of these gentlemen would warrant a letter of recommendation in my behalf, assuming that you wish to write such a letter. (I have some recollection of contact with Dr. Lachman in connection with the mushroom which a Hebrew University scientist named in your honor, but I have no idea of the nature and extent of your dealings with him.)

Permit me to suggest that any letter or letters that you may decide to send should make no specific reference to any placement agency in connection with the opening. It would be best to say that you had heard that the AFHU is currently seeking a top-flight public relations person, and that in view of your deep interest in the Hebrew University you venture to suggest that they might do well to get in touch with Harold P. Manson -- adding whatever favorable comments concerning my abilities you might be inclined to make with a clear conscience.

Dear Dr. Silver:

Further sniffing around the AFHU set-up does not indicate that the reportedly imminent public relations opening would involve Dr. Lachman's position. At the same time, I have no idea to what extent he is participating in the search for a new public relations director. (Mr. Steingarten, who contacted the agency, has been described to me as one of the newer lay leaders of the AFHU.)

If your interests in the Hebrew University should involve contact between Dr. Lachman and yourself during this period, you might wish to mention, agav urcha, that you have heard certain rumors regarding the future public relations set-up of the AFHU and that, if these rumors are correct, you may have an important suggestion to offer.

In any case, a letter to Ross or other AFHU lay leaders, along the lines suggested in my letter of March 11, would be helpful, assuming that this would be warranted by your relationship.

Dear Dr. Silver:

This will bring you up to date on the situation with respect to the American Friends of the Hebrew University.

Yesterday I met with an additional counsellor on public relations for various business firms and advertising agencies -- at the request of the agency which had originally contacted me. In the course of this conversation I managed to get a picture of what is cooking. It seems that a group of advertising agency owners and executives, headed by Henry W. Steingarten, have become deeply interested in the Hebrew University. These men, particularly Mr. Steingarten, have been highly critical of the character and quality of AFHU public relations, and have expressed themselves strongly along these lines to the Board of the AFHU. As a result of pressure by Steingarten and his associates, it was decided to replace the current public relations director, Mr. Cohen, and to obtain a new man -- if necessary, at a considerably higher salary than had been paid heretofore. Steingarten was authorized to find such a person -- with the understanding that his selection is to be confirmed by the Administrative Committee. Steingarten and his associates proceeded along the lines followed in their own businesses -- namely, they contacted the best executive personnel placement agencies, and this is how I was brought into the picture.

Both of the agencies which interviewed me agreed that I was the man and told me that they were advising Mr. Steingarten that they are accordingly eliminating all other candidates and recommending me alone. This morning I met with Mr. Steingarten. At the beginning of the conversation he told me that he had seen and was planning to see others; at the end of the conversation he indicated that he was eliminating all others from consideration and that, so far as he is concerned, I am the man. He went so far as to ask me when I could begin at the AFHU.

One question remained unresolved. He told me that while he had advised his AFHU associates that they should be prepared to go as high as \$25,000, and that he had indicated this figure to the placement agencies, he anticipated some resistance on this score and wished to know whether I would be amenable to further negotiations. I, of course, took a strong stand on the basis of the figure which had been officially listed by the placement agencies and am awaiting further word from him on the matter, which he indicated would be forthcoming soon, (perhaps even today) following conversations which he proposed to have with Mr. Ross and with Dr. Lachman, these two evidently being the key members of the Administrative Committee.

Page Two Dr. Abba Hillel Silver March 20, 1959 In the course of our conversation I mentioned your name in the context of our working relationship through the years. I also told him that you had indicated to me a desire to advise Mr. Ross of your opinion of me and I asked him to tell me frankly whether this would be called for in this situation. After expressing his own high opinion of you, he replied that this might be a good idea, but that since Mr. Ross (and probably Dr. Lachman as well) would be leaving either today or tomorrow for Jerusalem to attend a meeting of the Board of Governors of the Hebrew University, he suggests that you put in such a call upon Mr. Ross' return, which would probably be a week from Monday -- namely, on or about March 30th. There are other aspects, including internal administrative problems which Mr. Steingarten described, about which I shall not trouble you. I will continue to keep you posted on the progress of the matter and, unless you hear from me to the contrary, the call which you indicated you wished to make to Mr. Ross should be put through at the time suggested above.
