Several weeks ago the undersigned, acting as a Committee to plan the organization of the Palestine Economic Corporation, forwarded you a Statement of the Plan and Purpose of the proposed Corporation. Dear Rabbi Silver:

You have received notice of a conference which has been called for Sunday afternoon, May 3rd, at 2:15, at the Hotel Pennsylvania, New York City, for the purpose of considering certain plans relative to the economic developments in Palestine.

This conference will be the first attempt on the part of American Zionists to formulate a clear, definite, and consistent policy with regard to the vitally important question of investments in Palestine. As you know, I have recently returned from Palestine, after having made a thorough study of this problem and I am anxious to discuss it with a group of serious-minded business men who are vitally interested in our work there. I, therefore, would appreciate it if you could arrange to be present at this conference, as well as at the dinner which will be served at its conclusion.
