

My dear Rabbi Silver :-

I have just received a letter from Senator Pomerene in which he says that when the last resolution was brought up in the Committee on Foreign Relations, he merely asked that its consideration be postponed in order that he might discover what the sentiment of his own constituents on the subject was. He had heard that there was a sharp division of feeling in the Jewish Community on the subject of the Palestinian Home Land. He has no opposition whatever to the resolution if his own constituents desire him to favor it. I have written him a full explanation and have assured him that whatever differences as to method there may be, I think there is no division of sentiment on the subject of the desirability of the Mandate.

Hon. Atlee Ponerene, United States Senator, Washington, D.C.

I have just returned from a rather prolonged visit in the Bast and I find your letter dated May second, requesting an expression of my views on the Lodge resolution. Now that the resolution has been unanimously pessed by the United States Senate, I assume that such an expression is unnecessary.

You will recall the telegram which I sent you on April twentieth, copy of which I am enclosing herewith.

CONCURRENT RESOLUTION.

WHEREAS the Jewish people have for many centuries believed in and yearned for the rebuilding of their ancient home land; and

WHEREAS owing to the outcome of the World War and their part therein the Jewish people, under definite and adequate international guaranties are to be enabled, with due regard to the rights of all elements of the population of Palestine and to the sanctity of its holy places, to re-create and reorganize a national home in the land of their fathers: Therefore be it 1 RESOLVED BY THE HOUSE OF REPRESENTATIVES (The Senate concurring), That the Congress of the United 2 States hereby expresses its profound satisfaction in 3 that out come of the victorious war, which promises 4 5 the building up of a new and beneficient life in 6 Palestine, rejoices in this act of historic justice about to be consummated, and on behalf of the American 7 people commends an undertaking which will do homor 8 to Christendom and give to the House of Israel its 9 long denied opportunity to reestablish a fruitful 10 11 Jewish life and culture in the ancient Jewish land.
