

Dear Dr. Silver,

There was a bit of a misunderstanding with regard to your talk on the Radio Chapel on May 2nd. You were apparently not familiar with the fact that the law requires that a copy of the script be deposited with the radio station several days in advance of the broadcast. Mutual was after me to get your script, and was embarrassed by your last minute change of subject and your failure to submit the final draft. Mutual is certainly not desirous of offending the Office of War Information and the Federal Communications Commission, so I had to do alot of explaining, which was more difficult in view of my unfamiliarity with the facts. I promised them that I would write to you so that on future occasions you might bear these requirements in mind.

In the Synagogue Council, we are very eager to avoid any irritation because we are constantly seeking additional hours on the air, and incidents of this kind do not help us to win their confidence.

May I suggest that if you agree, you might send a note to Miss Elsie Dick, c/o WOR, 1440 Broadway, New York City, explaining the incident to her.

I am sure that you will understand the spirit in which this is written and the value that such a letter from yourself might have.

My dear Dr. Eisenstein:

Thank you for your kind letter of May 13th. I believe that any explanation which should be made to WOR should come from the Radio Committee of the Synagogue Council. I was asked to prepare an address for Radio Chapel, which I did, and was prepared to send a copy of it to WOR. The week before the broadcast your Rabbi Opher called me and asked me to write a new address, in view of the fact that the Sunday on which I was scheduled to speak was Compassion Sunday. I asked him whether he had taken the matter up with WOR and he said that he had and that they were agreeable. This meant that I had to write another address. It so happened that that week I was on a tour for the United Jewish Appeal, speaking in Harrisburg and Atlantic City, and ending up on Friday in Philadelphia for the National Conference of the United Palestine Appeal. You may, therefore, imagine how busy I was. On top of all, I had to finish my address for the United Palestine Appeal Conference. Actually, I did not get to dictate the radio address until late Saturday afternoon. I would suggest that you convey that information to Miss Dick.

I regret that I have no facilities for sending copies of my radio address to the people who have requested it. I sent the manuscript to Rabbi Opher, who may use it in whatever manner he deems advisable.
