



The Hall seats approximately eight hundred and fifty people and will be used for Religious School assemblies, Forums, plays, dinners, dances, etc. It will probably be the most used room in our institution.

First he was over at the Temple with Mrs. Joseph Printz and Mrs. Samuel Kauffman and Jimmy's wife refused to let them in and was very impertinent to them.

When I met them I got in communication with Rabbi Silver who gave us permission to go into the Temple and when I went over there with him, first Jimmy's wife refused to let us in and then when I asked for Jimmy and he came, he himself was very impertinent and white with rage and closed the door on us, refusing to let us go through.

I again got in communication with Rabbi Silver who called up the Temple and we were allowed to enter by Mr. Stevens but I had to show him through myself, although I could not show him everything as some parts were locked.


I certainly feel that Mr. Meissner should be written a letter of apology for the conduct of Jimmy toward him and hope for the good of the Temple this will not occur again.



My dear Rabbi Silver:

Some time ago, I understand, a plan was worked out which gave Monday to the Euclid Avenue Temple Sisterhood, Tuesday to the Temple Women's Association and Wednesday to the Council for meetings. It was with this arrangement in mind that we have sought to schedule not only our monthly open meetings, but all our afternoon meetings, as far as possible, on Wednesdays.

Our Big Sister Advisory Committee, composed of six women, met on the morning of the third Wednesday of every month last year. Since this was only a small committee meeting, we did not consider that it constituted a conflict with the Temple Women's Association Board meeting. The Big Sisters' Association, composed of our volunteer social service workers, held its luncheon meeting at noon of the same day. This meeting was arranged especially for our Big Sisters, but was open to any interested Council member. Since the Board of the Temple Women's Association adjourned by noon, we saw no conflict in that case.

The question of a possible conflict was raised at our recent Board meeting after Mrs. Sam Freedman announced, with evident distress, that the Temple Women's Association also would have a luncheon and afternoon meeting on the third Wednesday of the month, - November 19th. A simple statement of fact was then made, to the effect that a letter giving our program and the day of the Big Sister meetings had been sent to the Temple Women's Association in June and that the day had been mentioned again later to Mrs. Feder. You will note from that letter, copy of which is enclosed, that our Big Sister committee meetings are definitely scheduled as noon meetings on the third Wednesday of every month, which in November falls on the 19th. It is unfortunate

Inasmuch as we now know of the plan of The Temple Women's Association to hold luncheon meetings following the Board meeting, and since we consider the situation, which has arisen, most unfortunate, we shall arrange to change from the third to the fourth Wednesday, except in January and February, when Dr. Goddard of Columbus will speak. We regret that it will not be possible to change those dates, since Dr. Goddard arranged his engagements with special consideration for our request for the third Wednesday of the month. We shall urge that, in the future, program dates be cleared by a conference of Sisterhood and Council Program Committees. We feel confident that a situation, such as has arisen, will then not occur.

My dear Mrs. Grossman,

I am sorry that this new confusion of dates has occurred. Mrs. Feder tells me that she has taken into consideration the Council dates for its open meetings but that she did not and could not take into consideration the meetings of any sub-committee of the Council. As you know, The Temple Women's Association has held for years its big open meetings on Wednesdays, Tuesday being its sewing day. The Council likewise holds its open meetings on Wednesdays. With the Big Sisters also meeting on Wednesdays, the calendar would considerably limit the opportunities of The Temple Women's Association in arranging for speakers, etc. I would suggest that whenever the Big Sisters plan a large luncheon meeting, that the Sisterhoods be notified a month or so ahead of time.

Dear Eugene,

I thought that I should like to give you my ideas about the use of this building by other than Temple organizations.

1. In the first place our policy should be not to permit extra-Temple organizations to regular meeting quarters here. We are conducting a Temple center and not a community center. We wish to extend the courtesy of the use of parts of our building to worthy organizations from time to time, but we do not wish to saddle ourselves with organizations who wish to have permanent meeting quarters in The Temple. We must first develop our own resources and we will find that we shall have need for the building ourselves.

2. I believe that the Council of Jewish Women, the Cooperative League of Jewish Women, the Junior Council of Jewish Women, Hadassah, and the B'nai B'rith, should be given the use of Mahler Hall once or twice a year gratis. This has been our practice in years past. Other Congregations are pursuing the same policy.

3. This does not mean the use of the kitchen which imposes upon us an added expense both as to extra janitor service, heat, light etc. If the above organizations wish to use the kitchen, they should be asked to meet the additional expense; I should say approximately, \$20.00.

4. As a general policy we should discourage the use of the kitchen in entertainments. I do not wish The Temple to be turned into a restaurant and it is becoming increasingly rare to hold a meeting without feeding the people. That holds good for our own as well as outside activities.

5. We should not rent Mahler Hall to any other organizations than those above mentioned without approval of the House Committee and the Rabbi or of a special committee appointed for this purpose.

6. I believe that a fair charge for the use of the Chapel for wedding purposes would be \$15.00 for members and \$25.00 for non-members.

7. The use of class rooms for club purposes should for the time being be restricted to Temple clubs. Applications of outside organizations, juvenile or adult should first be approved by the above mentioned committees.

I was at the Temple last night, and only two of our Committee showed up. I rather expected to see you there as there were some things I wanted to take up with you.

I understand from Rabbi Silver, that janitors and the janitress have been in the habit of receiving tips from the various associations that participate in the Temple activities; I told 'Jimmie Gannon' very plainly, that under no circumstances, do we want any of the employes of the Temple to receive any tips of any kind, and that if it came to our attention again, that whoever received them would have to look for a job somewhere else. I also asked him to deputize his work in such a manner that there would be no cause for complaint on the part of the Rabbi. I am reasonably certain, however, that 'Jimmie's' statement to me has more or less merit. He claims there are activities that take place which he is not aware of. For instance: The other night, a bunch of young men came into the building and wanted to know what room they were going to have for their meeting? 'Jimmie' asked them who they were, and they said 'Western Reserve Students', and this was the first intimation that 'Jimmie' had of any such meeting; he knew nothing about it. They just walked in on him, and advised him accordingly. This is the second incident of this kind.

It seems to me that whoever is responsible for these various activities should work in conjunction with the Temple, at least until such a time as your new Secretary takes hold.

I am also advised that the office is working out very unsatisfactorily. The help are coming and going when they please. They report as late as 9:30 in the morning; take anywhere from one hour to two hours for dinner, and that last night they left the building without making any effort to have the Temple Bulletin properly mailed, and 'Jimmie' had to take his men off of their work and see that this part of the office work was completed.

Another thing which I think is very important is, for you to furnish me with a list of the activities that take place; that will have some bearing on charges to be made as a result thereof to the various associations that participate in the Temple activities. When women give affairs, it becomes necessary for 'Jimmie' and his people to clean up after them. I would like to know emphatically, just what the status of things are in this regard, so that the House Committee will know where they are at, in order to give the various bodies the proper support and a distinct understanding as to what they are entitled to and what they are not.

Another thing I noticed last night was, that some one upon their own authority, has caused to be installed on trial, an addressograph. I don't know whether you know or not, but it seems to me whether they are on approval or not, this means an obligation on our part, and I as Chairman of the Committee, do not like to have material, supplies and so forth, brought into the building without having the matter taken up with us, as it means that our Committee is 'groping in the dark'. We don't like the idea of just being 'a rubber stamp'. We want to do all we can to cooperate in every possible manner, and the objection that I have made heretofore was, that there are too many 'cooks' on the job, instead of having each branch of the Committee's service function properly.

In my opinion, things never will be right, until you get your new man installed, which should be done immediately.

I trust you will take all of my criticisms and suggestions in the spirit in which they are intended. I have no desire to usurp any one's authority, but in order for all the committees to function properly, there must be system and organization.

Replying to your letter of July twentieth - A resolution passed by the annual meeting of the Congregation held in April, 1913 the Board of Trustees was empowered to change the laws of the Congregation to permit a limited number of women of The Temple Women's Association to serve and act with the Executive Board of The Temple. The laws of the Congregation and of The Sisterhood (The Temple Women's Association) make it necessary that women representatives on the Board of the Congregation be wives of members of The Temple, or that they maintain an individual membership in the Congregation.

The Temple has a great many women who maintain membership in The Temple. The majority of these, however, are widows who have assumed the membership at the time of the husband's death, or have become members at that time to secure cemetery rights. A few women have joined because they preferred the service of The Temple to that of some Orthodox Synagogue to which the husband belongs. A few unmarried women hold membership in the congregation of The Temple. With few exceptions, the dues paid by women members of The Temple are the regulation dues for Temple membership.

Twenty-seven members constitute The Temple Board of Trustees, of which six are women. The women representatives are selected by the Sisterhood and accepted and sworn in at the first meeting of following the Congregational Annual Meeting.

The Temple roster contains the names of the persons who made applications for membership and who are responsible for obligations to The Temple.

I trust I have given you the information you desire, but please do not hesitate to question me further if I have not been quite clear.

BY-LAWS OF THE BOARD OF GOVERNORS
of

THE TEMPLE MEN'S CLUB

ARTICLE I OFFICERS

Sec. 1. The President of the Temple Men's Club shall be the presiding officer of the Board of Governors and the Secretary of the Club shall be the Secretary of the Board. The ranking Vice President shall preside in the absence of the President.

ARTICLE II MEETINGS

Sec. 1. A meeting of the Board of Governors shall be held on the first Wednesday of each month, unless otherwise ordered by the President, and due notice of every meeting shall be sent by the Secretary to each member of the Board. Special meetings may be called by the President or upon written request of nine members of the Board.

Sec. 2. Any member who fails to attend three consecutive meetings of the Board without an excuse acceptable to the remainder of the Board shall be deprived of his membership on the Board.

ARTICLE III COMMITTEES

Sec. 1. The President shall be ex-officio a member of all committees.

Sec. 2. The President may appoint such committees as are necessary for the proper conduct of the Club, provided that the chairman of each Committee be a member of the Board of Governors.

ARTICLE IV QUORUM

Sec. 1. A quorum of the Board of Governors shall consist of nine members.

Sec. 2. A motion or resolution may be adopted by a majority vote of the members present and voting.

ARTICLE V AMENDMENTS

Sec. 1. These By-Laws may be amended at any meeting of the Board by a resolution duly presented on the floor of the meeting and adopted by a two-thirds vote of the members of the Board.
