

Owen R. Lovejoy

OWEN R. LOVEJOY has been associated with the National Child Labor Committee since 1904, and its General Secretary from 1907 until his resignation in 1926. This Committee, "incorporated to promote the interests of children," has been very largely responsible for the tremendous evolution, during the past twenty years, in the attitude of America towards the protection of child life from exploitation. And during all these years Mr. Lovejoy has been its guiding spirit. The work of the Committee has fallen into two main divisions—investigation and legislation. Its reports upon the conditions under which children live and work have frequently been powerful instruments in moving sluggish legislatures to act in behalf of the best interests of the citizens of their states.

My dear Mr. Tuteur:-

I am sorry that you left the meeting yesterday afternoon before I had a chance to see you.

I noted your evident dissatisfaction with the defeat of the original recommendation of the Budget Committee. But the Budget Committee had hardly any hopes that its original budget would be accepted. It was altogether too drastic. The revised budget, which was adopted meets with our entire approval.

In the first place, regardless of the amount which we shall raise in 1928, it has been agreed that two-thirds of our indebtedness shall under all conditions be wiped out. This liquidation of our indebtedness will have priority so that by the end of 1928 instead of having an indebtedness of \$30,000, we shall have only an indebtedness of \$10,000.

In the second place, we adopted a sliding scale for our budget so that the expenditures of our constituent agencies will automatically be determined by the amount of money which we actually collect. Thus compelling the Talmud Torahs, if they desire any additional revenue to develop their own sources for obtaining it.

Should we collect \$60,000. next year, the Talmud Torah will only receive \$15000. Should we collect \$65,000, they will receive \$19,000, and should we collect \$75,000, they will receive \$24000.

The full budget of the Sunday Schools and Sabbath Schools was voted, so that under all conditions our Religious Schools as well as our extension work will go on unhampered.

Mr. Julius Tuteur. continued page 2. This was the first time that I have been able to put through such a radical program for our finances, and while you may not be aware of the fact, you proved a tremendous help to me. Your presence and your very definite statement to the Board, made it possible for us to put through the revised budget. Had you not spoken, even the revised budget would not have passed and we would have been left in the same morass that we have been in the past two years. The bearer of this note is the authorized agent for the Mayfield Cemetery Board to present to you the New Mausoleum project.

You will recall that some time ago the Boards of the two Reform Temples of Cleveland authorized the construction of a mausoleum in Mayfield cemetery whenever 60% of the space in the first unit is subscribed for. This action was taken by the Temples in view of the very limited space which still remains in the present cemetery.

Within a few years our community will be faced with the serious problem of purchasing a new cemetery. The Boards of the Temples felt that it would be preferable to erect a mausoleum in place of purchasing a new cemetery at the present time.

The Mausoleum will be a noble and beautiful structure. The outstanding mausoleum architects of the United States have been engaged to draw the plans for this edifice. The scale of prices for crypts and rooms has been so graded by the Cemetary Board as to make it possible for all, even those of very modest means, to purchase space.

The Mausoleum is not a private commercial enterprise. It is built by our Congregations and will be under the same board of control as the present Mayfield Cemetery.

It has been a time-honored custom among our people to provide for the inevitable advent of death during life. I would suggest that you give careful thought to this matter.
