## DR. GEORGE LEIKIN Eminent Russian-Jewish Scholar, Educator and Leader

Toledo will have the privilege Monday, January 30, of hearing an Old World scholar on two most engrossing subjects—What is really going on in Russia—and—What is the status of more than eight million Jews in central and eastern Europe.

Dr. Leikin is an outstanding scholar, thinker and leader. He holds the degree of Doctor of Jurisprudence from the University of St. Petersburg, and the degrees of Doctor of Philosophy and Doctor of Law from Heidelberg, that great center of German scholarship.

Dr. Leikin was Professor of Jurisprudence and Roman Law at the University of Kazan, the oldest and most important University of old Russia. He also lectured on Philosophy and Law at the University of Wurtzenburg, Germany.

Dr. Leikin was the leader of the Jews of Russia during the Great War and after the Revolution. He was Chairman of the Committee of Jewish Communities of all Russia; the chief Rabbi and the Government Rabbi for the entire Volga region—15 provinces, with Kazan as its capital. Dr. Leikin there had complete civil, religious and financial jurisdiction over 800,000 Jews living in that vast area. In 1916 he was the spokesman of the Jews before the Czar upon the latter's visit of state to Kazan.

During the war Dr. Leikin was in charge of the relief work among the German and Austrian war prisoners and refugees. He was entrusted with funds for their relief by the American Embassy and the Hoover relief commission.

At the downfall of the Czarist government, Dr. Leikin assisted Kerensky in drawing up the first republican constitution for Russia. When Lenin seized power, Leikin was drafted by the Communists to help draw up their constitution. Prof. Leikin was intimately acquainted with the contemporary writers, poets and philosophers of Russia and with the leading figures, like Kerensky, Lenin, Trotsky, Stalin, Molotov and others who have guided the destiny of Russia since the War.

Since his sojourn in America, Dr. Leikin has addressed distinguished audiences, including the Central Conference of American Rabbis, the Bar Associations of many cities, City Clubs, Forums and Civic organizations, Temples and Synagogues. As Professor Nathan Isaacs said of him, “His talk is rich in classic Latin and Hebraic illustrations, and his experiences in Russia under the Czars, under Kerensky and under the Bolsheviks, form an unique episode in modern Jewish history.”

Under the czarist government Dr. Leikin was considered suspect as a radical; under the Kerensky regime he was a progressive liberal and under the Communist rule he was again suspect as a conservative and therefor as a reactionary. A real liberal, it would be interesting beyond measure to get the views of a Russian scholar about the great Russian experiment now going on. Is it really “going places”?

My dear Gene:

I am sending you a copy of the letter which I sent to Mr. Max Meisel at his request. I wanted you to be acquainted with its contents so that you would be in a position to guide the discussion at the Board meeting in such a way that intelligent action can be taken. I would request you most earnestly to digest the contents of this letter at your leisure and to make a careful study of the constitution and by-laws of the Cemetery exactly as you would do, objectively and dispassionately, in the preparation of any legal brief.

I am very sorry indeed that the situation has become so snarled due entirely to the fact that the members of the Cemetery Board, by and large, have not taken the trouble to make a careful and detailed study of the entire subject, but have jumped to conclusions to which they now cling stubbornly. Other affairs of the Cemetery -- such as taxing resigned members -- have also suffered because the provisions of the by-laws have not been sufficiently understood and adhered to.

You realize, of course, that I have no personal interest in the matter one way or another. Should the Temple receive some of the money to which it is entitled, it will not go into the increase of my salary!...I am interested in seeing a palpable wrong rectified, justice done to the congregations, and a procedure definitely established which will avoid such unfortunate misunderstandings in the future.

I feel that you ought to help me in this not merely because you are President of the congregation, but principally because of your fairness and integrity of judgment which I have had so many occasions to observe and to admire.

After you have had the opportunity to study the situation

Dear Rabbi:

In reply to your letter of the 5th. I hope you will pardon me if what I am about to say may seem excessively argumentative. I have no intention of drawing you into a discussion with me on Brotherhood ideology. I realize that you are a busy man. I hope, therefore, that you do not regard my effort to give you my point of view as a presumption on my part, and an imposition on your good nature in replying to my first letter.

I appreciate also that because of my position as President of the National Federation, I may be taking the entire situation too seriously. All of us are inclined to take our own official positions over-seriously. I leave to your own judgment as to how much you ought to discount from my statements because of my official closeness to the entire question.

You refer in your opening paragraph to the fact that the National Federation "was of no direct benefit" to your Brotherhood and that, therefore, your Brotherhood was not entirely convinced of the necessity of a National. May I respectfully point out that the second statement is what my Latin teachers used to call a "non sequitur" from the first statement. For the moment, let me grant that the National would be of no benefit to your Brotherhood, but that does not mean that the National Federation of Temple Brotherhoods is not necessary. It is quite true that the more highly organized a particular congregation is, and the more able and energetic and influential its Rabbi is, the less is the necessity not only for a National Brotherhood, but for a local Brotherhood as well. But permit me to say that that ought not to be the measure of evaluation of a National organization. Stronger groups ought to be willing to help weaker groups, and your Brotherhood should regard it as an opportunity for service to help support an organization whose purpose it is to build lay groups where they are indispensable not only to the congregation with which they are allied, but to their own membership and to the community as well.

As a matter of fact, Rabbi, your congregation can function with undiminished efficiency and effectiveness if it divorced itself from the Union, and yet I question whether you would consider such a severance. I am quite sure that your support of the Union is not based on what your congregation can or does get out of the Union, but for the innumerable services which the Union can performs for Reform Judaism and Jewry.

You speak in your second paragraph of the slogan "lay participation in religious life." If the Brotherhoods rely on lay participation in religious life merely as a slogan, then it is open to the criticism you make of it -- but neither more nor less than any other organization which relies upon its main objective merely as a slogan. One can refer cynically to the objective of any organization and brush it aside as a mere slogan.

One ought not to do so merely in a spirit of cynicism. I quite agree with you that in many instances alleged purposes of an organization are nothing more than merely catch phrases -- mere window-dressing cardboard signs. The Brotherhood, however, is trying earnestly to make lay participation in religious life a real thing and not merely a slogan. Candor compels me to add that our efforts are not always successful. No one is more conscious of the shortcomings of our Brotherhood work than I am. No one is more eager to make the entire movement more vital, and virile, and significant than I am. No one is more impatient with the seeming slow progress we are making than I am. But we are trying -- and against great handicaps.

I take the liberty of using Zionism and the Zionist movement as an analogy. I feel that it is not entirely a liberty for me to do so because up until Monday night of this week, I was President of the Brookline Zionist Organization; and during my term of office, which voluntarily expired this week, I spent almost as much time as President of this local Zionist organization as I have as President of the National Brotherhoods. Parenthetically, let me add, and I know this will please you, that during my term of office I succeeded in attracting some very influential men to my organization, among them your friend, and my Rabbi, Harry Levi.

The point I want to make is that it might be said by anti-Zionists that the Zionist movement does not always live up to its purported ideals and that its methodology is not always in

conformance with the dignity of its ideology. And in a similar way, I also might have felt as President of the Brookline Zionist Organization, and with some justification, that the Zionist Organization of America had nothing to contribute to us, that it could be of "no direct benefit" to us, and that for this reason we should keep aloof from it. I did not take this position because I realized that the Z.O.A. is to be judged not by its value to our group, but by its value to the Zionist movement and to the Zionist ideal generally.

I am in full sympathy with you regarding the difficulty of integrating just another program into an already full congregational program. From a practical point of view that presents a real problem -- and I know it. But again I must say that if lay participation in religious work is something real, then there ought to be a way of meeting the practical difficulty of conflicting programs. All that is required is a little effort and a little imagination to synchronize one with the other. If the will is there, the way can be found.

You speak of keeping the men's clubs alive through "ceaseless artificial stimulation." Quite true, but quite sincerely and of course quite respectfully, I ask you: what of it? Men of science resort to artificial stimulation. In every organization you have artificial stimulation. But here again the important question is not the kind of stimulation one must use, but whether the organization to which the stimulants are being administered is worth stimulating.

Speaking of men of science reminds me to express to you my appreciation of your book "Religion in a Changing World." If you could see my volume of this book, you would find the two opening chapters elaborately underlined, and bracketed, and annotated. I spoke in Lynn Tuesday night, and much of what I said was based on what I got out of these two chapters.

I am asking the Cincinnati office to send you a pamphlet called "The Brotherhood Code", and one or two other short statements and pamphlets, and I will ask you to be good enough some time during your leisure to run over these statements. I haven't the slightest intention of making a nuisance of myself, and I shall not press the matter any further than I have already done.

Dear Rabbi Silver:

For the past half dozen years, the smaller communities of the United States have had little in the form of stimulating addresses, such as was furnished during the last decade by Chautauqua.

There is a demand and an evident need for an organization to supply honestly this purpose. I have been successful in securing the necessary financial backing to launch an enterprise which is known as "Co-Operators of 'merica - A Non-Profit Corporation". Limited conservative salaries only will be made to those actively participating in the work of the development of the enterprise. The plan which has been tried for the past two years at Uniontown, Pennsylvania is as follows:

Local guarantors in each community subscribe to a local capital fund which in turn is used in the event of a deficit. The people in each community are invited to attend each lecture free; a collection is taken to cover the actual costs of each speaker. Each community will pay exactly the same fee for each lecturer. These fees in turn are less than half the usual fees paid by Clubs Forums, Universities and Institutions that ordinarily use the same lecturers.

Because the lecturer will be on an organized circuit in fulfilling five or more engagements weekly, we are thus able to make the plan practical and genuinely cooperative at a great economic saving to each community.

If American ideals - Democracy, Christianity and Freedom are to be sustained, then the greatest bulwark for their sustainence is a constantly informed public opinion.

We are seeking a National Advisory Board and among those selected is your name and endorsement. I attach hereto a list of the names of the other distinguished Americans to whom this letter is being sent. Mr. Charles Henry Davis and myself are the originators of the plan and will have complete charge of its executive functions.

Extract from "Education As a Factor in Jewish Survival"  
delivered at The Temple by Dr. Joseph L. Fink, of  
Buffalo, N.Y., on Sunday, May 12th.

The chief need of Jewish life today is the need for education. It is not a mechanical but a dynamic process. When we speak of Jewish education we mean that process that fits the Jew to live his life wholesomely, naturally, happily. The first rational object of Jewish education is to affect the complete adjustment of the Jew with the environment in which he lives. It is necessary that we begin this process in our early youth in order to be adjusted for the sequel of our lives. Jewish education is not yet a finished science. It is a growing science. We need more material to work with. We need more expert and earnest teachers to do the work. We need a determined and deliberated goal toward which to work. We need to make the process not only palatable but most desirable to our youth and adults. Mere apparatus and costly buildings will not make Jews. We need the spirit behind the education process even more than we need the material equipment with which to work. A Jew who is thoroughly grounded in Jewish culture, devoted to the ideals of the Jewish faith, is thoroughly prepared to meet the contingencies of life. If suffering comes, such a Jew can bear it more nobly than others. He has a compensating culture to draw on. He is self-helpful. He is fit for life. If he has drunk deep of Israel's fountain of learning and idealism and he is forced to meet discrimination and bigotry in our yet imperfect world, his Judaism will sustain him and raise him to a level superior to his condition. Our road of salvation leads through our class-rooms.


Dear Abba:

Dr. Louis L. Mann, Rabbi of Chicago Sinai Congregation, and Professor at the University of Chicago, delivered the 85th Anniversary Address at The Temple, Cleveland, Ohio, on "The Religion of the Future," and said in part:

### Selections

The religion of the future must be broad and all inclusive. It will depend little, if at all, upon form, creed, ceremony, rite, ritual, all of which may remain as incidentals, but will consist of an all-inclusive philosophy of life, a "Weltanschauung" or Lebensanschauung" — a philosophy of life, a way of life. It must represent the sum total of all relationships that a man can sustain to the Universe in which he finds himself, sociological, biological, psychological, metaphysical, civic, national and international, ethical, industrial, esthetic, emotional, filial, and paternal; to the known and the unknown, to God, to man, to duty, to self, and every other possible relationship, ad infinitum.....

The response to this sum total of inter-related relationships in terms of an attitude, an aptitude, and a solicitude — an attitude toward one's fellowmen and the cosmos, an aptitude for service of unlimited varieties, and a solicitude for all that is human, that is religion.....

The church of the future will be a departmentalized institute of human relations. In addition to the clergyman, other aspects of human nature and human life must be administered to by those qualified to do so. I would add to the staff a scientist and philosopher, to help make the adjustment to the newer thought of the day, an economist because our ethics and our economics are so inter-related, a trained pedagogue because religious education has been greatly neglected, a sociologist to keep religion from becoming complacent and self-satisfied as long as the poor are exploited, a psychiatrist so there may be a scientific confessional, and a physician because without a healthy body a healthy mind is unlikely.....

The religion of the future must be vital and dynamic, rather than static. It cannot be, to use the phrase of the New Testament, "The same yesterday, today, and forever." The religion of the future must not "keep pace" but must, on the other hand, set the pace. What Matthew Arnold said of culture may also be said of the religion of the future; it must be "light and leading." If it tends to become static it will be led, and become a drag, and rather than shed light, will fall into the shadows.....

The religion of the future will realize that truth is not absolute but relative. That it is not made but in the making. That it is not final but a quest. No one has the truth. Anyone who says, "I've got the truth" has merely confessed that he has lost it. Religion in the future will not be so anxious — as has religion — to hold on to its so called "truths" until it has lost its truthfulness. The religion of the future will not be, as religion is so frequently termed, a "conservative" force. It must be radical, a

revolutionary force. If people were to put the principles of religion into practise tomorrow, we would have the most far reaching revolution of all the ages.....

The religion of the future will present itself as a living challenge, rather than rehash a dead issue. It will cry "halt" to the command of the dead. Read the history of religion and you will find how frequently the dead hand of the past has stretched forth its bony fingers to clutch the living present by the throat to the point of strangulation. The living dogmas of the dead become the dead dogmas of the living.....

The religion of the future would be a creative spirit rather than a stereotyped institution. In the past we have suffered from the curse of institutionalism. I know that institutions are necessary, otherwise the spirit would become nebulous, if not evaporate, but institutions tend to become impersonal stereotyped and routinized. When the spirit of the founders ceases to set aglow the hearts of the followers then has religion become canned or embalmed, for dead it is, whether it knows it or not.....

The religion of the future will not make a fetish out of any book, no matter how old, no matter how valuable, no matter how intrinsically worthwhile. I have reference now to bibliolatry — making an idol of the Bible. The Bible was not written by God. It was written by Jews. What a pity to take a book, the one book which above all other books protests against idolatry, and make of it an idol! The ultimate sanction for religious experience is human life, not a divine book. Do you recall the words of James Russell Lowell:

"God is not dumb, that he should speak no more,  
If thou hast wanderings in the wilderness, and  
find'st not Sinai,  
It is Thy soul that is poor."

The religion of the future will be more of a forum than a denomination. I have already spoken of the curse of institutionalism in the past. Let me now pay my respects to the blight of denominationalism. Of course I know that denominations represent differences of opinion. Differences stimulate; indifferences disintegrate. Differences are good, but I am finding fault with differences that do not differ. There are one hundred and eighty-three kinds of Protestant Christianity in the United States and two hundred and thirty-three in the world.....

The church of the future must practise tolerance. It has preached tolerance throughout the ages. The time has come for it to take "the beam out of its own eye before it can say unto another let me take the mote out of thine eyes." The church of the future must practise an active tolerance. It must seek to understand through an interpenetration of culture, of thought and of idealism the things upon which people differ, not the passive tolerance which is the tolerance of indifference. Voltaire once said: "I don't agree with a word that you are saying, but I'll give my life for your right to say it.".....

The religion of the future must boldly and courageously

face the social problem rather than have an air of timidity and pusillanimity. The religion of the future dare not say "the poor will be with us always." The religion of the future must concern itself with the abolition of poverty, the establishment of old age security, of unemployment insurance, of proper housing conditions, the prevention of crime, of social diseases, of exploitation, of juvenile delinquency, of corruption in politics, of the abuses of capital and labor. It dare not hold itself aloof from politics. It must realize that religion is not "preparation for life;" but that "religion is life." In the days of the Hebrew prophets — the world's greatest religious geniuses — they faced the poverty and corruption of their day instead of promising them golden staircases and pearly gates hereafter. A religion worthy of the name must establish righteousness here on earth.....

The religion of the future will not come to terms with the war system. It must meet that system in a head on collision. It must stop the private profit in the manufacture of arms. It must kill the killing business by taking its profit away. Need I remind you that a man named Schaffer, a paid propagandist for a munition factory, all but upset an international disarmament conference, with the destiny of nations involved, because it would make the munition business unprofitable..

The religion of the future will withhold a chaplain from the field of battle. A chaplain's value is as great as a hundred machine guns. He is not there, as some so erroneously believe, to bury the dead and to comfort the dying — if they cared about human life, they would not enter into the damnable business of war.....  
*It is their to give divine sanction to the hottest business of wholesale murder.*

If the religions of the world would unite and conscientiously object to war — to all war, to every war — you could kill the business of killing and no longer would there be a moratorium on morality and an abrogation of decency. Any church that will ever again bless war will therein and thereby damn itself!.....

When people everywhere can rise above geographical boundaries, and racial prejudices, and national animosities, and no longer permit the artificial, arbitrary, and man-made differences to obliterate the God-made resemblances between man and man, when the cry "humanity first, humanity last, humanity always" will be heard everywhere, when men will love God, whom they cannot see, because they love their fellowmen, whom they can see, then and then only will the religion of the future become the religion of the present, bestowing blessing and benediction upon suffering mankind.



My dear Dr. Silver,

Your letter of June 5th was forwarded to me here. I regret the delay involved.

The problem which you put to me is not an easy one. To find a Jewish educator of standing who is not a Hebrew secularist is a difficult, if not an impossible, task. The combination of traits which fails to make the breed, does not seem to include, among appreciable extent, a sympathy for the religious point of view. That is one reason why we have been forced, here in my department, to concentrate so hard on the training of Rabbis to specialize in educational work.

I know, personally, Chepkin, Drizin, Dubkin, Friedland, Samson, Solub, Honor, Henrich, Konowitz, Rosen, Schoolman, Scharfstein and Solter, to mention some of the prominent men in the field whose names I recall off-hand, and I do not believe that my statement above does any of them any very grave injustice. I should add, in all fairness, that I do not know Edidin, Abrams, Kaplan (of Baltimore), or Chonischky. Perhaps one of these is the man you are seeking - I cannot say.

If the choice were mine, I would probably place most confidence in Dr. Leo X Honor, of the Chicago Bureau. He is, at least, not a bare pessimist; on the positive side I can say that he is intelligent and a gentleman, has wide experience in the field and seems to me to have a more balanced point of view than many of the others.

I regret that I cannot be of greater assistance, but "the fault, dear Brutus," etc.
