The Temple, general, 1942-1943.

April 25th, 1942 Dear Mr. O'Reilly: You are a member of one of the outstanding Temples in the country, whose Rabbi is internationally famous and one of the most prominent in the world. Considering all of the problems that face us, both as citizens and as Jews, we consider it vitally important to maintain our institution on as high a plane and on as efficient a scale as possible. This cannot be done without money. Our problems are greater and our expenses are higher and we must either curtail our important activities or have your assistance. We have three problems -- you can help in all three: First - the Mortgage. This plan is familiar to you. If you have not yet subscribed, we would appreciate your doing so at once. This would relieve the Temple of interest and amortization in the amount of almost \$12,000 - if subscribed to by all members and therefore paid off. Second - We have been assessed \$3.00 per member, by the Union of American Hebrew Congregations, for the national work that they are doing for our mutual benefit. This we must add to your bill. Third - Of our total membership of 1300, we now have 700 who are paying the minimum rate of \$60. We are unable to function on this basis, and we ask you to pay \$75. as a minimum rate, instead of \$60. as heretofore. This letter is written to you on the assumption that you are sufficiently interested in The Temple to want to see it function not only satisfactorily but as a credit to the community. And on this assumption we must have your additional financial support. If you would like any further information we would be happy to have someone call on you. (To be signed by the President of The Temple, or Chairman of the Finance Committee -- or both).

I am getting up the service folder for the Assembly, of which we spoke, and I would like to have your advice as to what to include -- prayers, hymns, etc. Please telephone before you come to make sure that I am in. June 30, 1942 Miss Martha Markowitz 2600 Hampshire Rd. Cleveland, Ohio My dear Martha: I think that at every Children's Service, a short passage from the Scriptures should be read in the place indicated in the printed service. The Jewish Welfare Board has recently made available for Jewish soldiers and sailors readings from the Holy Scriptures, a copy of which I am sending you enclosed. They are well selected passages, and from this volume I have indicated some selections which you may use. In the first place, I would suggest that you use the following Psalms: 1, 5, 8, 9, 11, 16, 18, 19, 23, 24, 27, 42, 43, 46, 75, 84, 90, 91, 96, 103, 104, 111, 112, 113, 115, 116, 121, 123, 124, 125, 130 and 145. From the other Books of the Bible, I refer you to the following pages of this small volume: 44, 49, 53, 91, 113, 127, 135, 137, 139, 145, 147, 149, 150, 157, 239, 241, 243, 245 and 248. I would suggest that in reading from the Bible, you use not this small enclosed volume, but the standard one, preferable a large-sized one which you can obtain in The Temple Library. It will be much more impressive. I would also arrange to have a pulpit on the stage, and the Ark visible during the service. With all good wishes, I remain Very cordially yours, AHS: BK Enc.

I should like to suggest that you call a meeting of the Endowment Committee of The Temple of which you are chairman, at your earliest convenience. This committee can be of great value to The Temple in the stimulation of bequests and endowments. Jews, as a rule, are not in the habit of making bequests in their wills to religious and educational institutions. Their generosity is almost exclusively directed to hospitals, orphanages and other eleemosynary institutions. It is a common among Christians, however, to leave bequests to charches. Our President, Mr. Weitz, has appointed an Endowment Committee whose other members, as you probably know, are Julius Bloomberg, Eugene Freedheim, Isidor Grossman, Frank Joseph and I.R. Morris. May I suggest that you call a meeting at your convenience. You may wish to have the President of The Temple in attendance, and I should also be very happy to join with you. There is a desire for very concrete suggestions and actions on the part of these people. Therefore, I am sending along the following suggestions: 1. Will you take your pen in hand and write to your Senators Taft and Burton and say that you hope they will do everything possible to win the war expeditiously and work for a decent and durable peace? Say that you hope that no Ohio Senator will carry on as did Borah and Lodge following the last war. 2. Write in a similar vein to your own Congressman. 3. Get as many others as possible to do the same. 4. Cooperate fully with the Civilian Defense set-up and all other war efforts. Cooperate uncomplainingly and with enthusiasm. 5. Combat in every possible way all the "anti" propagandas. Do not repeat propaganda or rumors about Russia, China, England and the President. Strengthen every pro-democracy group. Inform yourself about democracy. Talk up democracy and defend democratic civilization. Do not join any organization because it has a high-sounding name. Find out what it is doing. Strengthen your own religious groups by regular attendance and full participation. Yours for the democratic way of life, L. N. Birkhead lmb/ns

Dear L. M. :

There are certain hard and ugly facts which deeply concern me and which we have agreed must determine the character of the program of Friends of Democracy.

First of all, there are those powerful obstructionist forces in the press which are sniping at the war effort and which threaten already to lead our country back into an era of isolationism. Even a casual reading of the editorials of the Chicago Tribune, the New York Daily News, certain of the Hearst papers and numerous smaller publications throughout the country indicate the direction in which these powerful obstructionist forces would lead us. They threaten the victory we are going to win.

In the second place, there is this powerful, extreme isolationist-America First Committee bloc in Congress which is directed by Wheeler, Nye, Reynolds, Brooks, Fish, Clare Hoffman, Day and their kind. This bloc may be able to wreck any constructive proposals for a decent and durable peace.

Moreover, we still have with us numerous subversive groups.

Hundreds of these committees and organisations which have followed
the pro-Axis line are still carrying on. A number of their publications continue to be sent through the mails. The America First
Committee has been revived as a political party and the Rev. Gerald
L.K. Smith is still on the radio.

Through these subversive groups and these obstructionist forces, distrust of democracy has been propagated throughout the country. There has been widespread effort to create doubt about

the ability of our government. Propaganda against our Allies, particularly the British and the Russians, has been widespread also.

As we look forward to the post-war period, we must think in terms of economic dislocations and the demobilisation of millions of soldiers as our nation changes from a war to a peace time economy. Already there are nasty rumors about responsibility for this war. Roosevelt and the British and the Jews are to blame, according to widespread propaganda. Among the extreme and fanatical Fundamentalists there has been the propaganda that Hitler is "the bulwark against the anti-Christ of Jewish Communism." The impact of all this propaganda upon us has been terrific. The minds of many of our citizens have been poisoned.

Now the pro-democracy groups are being attacked on the floor of Congress and in the powerful obstructionist press. There is an attempt to intimidate by threats and investigation and by libel suits.

These hard and ugly facts are a great challenge to Friends of Democracy. As we think of what has been done in the past, we recognize the importance of certain jobs which have been well done. For example, the Rev. Gerald B. Winrod was defeated as a candidate for the United States Senate; Joseph McWilliams likewise was defeated for Congress; Father Coughlin is no longer on the radio; and many other achievements are to be credited to the pro-democracy activities of such organizations as Friends of Democracy.

To do the job of combatting the forces against us adequately our program must be carried on more effectively and more comprehensively. We have been working on too piece-meal a basis. As I see it, here are the major things which Friends of Democracy should do.

Fundamentalist group. In this group are numerous fanatical Fundamentalist leaders like the Rev. W. B. Riley, Rev. Gerald Winrod, Rev. Harvey Springer and similar leaders. These fanatical Fundamentalists exploit such ideas as that "Hitler is the great bulwark against the anti-Christ" and "The anti-Christ will be a Communist Jew."

The program must include organizing the liberal wing of the Fundamentalists and the direction of a pamphleteering and speaking program within the Fundamentalist movement.

- 6. Checking on the subversive groups and publications throughout the country and a program of action against them. This
 project includes a nation-wide survey of mothers groups and
 related women's organizations, the surviving shirted groups
 and numerous other committees still functioning. A nationwide survey of the activities of these groups which have followed the Axis propaganda line should be made in connection
 with the project.
- 7. A project dealing with the representatives of the pro-Axis propaganda, such as, for example, the Spanish Library of Information, the Falangists, the Vichy crowd, the Steuben Society, and so forth. These representatives carry on, within the law, and it is quite important that they be observed and a program of action against their propaganda be carried out.
- 3. A special study of the impact of propaganda on western civilization; the meaning and significance of this propaganda and what to do about it. This project is not only important as a measure which would make the American people aware of propaganda, but also it is important as a basis of understanding the meaning and significance of propaganda and what to do about it.
- 9. Neighborhood groups and community organizations Many of these groups are already in existence. Others should be established and their activities directed. There will be, during the war and particularly in the immediate post-war period, the problems of violence, street meetings, anti-democratic propaganda and so forth which only neighborhood groups can deal with.

10. In the program of Friends of Democracy, of course there is also:

- a. Research which means observing and keeping careful records of all the anti-democratic propaganda groups and publications.
- b. Information service furnishing information to government agencies, publications and so forth.
- c. A directory of pro-Nazi and anti-democratic propaganda groups with an outline of their program, financial backers and so forth.
- d. The distribution of The Propaganda Battlefront mimeographed news-letter publishing exposes of subversive groups and reporting on happenings on the propaganda front.
- e. The preparation of a portable propaganda exhibit properly documented and illustrated and suited for exhibition in schools, clubs and civic groups. This exhibit will make it easier to explain the technique and devices of propaganda.

To do this job we need a minimum budget of \$150,000. I know that we can do the job and with this amount we can strike a blow that will turn the tide.

My dear Rabbi Silver:

Thank you for your letter of March 1st and for the honorarium. I appreciate your generous words concerning my address.

March 3, 1943

I was particularly interested in the following statement from your letter about the reactions of your Congregation to my address:

"They were deeply impressed -- and I am afraid a little frightened by what you told them. I have sometimes wondered whether it is helpful, taking everything into consideration, to over-stress with Jews, who are sufficiently shaken by events abroad, the motif of 'The Philistines are upon thee! ".

I have been thinking hard and long about the present crisis. The enclosed letter of Rex Stout, our president, which he wrate me recently, presents a sound approach. The situation is so critical that I believe it is necessary now to speak with the utmost candor and, if necessary, frighten people. The facts are frightening. In Europe and America the pro-democratic forces have appeased the enemy in one way or another. I see it particularly in this country among my Christian friends who indicate that when I speak with frankness about the critical situation confronting us, they say that I am an alarmist. They have reactions similar to those of your Congregation, but, of course it is not so personal. We have been working, both in Europe and in this country, for the past decade, on the principle of underestimating the enemy. It has always been the case of "too little and too late," both on the military and the propaganda fronts. Hence, our disaster. The situation in this country is potentially more dangerous than I can possibly convey in words. Our Committee, including Rex Stout and myself, are deeply disturbed.

There is a rising tide of the various "anti" propagandas. The growing anti-Russian propaganda may develop to such proportions

that we may not be allowed to sit down at the peace table with Russia. The anti-British propaganda is tremendous, and as it has been used as a political weapon in the past so it may be again. There is a widespread and sinister belief that we are fighting to preserve the British Empire.

But the most serious of the "anti" propagandas is anti-Semitism. In the Chicago Tribune and its satellites we read editorials to the effect that the "internationalists" are responsible for this war and the "internationalists" mentioned are the Sassoons, the Rothchilds and the Warburgs. The Washington Times-Herald and the Chicago Tribune recently had a vicious attack on Frankfurter. Just now coming to us are rumors to the effect that people in the Middle West and the South have seen chalked on the side of troop trains such slogans as, "We are going to lick the Nazis and the Japs. We'll be back to lick the Jews." There are such widespread rumors as the one which is now very familiar in all parts of the country entitled, "The First American." Irish names are mentioned as those who have sunk the first Japanese battleship, found the first Nazi spy, et cetera, and the first American to receive four new tires was Nathan Goldstein. You know the statement I have in mind. Msg. Sheen repeated this entire statement, with the exception of the last line about the Jews, in his radio address two or three Sundays ago. There is now a considerable amount of violence, as you know, aimed at the Jews. Swastikas have been painted on Jewish stores in various parts of the country and some fifteen to twenty temples and synagogues in Brooklyn have been stoned and broken into and sacred objects defiled. There have been similar happenings in other sections of the country.

If anti-Semitism were confined to hoodlums or to the ignorant, it wouldn't be quite so dangerous, but it is to be found in men and women in high places, in business, religion and politics. It is not anti-Semitism as a personal prejudice so much as it is anti-Semitism as a political weapon, and it is deep-seated. The other day one of our United States Senators remarked to a very intimate friend of mine, "Maybe we should never have got into this war. You know how the internationalists tricked the United States into it anyway." and he made a gesture indicating the Jews.

The serious anti-Semitism does not come alone from the little fellow who passes out the nasty leaflets on the street or in front of a church or at a meeting. The major focal points of infection may be found in the Chicago Tribune, the New York Daily News and their satellites. Also, in the extreme isolationist bloc in Congress. There are, moreover, certain powerful individuals who are involved in one way or another, such as, for example, Henry Ford and Lindbergh. They stand somewhat as symbols. Then there are also individuals all over

the country like the Rev. Gerald L. K. Smith, the Rev. Harvey Springer, Carl Mote and Father Edward Lodge Curran who carry on very effectively within limited areas. There is general agreement among all of these, including the powerful obstructionist forces in the press as well as among members in Congress, that the thirty-three seditionists were recently indicted only because of their anti-Semitism.

This propaganda, which slows down the war effort now, is likely to find its most fruitful soil in the post-war period. Congress has sabotaged the National Planning Resources Board. The organizations working in the post-war field are so far very academic, such as, for example, the Organization for the Study of Peace and the United Nations movement. They make no appeal for mass support. We may have to shift sixty million people from a war time to a peace time economy. We shall have to demobilize several million soldiers. Already such emotional slogans as "Get us out of this mess," "Back to normalcy," and "Let's make sure to preserve the sovereignty of our nation" are being bandied about, and then, of course, there is the inevitable question of who got us into this war. The answer is easy for the anti-propagandists.

I don't want to give you the impression that I despair of the situation, for I believe that something can be done as indicated in the letter of Rex Stout to me.

I believe that the Jewish organizations are not really tackling the heart of the problem. They are doing very good work, but that work is piece-meal and, for the most part, on the fringes. Every year, for example, the American Jewish Committee reports that anti-Semitism is declining. There are numerous meetings, conferences, many pamphlets, but the heart of the problem is not reached. By their very nature the Jewish groups must deal with the problem as though it were a sectarian matter.

Right now the American Jewish Committee is giving a great deal of time and energy to an effort to allay the conflict between the Zionists and the anti-Zionists. I understand that Judge Joseph L. Proskauer is afraid that this conflict may create a great deal of anti-Semitism. The fact is that very few Christians understand what the conflict is about, just as very few Jews understand the major doctrinal and policy conflicts between Christians.

Many of our pro-democracy groups are going out of business now. The only militant, non-sectarian group working in this field is Friends of Democracy. Our organization has taken over some of the defunct organizations. There are some very academic groups. They approach the problem in a very general way. There are fine words and good resolutions from Christian groups such as the Federal Council of Churches. The National Conference of Christians and Jews keeps the bridge across the chasm between Jews and Christians and this is a useful job, but otherwise it is not very effective.

It happens that the two persons most interested in Friends of Democracy are Rex Stout and myself. We are also the two biggest contributors to Friends of Democracy. It is interesting to note that Rex and myself are two middle western Christians of Quaker ancestry. Recently when Rex wrote a piece for the New York Times on "Hating the Germans," he was violently attacked by many Christians. I found it necessary to defend him and call the attention of my Christian brethren to the fact that they never exhibited any such resentment against their Christian brethren who preached violent and obscene hatred of the Jews.

The tide may be changed so that the Jews may not be engulfed, but at the moment the chances are that it will require heroic effort to turn the tide. Both Rex and I are devoting all of our time now to this cause. Rex is arranging to resign as chairman of the War Writers' Board so that he can devote more time to Friends of Democracy, but we are doubtful right now of obtaining adequate support to do the job that ought to be done.

If I were a leading and outstanding Jew, I would get some of my most reliable friends and associates in the country together and see that the problem of anti-Semitism is met with intelligence and I would see that it is dealt with realistically. Unfortunately, the Jewish organizations are still dealing with the problem as a matter of discrim-Vination and not as a political weapon. The Jewish organizations also sabotage many of the efforts of such groups as Friends of Democracy to get substantial sums of money. Having got such friends together, I would try to deal with the problem in a comprehensive and militant way. I would see that the job is done. I would not permit such fears as that "you may create more anti-Semitism by your efforts" to restrain my efforts. I had the experience of having the head of one of the most important Jewish organizations in the country write me when we were fighting Winrod and plead with me not to publish the Winrod pamphlet because, he said, "it would certainly elect Winrod to the Senate." He was so afraid of any action that he was almost paralyzed, and yet I believe that the late Justice Brandeis was right when he declared, "If we would guide by the light of reason, we must let the mind be bold." You may know about the great pressure put upon Friends of Democracy to prevent us from publishing our Ford pamphlet.

I have talked with a few leading Jews in the above manner. Most of them get nervous and say, "You overstate the case," and again I think to myself that it is a case of under-estimating the enemy. Rex likes W. L. Shirer's story of liberals and Jews who met in Berlin and could have gotten rid of Hitler for \$150,000, but they thought it was too much money.

I believe that the job can be done with a comparatively small amount of money. As a matter of fact, it isn't a case of huge sums of money, but of plans, strategy, brains and outwitting the enemy. The enemy is vulnerable and can be destroyed now, but I doubt that the enemy can be destroyed in the post-war period. The time to do the job is while the temper of the country is favorable.

Dear L. M.:

There are certain hard and ugly facts which deeply concern me and which we have agreed must determine the character of the program of Friends of Democracy.

First of all, there are the powerful obstructionist forces in the press which are sniping at the war effort and which threaten already to lead our country back into an era of isolationism. Even a casual reading of the editorials of the Chicago Tribune, the New York Daily News, certain of the Hearst papers and numerous smaller publications throughout the country indicate the direction in which these powerful obstructionist forces would lead us. They threaten the victory we are going to win.

In the second place, there is the powerful, extreme isolationist-America First Committee bloc in Congress which is directed by Wheeler, Nye, Reynolds, Brooks, Fish, Clare Hoffman, Day and their kind. This bloc may be able to wreck any constructive proposals for a decent and durable peace.

Moreover, we still have with us numerous subversive groups. Hundreds of these committees and organizations which have followed the pro-Axis line are still carrying on. A number of their publications continue to be sent through the mails. The America First Committee has been revived as a political party and the Rev. Gerald L.K. Smith is still on the radio.

Through these subversive groups and these obstructionist forces

distrust of democracy has been propagated throughout the country. There has been widespread effort to create doubt about the ability of our government. Propaganda against our Allies, particularly the British and the Russians, has been widespread also.

As we look forward to the post-war period, we must think in terms of economic dislocations and the demobilization of millions of soldiers as our nation changes from a war to a peace time economy. Already there are nasty rumors about responsibility for this war. Roosevelt and the British and the Jews are to blame, according to widespread propaganda. Among the extreme and fanatical Fundamentalists there has been the propaganda that Hitler is "the bulwark against the anti-Christ of Jewish Communism." The impact of all this propaganda upon us has been extreme. The minds of many of our citizens have been poisoned.

Now the pro-democracy groups are being at tacked on the floor of Congress and in the powerful obstructionist press. There is an attempt to intimidate by threats of investigation and by libel suits.

These hard and ugly facts are a great challenge to Friends of Democracy. As we think of what has been done in the past, we recognize the importance of certain jobs which have been well done. For example, the Rev. Gerald B. Winrod was defeated as a candidate for the United States Senate; Joseph McWilliams likewise was defeated for Congress; Father Coughlin is no longer on the radio; and many other achievements are to be credited to the pro-democracy activities of such organizations as Friends of Democracy.

the case of Smith, we have a complete record of his connections and his activities, and we have worked out a program of action against him and his radio program. One of the biggest religious blocs in the country is the Fundamentalist group. In this group are numerous fanatical Fundamentalist leaders like the Rev. W. B. Riley, Rev. Gerald Winrod, Rev. Harvey Springer and similar leaders. These fanatical Fundamentalists exploit such ideas as that "Hitler is the great bulwark against the anti-Christ" and "The anti-Christ will be a Communist Jew." The program must include organizing the liberal wing of the Fundamentalists and the direction of a pamphleteering and speaking program within the Fundamentalist movement. 6. Checking on the subversive groups and publications throughout the country and a program of action against them. This project includes a nation-wide survey of mothers groups and related women's organizations, the surviving shirted groups and numerous other committees still functioning. A nation-wide survey of the activities of these groups which have followed the Axis propaganda line should be made in connection with the project. 7. A project dealing with the representatives of the pro-Axis propaganda, such as, for example, the Spanish Library of Information, the Falangists, the Vichy crowd, the Steuben Society, and so forth. These representatives carry on, within the law, and it is quite important that they be observed and a program of action against their propaganda be carried out. 8. A special study of the impact of propaganda on western civilization; the meaning and significance of this propaganda and what to do about it. This project is not only important as a measure which would make the American people aware of propaganda, but also it is important as a basis of understanding the meaning and significance of propaganda and what to do about it. 9. Neighborhood groups and community organizations - Many of these groups are already in existence. Others should be established and their activities directed. There will be, during the war and particularly in the immediate post-war period, the problems of violence, street meetings, antidemocratic propaganda and so forth which only neighborhood groups can deal with.

10. In the program of Friends of Democracy, of course there is also:

- a. Research which means observing and keeping careful records of all the anti-democratic propaganda groups and publications.
- b. Information service furnishing information to government agencies, publications and so forth.
- c. A directory of pro-Nazi and anti-democratic propaganda groups with an outline of their program, financial backers and so forth.
- d. The distribution of The Propaganda Battlefront - mimeographed news-letter publishing exposes of subversive groups and reporting on happenings on the propaganda front.
- e. The preparation of a portable propaganda exhibit properly documented and illustrated and suited for exhibition in schools, clubs and civic groups. This exhibit will make it easier to explain the technique and devices of propaganda.

To do this job we need a minimum budget of \$150,000.

I know that we can do the job and with this amount we can strike a blow that will turn the tide.

Judging from the sentiments expressed at the meeting a few days ago, the consensus of opinion seems to be that contributions should be made directly to The Temple or the congregation, as such, but that the congregation should set up a special Trust Fund or Endowment Fund into which these bequests are to be placed. The Fund is to be administered by the Board of Trustees. I think this is a simpler arrangement, and one which will meet with the approval of the Board. It would be nice to have Mr. Grossman and Mr. Haber present at the next meeting of the Board to present the resolutions for the establishment of a Temple Trust or Endowment Fund. Elections for delegates to this Conference will be held in all the communities early in June. In Cleveland these elections will be held on June 7. Every Jewish organization, Temple Sisterhood, etc. is entitled to send electors to the meeting which will select the Cleveland delegates to the American Jewish Conference. There will be nine delegates sent from Cleveland. Jewish organizations in our community are entitled to send representatives to the meeting which will select these delegates on the basis of one representative for the first fifty members, and one for each succeeding seventy-five. On the basis of fourteen hundred members, our Temple would be entitled to nineteen representatives. These representatives must be selected at a membership meeting of the congregation. Such a list should be presented to the congregation at our Annual Meeting on way 26 for election. I shall be very happy to assist you in drawing up that list. It is important that every one who accepts to represent The Temple should be present at the meeting when the delegates will be selected because there will be no voting by proxy or by groups. My dear Rabbi Silver:

Thank you for your kind letter and for your check. I should have answered your note immediately, but as you can well understand the pressure of academic activities toward the close of the school year, which is normally great, has increased by the calling to the colors of practically all the men who are enrolled in the college. It was necessary to make out individual examinations for each man just prior to his induction, and to see that all records were complete so that he could take them with him on the morning when he reported for duty. The bulk of that work coincided with the period starting at about the week when I occupied your pulpit, and the 15th of May. Then came the regular examination period. A few notes on music problems. For your study, O.K., or otherwise.

1. I had a long talk with Mr. McKinnon on Friday last after the service. He will let me know our answer by Wednesday of this week. He is being paid nearly what we offered him for the one Sunday service at Dr. Phillipp's church, but would like to come to us if he can arrange his work and will talk over with his employer the possibility of getting away on Fridays and Saturdays.

- 2. On looking over the blanks filled out by Rabbi Harris I find that our second choice, Mr. Toomey, is very doubtful of getting away from work at all. This makes me think strongly of our third choice in a manner shown below.
- 3. We should be talking about music for the summer services, now only two weeks away. Last year we were fortunate in having two regular members of the quartette, Kraft and Dewhirst, with us all summer. Mrs. Kraft is going to California this summer as her plans now are, and Dewhirst of course is no longer available.
- 4. In thoughs run along the following lines. Get our tenor, Mr. Born, who is very important on account of the Kiddush. Get either Mrs. Fraley whom you have not heard, or Mrs. Bossinger for the alto. If McKinnon accepts the solo place, then get him for the bass. Instead of trying two sopranos for the summer, get Miss Dworkin for the entire time, if we can. I do not expect to go amplace this summer, so can be at the organ.
- 5. I do not know what you paid last summer for any of the voices, so do not know what money will be available for these nine summer Friday evening services. To go ahead with the above plans I should have a budget.
- 6. In case Mr. McKinnon does nto accept our solo job I am thinking strongly of asking the young voice that struck us so favorably last Monday to come in and sing with us during July. We can then hear him under routine conditions, and make up our minds of he is possible for the regular job. He is said to be a poor musician, which would not handicap him as much for the simple summer services as it will for the regular Holyday and winter work, but which I will be able to judge after a month's work with him. If he cannot handle even the summer work, then I will fill out August with Mr. Firshberger who has been singing with the quartette on Fridays during June, and whom I consider very competent.
- 7. I had a letter from Mr. Weitz with a list of the contracts sent out. These do not include the four additional voices we discussed last month. I mention this as Miss Cornsweet wants to locate elsewhere in case we do not take her at The Temple, and I have promised to let her know as soon as I know. Has this matter been fully discussed and decided upon?
- 8. I will talk over the above with you and go more into details on Friday next, or sconer if you think wise.
