It has been rather an uphill stuggle the past few weeks to get the Chorus going, but I believe we are going to make the grade.

their April meeting thru the singing of a few selections. As I have indicated to you, I am going to try and convert this participation into something a little different from they had in mind. What I shall aim for is a late friday night Service, followed by an Oneg Shabath, with singing at the Service and later at the Oneg Shabath, and perhaps with a brief sermon on the meaning of Shabos by you or Rabbi Stone. If you agree that this is a good idea, then I hope you will lend your support to this project, which if successful, can lead to a similar program once a month, as a start, and perhaps, someday, even as a weekly Service (without the Oneg Shabath). I know that the latter may involve some alteration in the present Service schedule, and therefore don't think that I go into this primas phase until you have had a chance to evaluate what can be done. But a monthly service sponsored by the Mr and Mrs Club and the temple Chorus combined that looks feasible to me, as I hope it will look to you.

While on the subject of Temple Services, I have a thought about the Sunday Service that I should like to propose for your consideration. It is this. What do you think of the idea of having two members of the Chorus (one make and one female) assist you with the leading of the singing of our Sunday Hymn. I have not discussed this matter with the members of the Choruson the basis that you may not consider such participation feasible. If you should agree that this is a good idea, I would rather that the invitation come from you to us. I believe that we could then establish a list of members that would rotate, so that no two would appear more than once or twice a season.

- 3. In bried, we wish to know whether it would be possible for the Hospital to have use of these quarters from Monday through Saturday, year-round, from approximately 7:00 A.M. to 5:15 F.M. In addition, we would like to use the kitchen facilities to the extent of use of refrigerator space for storing between meal

School for pre-school children of mothers who would be employed at the Hospital to fill critically needed jobs. As you know the inroads of the armed forces have further depleted our nursing staff, which was short of requirements to begin with. We hope through the operation of a Mursery School to attract married nurses with young children to work at the Hospital.

The Nursery School room at the Temple seemed to be a "natural" to fill our needs, especially since it is used only on Sundays. I have heard that the use of our gymnasium for this purpose has been suggested. Such a plan would not be suitable since our gymnasium is now being used for wolunteer sewing groups, conferences of the medical staff, and other meetings for which we have no meeting space elsewhere in the Hospital.

I shall be looking forward eagerly b your reply.

Dear Rabbi:

I have your letter in reference to the request of the Hospital for the possible use of our Nursery Room to persuade married nurses to come back to the hospital if their small children are well provided for.

Mr. Lewine failed to tell you, and I evidently overlooked doing so, that any expense in connection with this project will be borne by the hospital. Any Nursery School, of course, would be out of the question as the Hospital expects to send overthe necessary food and unless the Nursery were closely adjacent to the hospital, it would be impossible to interest prospective nurses. I am sure it could be worked out at no expense to The Temple.

There is also a practical good will factor involved in that many members of the hospital board are also members of The Temple and that in the future, there may be projects which can be worked out on a combined basis for the benefit of both.

As far as the parking lot situation is concerned, it was unfortunate that we did not work on this a number of years ago after the tennis courts had been abandoned, as at the time I worked on this project, definite plans had already been made for both parcels, to be used for hospital purposes.
