Sondo sant May 15, 1963 My dear Senator: I hate to intrude upon your busy schedule, but I should like to make this request of you. There is established here at the Temple an annual lectureship which is known as the "Harry D. and Lillian P. Koblitz Memorial Lectureship". We bring every year to the Temple pulpit an outstanding figure, who is preeminent in his field, to deliver an address on a subject of his own choosing. In the last few years we have had Dr. William Foxwell Albright, perhaps the world's outstanding Biblical scholar, Dr. T. Keith Glennan, who was the Administrator of the National Aeros and Space Administration, the eminent geo-physicist, Dr. Harrison Scott Brown, occupy the pulpit. These lectureships are given on a Sunday morning in connection with the Temple service. They have been exceedingly well attended and have aroused a great deal of community interest. We should very much love to have you deliver the 1963-64 Koblitz lectureship on any Sunday morning convenient for you, either in the fall of '63 or the spring of '64. You will probably prefer a time when you are not tied down in Washington. The lectureship provides an honorarium of five hundred dollars and traveling expenses.
