CLERGY FARES (Applicable to Allegheny, Central or Northeast)

- (A) Applicability This rule is applicable to local travel via Allegheny, Central or Northeast Airlines.
- (B) Fares Subject to the provisions of paragraph (C), the fare applicable to the transportation of a Minister of Religion shall be 50% (determined in accordance with Table No. 1) of
 - (1) the adult local one way or round trip first class fare (other than short limit excursion or family fares) applicable to such transportation via Allegheny or Central.
 - (2) the adult local one way or round trip first class or coach fare (other than short limit excursion or family fares) applicable to such transportation via Northeast.
- (C) Conditions The fares described in paragraph (b) above will apply subject to the following conditions:
 - (1) Each carrier named in this rule will issue tickets for transportation solely over its own lines.
 - (2) No ticket will be issued by a carrier named in this rule unless passenger is the holder of a valid clergy identification card issued by the ticketing carrier and presents same at the time of purchase of the ticket.
 - (3) All tickets sold under this rule will be on a space available basis only. Except as provided below, seating accommodations will not be reserved and passengers transported under this rule will be removed to accommodate other passengers for whom space has been reserved at any intermediate point.
 - EXCEPTION: Allegheny will reserve seating accommodations to the destination or stopover point named on the ticket or to the next intermediate point to which space is available, as the case may be, after such passenger has boarded the aircraft.
 - (4) In no case will the reduction apply to any other charges or services.

(D) Identification Cards

- (1) Application Written application on forms furnished by carrier must be submitted to such carrier's General Sales Office. Application must be accompanied by a check or money order in the amount of \$5.00, and
 - (a) if application is approved, carrier will supply applicant with an authorized clergy identification card, which will entitle applicant to transportation over issuing carrier's lines at fares described in paragraph (B) above under conditions shown in paragraph (C) above.

- (b) if application is disapproved, such check or money order will be returned to applicant.
- (2) Validity Clergy identification cards issued by Allegheny, Central and Northeast shall cease to be valid at 12:01 A.M., January 1 of the succeeding calendar year. A new application and check or money order in the amount of \$5.00 will be required by Allegheny, Central or Northeast Airlines for each subsequent clergy identification card.
- (3) Replacement of lost cards An application for replacement of a lost clergy identification card, for the purpose of this rule, shall be deemed to be a new application.
