My dear Dr. Newfield:

I was pleased to receive your letter and happy to learn that you have recovered from your illness. I trust that you are in excellent shape now. I shall look forward with pleasure to my visit to your community on January 16 in connection with your Welfare Fund Drive.

May I take this opportunity to request you to bring to the attention of your committee in charge of the "elfare Fund Campaign, the following. Birmingham raised \$4,000 in 1937 for the United Palestine Appeal. Communities of the size of Birmingham have, by and large, allocated to the United Palestine Appeal, substantially larger sums of money. Wilmington, Delaware, for example, which has a population of 3,900, raised last year the sum of \$6,000. Richmond, Virginia, which is a city whose population is about one-third larger than Birmingham's gave the United Palestine Appeal the sum of \$11,000.

It is, of course, difficult for an outsider to estimate the giving capacity of the community. The local leaders are the best judges of such a matter. But in view of the desperate emergency which exists, would it not be possible for Birmingham to allocate a much larger sum of money for overseas relief this year, including the Joint Distribution Committee and the United Palestine Appeal?

Dear Dr. Silver:

You will pardon my belated acknowledgment of your letter of November 25. However, I am still confined to my home and gradually recovering; from my illness. It will be some time yet, according to the doctors wishes, before I can go back to my office and resume my duties.

I noted your comments about the Birmingham contribution to the Birmingham Palestine Appeal. Want to call to your attention that the \$4000.00 given directly to the United Palestine Appeal was not all that we gave for work in Palestine. In addition to the \$4000.00 to the U. P. A., we gave to the Haddassah \$2250.00, to the Junior Haddassah \$300.00 and to the Palestine Emergency Fund raised last spring, \$300.00. This makes a total of \$6850.00 which went directly for Palestinian work. In addition to it, we have contributed to the Hebrew University and to some twenty odd Yeshivas and institutions in Palestine. This will indicate to you that we are fully aware of the need of giving as much support to the upbuilding of Palestine as possible. I may also mention that independent of this, there has been collection made for the Jewish National Fund from private individuals.

Our Committee has raised the goal which we desire to reach to \$40,000.00 a year, which is \$10,000.00 more than we raised a year ago. It is also our intention to devote this additional \$10,000.00 for overseas and refugee relief, in addition to the former quota, the oversea relief and refugee will mean J. D. C. & U. P. A. work. I am in hopes that we will raise this amount. Your purpose at the opening dinner of our campaign, you know, will be most effective in helping us to obtain the goal.

One thing is quite uncertain to me at present. My physician insists on my going to Florida for several weeks. This would mean that I will be absent from the city during your visit, a thing which I very much regret and against which I am putting most strenuous objections. With best wishes,



Of course, before writing you about any of the Texas engagements, we had very carefully checked the schedules of planes and trains. The schedule that had been set was to have you open the San Antonio campaign on the evening of March 28th. There is a sleeper leaving San Antonio at 3 A.M. the same night which arrives in El Paso in time for your meeting the next day. There is a car on the sleeper from San Antonio to El Paso which may be occupied any time after 10:00 in the evening. You would then spend the night in El Paso and leave the next noon on the American Airline's plane at 1:12 P.M., arriving in Fort Worth at 5:45 P.M. Your meeting in Fort Worth which opens their campaign, would be that evening and you can leave Fort Worth for Cleveland either by plane or train as you feel best, or you could take a plane directly from Fort Worth to New York City as you expect to be here on April 2nd.

I know that you appreciate that I got into this picture only after Mr. Montor left the city on his trip. The commitments had been made definitely for you in San Antonio, El Paso and Fort Worth. The communities have publicized your coming and have set their entire plans in accordance with Mr. Montor's assurance that you would be there. As I wired you, a cancellation or a substitution at this time would not only be most embarrassing, but might prove to be the undoing of some fine work that has been done in Texas. I assure you that our Speakers' Bureau would never make any engagements any place for any of our speakers unless they had first checked very carefully the train or plane connections.

I have already written you the details of the Boston campaign opening which you will address on March 19th.

Dear Ben:

I was sorry to learn from Miss Rubenstein that you were indisposed. I hope that it was nothing more than a bad New York cyster.

Miss Rubenstein tells me that you would like to have some ideas on methods of increasing standards of giving for a 1939 campaign. Of course, basically, the first problem is to get a few of the leaders such as Mr. Oppenheim and others to forget all past standards of giving and to do what every other wealthy leader in America is expected to do this year, and that is give in accordance with the needs that will insure \$20,000,000 being raised. I know of one woman in New York City who, together with her daughter, gave \$5,000 last year and who is giving \$250,000 this year. I know of a man in Chicago who gave \$25,000 last year, who is giving \$100,000 this year. I know of dozens of men throughout the country who gave \$500.00 last year, who are giving \$2,500 this year.

In the city of Trenton, sixty-eight contributors last year gave \$100.00 or more each. This year, 281 individuals gave \$100.00 or more each. Trenton has 7,129 Jewish men, women and children. This figure is accurate, because they have just completed a Jewish census. In 1937, Trenton gave about \$6,000 to the Joint Distribution Committee and the United Palestine Appeal. In 1938, Trenton gave \$13,000 to the Joint Distribution Committee, the United Palestine Appeal and the National Coordinating Committee Fund, Inc. They have just completed a welfare fund campaign and the United Jewish Appeal is receiving a minimum of \$55,000. Individuals who last year gave \$25.00 and \$50.00 to the Trenton campaign, gave \$25.00 per month, or \$300.00 to this year's campaign. This, of course, brings up the first point, and that is that sizable givers were committed on a monthly basis. There were over forty doctors, dentists and minor professional men who were in the \$5.00 and \$10.00 class last year, who gave a minimum of \$5.00 per month this year. You can see that these gifts, therefore, automatically came up from \$5.00 and \$10.00 to \$60.00.

Every young Jewish man and woman in the city of Trenton who was employed and making a salary of \$15.00 to \$25.00 a week was asked to and did subscribe fifty cents per week, payable monthly. This means a \$26.00 contribution from people who most likely give \$1.00, \$2.00 or \$3.00 in Scranton. Mr. Bernard Heing

Giving standards this year in campaigns from coast to coast are being established on the basis of the meeds this year, and not on the basis of any percentage of increase over last year's contribution.

As you undoubtedly know, Rabbi Silver and I expect to be in Scranton on the 22nd. I believe that a dinner is being arranged for 6:00 o'clock, prior to Rabbi Silver's address, which he is giving, not for the United Jewish Appeal, but on the forum at 8:30 o'clock. I expect to be there earlier in the afternoon and would like to talk over this entire program with you. I have some very definite ideas that I believe can be put to good use in your community.

Samuel Shair, Executive Director of the Young Men's Hebrew Association which sponsors the campaigns in Scranton, advised that they would hold an Executive Committee meeting March 13th to organize the 1939 campaign and discuss the \$40,000 assigned quota. Mr. Herman has asked that they postpone discussion in regard to the quota until after the March 22nd meeting which you and Mr. Herman will attend. Mr. Herman also wrote Mr. Shair that he discussed with Rabbi Max Arzt in New York ways and means of reising the suggested quota.

In response to a request from Bernard Heinz, Mr. Herman wrote him regarding methods of increasing standards of giving for 1939. A copy is attached hereto.

1938 - Scranton conducted its campaign during May for a total quota of \$20,000. They raised \$21,000 of which JDC, UPA and NCC reserved a total of \$15,500. The quota was originally set for \$15,000 but was increased to \$20,000 because of existing conditions.
