Will you be good enough to accept the enclosed check from a Unitarian who is an admirer of the Hebrew people. I regret that my financial condition does not permit me to send you a larger sum.

The least atonement organized Christianity should make for the implacable hatred and persecution it has visited on your race thru the centuries would be to acquire Palestine, present it to and protect your people in it. The history of organized Christianity however is evidence thatit will not do this, for organized Christianity has never practiced the religion of Christ. It has been too busy carving His image upon the face of courts and tombs of kings; in His name consecrating cruelty and hatred of man to man and wresting his Gospel to the defence of social injustice.

Dear Dr. Wise :-

My oldest brother, nearly 60 years of age, came to this country from Russia about 18 months ago. Curious to know what he thought of the "back to the soil movement",\* I sought his opinion on the subject, my brother being thoroughly familiar with the life of the Jews in the Ukarine.

I am enclosing copy of a letter received from him this morning. You will concede that one who, at his age, is capable of mastering the English language as he did, must be a person of splendid intelligence and insight, and that his views merit greatest consideration.

I am supremely happy that united Jewry will back them new and significant campaign on which we launched yesterday.

Best wishes for a Happy New Year to yourself and your family in which Ruth joins.

Dear Jacob:

In your last letter of September 1 you asked my opinion regarding the colonization work in the Crimea and Ukraine.

Before expressing my opinion on this subject, I have to answer the following questions:

1 - Is the soil of the land offered to the Jews by the Russian government good enough for agriculture?

2 - Are the Jews capable of giving themselves up to agriculture and becoming good farmers?

3 - Are they inclined to abandon their former occupations as traders and merchants and become farmers?

4 - Will they be safe in case, if the Soviet government will be overthrown?

As to the quality of the soil of the land offered to the Jews in Russia I can say nothing. All depends upon where the land is located. Everybody knows that Ukraine not only furnished all the northern part of Russia with grain and cattle, but was also considered as the granary of Europe. Before the World War they expected from Ukraine about \$400,000,000 worth of wheat annually notwithstanding that the peasants cultivated the ground with primitive ploughs and "sochas" (a sort of plough used by the Russian farmers and entirely unknown in America). But Ukraine is a vast country, and one can find there and especially in Crimea, where the ground is mostly sandy or saline, stretches of land that are worthless.

About forty years ago, when the Jews began settling in Palestine as farmers, many people doubted whether the Jews who for 1900 years have lived in towns and big cities and abandoned entirely their former occupations as farmers and cattle-breeder would be able to become good farmers. Experiments in Falestine, Argentine and even in Russia where there are many Jewish Colonies proved to be successful to such a degree that new nobody doubts the ability of the Jews to become good farmers. Even Suverin, the head of the anti-semitic party in Russia before the World War, after visiting the Jewish colonies in J910 or 1911, was obliged to confess in his most influential news-paper "Nobbie Vrenga" that the Jewish colonists were living exclusively upon farming and were in better circumstances than their neighbors, non-Jewish farmers. I believe in the wonderful ability of our people to adapt thenselves to new conditions whatever they may be, and new, when the Jews in Russia are forced to change their careers because of the social revolution that followed the war, it is the duty of all of us to do overything we can to help them out of this distressing situation.

As to the question whether or not the Jews in Russia have an inclination to forsake their present occupations and once more devote themselves to farming, I will add the following: even 3 and 4 years ago I have met in Russia many Jews who dreamed of devoting themselves to agriculture in spite of the fact that the situation of Russian farmers was terrible at that time, and many, many people- some with delight, some with regret and horror- believed in the near downfall of the Soviet regine in Russia. Now the circumstances of the Russian farmers are getting better every year because of the proper measures taken by the Soviets; the steadiness of the government increased to such an extend that only ill-informed foreigners who have never been in Russia and some credulous people who are inclined to believe in what suits their purposes can believe in the near downfall of the present regime in Russia. Consequently, the movement of Russian Jewry "back to soil" became so tremendous that the most sensitive of our leaders think it their duty to be at the head of this movement. In my opinion it would be a mortal sin not to take advantage of the offer afforded to our unfortunate people, not to grasp this wonderful opportunity.

Some people predict that in case if the Soviet government will be overthrown, pogroms will be the immediate result, and everything, including the land, will be taken from tham. Lately one of my acquaintances asked me what would become of the Jews in case if a monarchy will be re-established in Russia. In reply I asked him: "Can a chicken re-enter the shell of the egg from which it was hatched?" Likewise can Russia become a monarchy. The position of the Soviet government is getting stronger every year; the workers are, entirely without any exception, for the Soviets; the farmers became reconciled with the government not only in the central part of Russia where they were for the Soviets from the very beginning of the revolution, but also in Ukraine where in 1920 and 1921 the bolsheviks had to put down so many insurrections of the farmers incited to revolt by the priests and rich land-owners who had been deprived of their estates. I want to call your attention to the fact that even in 1921, when Vrangel took possession of a part of Ukraine, the same farmers mounted their horses and helped the bolsheviks to drive him out. They understood perfectly what restoration of monarchy meant; it meant pressure, iniquity, disorder, slavery of the lower classes, bloodshed, chaos, and they preferred the Soviet regime: out of two evils they chose the lesser.

Now when the government announced the so called "Nep" (New economic politics); when the Soviets proclaimed:"....., which means:"Everything for the farmers"; when they took heroic measures to improve the situation of the farmers, and their efforts proved to be successful, the farmers are on very good terms with the government.

You may tell me that I an exaggerating the strength of the present government in Russia. Suppose it to be so, but even if such be the case, it is much safer for the Jews to live in villages than to concentrate in towns and big cities. In 1906 there were many pogroms in Kishinev, Odessa, Kostov, Balta and many other towns all over the Ukraine, but none of the Jewish colonists in Ukraine was killed or injured, and they lived peacofully surrounded by their non- Jewish neighbors with whom they were on the best terms. I will try to explain you why it was so.

Many people think that the pogroms are the result of the hatred of the Christians against the Jews. One example will convince you that this is a In 1906 the population of Odessa was 430,000. During the first mistake. revolution, 1906, almost all warehouses of the crown were plundered by the citizens, and about 250,000 people took part in that robbery, among them some The socialists in their proclamations attributed this plunder policemen. to the rage of the citizens who in such a manner protested against the cruel regime of the tzar. About a month later there was a pogron in Odessa; many Jews were killed, still more injured; over 200,000 people took part in the pogron, and the minister for the Home Department in his announcement attributed the pogrom to the hatred of the Christians against the Jews for their partaking in the revolution. Who was right? Obviously both the government and the socialists were wrong; the same people who plundered the crown warehouses when the government was unable to prevent them from pillaging killed and robbed the Jews when they were allowed to do so. Not hatred, but avidity and greediness have always been the main cause of all pogroms. In small villages it is not so easy to plunder; a farmer cannot take a piece of land or a horse or even a plough in his pocket and carry it away, and that is why the farmers have been and always will be comparatively safe in their farms.

My conclusion is obvious:

The Jews in Russia are forced by necessity to change their present occupations. The Soviet government is willing to give them big stretches of land where they can devote themselves to agriculture. The Jews in Russia are preparing to accept this offer, but land without cattle, without machines does not mean anything. In 1922 our leaders collected about \$17,000,000 for the Jewish war sufferers; those measures were necessary at that time, but palliative. When a man is sick, the doctor gives him some medicine; but when he grows better it is necessary to sustain the patient, lest a greater evil happens; a lingering death is more painful than a sudden one.

There is a Russian saying: "Everybody is an architect of his own fortune". This saying can be applied to our people. We must help ourselves, and it is the duty of our leaders to accomplish this task.

In Russia all nations are absolutely equal in the eyes of the law, and of course the government will protect the Jewish colonists, but even if the Soviets will be overthrown, the Jews will be much safer in villages than in cities. The land cannot be taken from the farmers in general and from the Jews in particular because any government who will try to deprive the farmers of the land given to them by the bolsheviks would n cut off the twig on which it is sitting and would not exist even a week.

Do everything within your reach for our people, and God bless you.

Dear Rabbi Pilver:

I telephoned to your home this afternoon and was given the message left for me.

Kindly let me make one more attempt. Ι was in no condition this morning to speak at all, much less to present a case on which much depended. I was ingreat agony from an infection in my leg which had already cost me the last four nights of sleep -- I had to go to Mt. Sinai Hospital this afternoon for emergency treatment and may not be in a position to give the campaign in Rochester very much attention. If there is any possibility of bringing the campaign to a success-ful conclusion, I owe it to many considerations not to fail to do my very best to get every bit of strength.

I am firmly convinced that there is no other way to get \$50,000 in Rochester at this time than to work the community to enthusiasm with the prospect of having you at their windup affair. I repeat that there is no one I know of in America, in or out of the rabbinate, with the possible exception of Mr. Marshall, who has your personal prestige in Rochester. There is no one else whom menlike Simon Stein or "enry Kirstein or Joseph Micahels will go out of their way to honor, by their presence at an affair, or by a financial tribute. It is worth \$25,000 at least, to Palestine, for you to come -- half of a week's Palestine Budget. If you leave Cleveland on the 1:08, you will reach Buffalo at 5:30, and I will have a big car ready to meet you. At 7:30 you will be at the banquet hall or any other place in Rochester. At 10:58 you can enter train 44 at Rochester, reaching New York at 7:58 a.m., seven minutes later than the 6:00 express which you would no doubt have taken from Cleveland. This means sacrificing five hours inCleveland -- to achieve the success of the Rochester campaign. I will consider it a great favor in a difficult situationif you will wire me tomorrow morning, even if your decision still remain negative, and, if possible, before 9. Thank you sincerely.

You will be pleased also to know that Mr. Harry Weinraub has assumed charge of the follow-up work and it is hoped that our plan of "continuous enrollment" will be carried on all year around.

Our Cleveland effort is drawing to a close. You will admit Cleveland was not easy, but I for one, felt glad of the opportunity to be associated with you and the local Zionists in our adventure for Palestine. I still continue to feel swayed to carry on in the Keren Hayesod work, though really, you know the task is not a pleasant one by any means, but I suppose that is why we are Zionists.

### OUTLINE OF HADASSAH ACTIVITIES IN AMERICA AND PALESTINE

Four hospitals with 332 beds, each with a dispensary attached, and each of them open to all elements of the population, Arab, Christian and Jewish; medical stations in 34 Jewish settlements; four infant welfare stations in Jerusalem and three in other towns; medical aid to immigrants; medical inspection of 15,000 pupils in public schools and Talmud Torahs; anti-trachoma campaigns; a system of penny school luncheons, and the establishment and maintenance of a Nurses' Training School in Jerusalem, the only institution of its kind in the Orient; a Roentgen Institute which is one of the best in the world: - these items succinctly picture the remarkable range of effort in which the Hadassah Organization, composed of American Jewish women, is engaged in the Holy Land, in addition to furnishing adequate supplies of linens to fourteen institutions in Palestine other than its own.

Hadassah is exclusively a women's organization, under the leadership of Miss Henrietta Szold. In a brief period it has grown to a paid-up membership of 25,000, of which 17,000, were enrolled since 1922. The organization has 220 Chapters in as many Jewish communities in the United States, in addition to 624 sewing circles and 130 Junior groups.

During the first ten months of 1925, Hadassah received \$262,154.56 for Palestinian purposes, an increase of \$47,521.07 over the sum of \$214,633.49 received for the same purposes during the entire of 1924.

For the year ending June, 1926, Hadassah has assumed a budget of \$330,000. The increase of \$180,000 over the preceding year is due, first, to the cessation of contributions heretofore made to the Hadassah Medical Organization: second, to the expansion of Hadassh's work in Palestine, due to the increase of Jewish immigration, and, third, to the necessity that has arisen for Hadassah to undertake a building program.

One hundred cents of every dollar received by Hadassah for its work in the Holy Land goes directly to its institutions in Palestine. The cost of securing these contributions, as well as the administrative expenses of the organization, the cost of its propaganda, etc., is met from the dues paid by the members.

Outside of its clerical staff, Hadassah has no paid workers. Its officers and propagandists, many of whom devote all of their time to the direction and development of Hadassah's activities, are volunteers. They, and the thousands of members of the organization, bring to their self-imposed task zeal, intelligence and devotion, which make Hadassah the highest expression of Jewish womanhood in beneficent action.

Hadassah is a beloved word in Palestine. Its name is a blessing on the lips of Jews, Arabs and Christians alike. It has saved countless lives, threatened by disease, and has brought help and healing to thousands. Its beneficent influence has had a tremendous influence in the improvement of the hygienic and sanitary conditions not only of Palestine, but of the entire Near East. Its institutions, spread over the land like the loving embrace of a great mother, are visited by thousands of tourists from every part of the world, who have marvelled at the efficiency and humanity of Hadassah's work. Its praises are sung all over the world. Hadassah is a word of praise in America. To be counted among its members is to be included in that ever growing army of Jewish womanhood, who, answering the call of Israel in anguish, are giving themselves unsparingly, joyously, selflessly to the "Healing of the Daughter of My People."

One of its most enthusiastic friends of Hadassah is Mr. Nathan Straus, who has indicated his friendship in practical manner by liberal contributions to its work.

Upon his return from Palestine last Spring Mr. Straus said:

"Praise must be given to Hadassah, the Women's Zionist Organization, which has done marvelous work. It has proven indispensable for the life of the whole of Palestine. Under its auspices the sanitary conditions have greatly improved for the benefit of all its inhabitants. Hospitals, clinics and dispensaries have been established, and everything is being done for prevention and cure of disease. What I have personally been able to do in inaugurating and contributing towards the work is giving me great satisfaction.....

"The station in a purely Arab district where an Arab doctor works hand in hand with a Hadassah trained nurse is only one example of the non-sectarian character of all this health work. It would have been impossible without the leadership and untiring devotion and able services of Henrietta Szold. She has overcome stupendous obstacles and has brought the work to its present hopeful condition."

Many other well-known people have endorsed Hadassah's work. A few statements follow:

Mrs. Hanna G. Solomon, Honorary President of the Council of Jewish Women in Chicago, Illinois:

"It gives me the greatest joy to testify to the splendid achievement of Hadassah. 'The healing of my people' has been its motto and Hadassah has lived up to it. Splendid hospitals are giving care and help to those who need such service. The corps of trained nurses, all graduated in the training school are being sent to every part of the country. These are all native Palestinian girls. All of it has been established by those who know what the best standards are. Their work more than justifies our contribution of funds."

Justice Louis D. Brandeis:

"The Medical Unit takes high rank among Americans' contributions to Palestine. To the courage and devotion of the officers and members of Hadassah we owe in a large measure the important work which the the Unit has accomplished. All who love Palestine and wish to serve the Jewish people should lend aid to the Hadassah in carrying the heavy financial burden."

### Judge Julian W. Mack:

"I managed to visit the one institution that I most wanted to see, the Rothschild Hospital and Training School for Nurses. It is a first class institution in every way. Hadassah can well be proud not merely of this hospital but of all the work that it has done in Palestine. It made the first distinctive American Jewish contribution to the land."

### Mr. David A. Brown:

"There is no fiver piece of work being done in Palestine than that which is being so successfully carried out by your organization. Battling against the most unusual difficulties, it is, nevertheless, efficiently and successfully carrying on a fight against disease and malnutrition, which, in my judgment, is a tremendous factor in the upbuilding of the Holy Land, as a haven and refuge for thousands of Jews.

"More than that, by extending its beneficence to the non-Jewish population, and especially to the Arabs and Christians of Palestine, it has a marvelous influence in establishing peace and good will among the divergent elements of that country.

"I want to congratulate Hadassah and the thousands of American women who are members or contributors to Hadassah, on the fine humanitarian work that they are doing, and also for the selfless devotion which each and everyone of them brings to this task."

# Rabbi Stephen S. Wise:

"As an American Jew and Zionist I proudly and joyously claim that the victory over curable disease and preventable squalor has been won in part by reason of the heroic service of Hadassah, a pioneering and constructive achievement of the highest order."

Sir Alfred Mond, Former Minister of Health of Great Britain:

"One of the finest things done in Palestine is the Hadassah work. The service is rendered not only to the Jew but to all the population. I hope it will be continued to be supported on the most liberal scale. I hope there will never be a let down because it is rendering a great humanitarian service."

Senator Royal S. Copeland, Former Commissioner of Health of New York:

"The work of Hadassah is much more than simply a work of humanity for a few individuals. It is a work that should commend itself to every citizen of the world."

### Mr. Cyrus L. Sulzberger:

"During my stay in Palestine I saw enough of the work done by the Hadassah Medical Organization to enable me without hesitancy to commend it warmly."

# Professor Mordecai M. Kaplan:

"I wish to take this occasion to express my profound admiration for the indispensable and efficient activity of the Hadassah in Palestine. Whether it was the Hospital in Jerusalem, or a Health Station in a colony, everytime I observed the work of the Hadassah, I felt exactly as that Yemenite Jew whom I met in Rishon 1'Zion who, when speaking of the Hadassah, exclaimed in Hebrew, in his characteristic way, "A thousand thanks to the Lord for Hadassah."

"I hope that all who are interested in the upbuilding of Palestine will appreciate that any attempt to tamper with the Hadassah Organization would be an egregious blunder. It would not only cause a set-back in the development of health work, but would disintegrate the enthusiasm among thousands of women to whom Hadassah offers a program both Jewish and humanitarian in its scope."

MINUTES OF THE MEETING OF THE EXECUTIVE COMMITTEE OF THE UNITED PALESTINE APPEAL, HELD THURSDAY EVENING, NOVEMBER 19, 1925 - 9 P.M.-HOTEL MARTINIQUE.

Present:

Dr. Wise (in the Chair) Messrs. Meyer Brown, Bonchek, Berlin, Zeldin, Weisgal, Weinstein, Stone, Samuel, Ish Kishor, <sup>A</sup>braham Goldberg, Friedland, Conheim, Bublick, Spirer, Sendar, Morris Rothenberg, Morrison, Meister, Lamport, Neumann, Lipsky, Israel Goldberg, Edlin, Bernstein, Mrs. Berkson, Mrs. Adlerblum, Mrs. Jacobs, Mrs. Fromenson, Mrs. Szold, Miss Seligsberg, Miss Kussy, Dr. Kaliski, Rabbi Teitelbaum, Mrs. Lefkowitz, Mrs. Cohen, Mr. Hamlin, Goldstein, Eiser, Wilner, Schnur, Mrs. Gottheil, Mrs. Danziger, Mr. Liebovitz.

Dr. Wise opened the meeting by pointing out that the United Palestine Appeal was not in opposition to any other fund, but for the purpose of securing a minimum of \$5,000,000 a year to meet the urgent needs of Palestine, and that in this United Palestine Appeal were included the following organizations:

> Zionist Organization of America, Keren Hayesod Keren Kayemeth Hadassah Hebrew University

It was also understood that a place would be made also for various other national organizations which were carrying on activities on behalf of Palestine, in this country, such as the Mizrachi, Poale Zion, etc.

The Chairman then called upon Mr. Neumann to report on the activities of the United Palestine Appeal to date.

#### REPORT OF MR. NEUMANN:

Mr. Neumann stated that before a report of the activities of the United Palestine Appeal can be rendered, it was necessary to place on record the plans which have been adopted by the various organizations, to governing the United Palestine Appeal, as well as the distribution of the funds which will result from the campaign. Mr. Neumann added that the plan of organization and the plan for financial arrangements have been submitted to the various Administrative Committees of the constituent organizations, and that these plans have been acted upon by those committees, and adopted by the respective organizations, in some instances with suggestions or reservations.

Mr. Neumann suggested therefore that a subcommittee be appointed to consider both the original plans and the recommendations and observations and that this subcommittee submit its final report together with its mecommendations and the formal agreements with the various organizations, to this Executive Committee at its next meeting.

This was so moved, seconded and carried unanimously.

Mr. Neumann then reported that the campaign preparations have been taken in hand by a temporary committee of the administrative staff, consisting of the administrative heads of the various Organizations, including the Executive Secretary of the Keren Hayesod, the director of the Jewish National Fund the Executive Secretary of Hadassah, the Chairman of the Z.O.A., and other members of the staff on the floor. This temporary Committee has been proceeding with the plans for the campaign, but has been hampered by the fact that it has not yet been vested with sufficient authority to make a number of important decisions, which should be made to night. Mr. Neumann stated also that it is essential to have a strong Zionist propaganda and for this purpose it is necessary to have in addition to our own forces a delegation from abroad, and that in order to draw the attention of the whole country into this work, the first step would be the organization of a national Conference to be held in Baltimore on Sunday, November 29th, and that invitations to this Conference have been issued to members of national bodies and constituent organizations, Zionist Districts, Keren Hayesod Committee, Hadassah Chapters, large fraternal organizations, members of the nonpartisan conference, etc. This Conference would be addressed by prominent speakers and would serve to stimulate the workers throughout the country.

Mr. Neumann reported also that in a number of cities campaigns are already in progress, including Boston, Baltimore, Buffalo, Suracuse, etc., and that in those communites where Keren Hayesod campaigns have just been conducted, it is proposed to have supplementary campaigns later on in order to cover all the prospects.

# HADASSAH MEMBERSHIP DRIVE:

Attention was called to the fact that the Hadassah and the Z.O.A. were conducting membership drives in various cities.

After considerable discussion, it was decided in view of the supreme importance of concentrating all forces on the United Palestine Appeal, that the constituent organizations agree to abide by any decision which is made by the Praesidium or the Administrative Staff with regard to their activities, including not only the collection of funds, but the collection also of their organization income.

# PALESTINE SYNAGOGUE APPEAL:

Mr. Morrison called attention to the intensive propaganda for a campaign for \$500,000 for a Synagogue Centre in Jerusalem.

Decided that a committee consisting of Messrs. Lipsky, Bublick and Morrison confer with the heads of the United <sup>S</sup>ynagogues of America under whos auspices the appeal for a Synagogue Centre in Jerusalem was being made, with a view to the postponement of this drive until the \$5,000,000 for Palestine is concluded.

### D IRECTION OF CAMPAIGN:

It was moved by Mr. Rothenberg and seconded by Mr. Weinstein that the meeting proceed with the election of the Officers for the United Palestine Appeal. The following action was then taken.

1. Dr. Wise was unanimously elected Chairman of the United Palestine Appeal.

2. It was moved, seconded and carried unanimously that the Chairmen of the five constituent Organizations shall be elected Vice-Chairmen of the United Palestine Appeal, with the understanding that the chairmen of organizations which will be subsequently included in the U.P.A., on a parity with these five organizations, shall also become Vice-Chairmen of the U.P.A. 3. It was moved, seconded and carried unanimously that Mr. Hermann Conheim be elected Treasurer of the U.P.A.

4. It was moved, seconded and carried unanimously that the Chairman, Vice-Chairmen and Treasurer already elected be empowered to elect additional Vice-Presidents up to the number of ten.

The Officers elected are therefore as follows:

5. Dr. Wise then stated that as soon as he was asked to serve in this Campaign, he urged Mr. Neumann to accept the post of general director, knowing what it meant to Mr. Neumann by way of sacrifice from every point of view, and that Mr. Neumann was prepared to serve as General Director of the Campaign without compensation. Mr. Neumann then stated that he wanted it to be clearly understood that in accepting this post, he was to receive no compensation or remuneration of any kind either now or at any time during the campaign, or at its conclusion.

Mr. Neumann was then elected General Director of the campaign by a rising vote.

6. Rabbi Berlin proposed that Rabbi Leventhal be elcted Vice-Chairman of the U.P.A., and it was then moved, seconded and carried that this proposal to nominate Rabbi B.L. Levinthal as an additional Vice-Chairman be referred to the Committee in charge of the campaign.

7. Mrs. Gottheil proposed that a member of the Women's League be also elected Vice-Chairman. Decided to refer this to the Committee.

8. Mr. Rothenberg moved, and it was seconded and carried that a number of Honorary Vice-Chairman be appointed, the names to be determined by the Praesidum, and that the suggestion about Rabbi Leventhal be referred to this Committee.

9. It was moved, seconded and carried that the appointment of a Finance Committee be referred to the Praesidium, with full power.

# PROPOSALS RE MAINTAINING INTEGRITY OF CONSTITUENT ORGANIZATIONS

Mr. Rothenborg presented the following understanding for approval by this Executive Committee, in order to serve as a basis of cooperation on the part of the constituent organizations, and in order to maintain the integrity of the constituent organizations:

1. That the present staff of the Keren Hayesod, both national and regional shall remain intact for the period of the campaign, and shall continue in the capacities in which they now serve, subject to such directions as to work as the joint administrative staff may determine. Said staff shall be loaned to the U.P.A. for the period of the campaign. 2. That all regional Keren Hayesod committees shall remain intact and shall unite with other local or regional constituent organizations for the purpose of the united campaign.

3. The National Committee on Appeal shall include the National Executive Committees or National Boards of Directors of the constituent organizations.

4. The constituent organizations shall be represented on all standing subcommittees, the representatives to be chosen in consultation with the vice-presidents representing the constituent organizations.

5. Such other bodies as may be admitted to this union shall be admitted only upon consent of the constituent organizations.

Decided that this procedure applies in principle to every one of constituent organizations in the U.P.A.

## ADMINISTRATIVE STAFF:

It was moved, seconded and carried unanimously that the present Administrative Staff of the United Palestine Appeal be declared a permanent body.

### MEETING OF THE PRAESIDIUM:

Decided that if possible a meeting of the Praesidium be called for tomorrow in order to take up urgent matters now pressing for attention.

# NEXT MEETING OF EXECUTIVE COMMITTEE:

It was decided that a meeting of the Executive Committee of the United Palestine Appeal, together with the Executive Committee of the Z.O.A. take place on Saturday evening, November 28th in Baltimore.

Meeting adjourned 11 P.M.



You will, I am sure, recall the conversation I had with you and with Rabbi Goldman in which you suggested that later on a further effort would have to be made in Cleveland, in order that we might secure the balance of the quota which has not been reached during the Campaign which recently ended.

We would like to arrange for Sokolow, Wise, or Wedgwood to visit Cleveland, where, with your assistance, a dinner might be got up, where a further effort might perhaps net us an additional forty or fifty thousand dollars.

We are doing our best to provide a paid worker to organize the Campaign in the smaller cities in Ohio, where no United Palestine Appeal Campaign has so far been held. We will, of course, send this paid worker to Cleveland in connection with the suggested dinner, and also to help in obtaining the money outstanding which remains to be collected. Please let us have your counsel and advice on this matter as soon as possible.

I would like to associate myself with the telegram which Lipsky sent to you in response to yours informing him of the letter Brown sent to you. Unfortunately, not every recipient of Brown's letter communicates with this office, and it is quite possible that by these tactics some of our workers may be mislead into joining the U. J. C. Committee, without our being able to obtain adequate quid pro quo.

If it is agreeable to you and it seems practical to you, I will stop over in Cleveland for a considerable time, establish there temporary headquarters, and co-operate with you and your committee in making this supplementary effort for the United Palestine Appeal, by interviewing individuals, organizing small gatherings and arrange, if possible, one or two functions that will bring the satisfactory results expected.

In addition, I expect during my stay in Cleveland to come in contact, by communications, as well as by personal visits, with the following communities: Youngstown, Canton, Akron and Columbus and organize them for the United Palestine Appeal.

Before I make the necessary preparations for my visit to Cleveland, I would like to hear from you as to the advisablity of this step and the prospects for a success in this direction.

It will give me the greatest satisfaction if you would let me know that you could speak for me Sunday morning at the Free Synagogue, and in the evening at Mecca Temple, where we shall have a great beginning. It is more important than ever before to make a great beginning, because New York must raise \$1,500,000 and we think we can do it this year. Unless we get that, there will be no \$4,000,000 or \$5,000,000 for the country.


My dear Mr. Abramowitz,



My dear Mr. Neumann,





My dear Rabbi Silver:

In one of the late issues of the Jewish Advocate of Boston, Massachusetts, there appears a story of your address at the Palestine Luncheon at the Boston City Club, some little while ago.

I was very much surprised to read the following statement: "He showed the Russian Colonization plan was fraught with danger. He termed it a new Catholicism, a new Nostrum, a new panacea. It seems as though Russia was being pushed to the fore in lieu of Palestine."

In the light of certain correspondence of yours I have taken it for granted that while your still refuse to participate with us, publicly you had decided not to do us any harm.

You will be interested in knowing that in my travels throughout the country where I have the opportunity of addressing numbers of audiences composed of Zionists and non-Zionists and even anti-Zionists, I never hesitate to make an appeal for the Palestine Campaign and to express my general attitude towards Palestine, regardless of my personal opinion of some of the leaders who have messed things up horribly.

The Jewish press who are quoting me constantly have repeatedly told the story of my attitude towards the Campaign and have quoted me verbatim on what I have to say about Palestine.

> Give Them a Chance To Help Themselves

I don't believe that any Campaign or any effort, whether that of social or business, can be built up by destructive methods. I always feel that if I send out affirmative thoughts, that if I preach love and sympathy, that I secure the finer response on the part of those people who are my listeners.

Our mutual friend, Newman, who is the General Director of the United Palestine Fund, in a speech made in Pittsburgh some week or so ago charged the wealthy Jews of this country with sabotage and made other outrageous charges all of which left a miserable impression upon the Jews in Pittsburgh of the non-Zionist group. Already there has been considerable comment on that and I am sure that Mr. Newman has felt the boomerang affect of his wild remarks.

At this same meeting that you attended the Advocate reports Mrs. Archibald Silverman as saying, "As a Zionist she expressed her fear that the drive for relief and Russian coloniation would injure our United Palestine drive and so cautioned care for thought the \$15,000,000 origin-ally was to come from non-Zionists, now Zionists are overwhelmed with petitions to help this drive.

If she made a statement of this kind she certainly came far from the facts for no drive for European relief has every been made in this country unless an appeal went to every Jew in the land. What Mrs. Silverman says means little to me because she is a local figure but I do care what you say because a statement such as you made can not help but do harm to the cause you represent and in which I am interested, and to the cause that I at the present time am heading.
