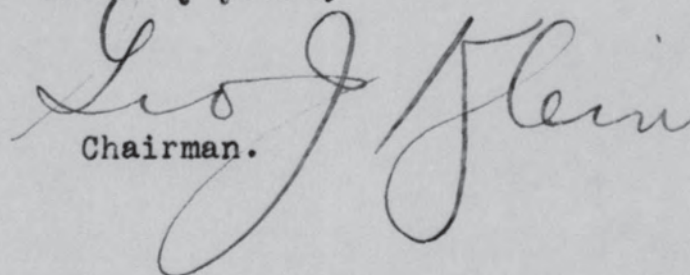

Dear Rabbi Silver:

After leaving you today, Rabbi Goldman spoke to Mrs. Herzog about calling this meeting. She feels that her efforts would be rather ineffective and questions the advisability of her calling this meeting, but would be willing to do this, however, if we desire it. Unfortunately she is leaving the city for a few days. Mr. Nate Loeser is also leaving the city with Mr. Halle and a group of folks who are going to French Lick.

We therefore believe that under the circumstances, it would be best to use our energies in behalf of obtaining pledges direct. Rabbi Goldman has agreed to endeavor to get a sizeable pledge from Mr. Wise. We shall endeavor to reach as best we can some of the other wealthy Jews of Cleveland, and believe ^{you} could reinstate Julius Tuteur on the same basis as he gave in 1926, which was \$2,000.00. You will recall he cut his pledge last year to \$1,000.00. Our committee believes that if our efforts were made direct without the possibility of having to humiliate Dr. Weizmann with a meeting that has a likelihood of being a failure from the point of collections, that we would at least have through these efforts about \$8,000.00, which, under the circumstances, is probably as well as we can do this year.

We are enclosing card for Julius Tuteur, and within a day or so I will forward a few cards for Eugene Geismer, which we will ask you to hand to him, and it is quite possible that he might be induced to increase on these pledges.

I was happy to learn that Mr. I. M. Stone was exceptionally thrilled by the fact that you called on him for the Bureau. He has expressed his admiration for you and particularly stresses the honor that he feels in your asking him to contribute toward the Bureau, and I believe it might be desirable for you to ask for his contribution to Palestine. You will note that he has not been a contributor in past years. May I ask your co-operation in securing this pledge?

My dear Friend:

The other day I made the boast while sitting in a meeting of the local Palestine Appeal Committee, that I felt morally certain that I could persuade or cajole you into coming to Kansas City for a great meeting some time within the next three months.

We must have a Campaign here no later than the end of January and I am exceedingly anxious to make the Campaign successful. I can think of no better way of assuring its success than by having you as the only speaker at the public meeting.

I am deeply interested in the cause, and you will be interested to know that my very first out-of-town engagement is at Oklahoma City on the 24th, when I appeal for funds for Palestine. I have already affiliated with the local Zionist group and had the pleasure of preaching to the Zionist congregation on the second day of Rosh Hashona. So you see, my dear boy, that I am asking you to do nothing that I am not willing to do, even though I know it will cost you great personal sacrifice in time and energy.

It occurs to me that you will attend the Union meeting at San Francisco in February. Would it be more convenient for you to stop at Kansas City at that time, either on your way going, or coming back?

Please treat this matter with utmost seriousness, because it means a tremendous amount to us and to the cause which you and I love.

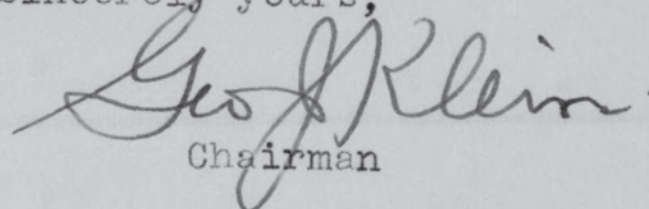

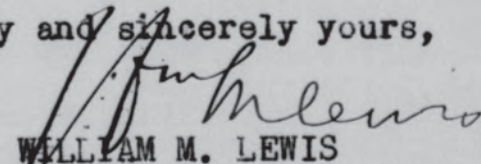

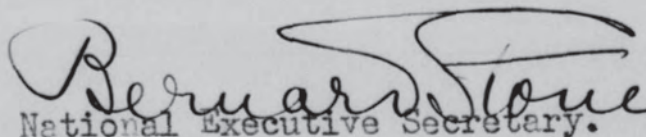
Dear Rabbi Silver:

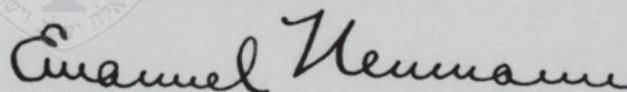

Dear Al:

The Denver community has just organized a committee for U.P.A. campaign. It is headed by Brother A. B. Cowen, as chairman. You have met Mr. Cowen at the Grand Lodge Conventions. He is one of our finest citizens and it is his desire as well as the desire of the committee that we put over the biggest campaign that has ever been conducted here.

We have a peculiar situation in Denver. Our Reform Rabbi has heretofore been an Anti-Zionist and notwithstanding the trend of Reform Jewry toward Palestinian Rehabilitation work he has been luke warm, although no longer antagonistic. Because of that fact it is necessary that we have in Denver a man of national prominence to address us. He must be a man that commands the love and respect of the entire community including Reform, Orthodox and Conservative Jews. We feel that the only man that fits this description is your Rabbi Abba Hillel Silver. Our community has long been anxious to have him as our guest, but unfortunately it could never be arranged. Rabbi Silver's reputation has preceded him in this community and if he were to come he could attract a larger number of Jews than any other national or international character could. The Reform Jews and the big givers are particularly the ones who will be attracted and who will come to hear him and I am sure that he can open their heart strings and their pocket books and put over the biggest campaign in Denver's history. I cannot too strongly impress upon you the great good that his presence in Denver could do; not only for the present cause but for Judaism in general. We know that it is a sacrifice for him to come as far west as Denver, but we feel that the cause and Judaism warrants it.

Rabbi Silver has already received a wire from Mr. Cowen as well as from U.P.A. headquarters and he has regretfully declined the invitation, saying that the present

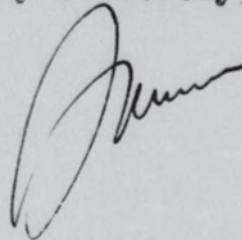
condition of his voice and his congregational duties make it impossible for him to come. So far as his voice is concerned I presume modesty compels him to urge that reason, but it is possible that so far as the objection based on congregational duties is concerned that may be a serious matter.

I recall talking to you at the Columbus Grand Lodge Convention about Rabbi Silver and I seem to remember you stating you were either a member of his Congregation or a member of the Board of Trustees. In any event I feel sure that you must have considerable influence with both the Rabbi and the Congregation. If the congregational duties are a serious handicap I sincerely trust that you may be able to use your influence to the end that he may be relieved of any embarrassment in that regard.

Denver wants and needs Rabbi Silver at this time and I know that I can call on you to use your influence in eliminating the objections urged by the Rabbi and try to induce him to accept our very sincere invitation.

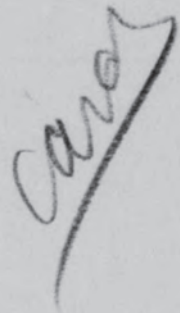
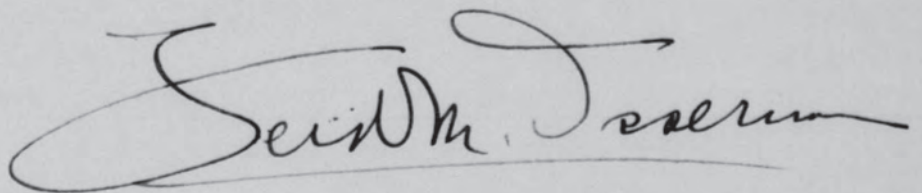

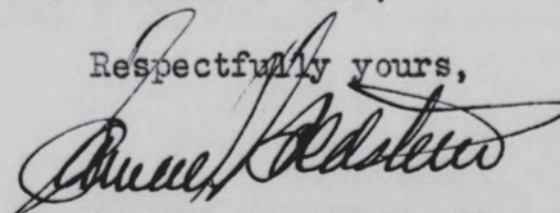
