My dear Dr. Goldstein:

I received a letter today from Dr. Stephen S. Wise enclosing one from Mr. Joseph Schlossberg of the Amalgamated Clothing Workers of America. Mr. Schlossberg writes that he was "shocked by the address of Mr. Ittamar Ben Avi."

He recalls particularly two points - the one in which the speaker compared the present Arab-Jewish situation in Palestine with the White-Indian situation in the American colonies; and the other in which Ittamar Ben Avi said "that trouble in Palestine had the advantage of lowering prices of land for the Jews."

He says: "If this is the sort of propaganda that Mr. Ben Avi is carrying on for the Jewish National Fund, I tremble. It will certainly do serious injury. If we, who are devoting ourselves to the upbuilding of the Jewish homeland in Palestine, cannot do so on high, and the highest ethical grounds, we will not be able to achieve it."

You know, of course, that there were many others at the Conference who resented the remarks of Ben Avi. I believe that as your representative in the Fund, he should be apprised of this fact and cautioned not to make such statements which are both ambiguous and open to the most damaging interpretations. I think that you are in a position to handle this matter satisfactorily.

Dear Dr. Silver:

I have yours of the 28th together with a letter which Mr. Schlossberg sent to Dr. Wise.

Mr. Ben Avi's address was painful to me as it was to many others. To my knowledge Mr. Ben Avi did not speak as a designee of the Jewish National Fund. He was invited as a distinguished Palestinian who happened to be here on a money-raising engagement for the Jewish National Fund. I was amazed in Washington to see that unlike the other two speakers on the radio hour Saturday night, Mr. Ben Avi spoke on the radio impromptu and without a script of his address. He should never have been permitted to speak unless his manuscript was furnished in advance to the person in charge. Immediately after his address, I made my resentment known in no uncertain terms.

Mr. Ben Avi's tour in behalf of the Jewish National Fund in this country will terminate on April 1st. You may be sure that he will be cautioned against a repetition of his "shtoos".

Dear Mr. Fisher:

Your letter of February 9th with regard to Worcester brings up an issue that affects other communities as well.

When the United Palestine Appeal enters into a combined drive with the Joint Distribution Committee and even though special allocations seem to be made by that combined drive to the Jewish National Fund, the money actually belongs to the United Falestine Appeal. I think you will agree with me on this subject if you will read the agreement constituting the United Falestine Appeal very carefully.

The only collections that ought to go directly to the Jewish National Fund are from compaigns specifically and solely under Jewish National Fund auspices. Otherwise we shall constantly be involved in questions of jurisdiction. Inasmuch as whatever funds come in to the United Palestine Appeal are divided equally between the Keren Hayesod and Keren Kayemeth, there should really be no objection to the procedure which has been adopted in the case of Worcester.

I do not think that the United Palestine Appeal should make out a check for \$300 to the Jewish National Fund because this allotment was made out of the Worcester 1937 campaign and forwarded to the United Palestine Appeal. The purpose of the separate allotment was merely to set aside a larger sum for the United Palestine Appeal than for other causes participating in the combined drive.

UNITED PALESTINE APPEAL

February 25, 1938

Mr. Alex Moyer Inter-City By Products Co Lorain, Ohio.

Dear Mr. Moyer:

Before Dr. Wise sailed on Wednesday for London at the urgent request of Dr. Weizmann I had an opportunity to go over with him the letter in which you describe the situation in Lorain.

Dr. Wise felt, as I de, that the urgent needs of Palestine require that the Zionist leadership should be more vigorous than ever before in protecting the interests of the United Palestine Appeal.

For the President of the Zionist District or for any Zionist organization to agree to a campaign from which the United Palestine Appeal would receive 25% as against 50% for the Joint Distribution Committee would represent a serious breach of the responsibility devolving upon every supporter of the Jewish Agency Executive.

We do not wish to minimize the needs and obligations of the Joint Distribution Committee, for we all realize how pressing are the olaims being made upon that organization. It is no less true to say that the situation confronting us in Palestine requires larger support rather then a decrease. Only last week Dr. Wise was in receipt of a cable from the Jewish Agency Executive of an urgent character unprecedented in the past ten years. So grave was the situation described by the Executive that the United Falestine Appeal felt compelled to do something which it has not done in the past decade. It made a large lean at one of the New York banks because it could not get the funds quickly enough in any other way.

It must be realized that the Jewish Agency Executive and the 'ewish people as a whole are facing a critical stage in their relations to the 'ewish National Home. In the first place, the political and economic uncertainty in Palestine has placed an extraordinarily heavy burden on the Keren Hayesod and the Keren Kayemeth. It is the funds being made available by and to these two institutions which will make possible the emergence from this critical transition period.

When Dr. Bernard Joseph, legal adviser of the Jewish Agencym came to America a few weeks ago he demanded of American Jewish leaders that our quota for 1938 be \$10,000,000. He **poi**nted out that what was at stake was not merely the fate of 430,000 Jews in Palestine but the destiny of hundreds of thousands of other Jews for whom room must be made in Palestine if they are to be saved from the tide which threatens to engulf them in such countries as Germany, Poland, Rumania and Austria.

At the recent National Conference for Palestine in Washington a resolution was adopted making it clear that no campaign was to be conducted for any other Palestine fund-raising institution, no matter how worthy, until after the maximum obligation to the United Palestine Appeal had been met. I enclose herewith a copy of that resolution for your guidance.

Whatever funds are raised for the Jewish National Fund are designed to be of a supplementary character. It would do the utmost harm to the Jewish National Fund and to Falestine as a whole if the large amounts that should be forthcoming for the United Palestine Appeal were diminished as a result of supplementary activities undertaken on behalf of the Jewish National Fund. The primary obligation has been and must continue to be the United Palestine Appeal.

Enclosed herewith is an analysis of the 1938 quota of \$4,500,000. Lorain in common with communities from one end of the land to the other must adopt a quota for the United Palestine Appeal commensurate with this national objective.

I beg of you to see to it that the United Palestine Appeal receives parity with the Joint Distribution Committee because the claims of one are as urgent and primary as the claims of the other. Both must have the fullest support.

In view of the splendid work that has been done under your leadership in building up and strengthening the Zionist movement in Lorain and its vicinity. I believe that you should be able to convince the other leaders in the community that you are prepared to take on additional tasks if necessary in order to obtain the funds that will warrant a fifty percent share for the United Palestine Appeal.

I feel sure that the United Palestine Appeal will cooperate with you wholeheartedly both in its national and regional offices so that your task may be shared.

Surely no outstanding leader of the United Palestine Appeal would be able to persuade himself to visit Lorain for a campaign function if the local Zionist leadership felt that 25% was an adequate acknowledgement of the important place that Palestine occupies in the solution of the problem of Jewish homelessness. I do not wish to close without expressing appreciation for the Zionist Organization of America and for the United Palestine Appeal for the work which you did to make possible the increasing understanding of Palestine's needs. In 1936 Lorain gave \$120. In 1937 it was raised to \$275. Your ambition should be to see to it that Lorain should give to the United Palestine Appeal a minimum of \$1,500. This is the amount given by other communities with a Jewish population equal to that in Lorain.

I note what you say about the situation in Elyria. An allotment of \$150 was announced for 1936. Only \$50 has been received on account of that sum. We received no word of an allotment for the year 1937.

Will you be good enough to inform me immediately of the name of the B'nai B'rith or other leaders in Elyria with whom we can communicate and assist you in improving a deplorable situation.

Would you not undertake to visit Elyria and apply the pressure that will secure the inclusion of the United Palestine Appeal in the Elyria campaign for 1938; and also obtain the sums outstanding for 1936 and 1937.

I an turning over a copy of this letter to Mr. Montor, Executive Director of the United Palestine Appeal, who will, I believe, then communicate with Mr. George Greenspun, who is the newly appointed Regional Director of the United Palestine Appeal in the mid-west for a group of states including Ohio. The address of Mr. Greenspun in Chicago is the Hamilton Hotel. You will hear from him within the next few days. He will place himself at the disposal of yourself and our other friends for work to be done in Lorain and Elyria.

I know that you will understand that everything that I have written is based on deep appreciation of the service you have given and of the devotion with which you continue to serve the Zionist movement and Palestine upbuilding through the United Palestine Appeal.

#### MEMORANDUM

March 3, 1938.

TO: HENRY MONTOR

FROM: GEORGE GREENSPUN

I am sorry to report that none of our leaders have been very active. Judge Braude went to Florida for a month and never showed his face at any of the Rallies. He is chairman of the JNF. Bill Katz is very busy signing members for the Zionist Organization and feels that this is of the utnost importance in spite of the campaign. Colonel Rosenberg also left during the campaign on an extensive business trip for two weeks, and 48 hours after his return was on his way to Florida for six weeks. He is chairman of the Finance division with a quota of \$17,500 to be raised, and only \$10,000 has been raised, and that money came in of its own accord. We cannot expect these men to carry the influence we desire. Their attitude toward responsibilities after they have accepted it is beyond comprehension. I say from actual observation that we should let well enough alone.

If you want to make an appeal for additional remittances I suggest that it be done from the national point of view and not from Chicago leadership at the present writing.

Confidentially speaking, Goldsmith is not very friendly, you know that. While it is true that he has calmed down considerably as a result of the splendid gesture you made in assisting him and the wonderful services you gave him in regard to the Chicago Jewish Welfare Fund this year, I am happy to state that they begard both you and our national headquarters in a better light. The melfare Fund group is still bitter with the Zionists of Chicago and I might say are the Orthodox groups. From what I've seen on the sidelines, the Reform groups of Chicago are nothing to brag about.

My dear Mr. Gould:

Let me thank you for your kind letter of March 2 enclosing a copy of the letter which you sent to Rabbi Jonah Wise. There is one inadvertant mis-statement in your letter. You say that the division for all communities agreed on between the U.P.A. and J.D.C. is 60% and 40%. The agreement as I pointed out to you, last Sunday morning, applied only to Welfare Fund communities which are members of the Council of Jewish Federations and welfare Federations. You may recall that I showed you the agreement and also read to you the names of the cities in Ohio which are affected by the agreement. Lorain is not one of them. All other communities make their own allocations. Some of them are guided by the 60-40 agreement, others have a 50-50 agreement or some other arrangement. In view of the fact which you quoted to me, that funds had been raised by the Jewish National Fund in your community in January, I thought it only fair to suggest a 60-40 arrangement instead of a 50-50 arrangement.

You may recall also that I urged that all beneficiaries of your campaign take their chances on the outcome of the campaign and that no preference be given to any one fund over the other. You seen not to have followed this suggestion. Three organizations are to get their full allotment regardless of the outcome of the campaign while the over-seas agencies are each to take their percentages of what remains. You suggest that you will be able to raise between one thousand and fifteen hundred dollars for the over-seas agencies. If only a thousand dollars is raised, the J.D.C. will receive \$510 and the U.P.A. \$540 as against \$500 for the wider scope. Do you really think that this is a fair allotment to the over-seas agencies in these critical times when the needs of our people abroad are so desperate and urgent? Mr. Gould

#### MEMORANDUM

TO Mr. Mendel Fisher

FROM Mr. Henry Montor

I am herewith returning to you the list which you submitted showing income of the Jewish National Fund by cities over the periods 1935-36 and 1936-37.

The amounts raised by the United Palestine Appeal in these various cities have been indicated on the right hand margin, so that the figures may be available for comparative purposes.

As I understand it, the purpose of your submission of the list was for us to work out a group of cities which, we might decide, would be made available exclusively for the special campaigns of the United Palestine Appeal or of the Jewish National Fund.

When the first discussion was held between Dr. Silver, Dr. Goldstein, yourself and myself, the plan of regional units for the United Palestine Appeal had not yet been fully realized. Since then, as you know, there has been a reorganization of the basis on which the United Palestine Appeal operates. George Greenspunis in Chicago, to cover the Midwestern Region; Bernard Stone is in Los Angeles for the Western Coast states; Dr. Braunstein is handling the Southwestern Region with headquarters in St. Louis; Robert Silverman is responsible for the New England States; Simon Levin is continuing his work in the Seaboard Region; Meyer Mintz is covering New Jersey and Eastern Pennsylvania.

The effect of the regional organizations is to provide a type of frequent and close contact which did not exist for many years, in fact, since the original United Palestine Appeal was disbanded.

In the past few years there were very many communities which did very little, or even nothing at all for the United Palestine Appeal because our directors were most frequently sent out from New York headquarters on flying trips which made it uneconomical and difficult for them to visit every single community on route, particularly when those communities had 25 or only 10 Jewish families. But this situation is now changed. By being in a given territory twelve months of the year a director is able to give adequate attention to the major communities and still have time to visit at least once, and possibly several times a year, the smaller towns from which anywhere from \$25 to \$300 or \$500 have been raised or may be expected. All this of course makes necessary a reconsideration of the relations between the United Palestine Appeal and the Jewish National Fund.

It is the intention of all of us that the Jewish National Fund should be enabled to obtain supplementary income for we realize that whatever additional funds are received by the Jewish National Fund are ultimately the income of the United Palestine Appeal.

On the other hand, in view of the larger appeal of the United Palestine Appeal and in view of the year round facilities for campaigning, it would be unwise and unprofitable for the Jewish National Fund to conduct special campaigns in certain communities, if by so doing the larger possibilities for the United Palestine Appeal are adversely affected. Obviously, when I speak of special campaigning. I do not have in mind the traditional collection activities of the Jewish National Fund. I refer exclusively to the type of project which involves a campaign as broad in appeal and as intensive in activity as the fund-raising effort usually sponsored by the United Palestine Appeal. Since the field directors of the United Palestine Appeal are in actuality also representatives of the Jewish National Fund it would be an undue hardship on them in their effort to raise maximum sums, if the Jewish National Fund were to send into communities upon which we have not previously agreed, representatives who would be expected to do exactly the sort of campaignin which the United Palestine Appeal field men are supposed to do.

With these observations in mind I append a list based on the records of the Jewish National Fund and the United Palestine Appeal. I believe that in this list of cities the Jewish National Fund might engage in its activities outside of the traditional fund-raising. This list is submitted to you as a basis for discussion. Please let me have your thoughts on the subject. I am sending copies of this memorandum and the list to Dr. Silver and Dr. Goldstein.

Subject: Jewish "ational Fund Activity Mid-West Region.

I have delayed answering your memos dated February 23rd and March 2nd regarding activities of the Jewish National Fund field representative in my territory. I also made a study of the compartive reports which you were kind enough to send me giving the figures of the amounts raised 1936-37 and 1935-36. I have also given consideration to the subject of marking cities which can be covered by JNF field men.

I have discussed this matter thoroughly with Rabbi Goldman and have talked with a number of key people in various communities within the region. I find that they concur with my views which are as follows:

- 1. Many communities have not been reached systematically and periodically for the UPA, and the JNF has taken advantage of this situation.
- 2. Funde can be secured for UPA from communities that have not subscribed within recent years and additional funds are available in those communities that now contribute. They merely need stimulation.
- 3. There is nothing to be gained in the fund raising activities for Palestine if there is to be a competitive effort between the JNF and UPA.
- 4. Competition between our own major fund-raising agencies gives the JDC the opportunity of creating disagreements in the local communities where definite arrangements have already been made for combined campaigns, thus embarrassing our key people and causing a resentment on the part of non-Zionists who may be favorable towards our cause.

I quota from a questionnaire just received, "The reason for the delay in this and JDC drive is that The Jewish National Fund had a drive and was just completed week. I am afraid if we start now we won't get much and so am delaying/Antil next month. The Jewish National Fund raised \$408.50. This is going to take away from our drive and I don't believe we will raise as much this year but am going to try.

In my talk with Alex Moyer of Lorain, Ohio, concerning this matter he intimated that much of their difficulty in Lorain was due to the fact that they put on a special campaign for JNF, and in order to pacify the community leaders they were willing to accept 25% for UPA rabher than fight for 40 or 50% because they had abready sent in a check for \$600, raised for Metional Fund, with a possibility of more to be sent later. This is a typical case due to the fact that it is not possible for men like Moyer to repeat these special efforts in behalf of JNF annually.

In fact he waid so himself, and also stated that he would much rather concentrate his efforts in behalf of UPA shan to continually be at odds with the leaders of the local campaign committee, charged with raising funds for overseas activities.

Col. Resenberg told me that in his negotiations with Mr. Goldsmith of the Chicago Jewish Welfare Fund, Goldsmith demanded that the JNF cancel its special campaign which was scheduled just prior to the present Welfare Fund drive, "Or Else/" This can be said for many other Welfare Fund communities.

I don't want you to think that I feel there is no place for JNF activity. On the contrary, there is a very important number of functions that they are sadly neglecting all over the country due to the fact that in recent years they have become competitors in the field to the UPA directly.

There is room for the placing of a million additional JNF boxes in the momes of the Jews throughout the country. There are thousands of boxes which have been placed that have not been followed up nor systematically emptied. The truth is that the Hadassah has taken over the box collection business on a large scale, but doing it on a meager basis.

From Exemu the standpoint of propaganda, publicity, good will, etc., to my mind, the JNF box can produce much more money net to the campaign annually than the EMEXAMMENTER specialized efforts which have crept in during recent years. This would stimulate the tree certificates, golden book certificates as well as the Flag and Flower Days.

There is no reason to my mind why any community should be marked off from the "PA. In time, every community should be contacted in person, by mail or through Regional Conferences. These communities can and should be stimulated for the raising of funds for UPA.

The JNF has its specialized work, and in order to avoid further difficulties both in the National Office as well as the field, they should be compelled to stick to these traditional functions and nothing else.

May I suggest that you, as National Executive Director of the UPA you should call a special meeting of your National officers and make sure that Rabbi Silver is present so that you can, at this meeting, take up no other matter but that of JNF activities and have a final showdown with Rabbi Goldstein and the JNF group. As a further evidence of what I have in mind in saying that the JNF and the UPA cannot both conduct campaigns in the same community, particularly a small one, I refer to a report from Bernard Stone on Nogales, Arizona.

In the past the United Palestine Appeal has not been able to do much in that community, but this situation has changed because of the regional set-up.

Mr. Stone tried to arrange a campaign in Nogales and suggested a quota of \$500 to be divided between the Joint Distribution Committee and the United Palestine Appeal. The local leaders pointed out that early in March Mrs. Avis Shulman had been in Nogales and was given about \$125 for the JNF alone. The local people felt therefore that the UPA could hardly expect much more money, certainly not in relationship to the JDC.

You spoke to me on the telephone about Joplin. Here are the facts in the matter:

1. We received \$379.50 from Joplin.

2. Pearlstein visited Joplin, which has been a very, very unproductive community both for the U.P.A. and for the Jewish National Fund, with a view of strengthening the work there. Rabbi Albert S. Goldstein suggested that Ben Avi should visit Joplin since he was booked into Kansas City.

3. We, therefore, booked Hen Avi into that community. Rabbi Albert 5. Goldstein who was in charge of the arrangements informed us in his letter of March 23rd that when Pearlstein visited Joplin they were concluding their United Jewish Appeal. It, therefore, cannot be argued by any stretch of the imagination that the money raised through Ben Avi's efforts was intended for the UIP.A. Furthermore, it was not Joplin that actually raised \$379.50, but twenty communities were contacted by Rabbi Goldstein and in all probabilities, **The** large part of the money wasn't given by Joplin itself. There were also a large number of non-Jews at the meeting. In fact there were more non-Jews than Jews.

I gote from a letter that Rabbi Goldstein of Joplin sent to us in commenting on the first \$183. that was raised when Ben Avi visited that community:

> "By a system of closed bids \$183 in pledges was gathered at the table. By personal calls on those not present at the dinner I hope to raise this sum to \$300."

I happen to know Joplin very well from my experience in that territory and I tell you that what has been done for the Jewish National Fund cannot and did not affect the U.P.A. It is just \$300. more for Palestine and was not and could not be secured otherwise.

There is not any mention of the word Hagalilah in Rabbi Goldstein's letter. It was simply a Jewish Mational Fund collection. Rabbi Goldstein of Soplin paid all the expenses for the meeting.

The contents of your letter of the 7th was a very great surprise to me. Having organized the Ben Avi meeting personally, raised and collected almost every penny of the amount forwarded, I believe I am abthorized to report that it is in no sense whatever to be considered as a substitute for U.P.A. It was meant, all of it, with no reservation at all for the Hagalilah project.

What U.P.A. must have heard is that we have just completed one drive, this one, and that we are in no position to begin a new one at this season of the year. We are moreover in process of creating a Federation, to prevent in future any such misunderstanding as the present one.

I hope this clears up the matter. I have discussed the think with Mr. Falk who is Chairman of the U.J.A. Drive here. He doesn't know where the U.P.A. got the idea.

Dear Morris:

When Irving Le Roy, who is handling our accepted portion of the Tri-State, visited Canonsburg recently to ascertain why collections had not been completed in connection with the 1937 campaign, he was advised by Mr. Albert B. Fickman that it was necessary to postpone collections because the Jewish National Fund had recently sold \$400 worth of Huleh bonds, against which Mr. Fickman has already collected \$300 in payment thereof.

Obviously when we agreed to hold combined campaigns with the United Palestine Appeal on a 50-50 basis for the year 1938 in the Tri-State area, primarily because you wished it, we understood completely, as we still understand, that the United Palestine Appeal includes the Jewish National Fund, the Keren Hayesod and the Mizrachi, and that under no circumstances could the Jewish National Fund or any other participant of the United Palestine Appeal raise funds independently. By virtue of the fact that the Jewish National Fund has raised funds through the sale of their bonds in Canonsburg, and perhaps in other communities, this agreement has been broken and invalidated by the United Palestine Appeal.

As matters stand as of this date, the Joint Distribution Committee expects that the \$400 collected by the Jewish National Fund in Canonsburg is to be deducted from the U.P.A.'s share in the combined campaign when held and that this procedure will also obtain in any other community in the Tri-State zone where such bonds have been or may be sold.

But that is not enough. It is perfectly clear that if the J.N.F. takes monies out of these communities independently, there will be no funds remaining to be raised when the J.D.C. and the U.P.A. come into these communities. The Jewish National Fund is undertaking to do this same sort of thing in devious ways in many communities throughout the country. We of the Joint Distribution Committee have no desire to be policemen to protect our rights when they are infringed upon in communities in which agreements have been made in good faith.

We do not for a moment consider that the incident in Canonsburg is a casual incident or a mistake. As I have indicated, we are experiencing the same methods in many sections of the country. As far as we are concerned, we will necessarily have to look to you to correct the situation with the U.P.A. and the J.N.F. in the Tri-State zone, of which you are the Chairman, or we shall have to consider our agreement as terminated and proceed as we think best in raising funds for the Joint Distribution Committee in the Tri-State zone.

I am sending a copy of this letter to Mr. Montor of the U.P.A. and I am sure that I may hear from you by return mail if possible, and at least at your earliest convenience as to what is being done to correct this intolerable

Attached herewith is an exchange of correspondence between myself and Mr. Coons of the Joint Distribution Committee in regard to Jewish National Fund campaigns together with a copy of the letter which Mr. Coons sent to Morris Menman, Chairman of the Tri-State United Jewish Appeal.

I must ask two things of you:

- A) Discontinue immediately every campaign that you have launched in any community in the Tri-State area.
- B) Inform me of the receipts from such compaigns in the Tri-State area so that we may take them into account in our dealings with the Joint Distribution Committee.

I must warn you that continued Jewish Mational Fund compaigns in the Tri-State area are jeopardizing not merely good will but the success of the compaign in that whole area.

#### MEMORANDUM

April 12, 1938

MR. HENRY MONTOR, U.P.A.

DR. ISRAEL GOLDSTEIN

With regard to the Reading situation and all other conflict situations, I can only repeat what I have said so often, namely:

1 - That as a general principle the U.P.A. should have priority over the J.N.F. in every instance. It does not require any resolutions to re-affirm that principle. I would urge it even without any agreement because I believe that it is to the best interests of the movement.

2 - That there are, no doubt, special situations where the J.N.F. approach can be utilized to supplement the U.P.A. income and not to supplant it. Where the J.N.F. can serve such a purpose, it actually benefits the U.P.A. and becomes an auxiliary arm of the U.P.A. In such situations, we cannot be arbitrary and say that the moment there is any slight irritation, we must abandon the supplementary J.N.F. effort. Bather should we take the position that if it is the kind of irritation which can be solved and which will not create difficulty with the Welfare Fund, that every effort should be made to do so in order to permit the J.N.F. and the U.P.A. to benefit from the additional approach. Those situations need to be considered separately and individually. There is no way of making a categorical rule about them. I take it that you and Mr. Fisher can solve these problems together if there is good will on both sides, as I beliege there is.

3 - It can be demonstrated that there are many small communities where the J.N.F. approach can bring greater sums for Palestine than the U.P.A. approach, due to the unique character and diversity of the J.N.F. items, such as trees, Sefer Ha'Yeled, Golden Book, etc. In such cases, it would obviously be to the advantage of the U.P.A. to permit the J.N.F. the right of way and to spare its own approach and effort for those situations where it can achieve the maximum results. These situations, too, require individual consideration. I am confident that you and Mr. Fisher can arrive at a satisfactory understanding as to which communities fall within this category.

With the above principles in mind, I think a satisfactory modus operandi can be worked out. Obviously, it will take a little time to do it, but as some of the difficult situations now arising are being ironed out, it will provide a valuable precedent and experience for dealing with future situations.

I believe I ought to state, in all fairness to the J.N.F. position in this question that we have already modified and reduced substantially our Hagalilah campaign. Not only have we, in deference to the desire not to create difficulties for the U.P.A., cancelled a number of campaigns in communities where we have invested substantial effort and money, as you well know, but we have actually

taken off our staff two of our most effective field men. One is Mr. Pearlstien

who was operating in the southwest and midwest regions and who was our most productive field man in the Palestine Land Redemption campaign in 1935. We have terminated his services because we are reducing the Hagalilah campaign and Mr. Pearlstien is too expensive a man for our traditional collections. The second is Mr. Ben Avi who has been our chief asset in the Hagalilah campaign in the past six months and who terminated his work at the end of March.

I believe that as a matter of policy, insofar as it depends on the J.N.F. administration, we are doing everything within reason to meet the needs of the situation. As Mr. Lipsky pointed out at the last meeting of the U.P.A. Administrative Committee, we cannot be expected, after having invested a substantial amount of money in laying the foundation for the Hagalilah campaign, with the knowledge and consent of the U.P.A., to abruptly, by one stroke of the axe, cut off the entire effort. We are doing whatever we can to taper it off gradually. Within our general policy, I believe that you and Mr. Fisher can mutually arrive at an agreement regarding individual and specific situations where the J.N.F. effort can be pursued either without causing any irritation or if some irritation must be the price of substantial accomplishments, at least keep it down to a minimum.

I should like to say one thing finally. The call "On To Galilee" by the World Zionist Executive, as published in the current issue of the New Palestine, indicates the importance of giving the utmost possible publicity and effort to this action. It has a political, a psychological and a practical value of first magnitude. In England it seems that in spite of the merging of all the campaigns, they still feel that this is sufficiently important to warrant the holding of a special J.N.F. dinner at which \$60,000. was raised and \$250,000. announced as the goal for the year. Why should this call and this action be hushed up, soft-pedaled and stultified here in the United States?

This observation is by way of an appeal to the Zionist leadership to push this effort for us because of its great implications. Nevertheless, if the U.P.A. feels that it ought to be hushed up, we shall do our best to accept the decree though we may believe ourselves that a great Zionist opportunity is being forfeited.

This will acknowledge the receipt of your letter of April 11th together with a copy of the letter which you wrote to Morris Neaman of Pittsburgh, in regard to the activities of the Jewish National Fund in selling Huleh Bonds in Canonsburg and Washington, Pa.

It is the intention of the United Palestine Appeal to adhere in letter and in spirit to the agreement which was made between the Joint Distribution Committee and United Palestine Appeal covering the Tri-State area. We shall check thoroughly with the Jewish National Fund and make sure that no competitive campaign activities are undertaken by that organization in any city in the Tri-State area.

If such competitive campaigns are held, we shall most certainly take into account the receipts from them in determining the division of funds between the Joint Distribution Committee and United Palestine Appeal in the Tri-State area.

I am sending a copy of this letter to Mr.Neaman so that he may be made aware of the fact that the United Falestine Appeal will not countenance competitive fund-raising efforts that interfere with the prospects of maximum success for the United Jewish Appeal drive.

My dear Mr. Fisher:

The communications which you send me about Joplin, Mo. illustrate again the chaotic condition which exists in our fund-raising efforts and the importance on the part of the JNF to living up to the arrangement whereby it will not send any speaker or solicitor into any community without first receiving the consent of the UPA. This will obviate at least some of the difficulties which have been progressively developing in our work.

You sent me a copy of the manifesto of the World Zionist Executive in connection with the "On to Galilee" campaign. Please remember that we have agreed that there will be no special campaigns of this character in any of the Jewish Welfare Fund towns or in any towns where joint campaigns are held. Furthermore, with reference to the remaining communities - it is understood that the JNF will not send any solicitors or speakers for the Hagalilah campaign without first obtaining the consent of the UPA in order to avoid conflict with the campaign plans of the United Palestine Appeal.

Such manifestoes as you send me are intended principally for those countries which do not have the kind of arrangement which we have in the United States, i.e., an annual United Palestine Appeal which appropriates fifty percent of its income to the JNF.

My dear Mr. Montor:

You write that on the date of June 5th, Milwaukee will launch its campaign. That day hap ens to be Shabuoth. I do not see how they can plan a meeting on that particular day.

I did not send the letter to Mr. Samuel A. Goldsmith of Chicago. The matter should be taken up with him personally by Rabbi Goldman who originally made the agreement with the Chicago people.

You may obtain a list of the member congregations of the Union of American Hebrew Congregations by writing to the office of the Union of American Hebrew Congregations, Merchants Bldg., Cincinnati, Ohio and requesting a copy of last year's Annual Report.

I am interested in knowing of the further development of the situation in New London, Conn. I think it would have been wiser to have divided the funds initially on the basis of 50-50.

With reference to the New Brunswick community -I am happy to know that they have accepted my proposition and that they will be able to give me a check of \$2500 for the UPA when I visit them. The difficulty, of course, is the time. It will not be possible for me to come to New Brunswick before I shall have completed my campaign here in Cleveland which closes on May 17th. Some week night after that day, I shall be available for the good people of New Brunswick.

I have received an invitation from Mr. A. H. Rosenberg, Chairman of the Executive Committee of the Mid-West Region to address the conference on April 24. Inasmuch as I am to be in New York on the following day and my program is terrifically crowded, I am compelled to define.

Someone here has made the suggestion that a broadcast be arranged from Dr. Chaim Weizmann in Palestine to the opening campaign dinner of the Cleveland Jewish Welfare Fund which will be held on Sunday evening, May 8. I understand that Pittsburgh, St. Loyis and Detroit will also hold their opening meetings that night. The same broadcast might reach them. I understand that the cost is not very great and I am sure that three or four communities would be glad to share in the expense. The broadcast need not last longer than five or ten minutes. I would suggest that you cable Dr. Weizmann and ask for his consent.

I have just seen some communications which passed between some of the officers of the local Welf re Federation and Jonah Wise with reference to the special Big Givers' Ap eal which we suggested some time ago. As I read between the lines, the sole objection to such an appeal on the part of the JDC people is the 60-40 arrangement under the terms of which, the UPA would share in such an appeal. This is, of course a very narrow point of view to take, rather like cutting off your nose to spite your face. Such an appeal will in all probability have to be made, perhaps after the International Conference on Refugees. It is regrettable that we cannot capitalize the present mood of American Jewry for this appeal.

I have received a communication from Dr. Isr el Goldstein addressed to you with reference to the JNF and the Hagalilah Campaign. Most decidedly we are opposed to the kind of ublicity given to the Hagalilah Manifesto in the New Palestine. This has all the earmarks of a new campaign for the JNF which I thought we had agreed should not be launched this year. We should insist that the JNF send no speakers to the Jewish communities of the United States in behalf of raising funds for the JNF without first obtaining the consent of the UPA.

If the "Talkie" which was made is ready, I would appreciate it if you would send me a copy of it.

Attached herewith is a copy of a memorandum written by Irving LeRoy, Field Director of the JDC, with regard to Canonsburg, Pa.

You well know that we are facing a very delicate situation in our relations with the JDC. The Tri-State area, which includes Canonsburg. is one in which a 50-50 agreement of distribution was affected at the infistence of Mr.Morris Meaman of Pittsburgh. How can we possibly feel that we have honored that agreement by permitting such obvious interference with the possibilities of the United Jewish Appeal campaign attaining a maximum success in Canonsburg, or in any other Tri-State community?

I have presented innumerable memoranda to you on the subject of interference between JNF and UPA activities. You have either ignored them or given me disingenuous explanations. I am afraid that there is nothing more I can do except repeat that the best interests of Palestine fundraising are being injured.

Dear Henry:

In the matter of the Jewish National Fund raising money indepently through the sale of Huleh Bonds in the Tri-State Zone, I am glad to note from your letter of April 12th that the United Palestine Appeal "intends to adhere in letter and in spirit to the agreement which was made between the Joint Distribution Committee and the United Palestine Appeal covering the Tri-State area."

I have some idea of your difficulties in controlling the activities of the Jewish National Fund, an important partner in the United Palestine Appeal, but what I shall have to know for the Joint Distribution Committee Campaign is what is definitely being done to terminate this independent fund-raising activity in the Tri-State area and when the withdrawal of the Jewish National Fund in the Tri-State area becomes effective and for what period of time in connection with the 1938 fund-raising effort of the Joint Distribution Committee and the United Palestine Appeal in that area.

I say this because in your letter to me you write:

"If such competitive campaigns are held, we shall most certainly take into account the receipts from them in determining the division of funds between the Joint Distribution Committee and United Palestine Appeal in the Tri-State area."

This, of course, is not satisfactory. For reasons which I stated to Mr. Neaman, competitive campaigns must not be held by the Jewish National Fund to which the agreement, which you so definitely respect, applies.

Before proceeding further with this discussion it is important, as I think you will agree with me, that we hear from our mutual friend, Mr. Morris Neaman, the Chairman of the combined campaign in the Tri-State area.

While have complete confidence in Mr. Montor's hope that this matter will be corrected and while we appreciate the willingness of the United Palestine Appeal to make the necessary adjustments if the Jewish National Fund competitive campaigns are held, I have written to him, per copy attached, that we must be officially notified by the United Palestine Appeal that the Jewish National Fund will not conduct competitive campaigns in the Tri-State area, while our agreement obtains.

We do not mean to be arbitrary but, as I suggested in my previous letter to you, if the Jewish National Fund is permitted to raise money independently, there will be nothing left for the Joint Distribution Committee - United Palestine Appeal campaign. Dear Dr.Silver:

The Milwaukee people apparently realized that June 5th was Shevuoth and have changed the date to June 7th. Could you go there?

Attached herewith is a copy of a letter from Henry Bauling of the Chicago Jewish Welfare Fund and my reply thereto.

The arrangements in New London were not made by the national office of the United Palestine Appeal but represented the determination of local Palestine friends that their cause should receive priority. I think it is fair to say that the United Palestine Appeal is doing everything in its power to meet the various objections made by the Joint Distribution Committee to situations which they deem unfair. I do not think, however, that the same willingness to compromise and be generous is evident on the part of the Joint Distribution Committee. Here in New York, for example, the Joint Distribution Committee is engaged in an aggressive drive to break up combined drives that were held last year and to conduct independent campaigns for the Joint Distribution Committee.

Another instance of the hardness of the Joint Distribution Committee's attitude is found in the case of Scranton, Pa. That community was included in the list which was attached to the 60-40 agreement between the Joint Distribution Committee and the United Palestine Appeal. Through a misunderstanding, aided by the National Council of Jewish Federations and Welfare Funds, Scranton was listed as a Welfare Fund city. Last week I was informed that it was not.

I called this to the attention of Mr.Coons and indicated that Scranton ought to be eliminated from the list so that we might have an opportunity at achieving parity in that community. Mr.Coons protested promptly and vehemently that again the United Palestine Appeal was breaking up an agreement and pointed to the literal fact that Scranton was on the list. Since he was taking this

stubborn, legalistic position that we had agreed to Scranton originally, there was nothing else that I could do but accede.

I admit that the Scranton situation is not a particularly important one since we received only 40% in 1937 and that it was not likely that we would receive more in 1938. However, Dr.Wise has consented to open the Scranton campaign on May 15th and it was the hope of some of our friends that as a result of Dr.Wise's visit, a 50-50 arrangement might be arrived at. However, this is now impossible.

My willingness to yield on the Scranton situation was due also to the rumpus that was being created by the campaigns conducted by the Jewish National Fund in the Tri-State area.

In regard to the National Fund, I consider myself as completely stumped. United Palestine Appeal decisions have about as much effect as an edict by the League of Nations on Italy. I have registered protests and have submitted demands that no National Fund speaker, field director or officer engage in any campaign activity without submitting the name of the city first to the United Palestine Appeal. This has not been done.

I am sorry about Chicago. As I wrote to you yesterday it needed your stimulus.

I have cabled to Palestine about your suggestion on Dr.Weizmann and will let you know promptly.

Your own experience with what is being done by the Joint Distribution Committee in an effort to obtain separate funds is corroborative of my feeling that the Joint Distribution Committee is wedded to parochialism in certain sections of its leadership.

Under the oreement that the U.P.A. has with the J.D.G., we are not precluded from conducting any JNF effort excepting in Welfare Fund communities. There is no justification for complaint on the part of Mr. Coons. We are living up 100% to our agreement insofar as the Welfare Fund cities are concerned.

Braunsteim is to be here on April 27th and as yet nothing has been done and my persuasions have not been effective, to gether and map out the plans and conduct the 1938 campaign. My dear Mr. Montor:

I am sorry that I will not be able to go to Boston. I shall be in Cumberland, Maryland on May 4th and I must then return to Cleveland for our own campaign here which begins on Sunday evening, May 8th.

I do not know what can be done about Baton Rouge. I would suggest a letter addressed to Mr. Ben R. Mayer and Mr. Henry Louis Cohn over the signature of Mr. Harold Jacobi calling attention to the fact that Baton Rouge is the one community in the United States where no allocation is being made for the United Palestine Appeal and that in view of the thousands of German refugees which Palestine has taken care of in the last few years, such an attitude is incomprehensible. Remind them also of the arrangement made between the JDC and the UPA.

The film arrived yesterday and I shall have a look at it today or tomorrow.

In Mr. Mendel Fisher's memorandum to you of April 14, he writes that "under the agreement that the UPA has with the JDC, we are not precluded from conducting any JNF effort excepting in Welfare Fund communities." What distinction is there between Welfare Fund communities and other communities where we conduct joint drives with the JDC? Do the JNF people think that the irritations and the conflicts in these communities are any less than in Welfare Fund communities?

I am enclosing herewith a copy of a letter which I received from Mr. Reuben B. Resnik of Los Angeles. H. Montor

In a letter which I have just received from Dr. Weizmann, he writes: "I am contemplating coming to the USA this summer, either June or September. I shall be waiting to hear what you and our other friends advise me to do. Please write to me." I would suggest that you put on the agenda for our meeting on the 25th, this matter of Dr. Weizmann's coming to the United States and the best time for his coming.

Dear Henry:

In behalf of the Joint Distribution Committee campaign, I wish to take official cognizance of your letter of April 15th that the Jewish National Fund has terminated its independent activities in the Tri-State Zone. We understand, therefore, that money to be raised for the Jewish National Fund in this area will be exclusively through the channel of the United Palestine Appeal in 1938.

We further understand, in accordance with your previous communication, that any moneys previously raised in the Tri-State Zone by the Jewish National Fund or through any mischance to be raised during the remainder of 1938, are to be divided on the basis of 50% for the United Palestine Appeal and 50% for the Joint Distribution Committee

All of this seems to be in precise accordance with the agreement entered into between the Joint Distribution Committee and the United Palestine Appeal for our respective 1938 campaigns in the Tri-State Zone.

With respect to your letter of April 15th, may I say that we have urged upon all communities affiliated with the Council of Federations and Welfare Funds to abide by the ratio indicated in the agreement between the Joint Distribution Committee and the United Falestine Appeal - that is 60/40.

There was a great deal of pressure in Trenton, N.J. for a 50/80 division. I made clear to our local friends that we could not support them in this move since we expected all communities to abide by the recommendation.

My understanding is that a number of people in Newark feel that anything less than a 50/50 division would militate against a maximum effort in the campaign. Both the Joint Distribution Committee and the United Palestine Appeal are, of course, deeply concerned that our agreement should not serve to decrease the sums raised in a community. We want Newark to abide by the agreement and yet find it difficult to cope with the position of leaders who insist that their spirit will be adversely affected by other than a 50/50 ratio.

Campaign date is April 26th. Combined with J.D.C. Divided JDC 60-40 UPA. No quota. Hope to raise more than last year. I found it most embarrassing to overcome JNF campaign held here last Tebruary. They raised \$408. This was no reflection on Rabbi Shapiro representing JNF, but I assure you he could not come back and repeat it. The leaders of the community are quite upset, especially since JDC's representative, Mr. Jacobson, so ably informed the committee that JNF is part of UPA. Also that we have an agreement between JDC and UPA. The officers showed me letters they have received in regard to this matter, as well as our booklet, entitled "For Him a New Life Through UPA". This book stresses all the way through it that the Karen Kayemeth and the Karen Hayesod is the UPA in America. I've run into this situation all along the line, and in many cities, local leaders were able to avoid this extra JNF campaign. This information has reached those communities that had campaigns and as a result, has made them still angrier. This situation puts me on the defensive and hampers my doing any constructive work when I come into a community. I believe I have saved this \$408 and have explained, to the entire satisfaction of the committee, the purpose of the JNF campaign.

My dear Rabbi Silver:-

Permit me to take this opportunity of thanking you for your kindness in receiving the Lorain committee on Sunday morning. We do appreciate your having given us the time which you did, knowing how busy you are, particularly this year.

I know that you are interested in both the Lorain community and its Welfare drive which indludes the UPA, as in the past. Last evening our initial committee meeting was held at which time I was appointed Chairman of the coming drive. We have set a goal of \$3,000 for this year which, however, I feel is high, but he committee felt it better to have a higher goal with an incentive towork toward and a basis for a stronger appeal to the individual contributor.

We have set up the following figures as division: Wider Scope \$500.00; Cleveland Orphan Home \$100.00; HIAS \$100;00, making a total set figure of \$700.00. These figures have been used in this community for more than ten years. All moneys raised beyond this fugure will be divided on a percentage basis with ORT receiving 15% and UPA and JDC receiving 60% and 40% of the balance, providing same is agreed to by Rabbi Jonah B. Wise, otherwise, a percentage to be agreed upon between you and Rabbi Wise.

I am enclosing herewith a copy of a letter I am writing today to Rabbi Wise, giving you this information so that in case Rabbi Wise does correspond with you in this matter you will have the picture before you.

I am happy to state that the committee is in an energetic mood toward this drive and we expect to hit the ball hard. A committee has been appointed to arrange for a speaker, knowing that it is questionable whether you could come to Lorain for the opening of this drive, we believe it advisable to try and contact someone who can give us a definite assurance of being here on that date, which at present is set for April 10th. Rabbi Jonah B. Wise, 35 East 62nd Street New York, N.Y.

My dear Rabbi Wise:

I am happy to advise that within the past few days the committees representing the major Jewish organizations of this city have formed a local Jewish Welfare Federation for the raising of funds for both National and Overseas Jewish causes. The writer was elected chairman for this year.

We have had some discussion in reference to the JDC drive with your Mr. Mayer with which you, no doubt, are familiar. On the last visit of your Mr. Mayer to the city in his comversation with Julius Kline, during the writer's absence from the city, a set-up of percentage quotas for each organization was given to your Mr. Mayer at which time he was told that all moneys raised above \$600 would be divided as follows: 10% for HIAS, 15% for ORT, 25% for UPA and 50% for JDC. In last night's meeting we decided to put an a maximum amount of \$100 for HIAS which would mean that the set amount would be changed to \$700 and the percentage divided would start beyond that amount with 15% going to ORT and the amount of the balance of 85% divided between UPA and JDC, to be determined to meet with your approval and that of Rabbi Abba Hillel Silver, National Chairman of UPA.

We know that the division for all communities as agreed on between JDC and UPA is 60% and 40%, but your Mr. Mayer insisted that since the UPA have raised funds in this city amounting to about \$750, manual in January of which amount a good bit was contributed by residents of other cities who attended the affair when this money was raised, such towns as Sandusky, Elyria, etc., that the entire amount raised cannot be credited wholly to the city of Lorain. Rabbi Silver does not feel justified in the division as set up heretofore, namely, of 50% to JDC and 25% to UPA, but feels that the division should be as agreed between the two organizations, namely 60% and 40%. We are advised by Rabbi Silver that the money heretofore raised by the selling of bonds for the purchasing of land in Palestine has no bearing whatsoever on the UPA drive, not only in our city but in all cities in the United States. We find that in the city of Cleveland approximately \$10,000 has been raised for the same purpose and that this will in no way affect the percentage of division for the funds raised for their Welfare drive. I appreciate that UPA does have an organization locally whose members fight for their cause and their rights and Julius Kline and I have designated ourselves as protectors to deal justly for the JDC cause, nevertheless, we are interested wholly in harmony between all causes and therefore we feel it right that this matter be brought to your attention and if you will agree to a division of 60% and 40% we will be happy to move forward on this basis. Should you, however, feel otherwise we would suggest that you contact Rabbi Silver of Cleveland and I am sure that between you arrangements can be made to satisfy both organizations which you two represent. In the future we do not expect to run into the situation that we face this year.

May I state that we hope to be able to raise between \$1,000 and \$1,500 beyond the set figure of \$700, this amount to be divided as above

stated, 15% to ORT and the bal nce as agreed between JDC AND UPA. The committee appreciates economic conditions at this time in our community but with hard work, and the committee is made up of members who will give their full energy to this drive, we hope to raise more money this year than in previous years.

We would like to have the percentage of division settled at the earliest possible date and would, therefore, appreciate your early attention to this matter.
