THE PALESTINE EXHIBIT - EMPIRE STATE BUILDING NEW YORK CITY March 30th, 1938 Mr. George J. Klein 2480 East 22nd Street Cleveland, Ohio My dear Mr. Klein: I have refrained from writing to you about the Cleveland quota of \$5,000 toward the \$250,000 budget of the Palestine Exhibit at the World's Fair for the reason that some time ago, Rabbi Silver made a tentative promise that he would take care of the matter in Cleveland and would call together the members of our National Committee and assign the task to an individual capable of raising the quota. What with the U.P.A. and his other activities, Rabbi Silver, however, is so preoccupied now that he has written us begging to be relieved of the responsibility. I am, therefore, turning to you in the hope that you will be able to take the initiative in calling together all the members of our National Committee, and such other persons as you may deem it advisable to ask for assistance to secure the Cleveland underwriting of the \$5,000 assigned your city. and other communities, it is not necessary that the entire amount be raised immediately so long as the obligation is assumed. If Cleveland will give us \$3,500 during the year of 1938 and the balance early in 1939, it will be in keeping with our budgetary plans and will enable has to proceed in an orderly manner in the building of the Palestine Exhibit. I hardly think it is necessary for me to urge upon you the importance of the Palestine Exhibit at the World's Fair. It is too early for me to give you a complete portrayal of what the Palestine Exhibit will consist of, other than to indicate that it will be a notable achievement and a great contribution toward our efforts to make the American public conscious of what Jewry has accomplished in Palestine and what it means to the Jewish people as a whole. For your information, I am sending you here a list of the members of our National Committee in Cleveland. Among them are men of high standing in the community, and of great responsibility, whose interest in Palestine is well known. I am also sending you a list of people who have been asked to serve on our Committee but who have so far not replied. It is quite possible that we may have left out certain people who will be valuable to you; if so, please advise us and we shall write to them. KLEIN April 1, 1938 George Backer, Chairman, The Palestine Exhibit at the New York World's Fair-1939 Empire State Building New York City, New York Dear Sir:-Replying to your letter of March 30th, we beg to advise that I am accepting no new jobs. I might make two observations, however, in connection with your letters one is, that some arch optimist established a \$5,000.00 quota for Cleveland and the second is that the purse strings of our city are apparently held by Rabbi Silver and it is probably unfortunate for your endeavor that he has stepped aside in fulfilling his promise and I know of no other individual in this town who can raise even a fraction of this amount and I am inclined to believe that on more mature thought Rabbi Silver also felt it strategically wise to side step this impossible undertaking. THE PALESTINE EXHIBIT EMPIRE STATE BUILDING NEW YORK CITY April 15, 1938. Mr. George J. Klein. 2480 East 22nd Street, Cleveland, Ohio. My dear Mr. Klein, I hope you will forgive me for not answering sooner your letter of April 1st. To say that your letter
shocked me is putting it very mildly. I was as amazed as I
was chagrined, both by the tone and the content of your communication. I might have expected such a response from one of my "own" so-called non-Zionist group. Coming from a Zion-ist and, as I understand, one who has been identified with the Zionist Movement in a leading capacity for many years, it is a bit bard to swallow. I accepted the chairmanship of the Nationat Committee and the presidency of the Palestine Exhibit at the request of Dr. Wise, and because of the assurance that I would receive the whole-hearted support of Zionists throughout the country. Although I am not a Zionist, and have never been identified officially or otherwise with the Zionist Movement, I accepted this responsibility because of my deep congiction that a dignified, impressive Exhibit of positive Jewish achievements in Palestine today; is of a significance to American and world Jewry transcending that of a mere physical exhibit. The Zionists, I thought, would be the first to understand this. It is, therefore, very discouraging to me, personally, to find that that understanding is lacking. I am perfectly aware of all the problems facing the Jewish communities, and demands being made upon them. I know also that the building of the Palestine Exhibit represents an additional burden which it is not easy to assume. Yet there is no other way in which this thing can be done. It, therefore, devolves upon those who have an understanding of it's signficance to give their aid in its execution.

If any support is to come from Cleveland, I am quite sure it will have to come from that section of the community which has sympathy and understanding for the project. I must confess that, as a non-Zionist, I am genuinely disappointed at the lukewarm and almost indifferent attitude of some community leaders from whom a different response was to be expected.

I hope you will not take amiss what I am saying here. I strongly feel the responsibility for the task undertaken, and I am hopeful that leading Zionists will help me carry this responsibility.

I am sending a copy of this correspondence to Rabbi Silver.
