In accordance with the promise made to you in our first announcement of the unification of fund-raising efforts into the United Jewish Appeal for Refugees and Overseas Needs of the American Jewish Joint Distribution Committee, the United Palestine Appeal and the National Coordinating Committee Fund, Inc., we are herewith sending you a further explanation of the great emergency campaign to raise a minimum of \$20,000,000 in 1939.
