My dear Dr. Goldman:

I received a copy of the draft of the statement to be issued in connection with the Emergency Committee for Zionist Affairs. I think that the fifth paragraph ought to be omitted. We ought not to say in public that "The High Commissioner seems unable to interpose legal barriers in the way of the hapless refugees" etc.

I would also suggest that all the names of the members of the Emergency Committee be published.

I am sorry that I will not be able to attend the next meeting of the Committee. I will be in New York on Monday, October 30 for a meeting of the United Jewish Appeal. If the next meeting of the Emergency Committee can be scheduled for that day, I shall be very happy to attend it.
