Mr. President:

All those concerned with the impact of the war upon civilian victims are grateful for the spirit of compassion which prompted you to recommend to Congress the appropriation of \$50,000,000 for assistance to refugees through the Red Cross and other agencies which you might designate.

The war has had tragic consequences for all who have come within its sphere. But its burden has been doubly heavy for the Jewish population in the areas affected. The racial philosophy of the Nazi Government has placed special hardships upon Jews and made their adjustment to war conditions much more difficult than those facing the ordinary individual.

In the seven years in which Hitler has been engaged in the extirpation of Jewish life over a succession of European countries, the ancient Jewish homeland of Palestine has played an important role not alone in holding aloft a beacon of hope to the dispossessed and the disinherited, but in giving actual shelter to hundreds of thousands of men, women and children. Today the Jews of Palestine stand ready with their resources and their lives to aid the cause of the allies to which the overwhelming majority of Americans have given their moral approval because it is identified with the cause of the democracies.

Arrangements have been made and can be made for the transport of Jewish refugees to Palestine. It is estimated that in the first eight months of the war over 14,000 Jews who fled from Europe were able to find shelter in Palestine. Thousands of others have legal permission to enter Palestine if funds can be made available to assist their transport to the place of safety which Palestine offers. There are thousands of Jews whose need to settle in Palestine has become far more urgent as a result of the events in Western Europe in the past few days. To permit them to remain in the countries in which they are waiting for transfer to Palestine is literally to doom them to the concentration camp or to death, for to the Jewish refugee is reserved a degree of hardship and suffering beyond those of the average refugee.

With these facts in mind, may I, on behalf of the United Palestine Appeal, respectfully submit to you the cause of these Jewish refugees who must be assisted in Europe while awaiting transfer to Palestine and to enable them to reach Palestine. It is my belief that these refugees come within the framework of the fund which you have asked the Congress of the United States to appropriate for your allocation.

My associates and I would be grateful for the opportunity of coming to Washington to discuss with the appropriate individual whom you will designate the details of this application and the actual extent of the financial requirements through which great numbers of men, women and children may be saved from the ravages of war.

CERTIFIED COPY OF SECTIONS OF CHARTER OF HOFHEIMER
FOUNDATION DEALING WITH GRANTS MADE BY FOUNDATION

The general object and purposes are primarily to collect, receive and maintain the fund or funds and apply two-thirds of the net income thereof to the improvement of living conditions of unfortunate persons. It shall be within the purposes of said corporation to use any lawful means to that end which from time to time shall seem expedient to its members and trustees including the search or publication as well as establishment of benevolent activities and agencies.

The territory within which its operations shall be conducted shall be in the United States of America.

Lawrence R. Klein, residing at 41-12 - 41st Street, Queens, New York City, being duly sworn, deposes and says that the above is a true copy of those sections of the charter of the Hofheimer Foundation, Inc. which deal with the restrictions of the Foundation with respect to gifts and grants.

You will recall that a decision made at the Executive Committee meeting of the UJA was to authorize the National Chairmen to appoint a committee to deal with the subject of a union contract.





At the earliest opportunity a meeting of the Distribution Committee will be arranged and you will, of course, be duly notified. At that time we trust that the Distribution Committee will constitute itself formally, designate such officers as it may desire to have, and take action on the appointment of a professional worker to undertake the research activity under the supervision of the Distribution Committee.

In connection with the latter, you will be interested to know that a special committee which has been requested to consider the availability of candidates for this post, is meeting on Monday, July 8th, at 2:30 P.M. at the office of the J.D.C., 100 East 42nd Street, New York City. Among those under consideration is Dr. Lewis Lorwin, now a member of the American Youth Commission. He has been invited to have a further discussion with the members of the special sub-committee at this meeting on Monday as to the possibility of his undertaking this post, subject to the approval of the Distribution Committee of the United Jewish Appeal.

If you are in New York, you may wish to avail yourself of the opportunity to be present and participate in the discussion with Dr. Lorwin.

MEMORANDUM

SUMMARY OF THE LOAN ACTION AS OF JULY 11, 1940:

NEW YORK

An invitation was issued by wire by Dr. Stephen S. Wise to some 350 people, many of them active in Zionist affairs, and others regarded as non-Zionist. The meeting to which they are invited is to be held at the Biltmore Hotel Thursday evening, July 11.

Mr. Louis Lipsky, Mr. Robert Szold, Dr. Stephen S. Wise undertook to speak to a number of leading individuals to obtain their attendance at the meeting, and their subscriptions.

CHICAGO

Dr. Solomon Goldman arranged a meeting on behalf of the loan in Chicago for Thursday evening, July 11. Invitations were issued to some 1,000 people.

MILWAUKEE

Dr. Solomon Goldman arranged for a loan meeting in Milwaukee on Friday noon, July 12. He is intending to fly from Chicago to address the meeting.

DETROIT

Dr. Goldman arranged with the cooperation of Simon Shetser for a loan meeting in Detroit on Monday evening, July 15. Dr. Goldman will address the meeting.

PITTSBURGH

A meeting has been arranged for Pittsburgh by Mr. Charles Rosenbloom, who has invited a group of leaders to his home for Tuesday evening, July 16. Dr. Nahum Goldmann has been requested as the speaker.

PHILADELPHIA

Judge Louis E. Levinthal, in cooperation with Robert M. Bernstein, is endeavoring to arrange a meeting in Philadelphia. The date will be either Monday or Tuesday. The delay is caused by the desire of the Philadelphia people to have a non-Zionist issue the invitation for the loan meeting. Mr. Robert Szold has been requested to address the meeting.

BALTIMORE

Mr. Daniel Ellison, in cooperation with Messrs. Fish and Gellman, is arranging a meeting for the loan at the Hotel Stafford in Baltimore on June 18. Dr. Nahum Goldmann has been requested as the speaker.

ST. LOUIS

Dr. Solomon Goldman has arranged a meeting for the loan for July 16. Dr. Goldman will attend and speak.

OTHER CITIES

Efforts are being made by Dr. Goldman to arrange meetings in KANSAS CITY and CINCINNATI. It has been deemed advisable, in view of the fact that these communities are in the midst of launching campaigns for the United Jewish Appeal, or else are still conducting campaigns, that they should not be contacted at this time on behalf of the loan. These cities are BOSTON and LOS ANGELES. Possibly Mr. Kaplan on his visit to the coast may find his visit opportune for a meeting.

OTHER ACTIVITIES

Mr. Eliezer Kaplan has arranged to meet with Hadassah for the purpose of determining whether the Hadassah Organization would participate in the loan.

Dr. Solomon Goldman has undertaken to meet with Mr. Henry Monsky to see whether the B'nai B'rith would be able to advance some of its funds to the Keren Hayesod loan. Mr. Edmund Kaufmann has undertaken to write letters to a group of 300 or 400 personal friends throughout the country, urging them to participate in the loan, and indicating his own participation.

Dr. Stephen S. Wise has written letters to leaders in the following communities, urging them to take some action and inquiring which of the leaders who had placed themselves at the disposal of the loan would be required to meet with the local people to get subscriptions for the loan.

In WASHINGTON, Rabbi Isadore Breslan undertook to arrange a meeting on behalf of the loan, some time next week.

Gentlemen:

As Co-Chairman of the Executive Committee of the 1939 Greater New York United Jewish Appeal, I respectfully request that you make an audit of the 1939 account as of June 30th, 1940. The last report that you have made was as of December 31, 1939.

May I request that you include the following:

- (a) An itemized list of monies received by the Joint Distribution Committee, the United Palestine Appeal and the National Refugee Service for the 1939 United Jewish Appeal campaign and the respective monies remitted or retained by each of the above recipient agencies.
- (b) An itemized list of transfers made from the 1939 account to the 1940 campaign account.
- (c) An itemized list of cancellations entered against the 1939 account since December 31, 1939.
- (d) An itemized list of payments received since March 15, 1940, which had been diverted and credited to the 1940 campaign account.
- (e) Such monies that have been charged as expenses or otherwise against the 1939 campaign since December 31, 1939.
- (f) An itemized list of amounts still due on the 1939 pledges.

I have been requested by Dr. Abba Hillel Silver to have the audit made and presented to him as early as possible. May I also request that you send a copy of such audit to the other National Chairman, Dr. Jonah B. Wise.

Gentlemen:

With the refugee problem on our very door-step, the program of the National Refugee Service, Inc., is of primary concern to all of us as American citizens. Unless both our allocation and cash problems can be worked out, further serious curtailment of our present activities is unavoidable,

During the first six months of this year, the National Refugee Service has been attempting to stretch available resources so as to meet ever-increasing needs.

Relief budgets, already low, were further reduced this month. Allowances for food and shelter are at a mere subsistence level. Yet the cumulative nature of our problem is such that, as every month passes, as every boat arrives, the number of refugees who may require assistance grows.

Relief may be denied to a great many of those in need. These would then be obliged to seek help from public relief agencies. But refugees on public relief are liable to deportation, with its attendant adverse publicity.

Our retraining program has been drastically retarded. Efforts to aid in the economic rehabilitation of refugees have been seriously curtailed. Programs of Americanization and social and cultural adjustment have not been given the emphasis due them.

The most rigid economies have been instituted; there is little still to be saved. There is no longer any choice but to admit, at this crucial juncture, that, unless our immediate financial needs are acted upon without delay, it will be virtually impossible for us to meet even the bare minimum requirements of our day-to-day undertaking.

At the time that Greater Germany and Poland were the sole sources of refugee immigration, the United Jewish Appeal allocated \$3,500,000 to us and gave us the right to apply for an additional \$500,000. Today France, Holland, Belgium, Rumania, Norway and Luxemborg are new sources of refugee immigration.

We have gone from crisis to crisis, so far as our finances are concerned, and today we are faced with such drastic curtailment

of our activities that the very objectives of the agency are threatened. Only through an immediate allocation of the greater part of the \$500,000 we are asking, and recognition of our need for priority in receiving cash, can new crises be averted.

While the assistance thus requested may seem to be comparatively small in dollars, should it be delayed the consequences loom large. All that we have worked for is threatened because our inability to carry out our minimum program will, of necessity, jeopardize our chances of achieving the ends for which this agency was created. Delay may be serious, not only to the refugees whom we serve, but to the American public which supports us and, conceivably, to the future of the United Jewish Appeal campaign as well as to its beneficiary agencies.

Under separate cover we shall send you a cash statement and certain accompanying data about our present situation. We are anxious to appear before your Committee and its professional representative. We urgently ask that you set an early date for an examination of our material in the hope that action may be taken, even on a preliminary or interim basis. The courtesy of a prompt response, with your guidance in the matter, will be deeply appreciated.

Dear Dr. Silver:

On Thursday, July 11th, Mr. Lampport met with six representatives of the Hofheimer Foundation in the office of Rabbi Jonah B. Wise, who was also present. From Mr. Lampport's description of the two-hour meeting, it was a hectic session.

But apparently there was no intention whatever of discussing the 1939 pledge of the Hofheimer Foundation to the New York United Jewish Appeal which I had understood was the essential purpose of the meeting. Instead, the session seems to have been arranged to persuade the United Palestine Appeal to sign a document which would assure the Hofheimer Foundation that it would give \$40,000 to the National Refugee Service without its being claimed by the United Jewish Appeal or by any of its beneficiary agencies, including the United Palestine Appeal.

The representatives of the Hofheimer Foundation took the position that 1939 was a closed book.

Attached hereto is a copy of a letter which Mr. Rosenwald addressed to Mr. Arthur M. Lampport who had perhaps indicated that the United Palestine Appeal might sign such a letter as Mr. Rosenwald seems to have drafted.

I told Mr. Lampport that no one but you would have the right to sign such a letter, if you chose to sign it.

My reading of the letter would indicate that the Distribution Committee of the United Jewish Appeal would not have the right to take the 1940 gift of \$40,000 from the Hofheimer Foundation in consideration in determining what the National Refugee Service should receive. Dr. William Haber has already indicated to me that the National Refugee Service is planning to make application to the Distribution Committee of the United Jewish Appeal for a grant in excess of \$3,500,000.

In view of my interpretation of the effect of a letter to the Hofheimer Foundation, Mr. Lamport suggested the addition of a paragraph as follows:

"It is, however, expected that when the committee on allocations for the 1940 United Jewish Appeal will convene, the National Refugee Service, Inc. will disclose the above amount, as well as all other amounts received by it to the committee, in order to enable the committee to reach a fair and equitable decision."

Will you let me know, at your earliest convenience, your decision on the following matters:


- a) Whether you wish a letter to be sent to the Hofheimer Foundation;
- b) Whether you wish to sign such a letter;
- c) Whether you think that the letter drafted by Mr. Rosenwald is satisfactory;
- d) Whether you have any suggestions as to what further action should be taken in connection with the 1939 Hofheimer Foundation pledge of \$40,000 to the New York City United Jewish Appeal which the Hofheimer Foundation has now officially repudiated in effect.

I have my own views on the attitude of the Hofheimer Foundation and the National Refugee Service in its inexorable demand for funds, but perhaps in view of the vigor of those views I ought not to express them and await your own decision and comments in the matter.

It may interest you to know that I requested of the Hofheimer Foundation a copy of the charter under which they operate in order to determine whether that charter denies them the right to make contributions to the United Jewish Appeal, as has been insisted. But Mr. Henry Siegbert, Secretary of the Hofheimer Foundation, has declined under all circumstances to permit us to examine the charter under which the Foundation operates. Mr. Rosenwald offered to provide a certified copy of a paragraph of the charter which would bear out his contention that the Hofheimer Foundation has not the power to make grants to such bodies as the United Jewish Appeal.



Dear Dr. Silver:

Telephone calls were made throughout the day today by various individuals connected with National Refugee Service. One of these was made by Mr. Ittleson this afternoon to Dr. Stephen S. Wise. Dr. Wise called me to ask what the situation was. I told him of my conversation with you this morning, and read to him the memorandum which I had sent to Mr. Rosenwald. Dr. Wise then sent the following letter to Mr. Ittleson: "In the light of Dr. Silver's communication with William Rosenwald this morning I naturally find it impossible to take up the matter with him again. Moreover, as members of the Distribution Committee for the United Palestine Appeal, we must alike keep our minds open with respect to decisions involving allocations."

Mr. Ittleson said to Dr. Wise that he contributed \$150,000 to the United Jewish Appeal: it was incidents such as this involving the Hofheimer Foundation which made him doubtful of the wisdom of unified campaigns.

I spoke to Mr. Rosenwald by telephone this morning. He felt that we had missed the essential point that was being made by the National Refugee Service. The Hofheimer Foundation Trustees adopted a resolution which specifically asks that the United Palestine Appeal and the Joint Distribution Committee provide written assurances that any grant from the Hofheimer Foundation to the National Refugee Service will not be raised as an offset against the allocation from the United Jewish Appeal. It is therefore not the National Refugee Service but the Hofheimer Foundation which has made the demand, Mr. Rosenwald states.

He declared to me however that he could understand the attitude of the Hofheimer Foundation in demanding this assurance, since under the reading of the 1940 agreement constituting the United Jewish Appeal, the Hofheimer Foundation might place in jeopardy its contribution of \$40,000 for 1940.



I have never seen such energy exerted on behalf of the \$23,000,000 campaign of the United Jewish Appeal throughout the campaign as I have witnessed in the past three days in order that the National Refugee Service might get the \$40,000 from the Hofheimer Foundation.

Are you prepared to make any changes in the decision already taken? In considering the tremendous agitation which has been witnessed and that will undoubtedly accumulate against you, I would give my personal advice that you ought to yield on this matter and give your consent to the signing of a letter; this has nothing whatever to do with the merits of the case, but only with expediency.



Dear Mr. Ittleson:

Mr. Goldwasser has asked me to review for you the facts involved in the controversy over the Hofheimer Foundation gift of \$40,000 to the United Jewish Appeal in 1939.

The charter of the Hofheimer Foundation provides that the Foundation's activities shall be confined to the United States. As you of course know, such a provision is a limitation upon the power of the Foundation and any transgression thereof would constitute nothing less than a breach of trust. Consequently, the Foundation has always meticulously complied with this limitation. The trustees are, and so far as I know always have been, keenly alive to it. Again and again, when applications have been made, the activity of the applicant has been scrutinized to ascertain whether or not it in any way collides with this provision of our charter. More than once, causes have been presented with which the members of the Board are intensely sympathetic but which have been turned down because, and only because, they involve activities outside the United States. It is here pertinent to call attention to the fact that when in 1938 the Foundation made a gift of \$20,000 to the National Coordinating Committee via the Joint Distribution Committee, the appropriation was carefully circumscribed so that all of it would go to the domestic activities of the National Coordinating Committee and that no offset should indirectly draw any part of the gift into foreign channels.

Against this background, the events involved in the present controversy will loom up boldly. At a meeting of the Board of Directors of the Hofheimer Foundation on April 12, 1939, the matter of a gift to the United Jewish Appeal was brought up for discussion. Immediately one of the directors stated, and I now quote from the minutes: "We should be slow about giving to the U.J.A. directly but if we do give directly, we should earmark our contribution 'For Domestic use only.'" Another director suggested that we find out exactly what the agreement of the division of the funds is to be between the three organizations, before we make any commitments. Still another director proposed that, if we can, we enable the U.J.A. to include the amount of our gift for campaign purposes. At the conclusion of this discussion a resolution was unanimously adopted that a committee be appointed "to work out a method that will assure any contribution of ours, to be a contribution Net for the work of the National Coordinating Committee, and not subject to offset from allocation from the General Fund. ~~that~~ ~~grant~~ and that in the event that such a plan can be evolved, that a grant of \$40,000 be authorized for the work of the National Coordinating Committee." I invite your attention to the significant fact that this resolution was passed before the occurrence of any of the events set forth in Mr. Montor's letter to you of July 17.

On May 31, 1939, the president of the Foundation wrote Mrs. David M. Levy that at a meeting of the Board of Directors of the Foundation held on April 12, 1939, a grant of \$40,000 was made to the National Coordinating Committee for the Committee on Scholars and Medical Scientists. At or about the same time, Mr. Goldwasser advised Mrs. Levy that the reason the Foundation wanted to have the appropriation go directly to the two committees was that its money would not be used in any part for work overseas, as that would be contrary to the conditions under which its gifts are made. The intervention

of a period of six weeks between the authorization of the conditional grant by the Board and the letter of notification to Mrs. Levy itself testifies to the fact that during this period efforts were being made to work out a plan whereby the gift could be effectuated in a way compatible with the provisions of our charter. After that time, as well, efforts were made almost continuously to remove the impediment from the path of our gift. Meanwhile, on October 13, 1939, the Foundation mailed a check to the National Coordinating Committee in the amount of \$25,000 on account of our grant. But hope that the complications could be cleared up soon vanished and the check had to be recalled. The Board subsequently confirmed the recall of the check and also approved a letter from Mr. Goldwasser to Mr. Lamport in which Mr. Goldwasser stated that because of certain demands made by Mr. Montor and his refusal to agree to the terms under which the grant had necessarily to be made under the permissive provisions for grants by the Hofheimer Foundation, the Board of Trustees rescinded the appropriation and requested the return of the check on account. Mr. Goldwasser concluded his letter saying, "I stated to you and to others no less than a dozen times after Mr. Montor made his demands, that the inevitable result would be the loss of this money for 1939. This is exactly what has occurred."

All efforts remained unsuccessful while the need of the National Refugee Service (successor to the National Coordinating Committee) for funds became ever more acute. At our board meeting of January 11, 1940, the matter of our \$40,000 grant was again brought up for discussion, as it had been at virtually every preceding meeting of the Board since the date of the original grant. The Board's attention was called to the fact that the cash condition of the National Refugee Service was desperate. The members of the Board felt that the situation was ludicrous, for here was a contributor eager to give away \$40,000 and a recipient unable to take it although it was in dire need of it. In order to demonstrate their whole-hearted desire to cooperate, the directors voted to make a loan of \$50,000 to the National Refugee Service with the understanding that if the conditions of our gift were met \$40,000 of the loan shall become an outright grant. At the same time the directors adopted the following resolution:

"RESOLVED, that \$40,000 be given to the National Refugee Service for displaced foreign scholars and displaced foreign medical scientists, provided we receive written assurances from the United Palestine Appeal and the Joint Distribution Committee that this amount will not be used as an offset against any amount allocated to the National Refugee Service in any United appeal."

Time continued to run and still the plan and simple conditions of our grant were not met, and because they were not met the loan was repaid in full. I am informed, however, that the National Refugee Service has received from the 1939 campaign \$40,000 less than the obligatory amount awarded it, for the sole reason that Mr. Lamport claims that N.R.S. has or should receive \$40,000 from the Hofheimer Foundation.

On July 11, 1940, a meeting was held in the study of Dr. Jonah Wise at which were present, in addition to Dr. Wise, Messrs. William Rosenwald, Arthur Lamport, Henry Siegbert, Fred Stein, and I. Mr. Lamport began the discussion with the assertion that the Hofheimer Foundation had made a pledge of \$40,000 to the 1939 campaign, that this pledge had originally been made without any conditions, and that subsequently the Foundation attempted to attach conditions. I think it is expressing it mildly to say that Henry Siegbert, Fred Stein and I were dismayed by Mr. Lamport's statement. We thought the conference was for the purpose of obtaining the assurance, required by our resolution, which would have made it possible for us to complete the gift or that we would be told why

such assurance was not forthcoming. Instead of this we were subjected to the charge of repudiating a solemn obligation. We attempted to explain to Mr. Lampert, as I have tried to explain above, why our gift was not and necessarily had to be subject to the conditions which were attached to it and that those conditions had always been a part of the grant. Mr. Lampert, however, refused to accept our explanation and insisted that we had made an unrestricted pledge and that we were now seeking to repudiate it. Mr. Lampert thundered that he would never directly or by implication concede that we had not made and repudiated a pledge of \$40,000 for 1939. On the other hand, Mr. Lampert conceded that a 1940 gift could be made to the National Refugee Service without offset and that he would be glad to give written assurance to that effect. It was agreed that Mr. Rosenwald would write to Mr. Lampert asking for such written assurance regarding a \$40,000 gift for 1940 and that Mr. Lampert would write a letter giving assurance against offset. When Mr. Lampert's attention was called to the fact that Dr. Silver had declined to give such written assurance on the ground that the agreement spoke for itself, Mr. Lampert qualified his promise by saying he would want to take the matter up with Dr. Silver first. Mr. Lampert emphasized, however, that under no circumstances would he write a letter containing even the slightest inference that the Hofheimer Foundation had not made a gift of \$40,000 for 1939 or that it had ever been relieved of the obligation incurred in the making of that pledge. I called Mr. Lampert's attention to the inconsistency between that statement and his promise to write a letter about 1940. I pointed out that the agreement for the 1940 campaign, which permits contributions by foundations to the National Refugee Service without offset, is followed by a proviso that there shall be no such right where the Foundation "contributed funds to the N.R.S. or U.J.A. on behalf of N.R.S. during this year 1939." If Mr. Lampert were to write a letter to the effect that a 1940 contribution could be made without offset, he would thus be impliedly admitting that the Foundation made no contribution for 1939, assuming of course that a contribution and a pledge are the same thing, which Mr. Lampert did assume. Mr. Lampert gave no satisfactory answer to this dilemma and the meeting ended with Mr. Lampert again asserting that he would write the letter about assurance against offset for 1940 but would never in any way expressly or impliedly concede that we had not made an unrestricted pledge in 1939.

It is regrettable that the National Refugee Service should be deprived of a substantial sum of money which it so desperately needs. No amount of ingenuity can divert any part of this proposed gift into the channels of the Joint Distribution Committee or the United Palestine Appeal, for the Hofheimer Foundation cannot contribute to those entities directly or indirectly. It must be evident to anyone who will take the trouble to analyze the facts that it is either \$40,000 to the National Refugee Service exclusively, or nothing. It seems incredible to me that in this grim hour anyone could obstruct our contribution to this urgent cause.

I hope I have succeeded in clarifying the situation. If you desire any further information or explanation, please do not hesitate to call upon me. I, and I am sure all the other directors of the Foundation, fervently hope that a way can be found to add \$40,000 of usefulness to the National Refugee Service and that the obstacles thrown in the way of this gift may be eliminated. I think you know that the directors of the Foundation, weary of the long and unsuccessful effort to obtain compliance with our conditions and unwilling to sterilize so large a sum, with the result of denying it to other urgent causes, have placed a deadline of August 1st on this gift. If the conditions are not met by that date, the directors of the Hofheimer Foundation will be compelled to look elsewhere for the use of this part of their funds.

Mr. Henry Ittleson telephoned to me today in reference to the matter of the Hofheimer Foundation.

He felt that the explanation given by Mr. Sher of the Hofheimer Foundation with respect to the 1939 gift should end all doubts that no gift to the National Refugee Service had been made in 1939.

Mr. Ittleson stated that a fundamental point was involved in the discussions with the Hofheimer Foundation:—"How could any organization undertake to dictate to a contributor through which channel he wished to make a gift?" Nevertheless that was the decision being taken by the United Palestine Appeal. He felt that the only recourse left to a donor under such pressure would be not to give at all.

"It might be true that organizations between themselves had a right to enter into an agreement as to the manner in which they would distribute their funds, but they could not compel a contributor to give in a direction to which he was opposed."

Mr. Ittleson believed that the officers of the United Palestine Appeal failed to see that principle. He felt that the consequences of the decision with respect to the Hofheimer Foundation gift would have a definite bearing on the future. He for one had contributed \$150,000 in 1940 despite certain hesitations and certain compromises that he had to make; but he felt that he was an exception to this rule. "Not all contributors, who were opposed to certain activities or ideas, could be expected to be equally lenient."

He assumed that this subject would be discussed by the officers of the United Palestine Appeal and he requested that his viewpoint be made known, since he doubted that it had been adequately understood.

The matter of obtaining contributions in some instances would have to be looked at not from the Talmudic but from the realistic point of view, he said. "Surely no organization was prepared to see the National Refugee Service suffer solely because a donor had certain restrictions."

I promised Mr. Ittleson that his views would be transmitted to the officers.

Since you have raised some questions concerning the division of responsibility between the National Refugee Service and other organizations, I am pleased to send you this letter confirming and clarifying our several conversations regarding the relationship between the Hebrew Sheltering and Immigrant Aid Society and the National Refugee Service, Inc. You know, of course, that the National Refugee Service is a national organization and is engaged in a great number of services to refugees. Among these are: resettlement, employment, vocational retraining, temporary relief and case work service, self support and loans, social and cultural adjustment, and similar activities. This letter, therefore, is written in order to clarify the division of responsibility between the Migration Department of the National Refugee Service -- one of our several activities -- and the Hebrew Sheltering and Immigrant Aid Society.

As to the matters that have been under advisement between us, the following is my understanding:

1. Appeals:- The National Refugee Service will rely on the Hebrew Sheltering and Immigrant Aid Society to handle cases of individual aliens who are excluded at the ports of entry into the United States, which need to be appealed to the Bureau of Immigration and Naturalization of the United States Department of Justice. It is understood, however, that in special cases, and without violating the spirit of the section, the National Refugee Service will make its own appeal after conference with the Hebrew Sheltering and Immigrant Aid Society.

2. Pier and Dock Service:- The National Refugee Service will refer requests for pier and dock work to the Hebrew Sheltering and Immigrant Aid Society and the National Council of Jewish Women, in accordance with the previous understanding which has been in effect for some time between these two organizations.

July 26, 1940

3. Preparation of Affidavits of Support and Other Related Documents:- The National Refugee Service will advise applicants requesting this service that there are several organizations in the city equipped to render this service, namely, the Hebrew Sheltering and Immigrant Aid Society, and the National Council of Jewish Women, among others.

4. Resettlement:- All matters pertaining to resettlement shall be considered the responsibility of the National Refugee Service.

5. Clearance:- It is understood that insofar as is practicable, the Hebrew Sheltering and Immigrant Aid Society will clear cases with the Central Index of the National Refugee Service.

Should any new matters arise requiring clarification, you may rest assured that I shall welcome further discussion.


It seems to me that this is perfect evidence, piled on to all the other evidence that has been accumulating, that the United Palestine Appeal has no representative--lay or professional--in the New York campaign.

No one can predict what will happen in 1941. But 1940 has provided ample experience to show that any concession which eliminates vigorous representatives of U.P.A. interests in New York makes UPA but a three-letter word on a letter-head. Neither in the decisions which have guided the New York campaign, nor in the promotion issued by the campaign, nor in the use of personnel, has the UPA in any way had a genuine part in the New York United Jewish Appeal in 1940.

I call this to your attention because in the very near future action ought to be taken to prevent a repetition of 1940.

RESOLUTION ADOPTED AT A MEETING OF THE BOARD OF DIRECTORS
OF THE JEWISH WELFARE FUND OF INDIANAPOLIS,
July 23rd, 1940.

Since the Hebrew Sheltering and Immigrant Aid Society is engaged in a program of immigration here and abroad, and its work is so closely identified with that of the National Refugee Service and the Joint Distribution Committee, and, to all intents and purposes, an integral part of the total program of immigration, refugee, and relief, Therefore

BE IT RESOLVED that the Hebrew Sheltering and Immigrant Aid Society be included in the United Jewish Appeal, the amount to be determined by negotiations between the United Jewish Appeal and the Hebrew Sheltering and Immigration Aid Society on the basis of budgetary needs and funds available.

The Jewish Welfare Fund of Indianapolis finds it impossible to make an intelligent appropriation to the Hebrew Sheltering and Immigrant Aid Society apart from the above mentioned organizations; and since it is the sentiment of many of the leaders in the community that the United Jewish Appeal be granted maximum support, it is only possible to secure a proper allocation to the Hebrew Sheltering and Immigrant Aid Society through the United Jewish Appeal.

It is true, of course, that there is panic in Hollywood, with 40% of the market cut off by war, with many employees being dismissed, and salaries being sharply cut. I have become impatient with Rabbi J. B. Wise's request (specifically made to me to do nothing on the subject) to halt procedure on the New York campaign study, and am writing, as per copy attached.

There is a representative of the United Palestine Appeal on the sub-committee to select a research director. He is Judge Morris Rothenberg. Dr. Solomon Lowenstein represents the Joint Distribution Committee, and Mr. David Watchmaker of Boston the three Welfare Fund representatives.

You have undoubtedly learned from Judge Rothenberg the status of the appointment of a Research Director for the United Jewish Appeal.

As you have learned by this time, Emanuel Neumann was selected to handle the loan from the New York end. This represents a voluntary service on his part. My own participation in the activity is terminated. I cannot embarrass my relations with the UPA and the UJA excessively. It is necessary, of course, that the loan program should be stopped by September 1st at the latest. To drag it out would make the whole loan idea absurd, since the idea is to get adequate time for use of the money. Moreover, we are getting closer to the period when decisions will have to be considered with respect to 1941 campaigns. It will not be healthy to let an impression gather that Palestine has already had its campaign --through this loan.

When I had left New York, Mr. Kaufmann had not yet done anything about the loan. Perhaps the situation has changed since. But he said he did not feel it right for him to ask his friends for subscriptions to this loan as his first act as Zionist President. More important things were coming on later, and he did not want to use up his friends immediately for what was, in the long run, a trivial thing. The loan discussion which he initiated at Manufacturers Trust Co. did not eventuate into action. After a week's delay, the bank said it could take no chances with \$500,000, in view of the international situation.

During my visit to Los Angeles, I attended a luncheon given for William Shroder, who is on vacation here. He made a splendid address, analyzing the problems of Jewish communities. He was sharply critical of the laziness and encrustations of Federation boards, of the ineptness with which the refugee problem is being handled.

But what interested me most was his statement, the theme of his talk, that in the near future a battle was going to be projected in American Jewry. A number of very influential people, hostile to Palestine, had suddenly decided they were going to attack Palestine and all its works. They felt that they had been quiescent too long, that their participation in activities with Zionists had come to be regarded as approval of Zionism; that, therefore, they must once and for all denounce the Palestine work as evil and have nothing to do with those who sponsored it.


He, Shroder, though not a Zionist and not interested in a political State--though very sympathetic to the general upbuilding of Palestine--had a warning to sound: that is, that each community should prepare itself to resist this call to break up the community: regardless of the influence, wealth and prestige of the individuals who call for such disharmony. The most important need of American Jews at this time, he said, is unity in action. Nothing is sufficiently important to destroy that prime necessity. He spoke with a great deal of feeling -- the group at the luncheon was quite representative. Apparently, Shroder is anticipating what has been privately discussed for a long time now. Shroder's remarks were especially interesting for me -- in view of our previous attitude to him on the Allocations Committee question.

In the meantime, the Willard Hotel has been reserved for January 25-26. In checking the correspondence with the Mayflower, it is quite evident that they have no desire to book the Conference even for February.

July 29, 1940.

I am returning to New York on Thursday, will spend two days in the city to clean up UJA and UPA matters, and then want to take a vacation. Looking at the records, I find that I visited more cities and talked to more meetings this year than anybody connected with the UJA. It's time for me to retire to silence for a while.



Dear Dr. Silver:

Before going away on my vacation, I would like to present to you for your consideration a suggestion which, I think, will be helpful to the daily functioning of the United Palestine Appeal, and would also be helpful to me, in removing from me the full responsibility for decisions that must constantly be made with respect to the daily and practical activities of the United Palestine Appeal.

During the coming months decisions on policy and concrete details will have to be made constantly. They will apply to a variety of problems, such as contact with the Research Director of the United Jewish Appeal, relations with the New York United Jewish Appeal, development of a United Palestine Appeal program in New York City, relationships between the United Palestine Appeal and the Emergency Committee, etc., etc.

It occurs to me that it would be very desirable if an Office Committee could be created which would be expected to meet in the United Palestine Appeal office every day, if necessary, but certainly frequently during the week. I thought that Mr. Lipsky as Chairman of the Emergency Committee might very appropriately be Chairman of this Office Committee, which might consist of three or four other people. These might include Charles Ress for the Keren Hayesod and Dr. Israel Goldstein for the Keren Kayemeth. In this way there would be an avoidance of difficulties that might arise when questions involving the consent of the Keren Hayesod and Keren Kayemeth are concerned. There might also be someone like Arthur M. Lampport, as Treasurer of the United Palestine Appeal.

It would be understood, of course, that all decisions of policy would be made as heretofore, that is, under your direction, but what I am worried about are not the major decisions of policy, for which there are appropriate channels, but the smaller problems which have bearing on policy, and which ordinarily have to be decided by myself alone. I think it would be much healthier for all concerned if these decisions were not made by myself alone.

Please let me know at your convenience what you think of



this idea as a means of simplifying and facilitating the daily operations of the United Palestine Appeal.

The existence of such a committee would provide the lay contact which for routine purposes with such bodies as the New York United Jewish Appeal, the Joint Distribution Committee and the National Refugee Service, we do not have at present, and with whom we need constantly to be in contact, for such a variety of reasons as exchange of currency in European countries, consultation on campaign procedure, excess distribution of funds, etc.





I have seen your memorandum of August 23rd containing a second draft of the outline you are preparing in summary of your examination on behalf of the Distribution Committee of the United Jewish Appeal.

In general, I should like to express appreciation for the thoroughness with which you are preparing to study the problem. I am looking forward to the opportunity of close contact with you for the submission of material and to cooperate with you in every way possible.

There are certain observations of a basic nature that I should like to make at this time on a tentative basis:

On Page 3, Clause 2, Section A, there is the phrase "recurring charity". In subsequent sections of your memorandum you have indicated that there is a basic distinction between the program projected for Palestine and that which may be attempted elsewhere either on a ameliorative or reconstructive basis. No program affecting Palestine can be judged on a plane whose foundation is solely charity. Knowing as I do your thorough familiarity with the Zionist movement, I am sure that I need not elaborate on this point.

Your, yourself, have called attention to the significance of the Palestine enterprise and its incommensurateness with other programs in Jewish life in pointing out on Page 4, Clause 3, Section B, that distribution must also take into account the "philosophy of Jewish life".

On Page 6, Clause F, Section 2, you ask the question whether amounts raised outside the United States shall affect allotment ratios within the United Jewish Appeal. If you are studying the amounts raised for assistance purposes not only in the United States but also abroad, I am sure that you will also make a study of the amounts which the countries to which assistance has been given have themselves raised for their local programs. I refer, for example, to such countries as Germany, Rumania, Hungary, Switzerland, Belgium, Holland, Poland, etc. It would be interesting to determine the ratios of outside and local self-assistance.

On Page 7, Clause M, referring to "past quotas", you speak of a miscellany of reports dated November 12, 1938, November 15, 1939, February 8, 1940. I would appreciate clarification as to what reports are referred to.

On Page 8, you indicate the desirability of taking a poll of community sentiment with regard to allocations. I assume that you have been considering how such a proposal squares with the fundamental purpose of the Distribution

Committee to study facts and needs objectively.

On Page 11, Clause 8, Section A, you mention the desirability of ascertaining what other organizations in related fields have been raising for assistance abroad. May I suggest that it would form an interesting section of your report to determine what sums are remitted by Jews in America for assistance to relatives and friends abroad. It might be noteworthy to determine the relationship between private and public support.

In Section A, you have indicated a number of organizations. I assume that these are merely illustrative in character and that you are planning to make studies of as many other organizations as possible, such as the Santo Domingo Settlement Association, the Joint Reconstruction Foundation, the Refugee Economic Corporation and the many organizations associated with or deriving their support from the National Refugee Service.


Dear Dr. Silver:





Gentlemen:

On August 5th we wrote you requesting your advice as to whom application should be made for cash priority on the basis of the \$2,500,000 allocation made to the National Refugee Service, Inc. by the 1940 United Jewish Appeal National Campaign. At that time three weeks ago, our cash problem was particularly serious and we requested your guidance.

Since we have had no reply to our previous communication, we again urge you to inform us which individuals would have jurisdiction in this matter. Our cash position is so dangerously serious that we bespeak your prompt advice and guidance.

CORRECTED DRAFT OF LETTER TO UPA CONSTITUENCY

Dear Friend:

The New Year finds the world in a grave hour of crisis. Every nation is shedding its blood in defense of its life. Every nation striving to survive must be prepared to make sacrifices. The measure of effort that must be exerted to live freely was summed up by Winston Churchill in calling upon the English people for "blood, sweat and tears."

The year that is now ending for the Jewish people has added incalculably to already intolerable burdens. But the cause of the Jewish people is not lost. It is not lost because it is the cause with which all free men are bound up. It is the cause whose triumph is the only beacon which is giving strength, courage and faith to all that is civilization.

In one part of the world it is given to Jews as a people to demonstrate pre-eminently their capacity for courage and perseverance. In Palestine, a strategic war center, some five hundred thousand Jews are standing fast against mounting dangers. They are preserving the historic gains and achievements of the Jewish National Home. In the world struggle against Hitlerism, whose chief bulwark today is the British Empire, Palestine occupies an important position. All who look to England as the front line for the defense of our own America must recognize that in a strange pattern of events it is the Jews of Palestine who ~~may~~ have been called upon to play an important role in those events whose outcome is of such moment to the United States.

From the very first day of the outbreak of war, the Yishuv insisted upon its right, as a community, to bear arms. It was only several months ago that a limited acceptance of that right was forthcoming. Immediately, the Jews of Palestine filled all the places that were open for volunteer service in the various units of the British Army of the Middle East. That quick response again emphasizes the stature of the Yishuv.

The token of the calibre of Palestine Jewry is to be found in the record of the past year. It was a year of severe testing, linked to events in the Mediterranean, the collapse of France, the interruption of normal markets, the slump in employment, the adjustment to new industrial needs, and facilities. There was hardship and suffering. But the Yishuv remained unshaken. It gave to the Diaspora an example of character. While the ~~normal~~ normal adaptations to new circumstances proceeded, there was a continuation of the building program of the Jewish National Home. Immigration, at a lower rate than in some other years, but nevertheless substantial, went on. Frequent dispatches told of the establishment of new colonies, the extension of colonization frontiers. The onerous tasks of integrating certificated and non-certificated immigrants into the country went on. New enterprises were launched.

We in America owe much to and can receive much from Palestine Jewry. We should pledge ourselves in this New Year season to enlarge our support of embattled Palestine Jewry that is fighting for rights to which our own destiny is linked. If our faith will match that of the Yishuv, we will not be discouraged by the difficulties and hazards which seem disproportionately magnified at a distance of six thousand miles.

Already the Yishuv has served to stimulate and inspire world Jewry. Rooted in the soil of our ancient homeland, it has shown its ability to build under all circumstances -- and to fight with dignity and skill. Confronted by a steady succession of new problems, it has adjusted itself to them like finesteel. To Jews the world over -- and to us in the United States -- the Yishuv has sounded this ~~to~~csin: Build soundly where you are and be prepared with sacrifices to resist encroachments upon your fundamental rights as men.

That is the message of encouragement and of strength that comes to us in this New Year season from the Jews of Palestine.



It should be noted that the services and responsibilities of the NRS are seemingly being restricted, with the burden being shifted to the Hias or elsewhere.

The agreement between the NRS and Hias provides that:

- a) The NRS shall make appeals on behalf of aliens excluded
- b) The NRS or the Council of Jewish Women shall provide for pier and dock services.
- c) Hias shall, or the Council of Jewish Women shall, prepare affidavits of support and similar documents.

My dear Mr. Montor:

I hope that it will be possible to shift the meeting with the New York representatives to Friday, September 20. In preparation for that meeting, I wish you would procure for me the following information:

1) A list of the 150 largest contributors in New York City - what they gave in 1939 and in 1940. This is an amplification of the list which you sent me some time ago.

2) As near as possible, an estimate of the number of individual contributions in New York City - exclusive of group contributions.

3) The number of meetings held by the New York campaign organization and the dates. By that I mean not meetings of the staff, but of the lay administrative or executive committees.

4) The number of individual contributors in 1940 in the four or five largest cities of the country. Cleveland, for example, had 22,000. How many did Detroit, Pittsburgh, St. Louis, Cincinnati and Philadelphia have?

I have received the memo which the JDC has prepared for the Distribution Committee. I would suggest that one of our men go over this memo in the same careful way as we did last year, shifting the wheat from the chaff, and separating expenditures from appropriations.

When will the UPA memo be ready? Particular emphasis should be dwelt in our memo on the loans which we have been forced to make to meet emergencies and on the great indebtedness of the Keren Hayesod and Keren Kayemeth in Palestine, which indebtedness must now be met entirely by funds from the United States. Stress

should also be laid on the number of new immigrants who have been coming into the country in the last nine or ten months.

I would be interested to know the names of the Governing Board members of the new Federated Council of Palestine Institutions and what connection there is between this group and the one Mr. Sol Lowenstein and others tried to organize last year.

Dear Dr. Silver:

On Monday, September 9th, I was in Washington accompanied by Dr. Nahum Goldmann to meet Mr. Ernest J. Swift, Vice-Chairman of the American Red Cross, and Mr. James T. Nicholson, assistant to Mr. Norman H. Davis, Chairman of the Red Cross.

The purpose of the meeting was to follow up on the letter which you had originally sent to President Roosevelt urging that part of the fund of \$50,000,000, recently appropriated by Congress, be made available for Palestine use.

Dr. Goldmann and I described a series of requirements in Palestine itself and for refugees in Europe.

These facts quickly became apparent:

(1) That it was very doubtful that the Red Cross would be able or willing to make any special allocations for refugees in Europe planning to go to Palestine. In the first place the Red Cross points out that it administers aid regardless of creed or nationality; and, secondly, there is the combined obstacle of the blockade and exchange restrictions which make difficult actual operations by the Red Cross. Not only does the Red Cross not send currency into continental Europe but, because of the attitude of the United States Treasury Department, it is even unwilling to buy food supplies within countries that are at present neutral for use in those countries or for shipment to nearby countries even though the latter may also be neutral. This would apply, for example, to Yugoslavia where some twelve hundred emigrants for Palestine are still stranded.

(2) The appropriation by the United States Congress of \$50,000,000 for the use of war victims specifically provides that the money can be used only through the expenditure of funds in the United States exclusively for supplies.

Mr. Swift and Mr. Nicholson both indicated that the Red Cross could not make any definite decisions at this time because of many factors involved; but, although non-committal, we received

the impression that the Red Cross was not unsympathetic to the problem and might possibly be able to do something.

These are some of the considerations that the Red Cross will keep in mind.


- (a) How the local agencies in Palestine operate for war relief
- (b) How ships can get through from the United States
- (c) What other traffic lanes there are
- (d) Costs of transportation.
Mr. Nicholson remarked that a decision on the sending of supplies to Palestine would be determined by the relationship of the cost of the supplies to the cost of transportation
- (e) What are the food, clothing, medical and similar requirements?
- (f) What is the Palestine Government doing to meet the special war refugee problems?

What are local medical organizations, such as Magen David, doing?

A summary of our conversation with Mr. Swift is contained in a cablegram which I have dispatched to Mr. Eliezer Kaplan, Treasurer of the Jewish Agency for Palestine, (a copy of which is attached) asking for detailed information which will be included in a memorandum to be submitted to Mr. Swift in accordance with his request.





I am arranging with Mr. Blitz to provide for me answers to the questions raised in your letter of September 9th.

I am inquiring from the communities which you listed as to the number of contributors in 1940. In the case of Cincinnati and Philadelphia this would have to be a list of the contributors in 1939 since the 1940 campaigns have not yet been held.

I have gone carefully over the memorandum prepared by the Joint Distribution Committee, and will send you a memorandum of analysis in a day or so.

The United Palestine Appeal memorandum has been prepared in DRAFT form. I regard the matter as too important to be submitted without careful consideration by all those who are in a position to offer comments and data.

This draft has a great deal of material. More material will be added as we receive additional cables from Palestine.

I enclose herewith a copy of a cable received from Eliezer Kaplan giving figures for June and July, and indicating that the audits requested by the Distribution Committee Director are being air mailed.

When you receive the draft of the memorandum within a day or so I know you will want to go through it very carefully for suggestions on content and form. I know that you will overlook any typographical errors that may occur, and also many omissions, of which I am conscious. The purpose of the draft was to get a picture of the situation as a whole so that it can be amplified.





My attention has been called to this situation as a result of a letter which I received from the Omaha Jewish Welfare Fund informing me that it had received an application from the HIAS for an Emergency Appeal. In making inquiries as to the nature of this appeal I found the following:

The Joint Distribution Committee, because of the withdrawal of the I.C.A. from the HICEM, declares that it now bears the greatest responsibility for transportation costs for emigrants from Europe. The J.D.C. is apparently contending, at least privately, that its resources do not permit it to bear the full share or the greatest part of this new responsibility. Accordingly, it initiated conversations with the HIAS and has apparently urged the HIAS to go to the country with an "emergency appeal", emphasizing the need for additional transportation money since the J.D.C. cannot bear the burden.

Instead of initiating a campaign which would bring it supplementary funds in various cities, all that the HIAS has done is to resort to the familiar practice of turning to the Welfare Funds, which have already completed their campaigns and cannot possibly get additional money, and is now asking for special grants toward this "Emergency Appeal" for transportation.

Under the circumstances it would seem to me that this is an evasion by the J.D.C. in relieving itself of responsibilities which the public regards as part of the functions of the J.D.C. by assigning some of these functions to an entirely different agency outside the United Jewish Appeal.

The net effect, of course, is to reduce the total amount which the U.J.A. would receive from each community. The funds at the disposal of each Welfare Fund are not flexible. Moreover, when special appropriations are made it is invariably the U.J.A. allotment which is affected.

I understand that the J.D.C. is about to issue a public statement indicating the nature of the conversations it has had with the HIAS and, in effect, endorsing the HIAS "Emergency Appeal". When



Attached hereto is an analysis of the percentages, as well as the amounts of the allotments to the United Jewish Appeal from the major Welfare Fund communities. Comparison is also made of the percentage of allotments to the United Jewish Appeal as between 1939 and 1940.

You will note that the cities of New York and Chicago have been omitted.

There is also attached an analysis of the percentages allotted to the United Jewish Appeal in combined campaigns where \$5,000 or over was pledged to the United Jewish Appeal.

It is interesting to note that the average percentage of allotment in 1940 declined in the Welfare Fund cities from 57% in 1939 to 54% in 1940, whereas in the combined campaign cities the percentage of 81% in 1939 is paralleled by 82% in 1940.

I am sending you herewith a DRAFT of a memorandum that is eventually to be submitted to the Distribution Committee of the United Jewish Appeal by the United Palestine Appeal.

The following should be noted:

- (a) Typographical errors should be overlooked;
- (b) I am conscious of the fact that various important material has been omitted. This is awaiting further clarification, and receipt from Palestine by cable and airmail;
- (c) The purpose of circulating this draft as early as possible is to obtain the benefit of comment and criticism on content and form, and to obtain further material of a statistical or informative nature that ought to be incorporated in this memorandum when finally submitted to the Distribution Committee of the United Jewish Appeal, which will have at its disposal the allotment of funds raised in 1940 by the United Jewish Appeal.

About \$11,000,000 already has been distributed: \$2,500,000 to the United Palestine Appeal, \$5,250,000 to the Joint Distribution Committee, and \$2,500,000 to the National Refugee Service (\$1,000,000 from New York City for the National Refugee Service).

I shall be most grateful if you could study this memorandum thoroughly and let me have your advice and suggestions at the earliest possible moment.



Dear Mrs. Gans:

The United Jewish Appeal has forwarded to us a copy of your letter of September 15th, stating that Dr. Ernst Wolfes, of Green's Eye Hospital, San Francisco, California, has requested you to cooperate with him in furnishing money for the transportation expenses of Mr. Bernard Neustaedter, now in Germany. You inquire in regard to the possibility of helping a prospective emigrant to leave Germany at the present time.

We are sure that you will be interested to learn that in recent weeks the Hilfsverein, the emigration aid division of the committee in Germany, whose work we subvention, has been cabling to relatives in this country of prospective emigrants abroad requesting them to deposit funds with us to cover the transportation expenses of the emigrants.

When such a deposit is made, we cable the Hilfsverein that the money has been left with us and to make the bookings from Berlin. The money, however, remains here, and subsequently, upon instructions from the Hilfsverein, we pay the bill to the steamship line at their offices outside of Germany.

People are coming to the United States by rails through Russia to Japan, and sailing from Japan to San Francisco or Seattle. The Russian Government is permitting emigrants to pay for their transportation expenses across Russia in Marks, and the payments in American currency, therefore, are needed for that part of the trip which begins after the emigrant leaves Russia.

Steamship fare costs, for Second Class, \$225.00 per person. There are a limited number of places also in Tourist Class at \$180.00, and in Third Class at \$105.00, but it is our understanding that those are very heavily booked. In addition, all passengers, no matter what class they are traveling, must pay for certain incidentals which are as follows: \$8.00 for the head tax, which is imposed by the United States upon each emigrant entering the country; \$10.00 "bordgelt" or money for use on board ship; and \$12.00 for maintenance on the trip through Manchukuo before reaching Japan.

If you should decide that you wish to assist Dr. Wolfes in bringing Mr. Neustaedter to this country, you may wish to deposit the money with us for this purpose. We would then cable the Hilfsverein in regard to the matter.

If we can be of any assistance to you in this matter, or if there is any further information you would like to have concerning transportation for prospective emigrants, please do not hesitate to write to us.

As you know, Denver raised a total in their Welfare Fund last year of \$58,000, out of which we were given approximately \$45,000, although they have not collected nor paid anywhere near this amount. In 1938, the UJA agencies received \$35,000 from Denver. Denver has a Jewish population of 17,000. Approximately 50 percent of this population who have gone to Denver for their health, is wholly dependent on either local charity or relatives, so that the true picture of Denver is that it represents a community of about 8,000.

The big wealth in Denver consists of Neustater, the Schlesinger-Wolff family, which represents the younger members of the old Gouldman family and Bernheimer. Bernheimer is only in Denver about two months a year. That is his legal home. Most of his time is spent in California. He is never in Denver anywhere around the campaign period, and his contribution, around \$2,000, is generally obtained by mail. He has no interest or activity in the local Denver community, having originally lived in Louisville.

Neustater could give a great more than he does, but no one in Denver has any influence with him. He is never active in the campaign, although his name appears as an officer merely for window-trim.

I am frank to say that I do not know how to get the Schlesinger-Wolff combination to give more money. They are just naturally tight. Perhaps you might personally be able to influence them.

The United Health Appeal, which is the hospital campaign and embodies the local fund-raising activity of the National Jewish Hospital, the JCRS, the Ex-Patients' Home and the Jewish Children's Home, has an annual campaign each Spring on a non-sectarian basis for \$75,000. The Jews feel justified in running a non-sectarian campaign for two reasons - one, these four institutions spend about \$1,000,000 a year in Denver of money that has been collected all over the United States, and therefore, helps the Denver economy - and therefore, the Gentile community should help support the hospitals. Two, that about sixty-odd percent of their patients are non-Jews. This campaign has never reached its goal, \$55,000 or \$58,000 being the total raised, and all but \$12,000 or \$15,000 comes from the Gentiles.

I personally don't believe that \$75,000 is in the cards for the UJA allocation in their Welfare Fund, although I am ready to admit that if the top givers, who are not active in the campaign, would give adequately, that this sum could be raised. I can't advise you on a compromise for Denver, but you might be able to discuss it with them personally and come to some understanding.



It is my belief that if you could spend the day in Denver the results for the United Jewish Appeal would be very worthwhile and at the same time you would be rendering a service to the building up of a stronger communal sense in Denver. If you could say "yes" to the November 26th date it would be most valuable for the United Jewish Appeal and for Denver.



Dear Dr. Silver:

I would like to call your attention to the retention by the United Jewish Appeal of its complete field staff, except for a number of men who were released in July since they were taken on on a part-time basis.

On the basis of actual production possibilities for the balance of the year, the retention of the entire staff of field representatives is not warranted. Obviously, however, in an organization such as ours those who enter service in it cannot be dismissed merely because the amount of business being done at a particular time slackens. Mr. Coons and I discussed this situation and he felt that the two of us owed a responsibility to the National Chairmen to apprise them of the fact that we regarded the ratio of expense as high and that the National Chairmen should share this knowledge with us.

I should only like to add, however, that the important phase of this issue does not relate to the rest of 1940 but to the future, that is, 1941.

There are several men on the field staff of the U.J.A. whom I would not engage as field representatives on the basis of their individual merit and capacity to produce results for the U.P.A. or the U.J.A. I believe it unfair to our common interests that a fund-raising organization like ours should keep on year after year retaining men who, whatever their capacities in the past, are not adapted to fund-raising requirements today. Possibly these men, if they are older, could be given a pension. Certainly, I would not be in sympathy with any effort to dismiss these men abruptly without adequate consideration of years of service and their present possibilities for further employment.

On the other hand, an organization, whether it be the U.P.A. or the U.J.A. does itself great harm if it continues the employment of representatives who not merely do not produce adequately but take the place of men who with greater knowledge, experience and personality could evoke greater responses for our needs.

In order that our study may proceed efficiently, may I again call your attention to the following:

The Committee, at its meeting on Friday, September 6th, approved the following under Section I D of the fourth draft of the report: "Final results will depend upon the tact of the staff and will call for the goodwill of the three organizations." In amplification, may I say:

1. We are not an investigating committee appointed from the outside to check up on willful errors or malfeasance.
2. We were appointed from within by representatives of the three organizations to help them find, if possible, a scientific basis for allotting funds.
3. We are agents of the Allotment Committee of seven. We derive our powers from them and have no powers beyond that. As agents of the Allotment Committee we must act with the same thoughtfulness as they would act if they were doing the research work themselves. As my co-workers, you must act with the same consideration and kindness as I should if I were in your place.
4. Our aim is to help and not to hinder.
5. We must keep good relations with the staff, avoid all possibility of friction, and not impede the work of the three organizations.
6. We must leave them as good friends as we found them, or even better.
7. I have been a friend, for a long time, of the members of the boards and of the officers in the three organizations. Will you please be careful to say nothing and do nothing which will hurt this friendship, or cast any reflections on my intent, my method or my scientific impartiality.
8. Instructions, verbal or written, given by me, intended to insure friendly relations with the three organizations, may not be changed without my consent.


Dear Dr. Silver:

EMERGENCY COMMITTEE AND THE UNITED PALESTINE APPEAL
FRIDAY, SEPT. 20, 1940 AT 4 P. M.
AT THE UNITED PALESTINE APPEAL OFFICE, 41 EAST 42 ST., NEW YORK, N.Y.

PRESENT: Isadore Breslau, Rehaviah Lewin-Epstein, Henry Montor, Mrs. David de Sola Pool

This sub-committee was designated by the Palestine Emergency Committee to deal with the American Red Cross in its relationship to the provision of needs in Palestine.

1. It was agreed to cable to Mr. Eliezer Kaplan informing him of the formation of the sub-committee of the Emergency Committee to deal with Red Cross problems. A copy of the cablegram to Mr. Kaplan is attached.
2. It was agreed to send a telegram to the American Red Cross asking for immediate provision of \$100,000 in cash to meet the emergency requirements. A copy of this telegram is attached.
3. A memorandum prepared by Rehaviah Lewin-Epstein on facilities of transportation of supplies to Palestine was read and approved.
4. It was agreed that in negotiations with the American Red Cross it should be noted that the Jewish Agency Executive is the supreme and central body representing the Jewish people in Palestine.

It was also noted that the Jewish Agency would call upon other bodies competent to deal with various phases of the problem. These include particularly the Vaad Leumi and Hadassah

Attached hereto is a copy of the statement of the Jewish National Fund, showing income and expenditure for August, 1940.

The income was \$27,654.37. Out of that sum \$15,962.43 came to the United Palestine Appeal, while expenditures absorbed \$11,391.94.

I do not know why the Zionist movement regards the Jewish National Fund as a sacred cow whose practices cannot be discussed, much less criticized. I do not know on what basis this ratio of expenditures to net income can be justified.

I am sending this observation to you in the thought that it may be taken into account when discussion is given to a thoroughgoing revision of our fund-raising methods for Palestine in America.

He said that he did not intend any criticism (although everything he said in comment upon things that had been done seemed to be regarded as criticism), but perhaps the \$25,000 was too hastily accepted. Perhaps if he had dealt with the situation more money could have been obtained from the Red Cross.

In any event, he agreed that there was no point in his seeing Mr. Davis today. I suggested to him that he defer his visit to Mr. Davis until after the memorandum on supplies had been received by the Red Cross.


This afternoon I was informed by telephone by Rabbi Breslau in Washington that Mr. Kaufmann had arranged to see Mr. Davis on Friday, September 27th, at 11:00 o'clock. I told Rabbi Breslau that I, too, would be present. It is rather hard on me to do all this running around but apparently it is essential to protect what has already been done.

It might interest you to know that Rabbi Breslau reported that Mr. Kaufmann had the suggestion that officers of the JDC, the American Jewish Committee, etc., be asked to telegraph the Red Cross thanking them for their action on behalf of Palestine. I may have become slightly apoplectic at this suggestion and I trust that Rabbi Breslau understands that it would be absurd for any such action to be initiated.

But who would believe that there are such people in the world!!!!



This will acknowledge the receipt of your letter of September 16th, 1940, to which was attached a memorandum to the Allotment Committee of the United Jewish Appeal.

You have asked for comments on the fifth draft.

I observe that on page 1 under I - 2, you speak of placing programs "in perspective in relation to current war problems."

It is undoubtedly true that activities of agencies within the United Jewish Appeal have been affected by the war, but the relationship of those activities to war requirements can be only a secondary factor in the determination of their value. This is particularly true of the upbuilding program in Palestine, which, through a period of some sixty years, has experienced many vicissitudes, and has always emerged stronger. Relief and emergency problems arising out of war have a special claim upon our support, but when we are engaged in a long-range project of building a National Home, war is only a transitory stage and cannot be the sole criterion or even the major criterion to determine the nature of our program.

On page 1 in I - 3, you speak of "The evaluation of the quality of the available data."

It seems to me as a member of the Allotment Committee that we are concerned with the nature of the activities of the organizations involved, and not so much with the character of the data which they have available except insofar as such data reflects the extent of activity. We are called upon to define the values being furthered by the organizations and to determine their needs.

On page 1 in I - 4, you refer to "furnishing a program of research for future years."

In view of the brief time available to your research staff it would seem to me a rather difficult task to concentrate, on the one hand, on evaluating the available material and, at the same time, map out a long-range program of research for future years.

On page 2 in C - 2 - d', you refer to "Goodwill of contributors."

I thought that we had agreed that even though goodwill of contributors is vital for the success of the United Jewish Appeal campaigns, the

criterion of the effectiveness of the expenditure was to be the gauge of the Allotment Committee. This same observation applies to page 3 - C - 2' - d', where you speak again of "Approval of United States contributors", etc.

On page 2 in I - 2, you speak of "Imponderables."

"Imponderables" constitute a factor which the members of the Allotment Committee will have to take into consideration, but I believe that these are of secondary importance insofar as the research staff is concerned, since "imponderables" are not statistically measurable.

In considering "imponderables" the Allotment Committee should be concerned not merely in evaluating the problem that such "imponderables" represent, but in analyzing the relationship of the particular organization within the United Jewish Appeal to these problem. It is true, for example, that the refugees in the United States constitute an important problem, but the mere fact that the satisfaction of their needs through proper employment and through resettlement is vital, does not mean automatically that this is the responsibility or the financial obligation of the National Refugee Service alone or as such. In other words, an "imponderable" may be used to give false weight to the determination of the function or responsibility of a particular organization if there is not at the same time a clear definition of the practical relationship of that organization to that "imponderable."

On page 8 you have again raised a question which I thought we had disposed of at the last meeting of the Allotment Committee when in III - C - 6 - b you ask "Have refugees in U.S. prior claim on U.S. funds?"

This seems to me to involve a final judgment in moral terms, for which the members of the Allotment Committee alone can assume responsibility. I do not see how that particular question can offer any sort of basis for the statistical analysis of your research staff.

On Tuesday, September 24, at 2:30 P.M., there was handed to me by your secretary a typewritten slip to the effect that you are preparing a statement for the Council of Federations and Welfare Funds which you want to have read by the United Palestine Appeal and returned to you by Wednesday, September 25th, at 1:00 P.M.

First, as to procedure: It is unfair to any organization to expect that its schedule should be adjusted to the lightning speed required in this instance.

Second, and much more important: The issuance to the Council of Federations and Welfare Funds of a statement on the functions of the Allotment Committee of the United Jewish Appeal is one that is of such importance that it must first have the approval, as a matter of policy, of the United Palestine Appeal. The functions of the Allotment Committee do not, as far as I know, involve the assumption of responsibilities in public relations which are exclusively the domain of the two partners in the United Jewish Appeal, that is, the United Palestine Appeal and the Joint Distribution Committee.

Under the circumstances, therefore, I must ask you, on behalf of Dr. Abba Hillel Silver, National Chairman of the United Palestine Appeal, that no statement be submitted to the Council of Federations and Welfare Funds and that no story be circulated with respect to the Allotment Committee until it has had the approval in writing of Dr. Silver.

Apparently, Dr. Lowenstein is assuming that the Allotment Committee and also the United Jewish Appeal are his personal perquisites and that Mr. Friedman is his private secretary.

I understand from Mr. Montor that the minutes of the last meeting of the Allotment Committee, at which I was present, record the adoption of a motion calling upon the research staff to "include not merely the facts and the evaluation of the conclusions, but also definite allotments as a basis of discussion."

I do not recall the adoption of any such resolution while I was present. On the contrary, I distinctly remember that I observed, when the discussion arose, that the research staff was at liberty to make any comment upon the facts, but that it would not be desirable to have the research staff make recommendations which would be a usurpation of the duties and responsibilities of the Allotment Committee. It would impair the usefulness of the research staff if it ventured to suggest the definite allotments that should be made.

Needless to say, both Dr. Wise and myself could not give our approval to the resolution which is reported to have been adopted.

Dear Dr. Silver:

As far as I know, the Red Cross has not yet made public announcement of its grant to Tel Aviv.

The memorandum has gone forward. You have by this time received a copy, I believe. The figures cabled by Mr. Kaplan were incorporated in the Red Cross memorandum.

Thank you for the letter which you sent to Elisha Friedman. Attached herewith is a copy of the letter which Mr. Lipsky wrote to Mr. Friedman.

I have been speaking to Hadassah for some time about their bill of \$47.54, which, as I indicated in a note to you yesterday, they insist is the obligation of the Cleveland Welfare Fund. If you feel the United Jewish Appeal should pay this instead of the Cleveland Welfare Fund, I shall put it through. I had hoped that I could convince Hadassah that it was a matter of good policy at least to pay the bill for sending its speaker to a campaign in whose proceeds it participated.

I note that you have not accepted membership on the budgetary committee established by the Council of Federations. However, your name has been listed on the stationery and in the various memoranda. I shall consult with Dr. Wise and Mr. Lipsky about my participation in it. I have the feeling, though, that we ought to be around to see what is happening.


Thanks very much for accepting the invitation to open the campaign in Dayton on October 6th and in Denver on November 26th.



Dear Dr. Silver:

I am unable to cope with the New York situation. I believe that as long as Blitz is the director, the United Palestine Appeal interest in New York City will not be protected.

Your New Year letter of greeting, which was sent to some 25,000 key leaders throughout the country, has not been sent from New York. Mr. Blitz declined to make available the New York list for this purpose. Either he or his leaders decided that the letter was too Palestine-minded. Suggestions were made that the letter should be revised and referred to the United Jewish Appeal as well. During my absence from the city on Friday in Washington, Steinglass even assented to these changes, but even despite that, the letters were not sent out, and the list not supplied. I immediately indicated that there would be no change whatever in the letter, if it were to go out to the New York list.

If the National Chairman of the United Palestine Appeal cannot get a list to whom his message on Palestine is to be sent, to a group of New York leaders, I would certainly regard the United Palestine Appeal participation in a New York campaign as a farce, and all our theories of unrestricted Palestine propaganda within the United Jewish Appeal become purely superficial.

I would strongly urge that the situation is important enough for you to telephone Edward Warburg in New York City, to ask in person for the list of names for which you had previously asked in writing, but to which you have not as yet received any reply. I wonder how long you would have been permitted to enjoy peace of mind in Cleveland, if the JDC or NRS had sent you a letter on their business which you had not acknowledged promptly.

Personally, I don't think that Palestine gets enough money from New York City to be able to swallow this disgusting exhibition of condescension to Palestine.

I shall be in Rochester, New York on Monday, September 30, on UJA business, returning on Monday evening. If you speak to Warburg, and Warburg obtains the list, you might send a wire, or otherwise have Miss Trebach, my secretary, informed, so that she may follow through.

You may be interested to learn that Jonah B. Wise sent out New Year greetings on his personal stationary, was able to get the list, and was not subjected to the necessity of referring in any way to the United Jewish Appeal, but only to the J.D.C.

Please inform the Hadassah that it is not the practise of the Jewish Welfare Fund of Cleveland to pay for any speakers which beneficiary organizations send to address the campaign luncheon meetings. The Hadassah received from the 1940 Jewish Welfare Fund Campaign of Cleveland the sum of \$10,000 and it is little enough of a campaign expense for the Hadassah to expend \$47.54 for a speaker which they send to Cleveland.

It was the Hadassah people here who requested the Cleveland Jewish Welfare Fund to invite Mrs. Judith Epstein. Please tell the Hadassah Organization of New York not to send the Cleveland Jewish Welfare Fund any further bills. They will not be paid.
