Dear Rabbi Silver:-

I tried to see you following our meeting last Wednesday evening but was unsuccessful in my efforts.

I want to tell you of the great satisfaction that was expressed to me by many members of the Governor's Committee that you had accepted its leadership. Your address was both an inspiration and a challenge to us to go forward and not to accept any defeatist attitude in spite of threatening conditions in the world today.

You will be happy to know that the reports given by the three sectional chairmen on Thursday morning were adopted unanimously by the committee, and that plans are going forward to make the recommendations in these reports effective in our state.

The three chairmen will continue to serve as leaders of their respective sections, and within a short time they will appoint commissions to make needed studies in the fields of Welfare, Health and Education, to be reported upon at the general meeting to be held in Akron next October in connection with the Ohio Welfare Conference. In the meantime, the Ohio Welfare Conference plans to hold Regional Conferences within the next two months covering the entire state at which there will be reports of the meeting of the Governor's Committee last week, and plans made for making the recommendations adopted, effective in counties and local communities.

There will be a meeting of the joint program committees of the Ohio Welfare Conference and the Governor's Committee on Friday morning, April 18, in Columbus. This is for the purpose of making plans for the meeting next fall which will begin on Tuesday evening, October 7 and end on Friday noon or late afternoon, October 10th. We should be most happy to receive any suggestions you may have for this program.



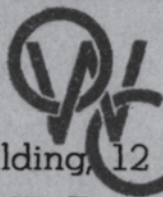



To: Members of the Executive and Program Committees  
of the Governor's Committee:

At the request of Governor Bricker, the various state agencies having to do with welfare, health, education and defense (related to the state administration) have been requested to cancel any state-wide meetings scheduled within the next few months, for the purpose of pooling all efforts on a program devoted to civilian participation in Ohio's Defense or War Program. We, therefore, are calling off the joint meeting of the Governor's Committee and the Ohio Welfare Conference which was to have been held in Columbus on April 29th and 30th.

In furtherance of this plan, on January 21st, Governor Bricker called a meeting in his office of representatives of a number of the agencies or groups affected. At this time a small steering committee was appointed to work out the details of a joint state-wide meeting - to be held in Columbus preferably in March - on civilian participation in the war program of Ohio. Mr. Harrison M. Sayre was appointed chairman, and Dr. Herschel W. Nisonger, secretary, of this committee.

At a recent meeting of the steering committee it was decided that the contemplated conference should be held on the campus of Ohio State University, Columbus, for a period of three consecutive days in the week of March 23rd. Further information in regard to this program will be sent you by the secretary of the steering or program-building committee.



In accordance with the plans made at our luncheon meeting last Monday in Cleveland, Judge Robison and I took up with Mr. Sherwood on Wednesday of this week the recommendations made at that time in regard to a program on Family Security in connection with the state-wide conference on Civilian Defense to be held in March, and also in regard to the status of the Governor's Committee on the Follow-up in Ohio of the White House Conference.

Mr. Sherwood feels that it is wiser for us to wait until the needs created by the war situation are more clearly defined before we attempt to set up a Family Security Program. He also feels that serious consideration should be given as to how the White House Conference Follow-Up Program can best serve in this war crisis - even though that service might be a suspension of activities - and to this end he approved Rabbi Silver's plan to call in the near future a meeting of the Executive Committee of the Governor's Committee.


In harmony with the opinions expressed above, Mr. Sherwood has relieved both the Ohio Welfare Conference and the Governor's Committee on the Follow-Up in Ohio of the White House Conference from participation in the institute on Civilian Defense to be held in Columbus the week of March 23rd. In making this decision, Mr. Sherwood said he felt the best needs of the Ohio Welfare Conference could be served by its participation in the Regional Conference of the Child Welfare League of America, to be held in Cleveland on March 12, 13 and 14, and to this end he has agreed to send out the usual call making it possible for the expenses of public employees to be paid.

Please believe we appreciate greatly your courtesy in meeting with us at our request last Monday to help think through the problems referred to in this letter.
