My dear Silver:

I have your letter and am delighted to think that you are planning to spend the summer abroad and especially that you are thinking of going to Palestine. Justice Brandeis at first planned to go to Palestine and subsequently, for reasons which I cannot disclose in this way, came to rest under the necessity of changing his plans. But during the last few days he has again changed his plans and now means to leave with deHaas on Saturday. If there had been any possibility of your securing a passport and a cabin on the Saturday boat so that you might have sailed with them, I would have telegraphed to you, but I know that is impossible. Moreover, Justice Brandeis does not wish to seem to be taking a party with him; so no one is to accompany him but deHaas. Personally, since you ask my opinion, I think it would be most admirable if you could go. I see no reason why you should not. Our office would facilitate your plan. If you could get away within a week or a fortnight, securing a passport through friends in Cleveland, you would have nearly three months before it ~~was~~ necessary for you to return owing to the lateness of the Holydays. If you can manage it, I should like to see you before you leave.

My dear Silver:

It was I who proposed yesterday to Judge Mack and others that we call upon you for a great service, -- namely, to come here and give us a fortnight in connection with Palestine Restoration. I know it may not be easy, but do come. Put aside other things. We really need you. We have no speakers, and if you can come you should. I am bearing a load to the point of breaking down, but there are limits. If you cannot give us two weeks, give us one week. If you cannot give us a whole week, give us four or five days, and let us know what they are and we will pile up engagements. But do come by all means. If you should have wired No, -and I hope you will not have done so, -I beg you will reconsider.

Dear Silver:

I have just returned from St. Louis where we did very well, getting one hundred and ten thousand, and Indianapolis where I went merely to lay foundations for Judge Mack or you. But something was done in the few minutes I had in which to get the train and I rather think it will be comparatively easy to continue the campaign.

I want to tell you that you cannot imagine what it means to Judge Mack and to me to feel that we may count upon your tremendously valuable assistance. The burden that just a few of us are bearing is so heavy that it is really providential to have the co-operation of one who is going to render the invaluable service which it lies within your power, and happily within your will, to accomplish.

As for your wire, I haven't caught my breath since I got in, so I cannot say now whether it will be possible for me to come to you. Give me a little time, although I ought to say at once that I think it very doubtful that I can leave town again before the end of February, when I go South for nearly two weeks. That would mean that I could not come until the end of March or early in April. I really don't think I ought to go to Cleveland. I distinctly have the feeling that it is not necessary. You and Judge Mack have done all

that can be done and my own word would surely be superfluous
in the circumstances.

My dear Dr. Wise,

I received your telegram urging me to a fuller co-operation in the Palestine Restoration Fund campaign, and suggesting that I go to Baltimore and Washington February 22nd.

I would gladly give more of my time to the campaign, but we are at present engaged in our local drive, which takes up a great deal of my time. I should be glad to accept all invitations, but I cannot leave my pulpit on Sunday. I have no one to take my place, and I feel that my first duty is to my people here. I do not see why all of these cities insist upon having their affairs on Sunday night.

I have just wired you with reference to your coming here. I feel that we need you here very much. The campaign is progressing, not disappointingly, but rather slowly. Your coming here would give the necessary impetus to it. We would arrange a dinner for you, at which a number of men whom we are endeavoring to reach would undoubtedly be present.

Should you find it possible, which I rather doubt, to come here on a Sunday, I should love to have you speak in my pulpit for me. You know that my people would be most eager to hear you.

Dear Abba Hillel:

I cannot tell you how disappointing it was not to have seen you on Monday. I tried to get into touch with you through your home and I know that you telephoned later, but when I phoned to the Pennsylvania you were not in.

I wanted very much to see you, -- in the first place, to thank you for the service you rendered my people and me on Sunday. Everywhere I hear of the uncommon and notable address you made. You seem to have stirred the congregation to its depths. That is the report which comes to me on every side. Then, I wanted to talk to you about a matter of very great importance. When will you be in New York? It is imperative and most urgent that we get together at the earliest moment for a joint and careful consideration of the problem that I have in mind.


I suppose you have heard that the Zionist Convention takes place on May 9th and 10th, having been called in order that we may take counsel touching the new conditions created by the conferring of the Palestinian mandate upon Great Britain. Of course you will come to the Convention.

I have been wondering whether I ought not have a Zionist celebration at my own service that morning. If you are here, of course you would have part in it, three or four of us speaking for ten or fifteen minutes apiece.
