

Dear Dr. Abba Silver,

I want to ask you a great favour. I need not tell you about the principles and activities of the World Union, for you have been associated with us from the beginning, but you have never, I think, addressed any of our conferences.

We are due to hold our eleventh International Meeting in London from July 9th to the 15th, 1959 and we should be infinitely grateful if we could have your co-operation. We would ask you to give an address of about 45 minutes on "THE PLACE OF JUDAISM IN THE RELIGION OF TOMORROW". The exact wording of the title would be subject to your approval or amendment. I am glad to say that Dr. Freehof has agreed to speak for us in the morning and we should be fortunate, indeed, if you would speak on the evening of Sunday the 12th July, 1959. We expect on that evening, besides the Delegates a fairly large English public as our Central Topic will, we fully expect, rouse considerable interest. It is "RELIGIOUS AUTHORITY IN PROGRESSIVE JUDAISM".

If you are able to accept our warm invitation we shall appoint from our Constituents two openers for discussion. Your personality has had international influence for so many years, that we are hopeful that, together with Dr. Freehof, you may make our Conference of outstanding importance. I shall be grateful indeed, if on this occasion, which will be the last when I can appear as President, I may have the pleasure of welcoming you. Although July 1959 seems a long way off, it is necessary that we make immediate arrangements to publicise our Conference and ascertain who will be able to attend.

Previously, on the 19th of June, 1958, the Sunshine Fund of my Temple sent a contribution payable to the same cause of \$100.00.


