

Dear Dr. Silver:

I am very happy to note that you have been advocated for the presidency of the Zionist Organization of America by a number of outstanding leaders of the organization. I note also that they say that you are willing to relinquish all other work in favor of Zionism for the coming year. We are facing a crucial period in our endeavors for Palestine and it is good to know that a man of your great talent is willing to give such service to the cause.

The difficulty is that since Dr. Goldstein is also a candidate for the presidency, a contest for the office may ensue, reminiscent of some of our previous Zionist battles. In my opinion your usefulness to Zionism would be even greater as head of the Emergency Committee rather than as President of the ZOA.

If you agree with this and are willing to permit me to bring this information confidentially to a number of prominent Zionists, I shall be glad to do so. I think I am in a position to do this successfully.

A parishoner of yours is a Cadet at West Point. His name is Leonard Gilbert. Don't you think it is your duty to pay him a pastoral visit? What I mean is that I should like to have you let me know what weekend you will be in New York. I would like to invite you to preach to my Cadet congregation at West Point on Sunday morning.

Dear Rabbi Silver:

Several weeks ago we asked you whether to send bills directly from our office to your members in arrears. You instructed us not to do so. We presume that you have taken care of this matter yourself. We urge you to remit forthwith all dues on hand to National Headquarters so that those already enrolled can be placed in good standing immediately.

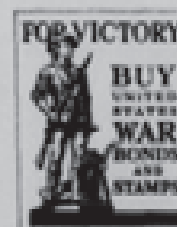

Registration of delegates and alternates to the convention will commence Saturday evening, September 11th, at 8:00 o'clock, at the convention headquarters in the Deshler-Wallick Hotel, Columbus, Ohio. Upon presenting the enclosed card at the registration desk and payment of the registration fee, your official credential will be issued to you together with your official badge, convention program, literature, annual reports, etc.

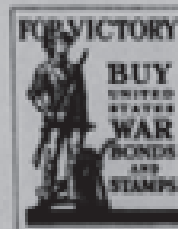
The Administrative Council at its July 18th meeting, acting upon a directive from the last convention, adopted a formula for the designation of the Committee on Committees in advance of the convention and voted to eliminate the usual convention-eve Administrative Council meeting. The Committee on Committees will meet on Friday afternoon preceding the convention.

Arrangements have been made for Sabbath Services at the Hotel. An Oneg Shabbat will be held under the auspices of the Histadruth Ivrit on Saturday at 3:00 p. m. All delegates are cordially invited.

The convention will open formally on Saturday night, September 11th at 8:30 p.m., at which time Judge Louis E. Levinthal will deliver the annual presidential message.

The convention banquet will take place on Monday evening, September 13th and will be addressed by outstanding national personalities. Please return the enclosed banquet reservation card at once in the self-addressed envelope.

Arrangements will be made by the Columbus Zionist District to provide kosher meals on Friday evening and Saturday noon outside of the hotel if sufficient advance reservations are made. Please use the enclosed return card promptly so that the committee will know how to proceed.



Reservations for breakfast and luncheon meetings should be made at the time of registration.

We urge that you make your round-trip transportation arrangements immediately to avoid any disappointments.

Delegates who are members of District and Regional Youth commissions are expected to attend the Sunday morning breakfast meeting under the auspices of the American Zionist Youth Commission. All other delegates are cordially invited to attend.

We enclose herewith your hotel reservation card. In order to assure yourself a choice room, please make your hotel reservations without delay. In doing so, please indicate that you will be attending the convention of the Zionist Organization of America.


A copy of the annual report of the Administration covering the activities of all of its departments during the past year will be furnished to you upon registering at the convention. A careful study of these reports prior to the opening of the convention proceedings will prove of immense value in the discussion of the respective problems within the range of the report.

The 46th Annual Convention of the Zionist Organization of America, the second war-time gathering of American Zionists, will be of historic significance. The latest developments on all war fronts have led to a revision in the general estimate regarding the extent of the war's duration. Not a minute must be lost in bringing our post-war demands to the attention of the United Nations and in formulating in clear and unmistakable terms our program for presentation at the peace conferences. The forthcoming convention as the voice of American Zionists can, therefore, be expected to present to the world our unequivocal demands relating to the future status of Palestine and the post-war Jewish position throughout the world.

We trust that you are making your plans now to attend all the sessions beginning Saturday evening, September 11th.

I shall appreciate to be enlightened by you on the following points:


1. Is the Emergency Committee for Zionist Affairs today, and does its set-up assure for the future, that this body is fully empowered to formulate and conduct all diplomatic negotiations with the various Governments?
2. Will the Emergency Committee for Zionist Affairs be the only authorized spokesman in dealings with the various Governments and with the Statesmen of those Governments, whose support we require?
3. Will the Co-Chairmanship of the Emergency Committee give you adequate opportunity to render such service to the Jewish People, as you feel you are able to?
4. Is there the danger, as you see it, that a divided authority in the Chairmanship of this Emergency Committee may create disention and therefor act to the disadvantage of the united voice of American Zionists?

Will you furthermore authorize me to publish my letter and your reply in the Newsletter, published monthly by our District?

ZIONIST CONVENTION TO BE HELD IN COLUMBUS AS SCHEDULED

Plans for the 46th annual convention of the Zionist Organization of America, to be held in Columbus, Ohio, September 11-13, are proceeding according to schedule, it is declared in a statement issued this week by the national Z.O.A. headquarters. Unauthorized reports appearing in the press to the effect that the site of the convention had been changed to Atlantic City are said in the statement to be erroneous.

Mr. Simon Shetzer, Executive Director, declared that the Deshler-Wallick Hotel, Columbus, Ohio, in which all sessions would be held, possessed all the necessary requirements for accomodating comfortably a large convention.

Sessions will be devoted to a discussion of current and post-war problems confronting Palestine and the Zionist movement, to plans for intensification of the participation by Zionist members in the all-out war effort of the United Nations, and to formulation of a program for expanding the work and influence of the organization.

1. The United Nations are engaged in a war for survival. As Americans and as Jews, we seek, first of all, the victory of the forces of democracy, of equality and of freedom over those of tyranny and brutal aggression to the end that men everywhere may enjoy the Four Freedoms—Freedom of Worship, Freedom of Expression, Freedom from Want, and Freedom from Fear.

•

2. For the uprooted and despoiled Jews of Europe, who were the first victims of the assault against democracy and civilization, we demand that relief and rehabilitation be provided at the earliest possible moment. Those who desire to return to their countries of origin must be enabled to do so; while opportunities for migration and settlement must be afforded to others who will wish to emigrate and begin life anew elsewhere. On behalf of the Jews in European countries, we demand, further, full equality of rights with their fellow countrymen as individuals. In those lands where group rights shall be granted to others and where the Jewish population involved desires such rights for themselves, we urge full equality of status; and we urge that guarantees to this end be provided by the United Nations.

•

3. We want an end to Jewish Homelessness. Now more than ever Palestine pro-

vices the most practical answer to the desperate need of the multitude of Jews whose rescue from Europe, as soon as possible, is imperative in a physical as well as in a spiritual sense. We ask that the Jewish people, too, shall have the opportunity to live and to develop as a free people in its own historic homeland, in Palestine. We demand that the gates of Palestine be opened wide on a scale commensurate with Jewish need; that all limitations on land settlement by Jews be removed; that the Jewish Agency for Palestine be vested with control of Jewish immigration into Palestine and with the necessary authority for the upbuilding and development of the country; that Palestine be established as the Jewish Commonwealth, in which Jews will be a majority of the population—a self-governing and democratic commonwealth in which the civil and religious rights of existing non-Jewish communities will be assured, and bound only by those reservations which in the post-war world shall apply to all states.



4. We ask, finally, that the Jews, through appropriate representation, shall be accorded the right to place their case directly and officially before any peace conference that may be called, or any authority designated by the United Nations for the reconstruction of the post-war world.

Your attention is directed to the following pertinent sections of Article VIII of the Constitution of the Zionist Organization of America relating to the election of Delegates to the Annual Convention:

SECTION 3 --- Each District or Society shall be entitled to one Delegate to the Convention for each 50 paid-up members in good standing

SECTION 4 --- Each Region shall be entitled to one Delegate for each 1,000 members, and major fraction thereof, in good standing, but in no event less than one Delegate.

SECTION 6 --- Delegates to the Convention shall be elected only by paid-up members of the Zionist Organization of America.

SECTION 7 --- No member shall be elected as a Delegate to the Convention unless he has been a member of record of a District or Society for at least six months prior to the election, and at the time of election is a paid-up member in good standing of the Zionist Organization of America.

The following rules for the election of Delegates and Alternates, adopted in 1940, pursuant to Article VIII, Section 8, by the Executive, with the approval of the Administrative Council, continue in effect:

1. No person shall be granted a credential as Delegate or Alternate to Conventions of the Z.O.A. unless (a) he shall have been duly elected by a District, Society or other duly constituted elective body, and (b) his election shall have been certified to the National Board of Elections by written certifications, as set forth below, no later than Monday, August 16th, 1943.
2. (a) Delegates and Alternates of Districts, Regions, Societies, Camps of the Order Sons of Zion, and Masada Chapters, shall be elected by the members thereof at an election which shall be held pursuant to regulations promulgated by the National Board of Elections.

(b) Delegates and Alternates of Regions shall be elected at a conference of representatives of all constituent bodies in the Region.

(c) Delegates and Alternates of affiliated organizations shall be elected as provided in their respective agreements with the Z.O.A.

(d) In no case shall proxies or substitutes be permitted for any duly elected Delegate or Alternate who fails to appear in person at the Convention. Hereafter committees on vacancies, whether local or national, shall be unauthorized.
3. Certification of the election of Delegates and Alternates shall be in writing subscribed by the President or Vice-President and the Secretary, or by the local Board of Elections of the District, or other elective body, and if so certified by the local Board of Elections, shall be accepted only if the members of the local Board of Elections and of the officers of the District, or other elective body, shall have filed such returns with the National Board of Elections no later than Monday, August 16th, 1943.
4. What constitutes a member in good standing? Any member, old or new, who has paid his dues in full within the twelve-month period, preceding August 31st, 1943, is a member in good standing of the Z.O.A. and is eligible to vote for Delegates to the Convention.

Will you, therefore, kindly call a meeting of your Executive Committee at which a Nominations Committee and a Board of Elections, each to consist of a minimum of five members, shall be elected.

Every registered member who has paid his dues for the year 1942-43 should be notified of the date and place of the elections and also of his right to nominate candidates by petition. Nominations may be made by petition over the signatures of not less than 15 members in good standing.

All nominations, whether by the Nominations Committee or by Petition, are to be filed with the District Board of Elections, one week prior to the date of election, which shall accept these nominations and place all names in alphabetical order on the official ballot to be printed by the Board of Elections.

The number of Delegates to which a District, Region, Society or Camp of the Order Sons of Zion is entitled, is to be determined by the number of members in good standing as of August 31st, 1943. The membership record of the District, Region, Society, C.S.Z. Camp, must agree with the records of the Comptroller's Office of the Zionist Organization of America.

No District, Camp, Society, or Masada Chapter having less than fifty members in good standing is qualified to elect a Delegate. Pooling the membership of one or more Districts, Camps, Societies, or Masada Chapters in order to acquire a total of fifty is not permissible.

The number of Alternates that may be elected shall not exceed the number of Delegates.

A member who is in good standing in one of the affiliated organizations (Order Sons of Zion, etc.) and who is also a member in good standing in the Zionist Organization of America, can vote only once for the election of Delegates to the Convention.

The Election of Delegates to the Convention may be held at any time hereafter but no later than Sunday, August 15th, 1943.

In all cases where more than two Delegates are to be elected, a member shall have the right to vote for only two-thirds of the entire number of Delegates. Voting shall be by secret ballot. The candidate or candidates, receiving the highest number of votes, shall be declared elected. The candidate or candidates receiving the next highest number of votes, shall act as Alternates. In case of the resignation of an elected Delegate, the Alternate receiving the next highest number of votes shall take his place as Delegate.

No Delegate or Alternate will be seated unless his election is certified by the National Board of Elections.

The official Election Report properly filled out and certified by the local Board of Elections must be filed with the National Board of Elections of the Zionist Organization of America, not later than Monday, August 16th, 1943, in order that credentials may be issued in time to the elected Delegates.

The Election Report of the affiliated groups must be filled directly with the National Board of Elections of the Zionist Organization of America in order that such Delegates may receive their credentials from the National Headquarters of the Zionist Organization of America.

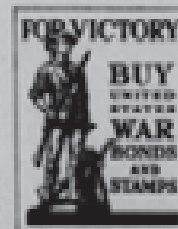





Thank you for your letter of October 7. I wish I could be with you for the Balfour Day Celebration, but as you probably know, I am scheduled to address the Hadassah Convention in New York on October 28. I think that is enough speaking for one week-end.

I have made plane reservations in order to arrive in time for the ZOA Executive Committee meeting on October 16. If I am pulled off the plane it will mean that I will not arrive until Sunday morning. I have made reservations both on the plane and on the train.

I am glad that you are going to call on the British Embassy. It is important to stress with the Ambassador not the guilt or innocence of the man, but the provocative nature of the trial, the planned publicity in connection with it, etc., coupled with the last act, the sentencing of Eliahu Sacharoff to seven years because there was found in his possession a single bullet more than he was entitled to have. Such trials have a way of inciting a population to bitter resentment which frequently culminate in riots and disturbances which everybody deprecates.

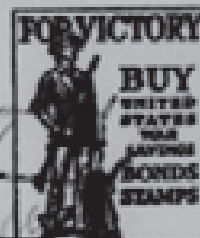



The American Zionist Emergency Council is about to engage upon an enlarged program of Zionist public relations. The principal item on the agenda at this time is the mobilization of American public opinion against the White Paper which, unless abrogated within the next several months, becomes effective on April 1, 1944, thus closing the doors of Palestine to further Jewish immigration.

The effectiveness of this program will depend in large measure upon the extent and the alertness of community participation and upon the readiness of local Zionist leadership to assume very definite responsibilities immediately.

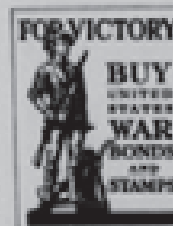
The Emergency Council has requested the Zionist Organization of America to take the initiative in organizing this community participation. We urge you, therefore, without a moment's delay to get in touch with the local officers of the Hadassah, the Poale-Zion and the Mizrahi. Invite them to a meeting within the next forty-eight hours and set up a local Emergency Council similar in character to the national body. The next step is to invite other persons in the community with special training, experience, aptitude and interest in public relations work to join the committee, which, however, must remain small and compact in order to operate quickly and effectively. A committee membership of not more than ten or twelve should be sufficient for these purposes.

Select a Committee Chairman and communicate the names and addresses of the entire committee personnel directly to Rabbi Leon Feuer of the American Emergency Council, 41 East 42nd Street, New York, 17, N. Y. Send a copy to our Washington office. Rabbi Feuer will advise the Committee Chairman forthwith, providing the committee with information and such other direction as may be required. As the program proceeds the members of our Z.O.A. field staff will be called upon to assume an important role in its implementation.

I cannot urge upon you too strongly the immediacy of this project. The current political situation will permit no delay. Prompt action is imperative. I have every confidence that you will take this great Zionist responsibility seriously to heart.

Dear Rabbi Silver:

The enclosure speaks for itself. And in order to organize the machinery to offset what we consider here the beginning of a national campaign, we must have your immediate attention and your support. Unfortunately, we are not capable in Houston of producing a leader around whom we can rally to such an extent that we would not have to call upon outside assistance. But this is by far, what I consider, too important an issue to be gleaned over lightly and neglected.

I am addressing a similar letter to Henry Monsky, Dr. Israel Goldstein, Mr. Freehoff, James G. Heller, Henry Montor, Maurice N. Eisendrath, Maurice Rosenberg, and other interested individuals to whom we look for support in our protest of the actions and the methods by our local group.

We cannot overlook the entrenchment these men have. The leaders in this movement here are all financially able, and because of their financial status have been accepted as the leading spirits in the community. Their machine is well oiled; their scruples, if they have any, are not in evidence; they have resorted to fascist methods in electing Schachtel; and they will not hesitate to stoop to any other measure to gain their ends.

I am interested in seeing what can be done, and I am devoting my entire time to organizing the opposition to them. We only have the three weeks in which to crystallize the thinking of a congregation of some 800 people, 75 per cent of whom are indifferent and from whom we must get our chief support.

My suggestion is that Henry Monsky come down here (and this is a must) under the auspices of B'nai B'rith, which I can arrange immediately upon receipt of word, and that he speak under the auspices of B'nai B'rith concerning B'nai B'rith activities

and in the time that he is here, we will try to get a small group of men whom he can influence directly in this attack on Judaism. Also I am to see Mr. Weingarten, and I believe it is his opinion, as well as mine, that if we can get Rabbi Heller the Sunday before the meeting, the 21st, we will have a city-wide meeting in the interest of the American Jewish Conference demanding of the Temple group the right to use the Temple for the meeting, and he can speak concerning the American Jewish Conference. Also during his stay, as the immediate past president of the Central Conference, it could be arranged that a group of the members could meet with him and he could discuss the problems on hand.

I have not given full consideration to the exact procedure nor have I given thought as to the possibilities of other individuals as I feel that those I have mentioned would prove an effective means of cementing our opposition group to the task of "beating" this first attempt at an organized breaking-down of what we have tried so hard to build up.

My dear Dr. Silver:

You will be interested, I am sure, in the enclosed copies of letters from Mr. Mortimer May of Nashville and Mr. Ike Abelson of Birmingham, both commenting upon the activities of the Rev. Richard Evans in their respective communities on recent dates. Rev. Evans, as you may know, was engaged by us some months ago for public relations activities. He is constantly out on pre-arranged tours addressing as many as two and three audiences a day. Most of these audiences are non-Jewish including Rotary, Kiwanis and other service clubs, Ministers Associations, Chambers of Commerce, veterans groups and the like. In no instance do we schedule an address before a Zionist group or in a synagogue unless one or more non-Jewish meetings have been arranged for him.

Before we engaged Rev. Evans, Judge Levinthal and I recommended him to the Emergency Committee. We took him on when the Emergency Committee failed to act.

In view of the fact that Mr. Evans' services fall peculiarly within the public relations program of the Emergency Council, do you not believe that some fair arrangement should be worked out for sharing his salary and expenses? I shall be glad to have your thoughts on the subject.

Gentlemen:

Yesterday afternoon and last night we heard addresses from the Rev. Richard Evans. The address at noon was to a small group, largely of Gentiles and included educators, clergymen and some men in public life. The impression made was most revealing in that a message was brought to certain individuals who are eager to help us but poorly informed as to what they can do and how. The evening meeting was of a more general character and nearly altogether Jewish.

One particular interest developed from both the meetings and my own thought is that if the Rev. Evans had accomplished nothing else on his whole Southeastern trip that the value of this one incident would be worth the whole trouble and expense. I refer to the fact that George Harold Earthman, Murfreesboro, Tennessee, was present at both meetings. He is a man of large political influence, not only in his own part of the state but pretty generally everywhere. As a matter of fact, he is spoken of as a candidate for Governor next year. In addition to his political influence, he is a very ardent churchman and feels that both on the authority of the Bible and the necessity of the immediate situation that the Jews must be given Palestine and he is ready to do anything in his power to be of help in this State or elsewhere. He was so much impressed by what Dr. Evans said at the first meeting that he attended the second and then came out to the home of Mr. Percy Cohen, our District President, after the speaking to go further into the matter. Judge Earthman visits Washington frequently; he knows all the Tennessee delegation both in the House and in the Senate quite intimately and I feel too is close to the ear of Secretary Hull. Now I have a promise from Judge Earthman that when he again goes to Washington that he will let me know and I want him to be able to meet Dr. Abba Hillel Silver, as I believe through his political relations and his sincere religious interest that he is a valuable man to us. I feel this particularly on account of the fact of his relations with Secretary Hull.

I shall try to keep in touch with Judge Earthman so as to get an idea when he may be in Washington next.

I was very much impressed by the particular type of work that Rev. Evans can do and it seems to me that he ought to remain in the service of the ZOA and maybe in the Emergency Council. On account of his position as a Presbyterian minister and the fact that he is so ardent and sincere in his convictions and beliefs as to the solution of the Jewish problem, he enjoys a strategical advantage that is not given to anyone of our own group. His talents should be employed, in my opinion, in reaching more and more Christian groups who do not understand our means and our aspirations but to whom the Rev. Evans can bring this in a way that no Jew can do. Particularly during these trying times, his talent should be used, in my humble opinion in that way.

He has made and is continuing his tour in the Southeast and all the reports that I have had have shown that he has awakened an unusual interest in every community that he has visited. I may again restate that, if he has done nothing else in the last several months than interest Judge Earhman the way he did, in my opinion, his trip would have been more than successful.

I am sending a copy of this letter to the Emergency Council.

Reverend Richard E. Evans arrived in Birmingham at noon Sunday and left for Memphis at 1:00 P.M. today (Monday). During the twenty-four hours that he was with us he did an exceptionally good job. He addressed a meeting Sunday night at Beth-El Synagogue at which there was an attendance of close to 500. He made a deep impression on all who listened to him. He presented a replica of the Bill of Rights to the President of our City Commission who was present at the meeting and sat on the platform. The President of the City Commission, Mr. Cooper Green, promised to have a resolution passed by the City Commission urging the abrogation of the White Paper.

After the meeting a group assembled at the home of Mr. and Mrs. Max Harvich. Those present were inspired by Reverend Evans and the result was an eleven minute radio broadcast this morning; and, allowing for difference in taste in reception of radio addresses, I believe that he did the most effective piece of work done in Birmingham in a long time in the interest of Jewish Palestine. He was interviewed by representatives of the two afternoon papers but it was too late to appear in today's editions. From the above you will see that his time here was utilized to the fullest extent and I can honestly state that I know of no one who could have made a better impression on his listeners than did Reverend Evans.



I gratefully acknowledge your kind letter of December 3rd with reference to the resolution adopted by the St. Joseph County, Indiana, Congress on Post-war Peace.

We know what a busy man you are and how many demands are made on your time, yet we hope you may think it worth while, as this group represents the most substantial elements of our community, and we hope will have far reaching effects, as the

clergy of this County are planning to set aside one Sunday when the abrogation of the "White Paper" will be advocated from every pulpit and resolutions with signatures of the church members, which will be forwarded to Congress at Washington.

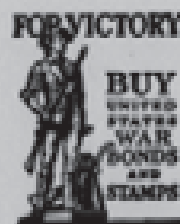



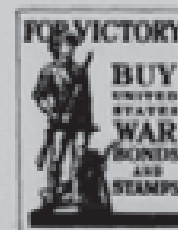

RESOLUTION ADOPTED BY THE EXECUTIVE OF THE
ZIONIST ORGANIZATION OF AMERICA
SATURDAY, JANUARY 22, 1944

In view of the political importance attaching at this time to resolutions and statements of principles regarding Palestine adopted by national Jewish organizations and important groups in American Jewish life - and in order to insure co-ordinated political action,

BE IT RESOLVED by the N.E.C. of the Z.O.A. that it is incumbent upon all Zionists having relations with non-Zionist groups to act with utmost circumspection and to refrain from entering upon negotiations or committing themselves by giving support or assent to any political formulation regarding Palestine different from the official Zionist formulation, without prior consultation with the American Zionist Emergency Council or its officers.

BE IT FURTHER RESOLVED that the N.E.C. recommend the adoption of similar resolutions by all other organizations affiliated with the American Zionist Emergency Council.





Dear Harry:

I note what you say, and I wish you to know that I am strongly and unchangeably against your program. We of the Zionist Organization and the American Jewish Conference cannot take the position that we did with regard to the so-called Emergency Committee to Save the Jewish People of Europe, and in Chicago cooperate with them for any reason whatsoever. Surely it is not important enough to win a few people in Chicago to make it worthwhile bowing to the dust in order to deal with people for whom we have no respect, and whom ultimately the American community will come to know!

You are making a grave mistake. I am sure that when Dr. Silver knows of the program, he will feel as I do about it. He has been strongest in his insistence that we shall not touch -- let alone traffic! -- with these gentlemen. I confronted one of their chief representatives, Mr. Johann Smertekko, in Los Angeles. They are not to be trusted. They are not decently honest or trustworthy. Moreover, as Zionists we ought to stay a million leagues away from them. Berkson and his crowd are of the Irgun, and after all they are the violentest branch of Revisionism. As an old friend, I beg you, I warn you, not to ~~do this~~ ^{make this} great attempt at compromise, which will ultimately lead to disaster, and lead immediately to the wrong of dealing with people whom we cannot conceivably respect.

Dear Fellow Zionists:

The four-day hearings on the Palestine Resolution (H.R. 418-419) before the House Foreign Affairs Committee have just been adjourned following testimony by advocates and apponents of the bill. The presentation of our case by our leaders was marked by powerful and incontrovertible arguments, backed by the historic justice of our claims and the impelling logic of our position.

The hearings have shown that the case for a Jewish Commonwealth in Palestine commands substantial support both in the Committee and in the House. The bipartisan sponsorship of the resolution, the sympathetic attitude of the Committee's Chairman, Congressman Sol Bloom, and the unanimous expressions of support which were recorded with the Committee by many members of the House are indicative of the favorable sentiment toward the pending resolution.

However, to our great shame, there arose out of the midst of our own community enemies of our cause who appeared before the Committee and joined with Arab spokesmen in an effort to frustrate our historic claims. These were the successors of the men who repulsed Herzl, those elements, who in Germany proclaimed themselves as Germans of the "Mosaic faith" and the same foes who opposed the Balfour Declaration in 1917 and the Joint Palestine Resolution adopted by the U.S. Congress in 1922. Having forgotten nothing and learned nothing, these inveterate enemies of our cause, organized through the so called American Council for Judaism, have dared to come before the House Foreign Affairs Committee with their timeworn and hackneyed arguments to dispute the historical justice of the Zionist cause.

Whereas the Arab witnesses openly defended the White Paper, the representatives of the Council for Judaism, through subtle methods, endeavored to win over the members of the House Committee by professing support for the first part of the resolution which deals with immigration, but opposing the establishment of a Jewish Commonwealth.



They know very well that these two parts of the resolution are inseparable - that without such a political foundation, immigration into Palestine, land acquisition and colonization would be at the mercy of the Arab majority. Unless Palestine be reconstituted as a Jewish Commonwealth the present Jewish community in Palestine will be frozen into a permanent minority and all hopes for further immigration of Jews are wholly illusory. The attitude of the American Council for Judaism is in this sense even more dangerous than the undisguised stand of the Arabs against Jewish immigration altogether. They must know, however, that they are waging a losing battle.

The hearings before the House Foreign Affairs Committee have proven conclusively that the aggressiveness of our enemies has gained in tempo, as they work overtly and covertly to poison the wells of public opinion against us. Never was there need for such all-out vigilance on the part of every Zionist and friend of our movement as today. We are only in the first stages of our battle. The passage of the Palestine Resolution by both Houses of the U.S. Congress is imperative for the salvation of our people.

Prompt and effective action must be taken to counteract the efforts of our enemies. Not a minute must be lost in demonstrating to the members of the Committee and of the House that American Jewry is overwhelmingly behind the resolution. You, as leaders of our movement in your community, have a great and historic task to perform:


1. Mobilize immediately your entire Zionist constituency with a view to having each one of them send wires and letters to your Congressmen and Senators requesting their support of House Resolution #418-419 and Senate Resolution #247.
2. Urge your Congressmen immediately to communicate their support of the Palestine Resolution in its entirety to Mr. Sol Bloom, Chairman of the House Foreign Affairs Committee and to the other members of the Committee. Emphasize that the provisions of the Resolution are inseparable. The Commonwealth portion is the heart of it. Unless Congress approves the whole resolution, as is, the portions dealing with immigration and colonization are mere empty gestures.
3. Ask our Christian friends to send similar messages.

The importance of such wires and communications has been underscored by testimony before the Committee as Congressman after Congressman appeared before the hearing, submitting telegrams they have received from their constituents.

ACT NOW! Tomorrow may be too late.

Please advise me what steps you have taken in this matter. It would be helpful if you would indicate approximately how many letters and telegrams have been sent from your community.

The situation calls for prompt and drastic action. To assure the passage of the Resolution, it is imperative to enlist the sympathetic attitude of the Executive Branch of our Government. To this end, an indication by President Roosevelt of his favorable attitude towards the Palestine Resolution would, we are persuaded, inspire Congress to act affirmatively thereon.

It is, therefore, most desirable that President Roosevelt be urged in a stream of telegrams and letters from all parts of the country, to communicate such an attitude to the Congress. Accordingly, we suggest that, in conjunction with all other Zionist groups in your community, you call immediately a public rally which should result in the following measures:

1. The adoption of a clear and unequivocal Resolution placing the entire community on record in favor of the adoption of the Palestine Resolution now pending in Congress.



2. Urge all Zionists and the entire Jewish community to dispatch individual wires and letters to the President of the United States at the White House urging his support of the Resolution, this being in harmony with the traditional policy of the United States as embodied in the Joint Palestine Resolution adopted by the 67th Congress in 1922. (I am enclosing herewith for your information copy of a wire which was sent to President Roosevelt in behalf of the Z.O.A. over the signatures of Judge Louis E. Levinthal and Dr. James G. Heller).

3. It is important that telegrams and letters be sent to the President by the Mayor of your city and other city officials as well as by leading Christian clergymen, educators, and laymen in your community.

4. Have your public relations chairman contact immediately your local newspapers with a view to the publication of favorable editorials addressed to the President of the United States. Copies of such editorials as well as statements by public figures should be forwarded directly to the White House. In a like manner, all resolutions already adopted and to be adopted by various organizations in your community, both Jewish and Christian, should be forwarded to the President in Washington.


5. Every Zionist should constitute himself as a committee of one to carry on this sacred battle by inducing his friends and neighbors, Jews and non-Jews, to act likewise.

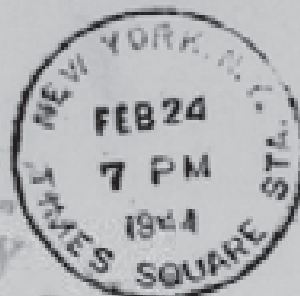



P. S. I might mention that I have just returned from a luncheon at which the Hon. Will Rogers Jr. was guest speaker. I had the opportunity of a chat with him after lunch, about the fate of the resolutions in the House and it was his opinion that all the confusion created amongst the members of the Committee by the Jewish protagonists in connection with a Jewish Commonwealth, created this delay which gave "The Military" inspired by the British Embassy and the State Department, the opportunity to oppose the resolutions. If we had pressed harder for "The Open Door" and left the problem of the Commonwealth to be determined after the war, the objections which came up, might not have arisen. We would at least have had free immigration. I mention this for what it is worth. You are probably more familiar with the situation than I. This is the opinion of Rogers, who is not in sympathy with the objections raised by "The Military."

You will be interested to know that I was instrumental in arranging a meeting for the Canadian Palestine Committee with our Canadian Prime Minister in connection with our representation at the coming Imperial Conference. We were accorded a very fine reception in response to a well-prepared brief. The

Prime Minister of Canada indicated his sympathy with us and his readiness to support our claims at the coming Imperial Conference.

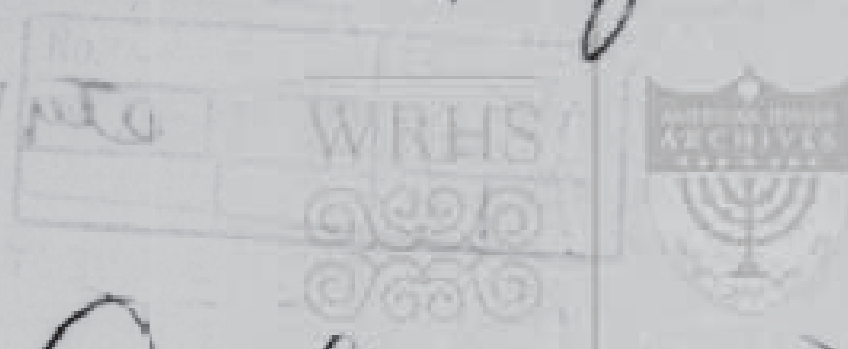



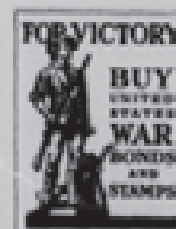

While the situation relating to the Palestine Resolution pending in the U. S. Congress is in a state of suspended animation due to the intervention of the military authorities, Zionist activities in Washington have not been relaxed. The pace of the effort to secure the abrogation of the White Paper and in the direction of the long range objective, - the establishment of Palestine as a Jewish Commonwealth, has not been slackened. Constant touch is being maintained both with the Executive and Legislative branches of the U. S. Government and the utmost and continuous vigilance is being exercised for safeguarding the interests of our people.

In view of President Roosevelt's recent statements to the effect that military considerations alone have dictated the present attitude of the Executive branch of the U. S. Government towards the Palestine Resolution, we are hopeful that as D-Day draws near portending a decisive turn in the military situation, conditions will warrant positive action on the Palestine Resolution on the part of the U. S. Congress.

At the same time our endeavors will also be directed toward securing the support of both the Democratic and Republican parties for our program and, if possible, to have it incorporated as part of the platform of both parties at their forthcoming national conventions.

Efforts to secure the adoption of pro-Zionist resolutions in the State Legislatures and by various civic and religious organizations should continue.



Our slogan for every day is: Carry on the fight for the abrogation of the White Paper and for the establishment of Palestine as a Jewish Commonwealth.

Pursuant to the ZOA directive urging initiative in the establishment of community councils to carry through on the local level the public relations policies formulated by the American Zionist Emergency Council on behalf of the ZOA and the other Zionist bodies, ZOA district leaders have taken the lead in mobilizing public support for the Palestine Resolution. This activity should be carried on without relaxing even for one moment. The fate of our people and the future of Palestine are at stake.

2. Challenge of "American Council for Judaism"

In conjunction with our work in the field of education and public relations, ZOA districts should not neglect to meet the serious challenge confronting our movement as a result of the activities of the so-called "American Council for Judaism." Their appearance before the House Foreign Affairs Committee by the leaders of this group in opposition to the Palestine Resolution was a depressing spectacle indeed. The menace presented by this group should not be underestimated even though they comprise a negligible minority in American Jewry.

Unfortunately, many of our own Jews are misled by the propaganda of the Council. Reports received in the national ZOA headquarters show that even enrolled Zionists tend to minimize the dangerous aspect of the type of arguments employed by the Council. In a subtle manner the propaganda of the Council for Judaism attempts to convey the impression that the group is not opposed to Jewish immigration into Palestine. This is intended to lull many into the belief that they are espousing Jewish settlement in Palestine. However, it should be borne in mind that the establishment of a Jewish Commonwealth in Palestine which they so strenuously oppose constitutes the major and basic plank in the Zionist platform which was endorsed by the overwhelming majority of American Jewry through the American Jewish Conference. Without the status of a Jewish Commonwealth, Palestine will lack political foundation. Without such foundation, the entire Jewish national structure will be jeopardized and the future of Jewish immigration into Palestine will be at the mercy of others.

3. Our Immediate Tasks

The main and immediate tasks confronting our ZOA districts are as follows:

- a. Maintain the closest contact with and representation on your local Zionist Emergency Council. In communities where no such body is functioning, the ZOA district leadership should assume the lead in mobilizing community-wide support for Zionist projects in line with the directives received from the American Zionist Emergency Council and the ZOA;

b. See your Congressman and Senator as well as the candidates for office with a view to eliciting commitments to support the Palestine Resolution;


c. A numerically strong ZOA will give your organization weight and authority. Devote the months of May and June to the reenrollment of your members in arrear and to the enlistment of the largest possible number of new recruits. The attainment of our 150,000 membership goal before our convention will make the ZOA the premier and largest Jewish organization in the world;

d. Every effort should be made through the medium of literature and the platform, to combat the activities of the American Council for Judaism in your community. The national ZOA headquarters is prepared to furnish you with adequate quantities of pamphlets calculated to answer and counteract the propaganda of the Council. These brochures include: "The Answer" by Dr. James G. Heller; "The American Council for Judaism" by Rabbi Jacob J. Weinstein; "Pathological Jews" by Dr. Israel Goldstein; and "The Jewish Commonwealth - our contribution to a better world" - a collection of articles by Ludwig Lewisohn, Judge Bernard Rosenblatt and A. K. Epstein; and a reprint of an article by Maurice Samuel;

e. The need of educating the non-Jewish public to the problems of our people has never been so important as now. There have been published recently a number of books which are powerful media for bringing an understanding of these problems to the general public at large. I refer to "The Forgotten Ally" by Pierre Van Paassan, "Breathe Upon These" by Ludwig Lewisohn, and "Palestine Land of Promise" by Walter C. Lowdermilk. Copies of these books may be obtained from the Book Department at our national ZOA headquarters. You are urged to do everything possible to promote the sale and distribution of these books in your community.



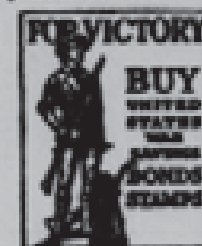

A commercial, which will be part of the program, will stress and factually document the specific contributions of the Zionist Organization of America to the particular phase of achievement in Palestine with which the story is concerned.

Time will be allowed at the end of the program for an announcement which will feature your District and which will ask the listener to drop a postal card to the Z.O.A. District care of the radio station to which he is listening asking for more information on the work of the Z.O.A.

Each program will feature a distinguished star of stage, screen or radio. Ben Grauer is our regular announcer for the full series and we have already produced program featuring



Joseph Schildkraut, Judith Evelyn, Gene Kelly, Victor Jory, Anne Seymour and J. Edward Bromberg. In addition we have commitments from a great many stars such as Spencer Tracy, Edward G. Robinson, Eddie Cantor and many, many others for production within a short time.

We are in the process of preparing a radio book and prospectus for your use and guidance in getting these programs on the air. We have found that the stations in big cities like New York, Philadelphia and Boston are willing to offer free time just to get these programs because of the names of the stars and the quality of the programs. All the details have been worked out very carefully with the best radio brains in New York City.

At the present writing we wish only to advise you of this activity and also to ask that you appoint in your city a chairman of the radio project and forward his name immediately to our office.


Needless to say, this activity will require some small financial support on the part of each of our districts which want to participate in getting the program on the air in their own cities.

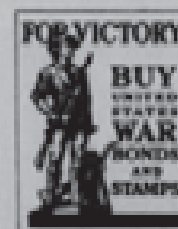

Dear Harry;

Several hours ago I was told that the American Council for Judaism is to make its stand in Houston October 28-29 & 30. A general meeting is planned for Sunday, the 29th. This meeting will be addressed by Lessing Rosenwald and Berger. Other than this particular phase of their visit I am not familiar with and, therefore, can't tell you what else is being planned. I do know, however, that the plans are for a thorough canvass of the city, and to reach every Jewish home for the general meeting. The place and hour of the meeting are unknown at this writing. Schechtel is in charge of publicity, and I am confident he will plaster the town.

I have just spoken to a number of our men, and the rabbis, and they are of the same mind with me - that we must do something to counteract them and do it on a scale larger than our opposition. I feel that we should schedule a public meeting for either Tuesday or Wednesday, Oct. 31 or Nov. 1, with an outstanding speaker, or speakers, to both refute and to encourage and build our Zionist following. This must be done immediately, and the answer from you must be made in the shortest possible time so that we can lend our every effort toward making our meeting one which will certainly be long remembered in the annals of our Jewish life in Houston.

You know the situation here. This is a battleground, and Berger purposely has been goaded into action by what we have done and what we are doing in the city. I feel that they are going to give their big guns a play, and a great deal is going to depend on the answer we give them.

I want your fullest cooperation in having come to Houston at the time suggested either Rabbi Abba Hillel Silver, Rabbi James G. Heller (who did such a remarkable job on his last trip), or a man of equal calibre. If this is going to be made a test, we want to meet it, and meet it on such terms as people in this community and surrounding territory



Because Columbus is so close to Cleveland, being only a three hour ride on the train, it would not take you away too long from your work in Cleveland. I sincerely hope that I can give a favorable reply to my Zionist associates, who are also anxiously awaiting to hear from you.




The New Hampshire Zionist Federation is to hold its Conference in Portsmouth on Sunday, June 24.

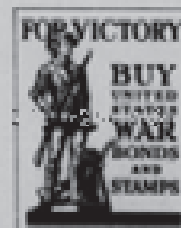

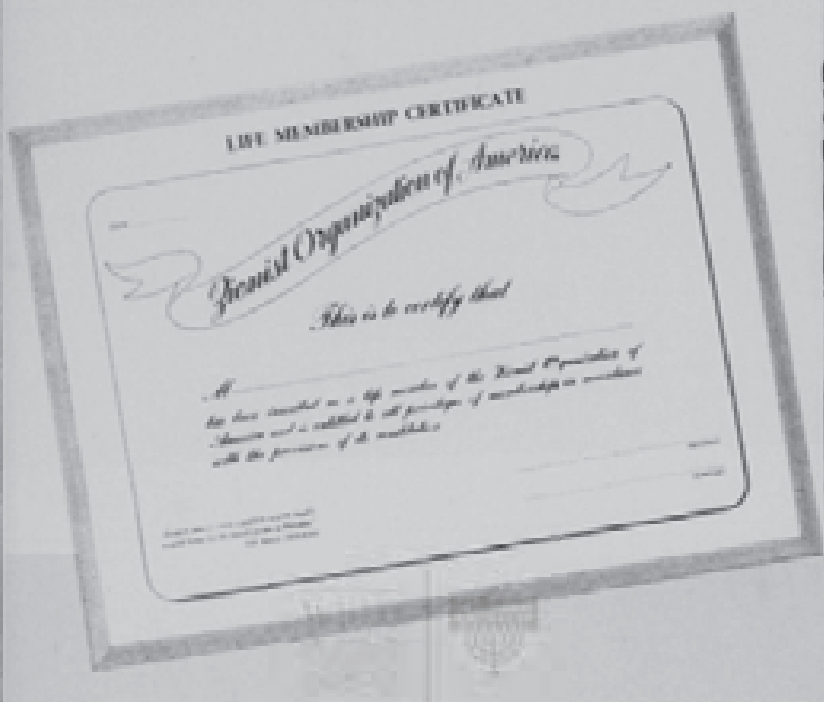

THE INDICENTS OF ZIONISM

1. The political nature of Zionism is driving a wedge between the Jews and the English. On the very day that Churchill visited Boston, the papers carried Zionistish slurs against the English. This is being ungrateful and narrow minded, and is subjecting us to dangerous reprisals. The English came to Palestine only to stop riots. The withdrawal of the English from Palestine is unthinkable and even the Zionists should see that. Except for a headache, what does England get out of Palestine? England is the godmother of contemporary Jewish settlement in Palestine. England was the first to stop the tyrannical Hitler hordes, who would destroy Jews everywhere. It was England who stopped Huns, practically at the gates of Palestine. Jews have prospered and become great among the English in the past. Our hopes for the future also are greatly dependent upon the cooperation and kindness of the English Empire. All thinking Jews thank, salute and bless the English.

2. The Zionists have created an immense lobby to further their political schemes. They have lathered cabinet members, senators, congressmen, governors, industrialists, professional men, generals and others. They promote, men and women, mass meetings, house parties, luncheons, conventions, congresses, conferences, under various names. Their newspaper publicity is greater than that of any non-Jewish group in America. It is greater than that of all other Jewish activities combined. They should save some of their emotion for America. We are American Jews and not Palestinian aliens. The Jewish Conference, held in New York, on paper supposed to represent sixty-five Jewish organizations, in reality was handled from its very inception as a camouflaged Zionistish oratorical contest, and that's all that was accomplished. What is it the Zionists want from us, Jews as well as non-Jews? If it is money they want, we would give it to them for a good purpose, subject to an accounting, but they don't ask for money. They get money deviously by means of our combined fund raising appeals. They are really looking for the impossible, a deed from England to someone else's property when the property is on fire and England has all it can do to put out the fire first.

3. Certain parties in Zionism want a Jewish army. If a Jewish army, why not an Arabian army also? What a chance that would be to revive wars that ended so catastrophically for us 3000 years ago. Palestinian Jews are welcome to fight in the English ranks and some of them do. The destruction of our enemy in the most effective way, regardless under what flag, is the only thing that matters. Do the Palestinians want a separate Jewish army, or is it an American Zionists' fancy?

4. The Zionists have robbed Jews of great leaders. They now look to non-Jews for leaders. This is something new in politics. It is like asking the Italians to expound the causes of the Crocks. A Jew must speak for Zionism or he is a traitor. To speak against them is forbidden. So today we have no great men with broad vision of the type of Warburg or Kirshtein, who could see the whole Jewish problem. Undoubtedly we have the talent but it will lie dormant as long as it is stifled by Zionism. Our great scientist Einstein who at one time showed interest in the movement, found it necessary as others have done, to take cover in seclusion from the extremists, those who have created perpetual emotion. We Jews have a symphony of problems all over the world, but the single flute of Zionism is so loud and constant that the rest of the orchestra cannot be heard. Their partiality for Zionism is so strong that they are prejudiced against all other Jewish ideas. They are therefore disqualified and should not speak on Jewish problems other than Zionism.

5. Zionist orators storm directors' meetings of our synagogues, and get them to vote their entire congregations in as members of the Zionist party, the body of the members not being present. This is undemocratic. The Zionists have crept into all Jewish institutions, synagogues, schools and organizations. Our schools have become propaganda centers to teach nationalism. They try to make every Jewish organization bend its knee to Zionism. By saying Zionism is their religion only adds to Jewish complications.

6. The Zionist party represents about one per cent of the Jewish population of America, yet they claim all Jews are in sympathy with their propaganda. That is a dream. Naturally all Jews believe in helping Jews, wherever they may settle, and this includes the 600,000 Jews in Palestine. But that is not to be construed that all Jews agree with the means the Zionists are employing. ~~to xxxxxxxx these ends~~

7. Do all the American Zionist activities have the approval of the Palestinians, who have to live there? Let the Palestinians speak for themselves. Let them experiment free from the chaos that would follow the wide opening of the gates of Palestine to millions, as the American Zionists agitate. A building cannot be constructed if the material is constantly deposited on a limited lot. They have a hard enough time to try to create some sort of economic security in Palestine. Culturally also there is the conflict between Eastern and Western ways of life. American Jewry has poured millions into Palestine to help support it. Only about fifteen per cent of the soil of Palestine is arable, without minerals or metals.

Palestine cannot be self-supporting. American Jewry as well as others from more prosperous countries will have to subsidize it, and we should do so for reasonable and peaceful purposes. Men have always migrated towards richer soil. We cannot therefore, to be practical, say that Palestine is our goal. Jews have settled in all parts of the world. Five million of us settled in America --- and without the aid of a political movement like Zionism.

8. The American Zionists want a solution to the peace problem of Zionism now. They want exclusive treatment before consideration of all the other matters that will be confronting the people of the world when Hitler and Tojo are destroyed. While the metal of war boils as does lava in a volcano, it is difficult to see what form it will take as it cools. It is the hope of mankind to have a peace that will be global in scope and fair in judgment. The Jewish question will undoubtedly be one of the problems to solve. We hope to have friends and to be treated fairly after this war as after the last war, if the Zionists will give us a chance, but let us win the war first. Next to religion, the secret of the survival of the Jew through the ages has been his ability to absorb or deflect a blow and, like a good defensive athlete, come up as strong as ever when the worst is over. But now the Zionists want us to reverse that policy and become a militant people. Even great nations deteriorated and were subdued when they trusted on militarism. What chance have we, being a minority? The Jewish policy used to be an appeal to reason, but the most common phrase in the Zionist vocabulary is "we demand".

9. The Zionists are not satisfied that already we have close to 600,000 Jews in Palestine, with a reasonably steady increase. The American Zionists, 4000 miles from the scene, demand a limitless, overpopulated, aggressive, expanding, fighting political state there. But the Arabs are there too, always more numerous, and they do not seem to agree with the Zionists.

10. But the greatest wrong of the Zionists is when they say that the present plight of the Eastern European Jew is hopeless and permanently so, and that Palestine is their only remedy. This is like trying to cure typhus with dope. They choose to judge the future by conditions brought on in war time, and deny to living people a hope for revival of better days in peace time, except on their terms. Zionists are using our Jewish miseries to advance their own nationalism. They have been exploiting our fears, forever crying defeatism. They

will make of us a neurotic, emotional people. Good cases in point are the Boston Garden show and the New York Conference. Do they fear that Zionism can shine only against the dismal background of war but not against normal conditions? Peace will come to all the troubled people of the world. Why should the Zionists deny to Jewry the hope of sharing in a cleansed, sober, better world, wherever they may choose to make their home? Jews have made great contributions to countries in which they lived. They have added zest to the life of the people with whom they associated. On the other hand, Jews were great only when they mingled with non-Jews. Spinoza, Mendelssohn, Karl Marx and Steinmetz, are but a few examples. History does not record great Jews who lived within the walls of a ghetto. For 2000 years we have survived as we are. Why gamble on a change to Zionist nationalism?

CONCLUSION. The Zionists say that to question their activities is a crime against the Jewish people. We must stick together, we must have harmony, especially now, they say. Yes, just yield to them. The Italian leaders said that twenty years ago, and they got Fascism. Revive the ancient glories of Rome, they shouted, as they went to war. Ten years ago the Germans wanted to build a religion around the ancient legend of a Valhalla, and their nationalistic lust turned the world into a slaughter house. The Zionists too are shouting "Blood and soil is Judaism", and where will that lead us? We can see the splinter in the other fellow's eye, but we cannot see the wood in our own eye. Nothing on this earth basically or idealistically lives or invigorates unless it has opposition.

We are now fighting the suppressors of opposition opinion in every jungle, desert, valley, mountain and ocean. We are now fighting the suppressors of opposition opinion for the freedom to say what we please. By what right do the Zionists prohibit expression against their nationalistic lust? Expression of independent thought is the very spirit of enlightened Jewry. It is the foundation of democracy, the indicator of truth. There is talk of a union of England and America, of an international citizenship, and other means of closer mingling of the people of the world. But the Zionists are trying to create a difficult, small, separate country, which may revive troubles we are now trying to end.

This pamphlet is written only because I hope that my small voice will help dissipate the narcotic of Zionism, which dulls our senses and thoughts of helping our suffering people in any practical way which may present itself. It is our duty to help our people re-settle and re-patriate wherever conditions warrant. Palestine may be one of those places under a

democratic, autonomous government, where Jew, Moslem and Christian are equally represented. But for the present, there ought to be a moratorium on Zionism for the duration. They should follow their leader, Dr. Weitzman, who dropped Zionist activities.

The shouting in a major voice "Next year in Jerusalem" is traditional and our forefathers have found spiritual exhilaration in it. That it is more pleasant to travel than to arrive has been proven to us very vividly. Jerusalem is now the shrine of three powerful religions, with hundreds of millions of followers. They would not even think of giving it up to us. If it were possible for us also to build a shrine or a temple in Jerusalem, we could raise enough funds to build one higher than the Empire State building, but if this should ever be realized, it would come only after delicate negotiations. In the meantime, let us face it graciously. We are complimented to have the other religious bodies revere Jerusalem with us. We gave birth to religion in Jerusalem. Therefore let us be the proud parents of the three religions enshrined there. Jerusalem is a matter of the spirit. The present Zionist activities, however, apply to the economic, governmental and military control of other parts of Palestine. ~~These activities are not the concern of the Jewish people in America, who are not responsible for the actions of the Zionists in Palestine.~~

The immediate future of the Jew depends on the outcome of this war, and not Palestine. Let us attend to first things first. The challenge of the Jew is not blind faith in the struggle over a difficult piece of land, as the Zionists would have us believe. The challenge of the Jew was laid down by Moses, who did not enter Palestine, when he gave us the Ten Commandments to pass on to all the people on earth. Our mission is to continue to live among all the people of the world as a perpetual reminder of those laws. Our duty is to be fair and understanding towards other people so that they may learn to be fair towards us.

This pamphlet is mailed only to a selected list of those Jews who have displayed feeling for our people in the past. The Zionists are embarrassing and jeopardizing American Jewry. The country can be told that the Zionist activities represent only the sentiments of that noisy political group, and that they do not speak for all Jews of America. But this can be done only by an organization of national scope interested in the welfare of Jews everywhere, with a character and opinion independent of the Zionists.

RESOLUTION ADOPTED BY THE EXECUTIVE OF THE
ZIONIST ORGANIZATION OF AMERICA
SATURDAY, JANUARY 22, 1944

In view of the political importance attaching at this time to resolutions and statements of principles regarding Palestine adopted by national Jewish organizations and important groups in American Jewish life - and in order to insure co-ordinated political action,

BE IT RESOLVED by the N.E.C. of the Z.O.A. that it is incumbent upon all Zionists having relations with non-Zionist groups to act with utmost circumspection and to refrain from entering upon negotiations or committing themselves by giving support or assent to any political formulation regarding Palestine different from the official Zionist formulation, without prior consultation with the American Zionist Emergency Council or its officers.

BE IT FURTHER RESOLVED that the N.E.C. recommend the adoption of similar resolutions by all other organizations affiliated with the American Zionist Emergency Council.

THE AMERICAN JEWISH

1. The United Nations are engaged in a war for survival. As Americans and as Jews, we seek, first of all, the victory of the forces of democracy, of equality and of freedom over those of tyranny and brutal aggression to the end that men everywhere may enjoy the Four Freedoms—Freedom of Worship, Freedom of Expression, Freedom from Want, and Freedom from Fear.

•

2. For the uprooted and despoiled Jews of Europe, who were the first victims of the assault against democracy and civilization, we demand that relief and rehabilitation be provided at the earliest possible moment. Those who desire to return to their countries of origin must be enabled to do so; while opportunities for migration and settlement must be afforded to others who will wish to emigrate and begin life anew elsewhere. On behalf of the Jews in European countries, we demand, further, full equality of rights with their fellow countrymen as individuals. In those lands where group rights shall be granted to others and where the Jewish population involved desires such rights for themselves, we urge full equality of status; and we urge that guarantees to this end be provided by the United Nations.

•

3. We want an end to Jewish Homelessness. Now more than ever Palestine pro-

vides the most practical answer to the desperate need of the multitude of Jews whose rescue from Europe, as soon as possible, is imperative in a physical as well as in a spiritual sense. We ask that the Jewish people, too, shall have the opportunity to live and to develop as a free people in its own historic homeland, in Palestine. We demand that the gates of Palestine be opened wide on a scale commensurate with Jewish need; that all limitations on land settlement by Jews be removed; that the Jewish Agency for Palestine be vested with control of Jewish immigration into Palestine and with the necessary authority for the upbuilding and development of the country; that Palestine be established as the Jewish Commonwealth, in which Jews will be a majority of the population—a self-governing and democratic commonwealth in which the civil and religious rights of existing non-Jewish communities will be assured, and bound only by those reservations which in the post-war world shall apply to all states.



4. We ask, finally, that the Jews, through appropriate representation, shall be accorded the right to place their case directly and officially before any peace conference that may be called, or any authority designated by the United Nations for the reconstruction of the post-war world.
