My dear Dr. Silver:

On behalf of the Zionist Organisation of Chicago I am extending to you an invitation to address the Annual Chanukah Festival of the Z.O.C. on December 5th in the Grand Ballroom of the Stevens Hotel. This evening is set aside annually as the city-wide traditional function of the Jewish community in Chicago.

We, here in Chicago, fully realize the militant stand you have taken for positive Zionist action. We know that within the next few months much might develop in the Halls of Council of the United Nations, and it is the opinion of the Annual Chanukah Festival Committee that in view of the fact that Chicago has not had the opportunity of hearing you since November, 1944, when you addressed the National U.P.A. Conference, we would be highly honored if you could accept our invitation.

In writing this letter to you at this time, I am of the thought that you may already be on your way to London to attend the World Zionist Congress, and I am, therefore, sending this letter in duplicate in order that your office may forward copy to you airmail and advise you as to your commitments in December.

My secretary will be in Cleveland the latter part of next week, and I am asking her to contact your office there if by chance you have not already left or if they can give her any advice.

Even though you might be in London, may I ask that you cable me your acceptance as it is urgent that we have a definite answer in order to proceed with our complete plans. I am hoping that you will accept and be with us on December 5th.

Dear Dr. Silver:

It was good hearing your voice and knowing that you have returned to the States to lead American Jewry not only as a spiritual leader, but as the individual upon whom the heavy responsibility falls of directing a firm and advanced policy on behalf of the Zionist Movement. Had only others listened to your pleas a year ago, the victory we have just achieved in the Congress of the United States might have been more fruitful; yet we know we can never say "die". We may be set back, but we will continue to adhere to our program and SUCCEED.

I know how busy you are, yet it is of utmost importance that you endeavor to arrange to be with us in Chicago in the near future. It goes without saying that the multitude assembled for our Annual Chanukah Festival on December 9th were highly disappointed that you were not with us; yet they know it was through no fault of yours for you were serving them and our people in a much more important assignment in Palestine.

In Chicago we have made progress during the past few years and must and will continue making progress, but the time is now ripe to further implement our program; and we, here, the majority of your constituents, are agreed that you are the only one to inaugurate our new program.

We have communicated with various places, and they are holding for us the following dates: February 27th, March 6th, and March 10th. If these dates cannot fit into your schedule, please advise me as to the date most convenient for you, and I shall endeavor to see what I can do to conform with your request.

It is our intention to invite to this meeting all of those who were present at our Annual Chanukah Festival and in addition, as soon as we received word from you as to the date you shall be with us, to commence a Membership Campaign -- the sponsor and the new member to also receive invitations for this meeting. As I must sign the contract for use of the hall and commence our activities that will culminate with the evening's program, I am hopeful that I will hear from you in the affirmative by return mail.

I should very much like to come to address the Zionist of Chicago. I am sorry that I could not be with them for the Chanukah Festival on December 9, but as you know I was in Palestine at the time. I note the dates which you say are open. I would much prefer a mid-week date, because Sundays are very crowded days for me here in Cleveland. If Wednesday evening February 27 is still open, I will make every effort to be with you on that date. I cannot come on March 6; I could come on March 10 only by flying in the afternoon, because I must be in my own pulpit Sunday morning. If the weather is bad, that means that I will have to disappoint the meeting. All in all, I should prefer February 27. I understand that my coming is to climax an intensive membership campaign for the ZOA. Chicago should enroll a very large class of new members, and especially of returning veterans. You will forgive me for not having written you last week, but with the rush of things I truly did not find the time.

For me to say that we are grateful that you will be with us the evening of March 11th is putting it mildly, especially when you acceded to my request to address a luncheon meeting of key people in behalf of the Expansion Fund the same day. I know it is tiring to speak once during the course of 24 hours -- not alone twice.

To this luncheon meeting we are planning to invite men who will be in a position to give in behalf of the Expansion Fund, and as it is a luncheon meeting we are calling same for 12 o'clock food service, program to start at 12:45, so that by 1:20 we can begin taking pledges and checks. This would allow approximately thirty minutes for your address. If you feel this fits in with your plans, we shall proceed accordingly.

I am pleased to note that you plan to utilize my coming to Chicago on March 11 to the best advantage. I am leaving earlier in order to attend the luncheon meeting. I hope that sufficient preliminary work will be done so that when funds are solicited at the luncheon meeting there will be a substantial number whose gifts can be immediately announced. In other words, considerable solicitation should be done before I come to the meeting. That is always good campaign tactics. With reference to the Membership Campaign in Chicago: Chicago, as you know, has not been one of our good membership points, whereas it should be one of the best inasmuch as it contains the second largest Jewish community in the United States. I am hoping that this year some gratifying new start will be made to get a Zionist enrollment in Chicago commensurate with the size of its Jewish community. I cannot see that anything is to be gained in starting a competition in newspaper advertisement between the Bergson outfit and the Zionist Organization of America. If you wish to run ads later on in connection with my visit to Chicago as part of the Membership Campaign, I can see no harm in it, but these ads should not be in answer to any of the Bergson ads. Minutes of the Ohio Valley Zionist Region Executive Meeting January 20, 1946

An Executive Meeting of the Ohio Valley Zionist Region was held in Dayton, Ohio, on Sunday, January 20, 1946, at the B. A. U. Synagogue Center. Paul J. Gaiser, Regional President, presided.

The following attended: Leonard Becker, Joseph Cunix, Ben Kopelove, George N. Lehr, Leon Nizny, Rabbi Jacob B. Agus and Wolfe Marcus, all of Dayton; Maurice Chanis, David Gaiser, Ben Grossman, Dr. M. P. Kanter, Sidney Katz, Leonard Manekin, Fred Yenkin and Daniel Harrison, all of Columbus; Gabriel Cohen, Shoolem Ettinger, Ben Prince and Cantor Myro Glass, all of Indianapolis; Ben Goldfarb, Harry Winston, both of Charleston; Harry Frankel of Cincinnati; Sam Schechter of Springfield; Jacob H. Gilbert of South Bend; Prof. Max Astrachen of Yellow Springs; I. G. Simon of Pittsburgh; Morris Negler attended as proxy for Philip Hershman of Cincinnati and Mr. Thurkow as proxy for Meyer Ruchman of Fort Wayne.

Daniel Harrison, Executive Secretary of the Region, reporting on the activities of the Region, stated that the total membership enrollment in the region for 1944-45 was 4,234 comparing with the previous year of 3,944, showing an increase of 290 members. During the last year 928 new members were enrolled. Mr. Harrison urged the members of the Regional Executive Committee to greater efforts in behalf of new membership and particularly to re-enroll those members which are already on the roster of the Zionist organization.

Mr. Harrison further reported that since the last meeting in June a Regional Bulletin was issued during last August and that the Regional office has made available eighteen speakers to the various districts in the region. Mr. Harrison expressed his appreciation to the Speakers Bureau of the national office for their cooperation in securing speakers.

TREASURER'S REPORT

In the absence of the Regional Treasurer, Mr. Fred R. Marks, Mr. Harrison made the following report in behalf of Mr. Marks:

Sidney Katz of Columbus made a motion that the Regional Secretary advise each district president the names of those who attended the Executive Meetings throughout the year so that they may guide themselves accordingly whom to retain on the Executive Committee. The motion was seconded by Dr. M. P. Kanter and carried.

A motion was made and carried that proxies at executive meetings may participate in all the deliberations of the meeting except voting.

Mr. Gaiser extended greetings to Mr. Harry Frankel of Cincinnati, upon his return to the activities of the OVZR.

Shoolem Ettinger of Indianapolis was

appointed National Vice Chairman of the Expansion Fund Activities. Mr. Ettinger reported that Indianapolis assumed a quota of \$8,000 for the expansion fund of which \$4,000 has already been raised.

In the absence of Benjamin Piser of South Bend, chairman of Constitutional Revision, Professor Max Astrachan reported on the proposed revision of Article VII, Section I, of the OVZR constitution as follows: Branch A to read "The Executive Committee shall include the officers, past presidents of the region, and presidents of districts within the region. Branch B: The Executive Committee of the Region shall further include representatives of each district on the basis of one for every one hundred members in good standing or major fraction thereof, but in no event less than one representative from each district." Branch A of said proposed revision was voted upon and unanimously adopted, Branch B was voted upon and rejected, whereupon Prof. Astrachan moved to refer Branch B of said proposed revision to a committee for further study. The motion was seconded by Mr. Winston of Charleston, and carried.

In the discussion that followed with reference to Branch B of said proposed revision, Mr. Katz of Columbus moved that this numerical question should remain as it is. The motion was seconded by Mr. Frankel of Cincinnati. Mr. Winston of Charleston made an amendment to Mr. Katz' motion as follows: Since the president of a district is automatically a delegate, he should be considered one of that number (one out of fifty). The amendment was yielded, and the original motion was carried.

Rabbi Jacob Agus, Chairman of Regional Youth Activities, addressed the assembly and reported on work during the past year.

Rabbi Agus further reported that it was necessary to abandon youth work here, and suggested that the remaining money (approximately \$200.00) for youth work be given to the Zionist Youth Commission of the Central States Region located in Cleveland, Ohio, in which most of our region is included.

A motion was made by Daniel Harrison, and seconded by David Gaiser that whatever Youth Funds there are in the Regional Treasury earmarked for youth activities be turned over to the Zionist Youth Commission of the Central States Region. The motion was carried.

Prior to the Executive Meeting Mr. Gaiser appointed a nominating committee to nominate three representatives from our region on the National Administrative Council. The committee consisted of Sidney Katz, Gabe Cohen, and Leonard Becker as chairman. Mr. Becker presented the report of the nominating committee and after a brief discussion and nominations from the floor, the following were nominated: Simon Meyer, Charleston; Shoolem Ettinger, Indianapolis; Fred Yenkin, Columbus; Rabbi Samuel Cooper, Charleston; Wolfe Marcus, Dayton, and Jacob Gilbert, South Bend. The vote was taken by a ballot and the following were elected to serve on the National Administrative Council for the current year: Rabbi Samuel Cooper, Shoolem Ettinger and Fred Yenkin.

Cantor Myro Glass, Regional Chairman of the Jewish National Fund reported on J. N. F. Activities in the Region and urged the district leaders to do more in behalf of the Ohio Valley Zoinist J. N. F. Nachla. Mr. I. G. Simon, Executive Director of the Tri-State Region appealed to all those present to concentrate all their efforts on membership and the expansion fund.

Mr. Gaiser then declared the meeting adjourned.

FIVE HEBREW FELLOWSHIPS ANNOUNCED BY ZOA

The establishment by the Zionist Organization of America of five fellowships at the Hebrew University at Jerusalem for the academic year commencing October, 1946, was announced by Dr. Abba Hillel Silver, president of the organization. The Committee on Fellowships is headed by Dr. Israel Goldstein, former ZOA president.

Making public the requirements to be met by applicants for these fellowships, Dr. Goldstein announced that one fellowship will be in the amount of \$2500 and four for \$1500 each. The funds will be furnished through the ZOA Expansion Fund.

The fellowships are open to graduates of recognized colleges or universities without restrictions as to sex, race or creed.

JEWS ON AGRICULTURAL LAND INCREASED TENFOLD

JERUSALEM (ZOA)—The number of Jews settled in rural areas in Palestine has risen tenfold since 1922, according to figures published here.

In 1922 there were 15,200 Jews in rural areas, while in 1946 the number rose to 145,000. Of this total, 111,000 were on the coastal plain and 24,000 in the valleys; another 9,500 reside in mountain villages on JNF land and 500 in the Negev.

During the same period the number of Arabs residing in rural areas increased by 66 per cent, from 477,700 to 793,000.

The Jews thus represent over 15 per cent of the total rural population, forming 38 per cent of the rural population on the coastal plain and 46 per cent in the valleys.

Shoolem Says-

There is only one way to get this money and that is to impress your members with this fund and to go out and get it. It is a good plan to call a few of your good Zionists, especially those who are willing givers to our cause, to a parlor meeting and explain what the money is for and to raise it then and there. This job must be done immediately. Our work cannot wait, and we must have this fund within sixty days.

AN ENGLISHMAN SPEAKS

JERUSALEM (ZOA)—A recent issue of the Palestine Post published the following letter from an Englishman who resided for two years in Palestine.

Sir: I was stationed in Palestine for two years. During that time I spent a number of my leaves in different Jewish settlements in the country.

The hospitality, friendliness and sincerity shown me there were such as I have never met with before and have a feeling of warm respect for all the people living in them.

Today when I hear that these same settlers offering harbour to their homeless, miserable refugees escaping from a hostile anti-Semitic Europe are being fired on and killed or sent to detention camps by my own British people, I am deeply ashamed. Lest the Jewish people think we are all insensitive, I wish to speak for a great many Englishmen who feel as I do. We appreciate the fine brave spirit you are showing and sincerely hope that your honest, worthy hopes and aspirations may be shortly fulfilled.

The will of the people must be registered by joining the movement. If membership is one of the necessary steps in the advancement of our Cause, no one must remain silent at the call of his name. We must solicit the endorsement of every self-respecting living Jew. It is a duty which no Jew can shirk, and a responsibility that every loyal Jew must share. It is a privilege that each member of our race should participate in the fulfillment of the prophecy of Israel less he remains alone and unidentified.





My dear Dr. Silver:

On behalf of the Zionist Organization of Chicago I am extending to you an invitation to address the Annual Chanukah Festival of the Z.O.C. on December 5th in the Grand Ballroom of the Stevens Hotel. This evening is set aside annually as the city-wide traditional function of the Jewish community in Chicago.

We, here in Chicago, fully realize the militant stand you have taken for positive Zionist action. We know that within the next few months much might develop in the Halls of Council of the United Nations, and it is the opinion of the Annual Chanukah Festival Committee that in view of the fact that Chicago has not had the opportunity of hearing you since November, 1944, when you addressed the National U.P.A. Conference, we would be highly honored if you could accept our invitation.

In writing this letter to you at this time, I am of the thought that you may already be on your way to London to attend the World Zionist Congress, and I am, therefore, sending this letter in duplicate in order that your office may forward copy to you airmail and advise you as to your commitments in December.

My secretary will be in Cleveland the latter part of next week, and I am asking her to contact your office there if by chance you have not already left or if they can give her any advice.

Even though you might be in London, may I ask that you cable me your acceptance as it is urgent that we have a definite answer in order to proceed with our complete plans. I am hoping that you will accept and be with us on December 5th.
