#### Re: Hechalutz Organization in America.

Pursuant to our conversation as of the 11th of December, 1945, I am submitting herewith the following proposals concerning the development of Hechaluts in the United States and Canada.

1. It is imperative to put in some order the process of distribution of Chaluz Certificates in the U.S.A. The present Palestine Office, though managed by capable people, must be reorganized in accordance with the decisions of the Zionist Congress and the recent London Conference. The Palestine Office shall include the representatives of all Zionist parties and one representative of Hechaluts in accordance with the established procedure.

The Hechalutz suggests that the above-entioned Palestine Office shall also be the official Zionist body interested in the development of Hechalutz in U.S.A. and to whom the Merkaz Hechalutz will report about its activities.

In order to facilitate the growth of Hechalutz in America it is intended to increase its present membership of 1200 to the minimum of 3000 in 1945/46. It is believed that next year the membership will grow to 5000, provided money will be made available for educational work in the cities and for hachshara in agriculture and industry. A budget of S 110,000 is necessar; for this year, and a guarantee that if the expansion program proves to be a success a budget will be made available next year.

The American Fund for Palestine Institutions will guarantee \$25,000 towards this budget. The Chalutzin themselves - 15,000. \$16,000 were allocated by the Jewish Agency, and a sum of approximately \$60,000 is lacking. We suggest that this amount shall be given by the Zionist Organizations in America either through initiating a special campaign or through direct allocation from their own funds.

It must be absolutely clearly understood that unless these funds are made available to Hechalutz, no serious expansion program will be possible.

There are right now 900 chalutain in the United States ready for immediate immigration. 450 of them were on hachshare for over four years, and their slight is an immediate necessity. We rejuest the Aliyah Department to take the situation into consideration and that the Zionist movement in America, through the Palestine Office, shall give prefere ce to these chalutaim.

In addition there are a few hundred candidates organized by the Hachalutz from amongst the war veterans, for study at the Hebrew University and the Technical School at Haifa. The Veteran Administration in Mashington has approved these schools as a part of eligible schools for American war veterans, and guaranteed the payment of tuition and maintenance. Many more will join this

organisation if at least a small fraction of candidates can arrive in Pelestine by March 1946. We suggest that at least a 125 war veterans shall arrive in Polastine in the first group on student visae or as tourists.

4. It is obvious that the growth of Hechalutz in America can be most properly secured by the presence of a large delegation from Palestine. Some of the schlichim are already in the United States and more are required. It is important that the work of the Palestinian Delegation be supported by the entire Zionist movement in America.



Dear Mr. Stone:

Your recent letters, relative to the Zionist Expansion Fund, had to be referred to our Executive Committee, which explains my delay in replying to you. Even now, I am unable to give you an optimistic reply, but I can only transmit the opinions of our directors.

To begin with, the amount assigned to our district seems excessive. While we realize the importance of this fund, we nevertheless feel that it should be borne equitably between all districts; according to the figures submitted by you, we are assigned one-twenty-fifth of your entire quota, but we certainly do not represent that proportion of the total ZOA membership.

Furthermore, we must be realistic. This year our community is being asked to give to numerous causes and to a much larger Our Welfare Fund has accepted a million dollar quota compared to a previous high of less than \$350,000. There is also a three quarter million dollar drive for a Jewish Center, a quarter million drive for a new, modern synogogue, plus drives for Hillel and other similar organizations.

Even in Zionist matters, we are raising this year for Haganah, a sum ten times larger than that of any previous year; and our district plans a small campaign for funds to carry on our own exten-The two dollars we receive from each membership is sive program. not sufficient to enable us to carry on our work.

Shortly after our annual convention last November, the subject was brought up before our Executive Committee and we accepted a quota of \$3500, which was the same as our contribution of last year. When your letter was introduced, our directors could see no way of increasing the original figure; but realizing the importance of your work, they voted that this \$3500 should be a minimum figure only, and that we should endeavor to raise as much more as possible. In other words, they did not actually accept your assignment, but neither did they hold to the original \$3500 figure. I realize that all this is indefinite, but it is the best we could do under the circumstances, and it, at least, leaves us room for increased efforts.

It was suggested by our board, that if Dr. Silver could arrange to visit Milwaukee and open our campaign, the results could be very satisfactory. I therefore hope that you will give this angle serious consideration. After all, I am sure that Dr. Silver plans to visit Milwaukee at least once during the year, so perhaps he can easily combine this matter with any other plans he may have in mind. Should you decide to act on this suggestion, there are several conditions which I must outine -1) that this effort must be postponed to some date after our Welfare Fund campaign. since we pladged full support to that campaign. This means that we can do nothing until the end of May. 2) That we be given sufficient notice so that we can properly publicize Dr. Silver's visit, and 3) that it is understood, that a certain percentage of all monies raised as a result of Dr. Silver's appeal and efforts, be retained by us for operating purposes, and that the entire balance be turned over to the Expansion Fund in full settlement of our obligation to that Fund. The reason for this condition, is that we do not want to have two campaigns for our district, and that we want to combine our Expansion Fund appeal with our drive for supplementary operating funds.

I would appreciate hearing from you in the very near future, as to your reaction to the above, especially as it relates to Dr. Silver.

For your records, I can also advise that our Ways and Means Chairman is Joseph Brindis, 5509 W. Washington Blvd, Milwaukee, 8, Wisc. You may want to communicate with him as well. At the present time Mr. Brindis is out of the city, but I expect him to return around the end of this month.

Dr. Blumenthal suggests that it may be possible for Dr. Silver to include Milwaukee as well, on his itinerary, since we are only one and a half hours out of Chicago; and it is his opinion that Dr. Silver could do much to stimulate our campaign. Will you kindly talk this matter over with Dr. Silver and Dr. Marks and advise me if something can be worked out. TO: Dr. Silver

In the implementation of the decisions taken at the luncheon, devoted to the Metropolitan Zionist Fund, I would suggest that a note be sent by you to Rabbi Harry Halperin, President of the Brooklyn Region, and Judge Hyman D. Reit, President of the Manhattan Region, both of whom are members of the National Executive, urging their participation in the arrangements which are to be made for an increased collection of funds for the Expansion Fund. I would place it on a plane of personal responsibility as members of the National Executive Committee.

Westchester County is under the Presidency of Mr. Jacob Lukashok, a very cooperative and decent fellow. A note to him might prove veny effective.

# MINUTES OF THE INNER COMMITTEE MEETING WEDNESDAY, FEBRUARY 20, 1946 HOTEL NEW YORKER, NEW YORK

PRESENT: Dr. Emanuel Neumann, Presiding, Dr. Israel Goldstein, Joseph W. Greenleaf, Rabbi Irving Miller, Milton Pollack, Mark Sugarman, Jacques Torczyner, and Yale Goldberg.

The following were present by special invitation: Rabbi Simon Greenberg, Manuel Posy, Abraham Tannenbaum and Herman Weisman.

## EDUCATION:

Dr. Neumann reviewed the plan of Rabbi Miller, as outlined in previous minutes, that an Education Director be appointed. Rabbi Greenberg suggested that the name of the Education Committee be changed to Committee on District Programs.

Rabbi Greenberg stated that there was no correlation between the various departments in respect to educational content. He indicated the need for a coordination of departmental activities which could be done by a man of stature with creative ability. Dr. Neumann suggested that Rabbi Miller and Rabbi Greenberg, on behalf of the Committee, survey the field and see whether a man of this type can be found.

Rabbi Greenberg further stated that the Hebrew Camp Masad will require approximately \$10,000 in order to provide additional facilities for training youth leaders. Dr. Neumann indicated that this subvention would depend upon the state of the finances and the Expansion Fund.

### BUILDING:

Mr. Pollack reported that two buildings are being considered by the Building Committee - one at 40th Street and Broadway, and the second at 40th Street and Madison Avenue. The latter, at 280 Madison Avenue, is a twelve story office building and was considered most desirable. He outlined the amount of space in each, indicating costs, etc.

The possibility of floating a bond issue to cover the down payment was considered. It was felt that there would be no difficulty in liquidating a bond issue of \$500,000 within 90 days. Dr. Goldstein suggested that the Funds might advance the monies to be charged towards future rentals. The Building Committee was asked to study the situation and report further on their findings.

Yale Goldberg indicated that the Zoning Commission in Washington has turned down three appeals due to the fact that the Organization is located in a zone that is restricted against commercial and office building use. It was further indicated that Dr. Silver stated that the Emergency Council does not desire to remain on the premises and he suggested that efforts be made to sell the building. The Building Committee will proceed with efforts to dispose of the building, and if the building cannot be sold for approximately \$70,000, the matter will be referred back to the Inner Committee.

## SHEKEL CAMPAIGN:

Jacques Torczyner reported that there will be a meeting of the Shekel Board at 10 A. M. on Friday, February 22nd, at the Biltmore Hotel. It was decided that membership work would be continued to the end of March and that the Shekel Campaign be devoted to the month of April. Mr. Torczyner further stated that 10% of the shekel monies are to be kept by the various organizations and another 10% is to be placed in a common fund to finance the campaign, at the end of which any amount over will be redistributed in proportion to the shekolim sold and any deficit will be financed by the Jewish Agency.

Abraham Tannenbaum indicated that the shekel campaign will involve the entire field staff. The probability: of over-lapping Membership campaigns into April was raised and it was agreed that nothing should prejudice these operations since they likewise involve shekel payments. Dr. Neumann suggested that Mr. Tannenbaum formulate plans for the operation of this campaign with some indication of the budget which will be required, using \$25,000 as a basis for these figures. Dr. Neumann further suggested that a reasonable estimate be made of the amount of shekolim that can be sold and that the budget be designed to accomplish that purpose. Mr. Tannenbaum and Mr. Torczyner will submit such plan and budget.

Dr. Goldstein indicated that he would be unable to serve as the Chairman of the Z. O. A. Shekel Committee and Mr. Daniel Frisch was designated to serve.

#### GENERAL ZIONISTS:

Dr. Israel Goldstein reported on the activity of the sub-committee in an effort to strengthen the position of the General Zionist position on the continent where there is a fine potential group and a very small actual group. In Palestine, the General Zionist group is a very weak segment of the picture. There is need to entrust former Americans with the responsibility of enlarging our numbers and to delegate one of the group in America to go to Palestine within the next few months. Judge Levinthal was considered in this connection.

The General Zionists in Palestine require \$250,000 for rural settlement. It will be indicated to the UPA that an allocation, not to exceed \$500,000 be made available for use in Palestine. Dr. Neumann suggested that Dr. Goldstein appear at the meeting of the Joint Committee to present this matter so that some provision be made in the new UPA contract.

Dr. Neumann suggested that this matter be placed on the agenda of the next meeting of the National Executive Committee.

It was also suggested that before the next meeting of the World Zionist Congress, a delegation of General Zionists should go to Palestine with a director who is trained in such matters, so as to make a study of the situation there for the use of our delegates to the Congress.

## PALESTINE CORRESPONDENT:

Dr. Neumann pointed out that he discussed with Dr. Silver the possibility of (1) having information sent to us regularly from Palestine,

perhaps in the form of a bi-weekly letter of information distinct from articles for publication, which would convey intimate details of conditions in Palestine for the information of Zionist leadership throughout the United States, and (2) clearing letters and dispatching publications, answering general inquiries from Z. O. A. Departments and securing material for our publications. Mr. Elias Epstein had been suggested. His submitted program could be covered by an annual budget of approximately \$3,000. Motion was made and carried to adopt this proposal and effectuate the establishment of this service.

#### PALESTINE BUREAU:

A letter from Dr. Simon Bernstein indicated that a meeting will be held on Tuesday, February 26th, to select representatives to the Palestine Bureau. The Zionist Organization would be entitled to four representatives. Mr. Morris Zeldin was suggested as one of the delegates. The remaining to be selected by Mr. Torczyner upon consultation with Dr. Bernstein.

# VETERANS PROGRAM:

Dr. Neumann indicated that Major H. Auerbach made a very fine impression and a temporary assignment was suggested so that he can make a survey of the situation and submit his plans.

Dr. Neumann reported on the activity of a group of Veterans in Philadelphia which may serve as a pattern for our efforts in this direction. Major Auerbach will be asked to undertake a survey and present a program of activities. He is to be engaged at a fee of \$400 over a four week period. It will be indicated that this will not in any way prejudice any future assignment in the organization. It was recommended that Major Auerbach consult with the Youth Commission regarding their suggestions.

#### PUBLICATIONS:

The resignation of Judge Louis E. Levinthal as Chairman of the Publications Committee was accepted and Eleazar Lipsky was appointed to that post.

Dr. Neumann indicated that the second volume of the "Palestine Year Book" should not cost as much as the first, and that an editorial committee work with Miss Udin. Mr. Abraham Duker, Dr. Benjam'n Schwadran, Prof. Joshua Neumann and others were recommended for the Editorial Board. The Publications Committee is to be informed of this decision.

Dr. Neumann indicated that a one-volume Jowish History has been prepared by Israel Goldberg, which fact should be transmitted to the Publication Committee.

## NEW PALESTINE:

Dr. Neumann indicated that Dr. Silver was dissatisfied with the New Palestine. It does not compare feverably with the publications of other organizations. Drl Neumann suggested that in planning for the coming year, (1) the News Reporter become a bi-weekly, to be sent to all members, and

Jacques Torczyner shall explore the possibility of also establishing a Business Board for the New Pelestine.

Neumann, Dr. Theodore N. Lewis and Marvin Lowenthal, Dr. Benjamin Akzin, Prof. Oscar Janowsky. Such a board might organize the next three or four issues

of the New Palestine to ascertain what they can accomplish.

## NEWS REPORTER:

The possibility of a bi-weekly edition of the News Reporter was discussed. Motion was made and carried that from March 21st, four half issues of the News Reporter are to be printed bi-weekly.

After a thorough discussion, the matter of an increase in salary for Mr. Barbarash was deferred for further study by the Inner Committee of the entire wage scale. Mr. Sugarman, Mr. Pollec' and Mr. Goodman, as financial officers of the organization, are to explore the situation.

### IMMER COMMITTEE:

Dr. Neumann asked Rabbi Trving Miller to serve as Chairman of the Inner Committee in the absence of Dr. Neumann, pending his return from Palestine.

#### EXPANSION FUND:

Mr. Manuel Posey reported on the progress of the Expansion Fund, indicating that before the close of the fiscal year, an amount very close to the estimated \$500,000 will be received. He cited various communities as examples of the progress which is being made and indicated that he had been approached by a community Welfare Fund who asked us to defer our campaign and who cited the fact that they had made an arrangement with another organization by which, in deference to their not running a campaign, they granted them an allocation of \$25,000. It was established that monies are not to be solicited from Welfare Funds but that offers of this type are to be considered and surveyed. It was also indicated that Expansion Fund campaigns should be timed throughout the country so as not to conflict with UJA campaigns. The Acting Chairman of the Inner Committee should contact Dr. Silver, advising him of this content.

Dr. Marks and Mr. Posy, in consultation with Mr. Herman Weisman, shall draft a memorandum containing the e sence of the aforementioned suggestions. This entire matter should be placed on the agenda of the National Executive Committee meeting.

It was suggested that members of the staff, such as Dr. David Tannenbaum, Rabbi Arthur J. Lelyveld, and members of the Executive be asked

to travel throughout the country on behalf of the Expension Fund. Immediate steps in this direction will be taken.

Jacques Torczyner and Herman Weisman are to discuss with Mendel Fisher the question of co-ordination between Jewish National Fund and Expansion Fund efforts.

Dr. Neumann felt that inasmuch as there is a duplication of activities by the Unity Committee and the work of the Emergency Council, that a reduction in the budget of the Unity Committee can be effected. It was decided that \$25,000 be eliminated from this budget.

Mr. Weismand and Mr. Sugarman were asked to explore the possibility of the transfer of the Palestine Economic Bureau to the Keren Hayesod.

## AMERICAN FUND FOR PALESTINE INSTITUTIONS:

A letter from the American Fund for Palestine Institutions indicated that there was no precise formula for representation on their Board of Directors. Yale Goldberg was instructed to speak with Judge Levinthal and Judge Rothenberg with regard to Z. O. A. representation on the American Fund for Palestine Institutions.

# MASADA:

Mr. Torczyner is to arrange with the Youth Commission that \$3,000 or \$4,000 of their funds are to be granted to Masada over a period of four menths so that Masada be given a better opportunity to prove their ability to organize Zionist youth.

#### MISCHLIANTOUS:

It was the unanimous decision of the Inner Committee to recommend the appointment of Rabbi Max Nussbeum of Los Angeles as a member of the National Administrative Council.

Dr. Israel Wochsler shall be invited to attend a meeting of the Inner Committee or Executive Committee to discuss his program for the Hebrew University.

Dr. Shlomo Bardin will be invited to the next meeting of the Inner Committee to report on his trip to Palestine.

It was recommended that Mr. Hyman Shoulson be assigned to assist Dr. Akzin of the Emergency Council in Washington.

The meeting adjourned at 11:15 P. M.

I have just returned from a conference with Reverend Martin Adolf, President of the Paterson Zionist District. He is one of the most ardent worker in our movement.

He has taken Paterson, a dormant community, and has created a district which will double its membership this year. They are already considerably beyond their membership reached at the end of last year.

He has ascertained that you will be in New York on March 31st and wants you to come to Paterson on the evening of April 1st.

Here are the points he makes:

(1) \$5,000 will be given to you for the Expansion Fund
(he has already collected this money. I saw the bankbook in which it is deposited. Last year he gave us
\$2,000, which was one-third of all that we collected
in New Jersey)

- (2) On this occasion they will present \$1,000 to Nachlath, New Jersey in your honor.
- (3) They are inscribing in the Golden Book two editors of the two local papers together with Dr. Claire S. Wightman, President of the New Jersey State Teachers College. Mr. Haines, one of the editors and Dr. Wightman are co-chairman of the American Christian Palestine Committee in their community and are ardent Zionists in the fullest sense of the word.

The community mass meeting will be preceded by a small informal dinner wherein the editors, the follege President, and some of the biggest men in Paterson public life will be present.

I know of your feelings in this matter and the great demands made upon your time but I do believe that this particular request deserves your particular attention and consideration. Paterson today is, in my opinion, one of the foremost Zionist communities in the country.

Membership Report: I was disturbed to see in the press a report of our total national membership in the following terms:

"Over 90,000 members have enrolled in the Zionist Organization of America in the four months period ended Jan. 31, 1946, marking a net gain of 25,000 over the same period last year, according to a report issued by the national headquarters."

I feel that it is confusing to the public to make our public announcement of membership dependent upon our system of wiping the slate clean and beginning our enrollment each September. Every other national organization includes the paid-up members of the previous year in its total enrollment figures. This report gives the erroneous impression that our total membership is only 90,000, when, as a matter of fact, we would be justified in claiming at this time over 150,000 members.

My dear Dr. Marks:

The two meetings in Baltimore were very successful. At dinner, I met with some forty or fifty members of the Board of the Baltimore Zionist District and talked to them about membership and the Expansion Fund. They made a pledge to obtain an additional 2800 members which would bring up their total to 5000. Mr. Zinberg seems to be a very energetic person, and he is ably assisted by Mr. Fram who has himself brought in 130 new members.

They have not made much headway on the Expansion Fund. At the evening mass meeting, Rabbi Coblenz publicly presented me with a check for \$5,000.00 as a token payment. The leaders do not seem to know what is expected of Baltimore, nor is any organized effort being made to raise its quota. I understand that Mr. Posy has been there, but evidently additional work must be put in if we are to realize a substantial contribution from Baltimore. This should be attended to at once.

The evening meeting was a great success. The Temple was packed and there was a fine spirit of enthusiasm.

At noon, I meet with about seventy-five at luncheon where funds were raised for the Expansion Fund. Milton is under the impression that we will be able to get about \$25,000 from Chicago.

There was considerable criticism of the neglect of the region outside of Chicago. They told me that there has been no one in charge of that region since last October and that quite a number of districts haven't done much even by way of renewing the memberships of last year, not to speak of new memberships. What is being done about it? A field director should be dispatched to that important region at once, and some one ought to remain in Chicago to follow up the work of the Expansion Fund.

I contacted Mr. Louis I. Gilgor, grand secretary of the Independent Order Brith Sholom at 506 Pine Street, Philadelphia, Pennsylvania. I am glad that it happened just a day before his planned visit to New York. That saved me a trip to Philadelphia. Mr. Gilgor came to our office, and we went into the past history of negotiations with the Z O A.

Mr. Gilgor states that the Brith Sholom was the first Jewish fraternal order to endorse the Basel program, when other fraternal orders were afraid of Zionism. For years, the Brith Sholom was invited officially to Zionist conventions, with full rights for the delegates. Five or six years ago, the Z O A for some reason stopped inviting the Brith Sholom. But as a Zionist he can't hold that against the organization. He is willing to do everything in his power to help the Brith Sholom membership to affiliate collectively with the Z O A. He says that negotiations a year or two ago seemed to be promissing, but someone on the Z O A executive committee "sabotaged the project".

Coming down to practical suggestions, here is the plan that we have in mind. Mr. Gilgor and Mr. Stanton, grand master of the Brith Sholom, and one or two other leading members of that fraternal order will meet with Judge Leventhal and me in Judge Leventhal's chambers in Philadelphia to trash out this matter and arrive at definite propositions to be placed before the ZOA executive committee.

The flew was particularly satisfactory, because Mr. Gilgor says that if an agreement is reached at least the Sheckel for the entire membership could be paid immediately out of special funds that the organization has on hand.

Furthermore, he says that whatever financial arrangements can be made, it will cost the ZOA very little to carry the Brith Sholom membership. The organization is willing to serve its own members, in other words, if the ZOA wishes to reach the Brith Sholom members with a proposition of letting on new members. This can be turned over in bulk to the Brith Sholom office, which will see to the addressing, postage, etc. at its own expense.

Please let me know immediately, what suggestion you have as to the proposed conference in Philadelphia with the Brith Sholom.

Mr. Gilgor also feels it will be very beneficial for the ZOA to have Dr. Silver address the next convention June 23 to 25 in Atlantic City. I am attaching the letter from Mr. Gilgor, which, I hope you will take up with Dr. Silver immediately.

All arrangements for Dr. Silver's visit to Atlantic City will be made by Brith Sholom, transportation, hotel, etc. Please call Dr. Silver's attention to the fact that he can choose his own time. Any of the sessions that he wishes to address will suit the Brith Sholom.

Dear Sidney: Answering your letters of March 15th and 18th, I can well understand your bewilderment concerning the following: "If the Zionist Organization of America, \*\*\*\* is precluded from occupancy of these premises, how is it possible for the local groups \*\*\*\* to secure possession?" In this connection, please be advised as follows: I gave up the fight on the matter of the re-zoning in behalf of the Z.O.A. because of the fact that the premises were abandoned. I was prepared to take the necessary steps to appeal first to the Commissioners and thereafter to the Courts for as you know, the ruling of the Board of Zoning Adjustment was 3 to 2. If the building were to be acquired by the local bodies, a new application would be submitted, and I am sure that we could get the re-zoning. The activities of the local group would be quite different from those of the Z.O.A. After all, the Z.O.A. did use the premises merely as an office building. Lastly, I want to say this, I heard by the grapevine that one of the reasons for the adverse decision was that a confidential report had reached the Board of Zoning Adjustment that colored help was being employed by the Z.O.A. This may or may not have affected the ruling. Of course the matter of the re-zoning would be no concern of the Z.O.A. That would be a problem for the local bodies. What we have in mind, plainly, is as I have stated, that all the local Z.O.A. bodies, including the Zionist Emergency Council, Seaboard Region, etc., would occupy the building, but the ownership may be confined to the District and Hadassah.

We, the General Zionists of America, representing in this critical hour the ideal of national unity and solidarity, and speaking for the overwhelming majority of the enrolled Zionists of this country, call upon the Jewish community of America to support us in the coming elections of the World Zionist Congress on the basis of the following declaration:

- (1) The Jewish people today is fighting for survival and for a brighter and happier future. After the appalling tragedy of the past few years an heroic effort must now be made to rebuild the national life of our people, to make it secure in its national home, and to restore Jewish dignity and self-respect and all the paramount values of our history and tradition. Zionism is the age-old struggle of our people to live greatly and worthily as a nation in a free world, and to conserve and advance the great social, cultural and spiritual values of our people. This was the Zionism of Theodor Heral. It is our Zionism today.
- (2) The primary aim of our movement in this hour is the attainment of its political objective—the establishment of a free and democratic Jewish Commonwealth in Palestine. To this aim all party and group considerations must be subordinated at this time. General Zionism fully recognizes this fact and bases all of its activities on this major consideration. We General Zionists believe that we are in the best position to assume the leadership in the attainment of this aim. Because of our over-all, non-partisan political outlook, and because of the numbers we represent and our historical achievements, we are equipped to lead the Zionist movement to victory as we have led it through decades of great achievements in the past. The leaders of our movement, Herzl, Nordau, Wolfsohn, Brandeis and Weizmann, came from the ranks of General Zionists. The establishment of the great historical Zionist institutions—the Jewish National Fund, the Jewish Foundation Fund, and the creation of the World Zionist Congress represent notable achievements of General Zionists. General Zionists have been responsible in the main for the raising of the large funds by means of which the development of Palestine has been carried on. We are especially

proud of the role which General Zionism played in the foremost historical achievement of our movement—the Balfour Declaration. This uninterrupted record of achievement we purpose to continue into the future.

(3) General Zionism has always championed the principles of social justice and human rights as fundamental concepts in the Jewish State which we wish to establish. General Zionists have given their unstinted support to every measure and agency calculated to elevate and to protect the status of Jewish labor in Palestine, whether on the land or in the city, as well as to establish the many social agencies which a progressive, modern community requires. These social ideals are the cornerstones not alone of Zionism, but of Judaism itself. Likewise, we General Zionists can hardly envisage a Jewish Palestine which is not responsive to Jewish spiritual traditions and to the high mandates of our historic faith. We heartly endorse and applaud all efforts which are being made by individuals and groups within Palestine to realize these aims which are common to all Zionists.

Nevertheless, we believe that the fragmentation of the economic, educational and cultural life and resources of the Yishuv tend seriously to weaken it in respect to the struggle in which it is now engaged. We are seriously concerned about this excessive and unwarranted partisanship and party strife. This is the hour of decision when we must present a united front, strong internally and externally.

Only under the banner of General Zionism, which is the Zionism above parties, can this united front be achieved.

It is on this record and on this program that we ask the Zionists of America to give us their fullest support in the forthcoming elections.

- 1) I am sending you a letter which I received from Dr. Scheps, the director of the Palestine Bureau in Geneva, with the attached report on Dobkin's statements at a conference which was held there. This statement is of recent date; I thought you might be interested in it.
- 2) I just participated in a Shekel meeting at our office under the chairmanship of Sidney Marks where all department heads were practically mobilized in the Shekel campaign. I desire to repeat to you two points which I think are of vital importance in this matter:
  - a) The name "Shekel Campaign", I am afraid, will not bring us the desired results. The very word "Shekel" cannot appeal to large masses of people who would not understand what it is all about.
  - b) It is unfortunate that we are talking about two actions—a Shekel sale and voting later on. Both things must be put to the public as one, and this can be achieved in the following manner;

Our appeal to American Jews is our demand that not 100,000 Jews but half a million Jews should be brought to Palestine. Every Jew who is in favor of it should register by the Shekel and thus be entitled to vote.

Our "Slogan" therefore should be: "Do you want to save our brothers in Europe? You can achieve this through your vote." This has an appeal and will be understood by everyone.

3) Under this slogan we should be able to have all the temples and synogogues become a part of this campaign. It may not be easy for a congregation to pay \$5.00 for each member but they will readily pay 50¢ for each member thus making all the members of the congregation voters. Each congregation should be declared as a separate voting place. I am confident that we will get the support of the Rabbinical Assembly for this action.



I just had lunch with Maxwell Cohen, National Commander of the J.W.V. to discuse the Shekel drive with him. He finds it impossible to buy a block of Shekelim for the J.W.V. due to the internal, organisational set-up where members of the National Executive Committee might object to such an action. The next meeting of the National Executive Committee is not until May 19th in New York City. However, Commander Cohen is interested in being a delegate to the World Zionist Congress.

He approved our approaching each local J.W.V. Post Commander with the letter received from Commander Cohen and sending each J.W.V. Post Shekelim receipts to be sold. He is providing me with a list of the number of members from each J.W.V. Post so that we can send an appropriate number of books to them. Commander Cohen will be at the luncheon on Thursday, April 18th and can be further approached at that time. It seems to be outside of his province to buy a block of Shekelim, but I think that if we can list him on the Z.O.A. slate and send a flyer to each J.W.V. Post with a picture of Commander Cohen buying a Shekel, a copy of Commander Cohen's letter and the slogan that each J.W.V. member buy and sell Shekelim to vote for Commander Cohen on the Z.O.A. elate, we can accomplish almost as much. SUBJECT: Brith Sholom

The conference with officers of the Brith Sholom, was to take place in Judge Leventhal's chambers, Wednesday, April 10, at 4 o'clock.

I made a train at noon, so as to have enough time in Philadelphia to confer individually with Mrs. Bender, Judge Leventhat, and Mr. Gilgor, grand secretary of the Brith Sholom. This was done, so that I may be prepared at the conference, knowing in advance the various points of view. I was particularly eager to do that, as I understood that on previous occasions, when there was discussion about Brith Sholom affiliating with the ZOA, members of the executive committee of the ZOA, living in Philadelphia, opposed the affiliation.

I am glad to say that Mrs. Bender is completely in favor of affiliation, even though it may mean some financial loss to the Philadelphia region in the beginning.

Judge Leventhal, of course, favors the affiliation completely.

Mr. Gilgor is eager for the affiliation, but he told me that the executive committee of his organization still feels the humiliation put upon them during the discussions which took place a year or two ago. In his own words, "Brith Sholom', has been kicked in the face by the ZOA executive committee." He warned me to handle the situation very diplomatically when we confer in Judge Leventhal's office.

While the conference was to take place at 4 o'clock, and Mr. Gilgor and Mr. Frank A. Simons, chairman, Zionist Affairs Committee of the Brith Sholom, were there promptly, as were Judge Leventhal and Mrs. Bender, Mr. Alex F. Stanton, grand master of the Brith Sholom, phoned that he had tire trouble, and would be delayed. He came five minutes past five, just about when Judge Leventhal was about to leave on an important engagement. However before Mr. Stanton came, we explored the situation. We made it clear, that at this time, the thing that interests the ZOA is a collective enrollment of the Brith Sholom members as Shekel payers. We also suggested that whatever arrangements were made for affiliation, the Shekel payment would be taken into consideration as a payment on account.

We find that both Mr. Simons and Mr. Gilgor estimate the present membership of Brith Sholomites in the ZOA runs between 15 and 20%, in other words, that there is a possibility of some 9,000 new members or Shekel payers, as the case may be.

One of the problems that came up was that even if it is decided by the Brith Sholom to pay the Shekel for all its members, this being the end of their fiscal year, there is no money in the treasury for that. Judge Leventhal suggested that if the Brith Sholom writes a letter to the ZOA, obligating itself for a definite amount, representing a number of Shekolim, the ZOA would make a loan to the Brith Sholom, which could be repaid three or four months after the Brith Sholom conference.

After Mr. Stanton arrived, we started the conference officially. Mr. Stanton made it very clear that the Brith Sholom was very eager to affiliate, that instead of finding a welcome on the part of the ZOA executive committee, it was "kicked around".

He said that he and a committee, in their eagerness to affiliate, went to see Dr. Silver once in Washington, and according to grand master Stanton, Dr. Silver did not seem very eager. I assured them that Dr. Silver is very much in favor of the Brith Sholom affiliation.

Grand master Stanton, also gave it as his opinion, that bytween 15 and 20% of the Brith Sholomites are members of the ZOA at present.

He said that while he and Mr. Gilgor and Mr. Simons are very much for affiliation, he felt that as far as buying the Shekel at present, the executive committee of his organization may object on the grounds that after 4 or 5 thousand dollars in Shekolim have been turned over to the ZOA, the executive committee of the ZOA may again "kick us in the face". He said that he and the others present at the conference would have to do everything they can to convince the executive of Brith Sholom, that this time the ZOA actually means to arrange for affiliation of the Brith Sholom.

### IMPORTANT

The Brith Sholom representatives suggest that a letter be addressed to the grand master of the Brith Sholom, inviting the Brith Sholom to apply for affiliation with the ZOA. This letter should be in the name of the president of the ZOA, in order to carry the prestige necessary to put this over with the Brith Sholom executive committee.

I would suggest that the letter also emphasize the need of paying the Shekel immediately, and perhaps a suggestion, if that can be done, that if the Shekolim for the entire Brith Sholom are turned over to the ZOA immediately, the Brith Sholom could place one of their representatives on the ZOA ticket.

I also held out to the Brith Sholom representatives the idea that if they come in before any other Fraternal organization, that we would issue a National release, and they would have the satisfaction of feeling that they pioneered in this important Zionist endeavor. This letter should be weitten immediately, since the executive committee of the Brith Sholom meets April 22.

It would be advisable also, if the suggestions in this memo are carried out, that Dr. Marks write to Judge Leventhal and Mrs. Bender, and urge them to do a little preliminary work with members of the Brith Sholom executive committee, so that when the matter is taken up by the executive committee, the ground will have been prepared in advance.





I am rather amazed to read in your letter that "Unfortunately our Board does not feel that they can devote much time to this particular campaign in view of other important work which we are now in the midst of." The matter of selling shekolim is not left to the discretion of the individual boards of districts, or for that matter of the other parties in the Zionist movement. This is a mandate from the World Organization.

The Zionist Organization of America has called upon all of its districts to devote themselves almost exclusively between now and the time of the elections to the Congress, first, to the sale of shekolim, and then to getting the voters out to vote at the polls. This is a very urgent matter. The World Zionist Congress, the first since the war, will meet at the time when it will have before it the report of the Anglo-American Committee of Inquiry, which in many regards is a very hostile document. It will have to take action in opposition to many of its recommendations and it will need the support of a maximum number of Jews who are behind the delegates attending the Congress.

I wish you would call a special meeting of your district and convey to them my sentiments on the urgency of the matter, and get the Zionists of Columbus out in the field selling shekolim among individuals, societies, synagogues, etc. There are only three weeks left.

My dear Dr. Marks:

The statement of Dr. Wise on the Shekel campaign and the elections should be given immediately to the Yiddish Press, where Dr. Wise's criticism of the general Zionists appeared a few days ago. The, I received your mimeographed announcements which are sent broadcast. Unfortunately, most of them are unreadable because of indistinct typing. Please see to it that whatever is sent out from the office in mimeograph form is legible.

I am glad that you have finally sent out someone to Los Angeles. I hope that it isn't too late. Mr. Auerbach was in to see me yesterday prior to his leaving for his western tour. I gave him some suggestions with reference to his tour.

Mr. Passow was in to see me yesterday. He is making a tour of the communities of Ohio and the neighborhood. He was not himself very clear on the platform of the ZOA. I believe that a memorandum should be sent out to all of our field workers along the lines of the letter which I wrote to Mr. Barbarash the other day, and along the lines that Mr. Lipsky followed at the meeting of the Executive. The lines should be: The ZOA has carried the major responsibility for Zionist activity and education in the United States. It is now carrying on vigorous political activity in behalf of our movement. Its leaders are the leaders of Zionism in the United States. Their arms should be upheld at the polls, and their position of leadership should be strengthened at the World Zionist Congress. Those who believe in the ZOA and in its leadership will endorse them through the purchase of shekolim and through their votes.

An editorial appeared in the May 3rd issue of the "Reconstructionist" called "Platforms for the Zionist Congress" which calls for a reply. I would suggest that Rabbi Miller or Rabbi Newman be asked to draft a reply.

I am eager to hear what the response has been to the Report Questionnaire which you sent out last week. I received the report of Mr. Torczyner about the Conference in St. Louis. It is an encouraging report. Torczyner is doing a good job. He recommends that a field man should be sent to St. Louis to assist the district in its work before May 24. That should be attended to at once. He also requests that a Zionist leader go to St. Louis between May 24 and June 16 to address a mass meeting. Perhaps Mr. Neumann can be persuaded to go there. It is an important community.

Dear Sidney:

From the calls I received yesterday, Sunday, for the Hadassah members, we still stand a damn good chance of taking most of their votes. The Labor Bloc followed me on the air for five minutes, and all they could say was that they apologize for the postponement, because they did not have enough time to prepare for the elections. All in all, I feel that Chicago Z.O. will still show a good return two weeks hence.

It is important that the ZOA should continue to play a significant part in the American Jewish Conference which is holding its next session in Cleveland February 17-19. The ZOA, which has been the strongest single group within the American Jewish Conference, must continue so. At the last Executive and Administrative Committee meetings of the ZOA, a resolution was unanimously adopted that the ZOA give the American Jewish Conference every support and cooperation and use its influence in strengthening that body.

It is disturbing to us therefore to learn that you have not yet replied to the inquiry of the American Jewish Conference as to whether you will attend the next session, (that in reply to the American Jewish Conference inquiry whether you intend to attend the next session, you replied that you are not coming, ( you replied that you are uncertain).

months particularly, the American Jewish Conference has been an effective instrument and a source of significant activity. It effected a coordination with the World Jewish Confress and the British Board of Jewish Deputies by the establishment of a representative body which gained recognition at the hands of our own government and before important intergovernmental bodies, such as, UNRRA, the Committee dealing with reparations, etc. It played an important role at the San Francisco Conference. Latterly, its appearance before the Palestine Inquiry Committee in Washington made a deep impression and was recognized as the spokesman for the majority of American Jews, Its delegation to the camps for Displaced Persons in Germany was welcomed by the Displaced Persons and came back with important recommendations, some of which have been adopted. It is constantly on the alert to protect Jewish interests.

It will have occasions to appear/before UNC and other intergovernmental bodies.

We therefore urge you, both as a Zionist and as one who has taken part in the work of the Conference heretofore, to make every effort to attend the next session and to send in your reply immediately to the American Jewish Conference. If, however, it will be impossible for you to attend the next session, it will be necessary for you, in accordance with the rules of procedure, to designate an alternate from your ZOA group in your community, one who was a candidate on the list; or if you are an organizational representative, to have the organization designate someone in your place. There must be a full ZOA contingent at the Conference.
