January 4, 1946 Mr. Fnanuel Neumann 749 West End Avenue New York, N. Y. My dear Emanuel: I understand that, as President of the ZOA, I have the right to appoint five additional members to its executive committee. February 6, 1946 Mr. Emanuel Neumann 521 Fifth Avenue New York, N. Y. My dear Emanuel: The enclosed cable from Shertok is self-explanatory. Skey He certainly don't want Tulin there. I do not believe that failure to invite him will create any internal problem, and I assume therefore that the matter should be dropped. Have you done anything about getting the Mayor of New York to invite Mr. Rokach? I am enclosing also a letter from Mr. Frank. After reading it, please return it to me. There is considerable irony in the third paragraph before the end, in which Mr. Frank reports an American member of the Committee of Inquiry saying "If the Jewish Agency or the Zionists could get a definitive statement from Molotov or Stalin on Russian policy so far as Palestine is concerned, half our battle would be won. ### MEMORANDUM

TO: DR. EMANUEL NEUMANN FROM: JACQUES TORCZYNER

DATE: May 4, 1946

SUBJECT: Following your suggestion I had a meeting with Abe Tannerbaum and we and we discussed the various problems we are facing.

- I. At the next meeting of the National Executive, which should be called at the earliest possible date, a nominations committee of nine (9) persons should be elected.
  - A. It should have full power to arrange the names as they are to appear on the ballot.
- II. The Slate should consist of two distinct sections.
  - A. The first should be the National leadership.
  - B. The second should be composed of candidates chosen by the Regions.
  - C. Following a "key" which should take in consideration the number of members and the number of Shekolim sold.
  - D. Each candidate should:
    - a .- endorse our platform,
    - b.- affirm his intention to attend the Congress wherever it may be held
    - c.- affirm to abide by the majority rule at the caucus of general Zionists.
- III. A Conference of General Zionists of the Western Hemisphere to be held in New York is not advisable at this time.
  - A. A pre-Congress Conference of General Zionists delegates of the Western Hemisphere could be held in New York, as most of the delegates will leave through or from the United States in New York.
  - B. We feel that a <u>speaker</u> should be sent through Central and South America, and for this purpose we recommend the following names, in alphabetical order:

Jacob Frischman Daniel Frisch Rabbi Harry Halpern.

- a.- It should not be forgotten that a person traveling through South America must be a good Yiddish speaker.
- IV. In reference to your tour we came to the following decisions:
  - A. The following cities must be visited by you and nobody else due to their strategic importance: Detroit, Chicago, St. Louis, Los Angeles and San Francisco.
  - B. Other cities which must be visited by leaders are: Baltimore, Philadelphia, Newark, Cleveland, Cinci mati, Kansas City.
  - V. I have again asked the National office to give me a list of the Hadassah leaders as soon as possible.
    - A. We feel that we should start a campaign which will attempt to win people to vote our ticket.
    - B. During my recent visits to a few communities, I noticed that if there are Hadassah women who will vote our ticket, there are a few Hadassah husbands left who will vote their ticket.
- NOTE: In general I must say that the picture is brighter than it was a few weeks ago. Our campaign is in full swing while the other parties seem to have spent themselves already.
