Dear Dr. Silver:

Mr. Yale Goldberg met with the Steering Committee of our Zionist Membership Campaign last Saturday. We described to him the general outlines of the Campaign and its goal, which is to add 2,000 new members to the Pittsburgh Zionist District which already has over 3,000 members. In other words, we are trying to create a membership in excess of 5,000 members for the Pittsburgh Zionist District. The Campaign was formally launched last Wednesday night, January 16, and will last for about four weeks. As an added stimulant to the Drive, he stated that if we would attain our goal you would be willing to come to Pittsburgh for a mass Victory demonstration. He suggested several dates. We would like to submit to you February 21, or February 28, 1946.

Needless to say, the Pittsburgh Zionist District would be greatly honored to have you accept, and we will make the occasion worthy of your visit. Will you please advise us as soon as possible whether you will accept and for what time, so that this news can be used for Campaign purposes, and so that we may also prepare the community for your visit.

Mr. I.G. Simon forwarded to me a copy of his

letter to you concerning your conversation with him with reference to the Pittsburgh district's Expansion Fund effort.

During the course of the election campaign, I had the occasion to confer with the Pittsburgh district on their plans, and at the opportune moment I brought up the Expansion Fund, which was subjected to a lengthy discussion on the part of the members of the Executive Committee of the district.

Because of the pressure of the election campaign, and realizing full well that at that specific time you were otherwise preoccupied, I delayed conveying to you the message from the Pittsburgh district until this time.

The Pittsburgh district, at a meeting of their Executive Committee, passed the following resolution and asked me to convey this to you.

"Be it resolved that the Pittsburgh Zionist District will, during the month of September, 1946, embark upon a campaign to raise its Expansion Fund quota. Precedence will be given above all other projects during the month of September to the Expansion Fund. Our efforts will be insured success if Dr. Abba Hillel Silver will agree to visit us as our guest of honor on the occasion of a dinner to be given at a date to be reached by mutual agreement between Dr. Silver and the Pittsburgh Zionist District."

I believe that Mr. I.G. Simon, in his letter to COMMITTEE INCOMPLETE you, covered the circumstances and the reason why the district is so insistent.

Dear Dr. Silver:

In accordance with your suggestion to me at the Ohio Valley Conference, I am addressing this letter to you in regard to the Expansion Fund plans.

Mr. Alex Lowenthal, President of the Pittsburgh Zionist District, and his co-officers have been anxious for
some time to carry out the local Expansion Fund campaign.
Due to many difficulties which they were unable to overcome,
they found it impossible to undertake this effort earlier
in the year. As things stand now, it will be impossible to
undertake such an effort before the month of September.

If a substantial sum is to be raised at that time, it can only be possible if you will accept the invitation (extended to you through Mr. Posy) from Mr. Lowenthal to be guest of honor at an Expansion Fund dinner in September. I know that you get many, many more of such requests than you can possibly accept without injury to your health. You must, of course, draw the line somewhere. However, the Pittsburgh Zionist District must not always remain below the line. The last time this happened was when you gave preference to Baltimore over Pittsburgh, despite the fact that you were committed to the Pittsburgh District, which promised 2,000 new members if you would address a victory dinner. Incidentally, the District lived up to its promise.

Unless the Pittsburgh District can arrange for an Expansion Fund dinner in September it will not be able to meet its obligation to the Expansion Fund for the current fiscal year. The Pittsburgh Zionist leaders are anxious to fulfill the District's quota. Unfortunately, in light of the situation here, they cannot do so without your pre-

This suggestion has been favorably received by Mr. Goldstock and his associates and I will be aprised tomorrow morning as to the final outcome of this suggestion.

Meanwhile, I have been in constant contact with Pittsburgh and favorable reports have been forthcoming. I will keep you informed of any further developments.
