1945-1946

PUBLICITY AND PUBLIC RELATIONS

1. Press Coverage: En the fiscal year ending September 50, 1946, a total of some 6,000 columns of Z.O.A. items have been published in the general Anglo-Jewish and Middish press. (Each column comprises approximately 500 words.) The ratio of coverage in the general press is approximately 25%.

The Z.O. A. items published include the following material: News releases, articles, messages on special occasions, photographs and Palestime dispatches.

Many of the items were put on the wires of the national news agencies, such as Associated Press, United Press, and International News Service.

ZOA releaces and feature articles are also furnished to publications appearing in major communities abroad,

2. "INSIDE PALESTINE": This monthly bulletin is being mailed to United States government departments, libraries, newspaper columnists, research workers, district presidents and cultural loaders, educational and religious institutions and to U. S. Army posts throughout the world. Compiled in compact form, INSIDE PALESTINE contains factual information on all phases of the economic and cultural development of Palestine. INSIDE PALESTINE is widely reprinted in bullatins and publications everywhere. Since the last convention, 11 issues have appeared. 5. <u>Promotional Material</u>: The Public Relations Department is responsible for the preparation of all promotional material in furtherance of the activities of all Z.O.A. departments including membership drives and expansion fund efforts. The leaflets and folders published during the year include "A Seed", "I Will Tell You What I Have Seen", "1,500,000 Reasons", revised "Facts You Should Know", "Veterans Album", "Expansion Fund Album", pocket leaflet "What Happens to your Membership Dollar", new flyers, multi-colored posters, enrollment manual, and numerous propaganda handouts.

During special Zionist enrollment periods, this department supervises the publication of advertisements in all morning and afternoon papers in New York as well as other communities throughout the country.

4. <u>Information Services</u> This department has furnished special Palestine news dispatches and photographs to Jewish and non-Jewish public organizations and publications. It also has furnished basic material for articles on Palestine to <u>xuskxywkkksxthawx</u> the United States News of Washington, to the American Council on Public Affairs, to members of the Congress and Senate, to feature writers on the New York Herald Tribune, New York Post and Washington Post.

5. <u>Shekel and Election Campaign</u>: During April, May and June, the major activities of the Publicity Department were devoted to furthering the shekel and election effort of the Z.O. A. for the forthcoming Zionist Congress. This special effort entailed in addition to publicity items, the publication of special campaign bulletins, leaflets, posters, handouts,

advertising copy, and special election issues of the New Palestine-News Reporter. The success of the publicity campaign can be gauged by the extraordinarily wide coverage which the Z.O. A. election platform and issues have received in the Anglo-Jewish and Yiddish press.

SUBJECT: Convention Messages

On the eve of the last convention, I secured messages from a great many organizations and political figures. The publication of these messages before the opening of the convention helped to create the proper stimmung in the press of the country.

I assume that there is no objection to my securing greetings from such organizations as the A. F. of L., C.I.O. and other political bodies and individuals such as Summer Welles, Ickes, etc.

However, I should like your ruling as to whether I should try to secure this time messages from leaders of both Houses of Congress such as Representatives Martin and McCormack, etc. as well as from Ambassadors of various countries. I might add that messages which were lukewarm were usually ignored insofar as the press was concerned.

Inasmuch as very little time remains until our convention, I shall be very grateful to you if you will give me your ruling as soon as possible. These messages are not for the New Palestine but for the general press.





Dear Mr. Ortman:

This is to acknowledge receipt of your letter of January 12th, in which you state that you "have examined the last two numbers of The New Palestine very closely but fail to find any record of participation in the recent Congress, in the aeliberations of that body, on the part of Rabbi Wise." Accordingly you submit your "personal protest" which, we regret, is accompanied by such charges as "partisan manipulation and political chicknery."

It ill befits a Zionist to make such ugly charges, particularly in view of the fact that our publication did report Dr. Wise's participation in the Congress and quarte from his address.

I an enclosing herewith tear sheet of pages 5 and 4 of the New Palestine of December 20th, containing (1) photograph of the opening of the Warld Zionist Congress which shows Dr. Mise sitting on the rostrum next to David Ben Gurion and Rabbi Judah Fishmen; (2) excerpts of the salient remarks made by Dr. Wise on "Fifty Years of Zionism"; and (3) streamer across page entitled "Second Day of Congress Highlighted by Address of Silver, ben Gurion and Mise" giving again quotation of same address. In our issue of January Srd, on page 2, we reported Dr. Mise's election on the praceidium of the Actions Committee as well as his election as senior member of that body.

The reports published in the last two issues of The New Falestine were entirely based upon dispatches of the Jewish Telegrephic Agency, Palcor, the Yiddish press and of New York dailies. We urge you to check with these press reports against the coverage given Dr. Nise in The New Palestine. We categorically deny and reject any contention that we deliberately failed to record any remarks or participation of Dr. Wise in the Congress sessions.

We yield to no one in our respect and esteen of Dr. Wise. The charges contained in your letter are both unfair and unwarranted.

I received your telegram with reference to the request of Reuters for a statement on the American Zionist attitude towards the question of entrusting the Palestine problem to the United Nations. I do not believe that I could issue such a statement. This is a matter for the entire Executive of the Jewish Agency. At the moment there is the decision of the World Zionist Congress against transferring the Palestine problem to the United Mations.

EDITORIAL

The Anglo-Arab Conference in London has ended. The attitude of the British Cabinet rendered its failure inevitable. Though the reasons for it are somewhat obscure, the facts of Britain's policy stand starkly revealed: The British Government will make no decision that is not entirely satisfactory to the British. The Balfour Declaration, the Palestine Mandate and her international treaties are obligations which Britain will continue to violate and to ignore. The terms of the infamous White Paper of 1939 will be enforced, if necessary through force of arms. The doors of Palestine will remain closed to the homeless and destitute Jews of Europe; they will languish hehind barbed wire in the liberated countries or in Cyprus.

The "Plan" finally presented by Mr. Bevin was even more outrageous than the repudiated Morrison-Grady plan. Here was a frank attempt to Ghettoize the Jewish Community of Palestine in so-called Cantons. The Jewish population was to be frozen into a permanent minority and a Jewish Commonwealth completely shelved. Bevin's determination, for which he obtained Cabinet approval, to submit the matter to the United Nations Assembly next September, appears to be only a delaying device to insure the perpetuation of the military administration of Palestine. These facts, coupled with the indefensible ultimatum demanding that the Jews in Palestine make war upon each other and Britain's armed assault upon the Yishuv, amply vindicate the decision of the Zionist Congress not to participate in the Conference and the warnings of our leaders that a proposal for the just solution of the Palestine Problem would not come from the British.

The aftermath of the Conference has been renewed and vigorous Zionist activity. Under the sponsorship of the American Zionist Emergency Council, 650 delegates from 37 States met in Washington on February 17th. They succeeded well in mobilizing pressure within Congress and the Administration for the carrying out of our Government's established policy—immediate entry of 100,000 Displaced Jews into Palestine and abrogation of the restrictive land laws. If, like the Yishuv, we are resolved not to be intimidated by threats of force, not to be discouraged by unjustified assault, but to continue, with unified and disciplined efforts, the upbuilding of our Homeland, we shall yet realize our objective.

SUBJECT:

I deem it my duty to sound a note of alarm in regard to charges of inaction which are now spreading like wildfire throughout the country against the ZOA in its public relations program. A day does not pass when individual Zionists and Zionist districts complain either in their bulletins, over the phone or in person as well as in letters, about the lack of propaganda counteracting anti-Zionist articles and letters appearing in the press. Dr. Sidney Marks has already written to you about this since it was a subject of discussion at our last Office Committee meeting.

I am sending you herewith copy of two letters which we received from active Zionist districts which are typical of the view which is getting hold of ZOA members throughout the country. Open attacks against the ZOA inaction in its public relations program are being made frequently at district meetings and at various other gatherings.

The ZOA publicity department is doing all it can to cope with this situation. Despite our strictly limited facilities we have been drafting here answers to anti-Zionist editorials and letters appearing in various parts of the country. I am enclosing herewith another letter which we received this morning from Julius Livingston, president of the Bouthwest Region commenting on one of our replies. However since we were told here that the Emergency Council is the public relations agency in all publicial matters we refrained from dealing with all matters involving policy. Besides the ZOA publicity department operates on a ridiculously small budget and is handicapped by lack of appropriate manpower to cope with the mounting anti-Zionist material requiring replies.

Before the situation gets any more serious I would therefore in all earnestness suggest that the ZOA public relations department be allocated the amount of \$25,000 immediately for the purpose of hiring men to draw up individual replies to the numerous anti-Zionist articles and letters which are beginning to appear throughout the country, obviously inspired by Arab and British sources. This additional budget will enable also the ZOA public relations department to instal teletype machines through the ZOA regions to receive last-minute instructions and drafts of replies as well as to send out expert public relations men to the various communities to hold press conferences and to reply to anti-Zionist utterances.

I cannot stress too strongly the urgency of immediate action as any attackes for flaws in our public relations program will be directed at the ZOA and not at the Emergency Council.

Typical of this is the fairly long letter published in yesterday's "Times" justifying Bevin's actions in a phase of the Palestine matter.

Also Kermit Roosevelt's article in the "Readers Digest" should have been answered. I am certain that the "Times" newspaper wouldgladly publish any items from the ZOA in rebuttal of letters they publish. This opportunity should not be neglected by the ZOA. Also I believe that a great deal of information should be released to the various newspapers relative to the great accomplishments of the Jews in Palestine.

Our Zionist group in Perth Amboy has been active, having increased the membership from 40 to about 225. We have joined with several Hadassah Organizations in our city in several Zionist endeavors and believe that this is an important point for the success of Zionism in any city. We have instituted a "write to your Congressman" endeavor and have had good results.

We shall do all in our power to implement it, but this thought occurs. Should we not expect National, or the Zionist Emergency Council to takethe leadership in carrying out this campaign for individual letters, organizational resolutions, etc.

We are calling a special meeting on this issue. Why should it be left to each group to decide how to effectuate its program of political pressure. It is too important a matter to be left to the whims and vagaries of each individual group.

I know that big meetings are not always fruitful of results; yet if ever there was a time to rent the largest hall in each city where Jews live for the purpose of mobilizing Jewish opinion, the time is now. I strongly believe in the value of newspaper ads to present our position at such a time.

I will be very happy if you find it possible to give me your reaction to these ideas.

By ending martial law, that for the support of all Jews. The very 15 days kept about half of the fret that all Jews, with hardly any Jewish population of Palestine shut exceptions, are for the abolition of off from the rest of the Yishuv and the world, Britain, against her own will, admitted defeat. She had set out with the aim of uprooting terrorism and failed. Jewish resistance goes on as before. She had expected that by sterr measures, the Yishuv would be forced into siding with and aiding the police and the military by denouncing and delivering the underground leaders and she failed in this, too. Britain even failed in gaining worldwide approval of her decision to use her military might against the Yishuy as she, presumably had expected. The world, rather, began to realize that Britain is committing the great folly of fighting against potential friends and probable defenders of her empire rather than "dissidents." In fact, as former Prime Minister Winston Churchill put it so elo quently by fighting the Yishuv, the Labor government incurred the hatred of the world and put Britain to shame and disgrace.

Yet we Jews may hardly regard ourselves as the victors in this unequal and as yet unended struggle. If martial law has not weakened. but rather strengthened the Yishuv morally, it surely has weakened it economically. There is no assurance that martia. law as a weapon will not be used again by the British. In fact, we cannot be certain what the British have up their sleeves politically, militarily and economically.

Job for U. S. Jewry

While this sword of Damocles hangs over our heads, we must plan our immediate activities along a new or renewed lire that may embrace two distinct efforts: one directed against the White Paper and the other concentrated on Washington where the final decisio: on

the White Paper and the opening of the doors of Palestine for Jewish immigrants should make it quite easy to mobilize all Jewry for this particular purpose. Here we may really have a united Jewry speaking with one voice.

U. S. Jewish Assembly

The immediate calling of an all-American Jewish assembly for this purpose, to insist on the withdrawal of the White Paper, should be in order and the first business of the day. The call must not necessarily be issued by the Zionists. It would be quite fitting to the occasion that the initiative be taken by "independents" with no political or ideological restrictions. It should be a real Kol Israel effort.

If properly organized, such an assembly may become a real force that would be reckoned with in Washington as well as in London. No doubt such effort would be crowned with success. But it must be understood that this can be accomplished only if the effort is free from "politics" and is purely and simply an all-out Jewish ef-For this alone, the effort fort. should be worthwhile.

As to our effort to concentrate on Washington, it is not only of a long-range character, but it is also, primarily and purely, an all-Zionist activity. The Labor government is doing its utmost to Jull Washington into inactivity, to make it believe that the Palestine problem will be solved by Britain if she only is left alone and not "interfered" with, particularly by Washington and the militant Yankee Zionists, who are not "reasonable" enough to be dealt with by such "good friends" of the Jews as Bewin.



(by Air Mail) .- At 7:15 A.M. yesterday, the radio announced martial law, the long-

highly-feared evil deawaited, cree. Bet Hakerem was out of the area and the three small food shops there were besieged by men, women and children, panic-stricken by the ugly words, "martial law." Not knowing what they meant, they attempted to prepare for a siege.

At 1:15, the radio announced that the house curfew was lifted in Jerusalem except for the area where martial law was decreed. I walked inte town.

It was possible to walk only on the south side of Mia Shearim Road. This served as the boundary of the martial law area. The contrast was frightening-to the south. life went on; to the north, stoic intersection, At every silence. groups of little children stood staring at the suddenly-silenced streets.

As I turned back into the free zone, I noticed the housewives herdtheir children homeward. 1 ing their shocked voices, overheard They shot a girl, they shot a child."

JERJSALEM, in answer to my request, told me to go to the Syrian Orphanage (a mile away) for a zone pass.

Seeing the Brigadier in charge escorting a group of newspapermen, I walked over to him. I explained the situation and asked if I might bring the milk to my grandmother, not knowing the name of the woman who had asked for it. "I'm sorry, but no exceptions," was the reply. I continued further that she was a very old woman and that I was certain that there was no food in the house. He answered that "there are children in the same area, too." To which I rejoined that I didn't see the sense of those innocents suffering. The Brigadier's face blushed, then frowned. I left.

At 1 P.M., the sound trucks ordered all pedestrians on both sides of the road to leave. When I returned shortly before sunset, the entire street had been blocked by hastilystrung barbed wire. A 16-year-old girl stood at an intersection, tears slowly rolling down her cheeks. She extended her arm, pointed at the sight and said, "This reminds me of the camps in Europe." As I walked home, I wondered if the others in

The British had shot and fatallywounded a four-year-old girl. Jewish Jerusalem was alive with this story for hours. The radio broadcasts denied that anything but warning shots had been fired. Only in the last evening announcements was it reported that a girl had been found in the streets, wounded in the head, and that she had died later in the Hadassah Hospital.

Early this morning I went back to the area. On the free side of Mia Shearim Road, relatives and friends stood throwing food to those in the forbidden area. My eyes filled with tears as I watched an aged, bearded man awkwardly stoop to pick up some fruit that had been thrown by his son. I wondered whether this was not a scene of ghetto days again.

The latest newspaper analysis (May 24, 1947) on the Palestine question as reported by the Twohey Analysis of Newspaper Opinion of Washington, D. C. is as follows:

Verty seven per cent of the comment revolves about the decision of Jewish resistance groups to continue terrorism in Palestine. Here 32% rebuke the Jewish terrorists, hold the UN investigation committee should be allowed to come to decision in calm atmosphere, disapprove activities by Ben Hecht and others seeking U. S. aid for Palestine resisters, point out the British have questioned U. S. contributions to terrorists, suggest U. S. interests are endangered by the disorder in Palestine.

"The other 15% condemn British treatment of Jaws and hold terrorism justified, disapprove British protests against fund raising in the U.S. to aid Palestine resisters, etc. Both the discussion disapproving and approving Palestine resistance comes in large measure from that portion of the Eastern seaboard press which over the past year has more or less consistently upheld the Jewish side in Palestine.

Remaining comment is of a miscellaneous nature and much of it is of the vague, something-ought-to-be-done type. There are more references in all comment on the role that Russia is seeking to play in Palestine. The same suspicion of Russia evidenced in comment on other subjects is apparent in most of these references, but the press seems unsure of the aims of Russia.
