Dear Dr. Silver:


I have been home ill for over a week and that explains why I have not acknowledged earlier your kind letter about my chapter on Zionism in the United States. I am only now able to dictate this note over the telephone.

I appreciate what you say about my initial effort to give an outline of the development of American Zionism. If it is possible to do so in the page proofs, I will endeavor to make some of the corrections you suggest but, as you surmise, it would be too late to go into any further elaborations of some of the points to which you refer.

As a matter of fact, I did not intend to treat so extensively the various developments in detail as that would have applied to various other aspects and would have involved a much longer essay than I originally contemplated. Dear Mr. Ress:

Hadassah wishes to record with the United States Central Shekel and Election Board its protest against the Board's method of tallying challenged votes cast in the 1946 election of delegates to the World Zionist Congress.

As our representatives have consistently stated at meetings of the Shekel Board, we consider that the only correct and legal procedure in respect to challenged votes is to check the name and address of each such voter against the original registration lists of shekel holders as submitted to the Board by local party groups. At the last meeting of the U. S. Central Shekel and Election Board on Tuesday, July 30th, it was voted to admit every challenged vote for which there was a shekel bearing the voter's name and address, without checking the name and address against the registration lists. Hadassah representatives voted against the motion on the ground that this policy has the effect of validating questionable votes many of which had been challenged on the ground that they represented multiple voting. The admission of such votes merely on the basis of an accompanying shekel, upon whose sale there was no check, constitutes a violation of both the letter and the spirit of the Congress election laws.

In view of the fact that Hadassah regards this formula for the challenged votes adopted by the U. S. Central Shekel and Election Board as illegal, Hadassah hereby disassociates itself and withdraws its watchers from the count of the challenged votes as it is now proceeding. This protest will be brought to the attention of the Congress Court.


Dear Dr. Silver:


Dear Dr. Silver,



The "Morrison Scheme" as a solution of the Palestine problem indicates how far we have wandered from the realities of the situation. Any careful student of the problem must conclude that immigration is the key to the Jewish National Home, and for the salvation of the surviving remnants of European Jewry there must be both adequate area and a territory where Jews may freely enter - to reiterate Churchill's famous phrase - "as of right and not on sufferance." The Morrison scheme violates both of these principles, for it would attempt to subvert the Zionist ideal of a Jewish Commonwealth into a regimented ghetto with the vital key of immigration in the hands that "knew not Joseph." But perhaps the worst aspect is the false nomenclature employed, for it inevitably prejudices the mind against "federalism" even as "partition" is compromised when inadequate territory is offered for the establishment of a "Jewish State." Had the Peel Commission suggested the division of Palestine and Trans-Jordan in such a way as to have assured adequate territory for Jewish immigration, its speedy acceptance would have resulted in saving a couple of a couple of million Jews from Hitler's gas chambers.

A similar error must not be permitted to destroy "federalism." In August, 1938, I appeared as a witness in London before the Woodhead Commission, and for the first time urged a federal plan for Palestine and Transjordan, based upon the well tried principles of the American Federal system, with its hundred and fifty years of successful experience. This was not a mere personal opinion, but backed by a committee of representative Jews of Haifa, where, despite sporadic attacks, Jews and Arabs have lived in peaceful cooperation for a quarter of a century. The Morrison Scheme would appropriate the term "federalism" in such a way as to bring suspicion upon the very name. But we must not be misled by a false name. The Morrison Scheme is no such federalism as can be found anywhere in history - neither in the heavens above, the earth below nor the waters under the sea. Merely



giving the dog a good name does not guarantee that he will not bite.

Now what is federalism. We have two outstanding examples in history- Switzerland on a small scale and the United States of America on the world stage. Both grew out of the necessities in each case: the former with four language groups, divided into separate religious communities, manage to overcome their separatism through a federal system which guaranteed local customs within the autonomous cantons and religious freedom throughout the whole federal territory. The thirteen original states of the American Union, on the other hand, were fashioned out of a Revolutionary War against the mother country, which formed the prelude to a French Revolution that shook the world. Both Switzerland and America offered the widest possible range for local self-government - which is the very essence of federalism. Any scheme restricting such "state rights" is simply not federalism, but something else operating under the mask of a false title.

There are, of course, differences between the federalism of little Switzerland cantons and huge American states, arising out of local conditions, but the essence of both is the widest possible latitude for self government, with only the limited powers vested in the Federal Council or Congress. Thus, despite differences in language and religion between French Protestant Geneva and German speaking Catholic Lucerne, the legal system remains the same, whereas among the English speaking American States, where religion is a mere private matter of conscience, the various systems of law may differ as widely as that between New York State, based upon the English Common Law and that of the State of Louisiana, with its basis upon the French Code. Indeed, Americans are proud of the fact that each state may carry on experiments in social and political areas, which, if successful, may be adopted by the other sister commonwealth. Thus, while the matter of immigration became a federal concern, under the original constitution, the same principle does not apply to the "immigration" of other "legal persons" known as cooperations or limited companies, which remain "residents" of the states in which they are



organized. Instead, such limited companies are bound by the principle of reciprocity between the 48 states, and may emigrate to another state only upon the same general conditions offered to the "foreign" cooperations of the state in which they were organized.

Such a salutary principle of reciprocity may well be applied to all immigrants, whether persons or cooperations, that might desire to travel between the two sister states - the Jewish Commonwealth and the Arab Dominion - of Palestine and Transjordan. This would solve the immigration problem for both Jews and Arabs, since each would control its own immigration within the prescribed boundaries, while the residents of each state (including, of course, the substantial Arab residents with equal rights, of the Jewish Commonwealth) would have reciprocal rights equal to those granted by the sister states to the residents of its neighbour.

Once the subject of immigration is satisfactorily solved there will be no serious obstacles for the evolution of a federal system for Palestine and Transjordan, since both states will receive undoubted advantages while the individual Arabs and Jews of the two sister states will reap the large benefits of friendly cooperation. The chief basis of the Federal Union must be economic. The collection of the customs duties, as a federal function, would be more than sufficient to cover all the federal obligations, while the surplus might be divided equally between the two sister states - the Jewish Commonwealth and the Arab Kingdom. The federal government would likewise operate the Post Office (including the Telephone and the Telegraph system), the Railways and such other public utilities as may be provided for in the Federal Constitution "to promote the general welfare" of all the inhabitants. Ultimately, it should be possible even to set up a Jordan Valley Authority to carry out the far reaching plans for the development of Palestine as a whole. Indeed, we might establish a principle that while the two sister states might differ in their politics, even as the right hand from the left, economically they must be united in the sustenance of



an integrated body for the benefit of the whole Near East.

The chief objection urged by the Arabs of Palestine against any Zionist solution is the expressed fear of domination by a minority of Jews, while any ordinary partition scheme may seem as objectionable as the separation of Northern Ireland from the rest of that country. But a true Federal plan - along American lines - whereby Palestine and Transjordan might be divided geographically between the Jews and Arabs, while yet remaining united for limited federal purposes, may meet all valid objections, and at the same time preserve the British strategic interest in the Near East. In setting up such a Federal plan we must take note of the insistent demand that the Jewish Commonwealth (within a federated Palestine) must be adequate in area and have control over its immigration within that territory, for otherwise the whole Jewish problem is thrown back again for a solution in a distracted world that remains closed to Jewish immigrants.

At the same time, the Arabs of Palestine may be assured of ample space for full development not only in Transjordan but in that part of Palestine which is predominantly Arab, while the two sister states - Arab and Jewish - will form an economic unit for federal control over customs and currency that should prove highly beneficial to both. Supervision over the Holy Sites would be entrusted to the British High Commissioner, who would likewise preside over the Federal Council, in which the Arab State and the Jewish Commonwealth would have equal representation.

The key to the solution of the knotty problem of Palestine is the formulation of a principle that the Jewish National Home shall cover the maximum possible area in which Jews constitute now 51% of the total population, and vesting control over immigration within that area to the Jewish Agency or the autonomous commonwealth. Such a formulation must end once and for all the specious argument about the Jewish domination over an Arab majority - as if the 200,000 Jews of throbbing and bustling Tel-Aviv could ever submit to be ruled, under democratic principles, by a handful of notables from nearby Jaffa. Such a program would offer the prospect



for a "Jewish territory" immediately that would include Galilee, the Coastal Plain and the larger part of Judaea with the Negeb, to form a full fledged Jewish Commonwealth with representation in the United Nations, on a plan similar to that accorded to the Lebanon. The Arab State, on the other hand, would include not only Transjordan but also the territory of ancient Samaria (stretching from Jenin in the north to near Jerusalem in the south with Tul Kerem in the west as the apex of what has been aptly called the "Nablus Triangle"). Both states together would constitute an economic entity, while politically each would have full autonomy, including control over its own immigration policy.

In view of the fact that as a result of the First World War the Arabs were rewarded with an immense territory conquered from Turkey, including an area now constituting the independent States of Iraq, Syria (and Lebanon), with Transjordan, or about 25 times the size of little Palestine, it certainly is not too much to require that out of the remainder former Turkish territories, which British arms under Allendy, aided by three Jewish regiments (who served under him), had conquered, a small portion representing 60 or 65% of western Palestine, in which the Jews already constitute a majority of the population, shall be set aside for the fulfillment of the Balfour Declaration and the execution of the Palestine trust which Great Britain voluntarily assumed.

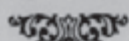
It seems to me that such a federal plan would meet with the approval of the American Government and might induce the latter to accept the proposition of a 75 Million Pound loan for development purposes now so sadly needed.

SUBJECT Zionist Expansion Fund

I would like to ask for your assistance on a matter which gravely affects the U.P.A. and the Welfare Funds throughout the country. There seems to be a rather determined effort on the part of some of our Zionists to transfer responsibility for the Z.O.A.'s organizational fund, the Expansion Fund, to the local Welfare Fund. This would be a very serious mistake, even in those communities where the Zionists are in complete control of the Welfare Fund. The inclusion of the Expansion Fund would automatically open up the invasion by every organization, regardless of size or influence for their organizational funds. Thus, the American Council for Judaism in such cities as San Francisco, Chicago, St. Louis, Houston, Philadelphia, etc., would have a completely justified claim for support for their program by the local Welfare Fund. We must recognize that the Zionists would be charged with being responsible for opening a breach which would, undoubtedly, result in the destruction not only of the Welfare Fund, but of the combined U.J. A. campaign.

I appreciate that the Zionists are anxious to avoid the multiplicity of campaigns for local Zionist projects, the Zionist Expansion Fund, etc., but statesmanship would require that they contemplate the effect on the organizations and on the Welfare Funds. Obviously, if the Z.O.A. gets its funds from the Welfare Fund, Mizrahi has a claim for its organizational fund, the Labor Zionists for its Emergency Fund, the National Council of Jewish Women, the B'nai B'rith, the Workmen's Circle, the International Workers Order, etc., etc., until complete chaos exists. The strength of the Welfare Fund has been the fact that it was projected on the basis that it supported those programs which have claim on Jews of all ideologies and interests. Any deviation of that, would spell its destruction.

The problem has become very real in Boston, where some of the Welfare Fund leaders and some of the local Zionists are now in the stage of negotiations. It is also real in Atlantic City, where plans are being made to make application to the Welfare Fund.

I know of no matter which is so urgently important and which needs our immediate attention. I would appreciate whatever steps you can take to avert this serious development.

For the past week the Zionist Archives and Library has utilized its resources and staff for the compilation of documents in preparation for the forthcoming Meeting on Palestine of the General Assembly of the United Nations.

1. The Jewish Agency for Palestine here requested certain documents from the Zionist Archives and Library which were provided. We have also supplied them with a complete list of all the documents issued by the Jewish Agency of which the Zionist Archives and Library has almost a complete file; and a list of all the Commissions with the official replies of the Jewish Agency. We made photostat copies of documents for the Jewish Agency for official presentation to the United Nations.

2. We supplied and are supplying material directly to the United Nations. This was done in the following ways:

a. Mr. S. Hartz Rasmussen, Librarian of the United Nations telephoned to tell us that Miss Marie J. Carroll, reference librarian, would come to the Zionist Archives and Library in order to consult the bibliographical aids to documents and secondary material on Palestine.

b. As a result of Miss Carroll's two-day visit to the library, we have sent to the United Nations Library about one-hundred books and pamphlets on Palestine and Zionism. We are now preparing an additional collection of about fifty documents for them. This material will be kept in Flushing Meadows for the use of the research workers for the duration of the meeting.

c. In addition, upon telephonic requests from the librarian we have forwarded to the United Nations copies of various statements, such as the Roosevelt message to the Zionist Organization of America Convention of 1944 and his statement on the White Paper, as well as the Truman statement of October, 1946, etc. These were sent directly to the Library of the United Nations upon their request for official documentation.

d. We have now established such close relationship between the Zionist Archives and Library and the Library of the United Nations that they telephone to us to check reference to documents, etc.

e. For the last week a research worker of the Trusteeship Committee, Mrs. Erville, with a staff of one or two stenographers, has been working in the Zionist Archives and Library compiling material for a survey on Palestine for the Trusteeship Committee. We have given her basic material and she is in constant consultation with our staff as to what material to use. We have also photostated for her material which is to be found only in our library.

We will be very glad to give you a list of the books and pamphlets which were sent to the United Nations as well as copies of the list of documents issued by the Jewish Agency which we compiled for the Jewish Agency here.

It is indeed gratifying that we are able to render this service.

I consider the addition of your district as an important acquisition for our organization. It strengthens our organizational structure and enhances our influence in an hour when numbers count and active membership supports our voice.

The special session of the United Nations on the Palestine problem has shown that our case is being understood by many countries. This was particularly manifested in the last days of the Assembly meeting.

However many unpleasant surprises may yet be in store for us. Powerful forces are working relentlessly to frustrate our just aims. As we enter the final stages of our struggle for a Jewish Palestine, requiring presentation of our case to the special investigating committee and subsequently to the full Assembly of the UN, our vigilance and efforts must be redoubled. The success of our struggle will in the final analysis depend upon the measure of our own efforts and devotion. Upon the shoulders of American Zionists there now devolve greater and heavier responsibilities than ever before. Let us exert every ounce of our strength and resourcefulness to rally American public opinion and to impress the nations of the world that entire Jewry stands behind our just claims.

It is gratifying to know that I can count upon your valuable cooperation and upon the active participation in our work by all your associate officers and the entire membership of your district.



Dear Dr. Neumann,

I was sorry that I had to leave the meeting last night early in order to catch my train home, and that I therefore had no opportunity to talk with you with reference to getting a representative from the Rhode Island Region on the National Executive Committee. If you recall, I spoke to you, and to others, at the last convention with reference to this same matter, but nothing came of it. I believe that we ought to have a member on the Committee, and that we are entitled to it. Last year, we were told by the Nominating Committee that the first consideration is numerical membership strength, and I wish to point out to you that on the basis of the national office records, we increased our membership by 1185, or 68% from September 30th last year to April 30th this year, as follows:

Newport	Up 12
Pawtucket	Up 217
Providence	Up 832
Westerly	Up 1
Woonsocket	Up 123

Actually, we got considerably more new members than the national office records indicate because of the fact that the national carries delinquent members for several years, and when we get them signed up, they credit the membership against the old account rather than to new membership.

Further, we have about 350 members signed up in Providence whose names are being sent in to National constantly as fast as their dues are paid. Counting these members, we have increased our membership by 1535, or 88%, and the Providence figure above would read "up 1182."

Dr. Silver was here in Rhode Island last February to address our regional conference, when we had a record crowd of about 1400, and he saw what we in Rhode Island are endeavoring to do to carry through the Zionist program and the enthusiasm of our members. I believe that he will tell you that we are sparing no effort in behalf of the Zionist cause.

The man whom we have in mind for nomination to the National Executive Committee is Mr. Archibald Silverman, who is one of the outstanding Zionists in the country. As a matter of justice, we feel that we should be granted this representation.
