FORMER PRESIDENTS GOLDMAN KAUFMAN LEVINTHAL LIPSKY ROTHERBERG SZOLD AND
WISE QUOTE YOUR TELEGRAM ADDRESSED TO DISTRICT PRESIDENT IN OUR REGION HAS
COME TO MY ATTENTION I DEEPLY DEPLORE THIS UNNECESSARY AND CONFUSING ACTION
ON YOUR RART NEW ENGLAND HAS NEVER HAD TO BE ADVISED HOW TO FUNCTION IN A
DEMOCRATIC MANNER AND HAS ALWAYS PERMITTED COMPLETE FREEDOM OF EXPRESSION
BY ITS DELEGATES PRESENT NATIONAL ADMINISTRATION HAVE NEVER INSTRUCTED
NEW ENGLAND TO BIND DELEGATES NOR ADVISED US HOW TO VOTE ON THE CONTRARY
SOME FORMER ADMINISTRATIONS HAVE DONE SO WE ARE GRAVELY DISTURBED BY THIS

Dear Dr. Wise:

I have received a telegram signed by you and six other former presidents of the ZOA.

For your information, mone of the delegates of this Region elected as delegates have, I am positive, been instructed, directly or indirectly, with respect to any matter which may present itself before the coming Convention — nor have any been solicited until now to take any position with respect to any candidate for office. I say "until now" advisedly though the telegram which I received does not specifically solicit support of a particular candidate, it is sufficiently clear to any informed Zionist that it does solicit opposition to one.

Before receipt of this telegram, considering all of the events which have occured since the last Convention, the progress we have made, the mistakes, the fortunes, and misfortunes which have befallen us, I came to the conclusion without solicitation or request of any kind, that Dr. Emanuel Neumann, if he would accept the presidency, deserved my support. I so wrote him. My first knowledge that he would be a candidate came on reading of it in the press.

Following the writing of that letter, we held a Regional Administrative Council meeting at Chattanooga this Sunday last. It was attended by delegates from all of the districts of this Region. The matter of the candidacy of Dr. Neumann was not on our agenda but in our general discussions with respect to the coming Convention, I fould a remarkable unanimity of opinion among our leaders for his candidacy. This unanimity was spentaneous and was so far as I could ascertain, in no way inspired by solicitation or suggestion by anyone outside of our Region. It aroused, as I see it, as a result of the sober recognition of the services which Dr. Neumann had rendered during his lifetime to our cause.

I think, furthermore, that the sniping and snapping at the heels of Dr. Silver and Dr. Neumann by former presidents of the ZOA will not register too well with our delegates. I think, therefore, though I can speak for no individual and control no vote other than my own, that when the delegates from the Southeastern Region vote, they will do so without instruction, without solicitation, without pressure and unanimously for the candidacy of Dr. Neumann exercising, in so doing, their full right of freedom of speech. As for myself, I can state no freer spirit ever lived than I. It is about the only worthwhile thing I pessess and I guard it zealously. However, it has been my experience that there is often a confusion between "freedom" and "license". I have never understood democracy to be synonymous with anarchy and confusion. Though democracy does not require regimentation, I do believe that to be effective some discipline is necessary. Discipline was rather sadly breached at the Congress in Basle and by subsequent events in which former presidents of the ZOA participated.

It is my considered opinion that neither influence requested nor solicited by anyone exceptyourselves and therefore freely given to you, that Dr. Emanuel Neumann will be elected president of the ZOA, that following the end of his term, he will probably join with other former presidents in sending telegrams on the eve of the Convention which I will receive and to which I will make reply as I do now; and thus we will go on from strength to strength sending telegrams and electing presidents as democratically as we always have in the past.

Dear Dr. Wise:

I have recently received a telegram signed by you and Solomon Goldman, Edmund I. Kaufmann, Louis E. Levinthal, Louis Lipsky, Morris Rothenberg and Robert Szold.

The Seventh Zionist District, of which I have the honor to be president, in accordance with its usual practice, is sending to the National Convention delegates "uninstructed, unbound, uncommitted to any group or faction, and unpledged to any candidates or list of efficers."

Though I agree that the conventions should be a legislative assembly and that no administration should use its
machinery to perpetuate its power, I am amused at finding the
names of certain signatories attached to the telegram criticizing the tendency to reduce the convention to a mere demonstration and to perpetuate administrative power. Further, I
recall that the tendency to concentrate power in the administration and to use the convention as a mere demonstration
or series of mass meetings was the practice of the administrations whose presidents are among the signatories of the
telegram. I recall also, that the last convention, under
the administration of Dr. Silver was more of a deliberative
body than many preceding conventions. The telegram seems
to me in this respect, rather laughable.

This letter is an expression of my own opinion, since I have not had the opportunity to present this matter either to my Executive committee or to my membership.

YOUR TELEGRAM OF JUNE THIRD WAS A GREAT SURPRISE TO ME SINCE IT IS RATHER
AN UNUSUAL EXPERIENCE THAT PAST PRESIDENTS SHOULD ATTEMPT TO CAUSE DISSENTION
WHEN WE ARE IN THE MIDST OF TRYING TO SOLVE A DIFFICULT POLITICAL SITUATION.
IN OUR REGION WE ARE FULLY AWARE OF THE DEMOCRATIC PROCESSES GOVERNING OUR
ORGANIZATION. WE HAVE NO KNOWLEDGE OF EFFORTS MADE BY THIS ADMINISTRATION
TO INTERFERE WITH THE INNER POLITICS OF OUR REGION OR OF ANY ATTEMPTS TO
INSTRUCT OUR DELEGATES IN THE MINNER IN WHICH THEY SHOULD VOTE AT THE
NATIONAL CONVENTION. I DO RECALL HOWEVER THAT THIS PROCEDURE HAS BEEN
QUITE PREVALENT DURING THE ADMINISTRATION OF SOME OF THE SIGNATORIES OF
THIS TELEGRAM. WE FULLY RECOGNIZE OUR RESPONSIBILITY TOWARDS OUR MOVEMENT
AND WE SHALL COME TO OUR NATIONAL CONVENTION WHICH IS COMPLETELY INDEPENDENT
AND WHICH WILL BE MAINTAINED ON A HIGH DEMOCRATIC LEVEL. IT IS THE WILL
OF THE DELEGATES OF THE CONVENTION WHICH WILL PREVAIL AND SHAPE THE COURSE
OF OUR DECISIONS AND ACTION.

## STATEMENT BY ORDER BNAI ZION

It is a source of deep regret to me as Nasi of Bnai Zion that a group of past Presidents deemed it desirable to launch an attempt at division by sending out an uncalled for and unwarranted telegram to the various Districts and Regions, accusing the present Administration under the leadership of Dr. Silver that it is attempting to perpetuate itself in power by having asked for instructed delegates to this Convention. The Order knows from experience that the present Administration has never directly or indirectly tried to influence its inner affairs or indicate the attitude of the delegates to the coming Convention.

Not only does this telegram create a very bad impression at this crucial moment in Zionist history, but it casts a deep reflection upon the motives of some of the signatories whom we learned to look upon as spokesmen for the cause.

Zionist leaders, even though not past Presidents, need not be taught in matters of democratic procedure.

Bnai Zion recognizes its responsibility towards the movement and is coming to this Convention with but one thought in mind - to elect the best man available and to continue the militant and activated policy and tempo of the present Administration.

I am confident that I bespeak the sentiments of most if not all of my colleagues in the Order.
