My dear Rabbi Silver;-

A remarkable opportunity is offered now for those concerned with the housing problem in Cleveland, to help in solving some fundamental social problems and to build for a better community. The enabling legislation providing for a Public Housing Authority to make low-cost housing possible, was enacted at Columbus last week. An authority of five is to be appointed shortly, two to be chosen by the Mayor, one by the County Commissioners, one by The Probate Court and one by the Court of Common Pleas. Every credit is due Councilman Ernest J. Bohn for obtaining this important legislative action. This group of five will be able to affect the lives of thousands of Clevelandors and to determine the course of much future development for the City. It is importative that men and women who are competent, disinterested and socially-minded be chosen.

The Committee on the Social Aspects of Housing is calling a meeting of various civic bodies to consider this matter on Monday, September 11th, in the auditorium of The Engineering Society, 410 Hanna Building, at 8:15 p.m. We hope to develop out of this meeting, a Citizens' Committee, that shall work and agitate for a proper Public Housing Authority. We hope the representatives of your organization will be present at this important meeting. We must not miss this opportunity to build for a better future for Cleveland. We must ast quickly.

MANIFESTO AGAINST WAR

Adopted by the Trustees of THE CHURCH PEACE UNION MAY 1933 Made neservations on Ingats Lianus att.

WE must have a warless world if we are to have any world fit to live in. The time has come when organized religion must proclaim that never again shall war be waged under the sanction of the Church.

The World War stabbed the religious conscience awake. It is now self evident that war cannot be humanized, controlled or localized. It must be abolished. With the ruins of the last war piled high at its feet the Church should solemnly declare herse f the implacable enemy of war. The nation which unsheathes the sword, except solely in self defense, is henceforward to be regarded as the deadly foe of all mankind.

In times past good men have often fought on the battlefield because their eyes have been blinded by tradition, false teaching and an undeveloped conscience, and sometimes they have drawn the sword because diplomats and statesmen have driven the nation into a position from which the only honorable way out seemed to be across the field of slaughter. But God is now calling upon all men everywhere to repent. The time has arrived to change our mind and our conduct. Under the influence of the Spirit of God men change their ideals and their policies. They forbid what they once allowed, and accept standards which they once rejected.

Modern War is Suicide

WE have had in our generation an appalling revelation of the true nature of war. War is not what it was. When science added the aimstane, the submarine and poison gas warfare emered on a new stage.

With the advent of poison gas and bacteriological germs it laid aside the last vestige of decency. War has always been bloody and brutal. It is now an atrocity. In olden times it seemed honorable, for it gave occasional opportunities to show chivalry, but now it is indecent and revolting. Boys are now butchered at long distances and by machines manipulated by executioners who do not see their victims. All distinctions are blotted out. No regard is paid or can be paid to sex or age or civil status. Mothers and their babies are torn to shreds by bombs hurled from the clouds. Aged mem and women are tortured by slow starvation. Nurses and their patients, under the protection of the flag of the Red Cross, are ground into bloody pulp.

There is no mercy in war and no justice. No question of honor can be settled by war. No problem of right and wrong can be solved by force. War is as futile as it is barbarous. No nation can be sure of gaining anything by war. There is no victor. All are defeated. All are loaded with debts. All are compelled to build hospitals to house the maimed. All carry on their backs a load of human wreckage which drives millions to despondency and despair. Modern war is suicide. The sword is so sharp that a nation can cut not only the throats of its neighbors but its own throat also. Civilization itself is in jeopardy. The nations have in their possession the means of blotting out all that man has achieved.

Military Preparedness No Guaranty of Peace

AN war be abolished? Have not men always fought? Is not man a fighting animal? Can human nature be changed? Is not war inevitable? Multitudes believe it is. This is a superstition. War is not like a hurricane, or a volcano, or an earthquake, or a tidal ware. These are inevitable because man has nothing to do with their creation;

but war is man made. It comes out of the human heart. What comes out of the human heart can be ended.

That military preparedness is the only guaranty of peace is one of those illusions which only knowledge can banish. When men say in time of peace prepare for war, they repeat a slogan of the ancient pagan world which has no rightful place in the twentieth century. War is not inevitable. The fact that it remains is not due to our stars but to our stupidity and bad dispositions. Big armies are not the result of "heavenly compulsion," nor do huge navies ride the seas because of a divine "thrusting on." Our wishes for peace have been fervent and our prayers have been many, but our technique has been at fault. If once we have a will to perpetual peace we shall not lack the wisdom to devise a way to attain t.

Governments Should Control Arms Manufacture

NO eliminate war two kinds of work are called for. We must both lay down the weapons of war and strengthen the agencies of peace. The two efforts must be carried on concurrently. We must attack the institutions which breed war. One of these is private armament firms. They make big profits for their stockholders and are able to subsidize newspapers of the baser sort, Some manufacture war scares and throw the multitude into panic. We can never have a warless world so long as powerful syndicates and an incendiary press are allowed to coin gold out of the peoples' fears and hatreds. If guns and warships are to be manufactured at all, their manufacture must be lodged in the hands of the governments. This is one of the first steps toward universal peace.

War games should cease. The boys of the nations should not be drilled in the art of killing human beings. Patrionism should not be linked in their minds with a gun. If we are to have a warless world, then military drill on the present scale must go.

A third step is essential. Military and naval officers should not be delegates at international peace conferences. The recent conferences on disarmament have come to little, largely because attending army and navy experts have been legion. The conferences are frequently sidetracked by the war specialists. Instead of tackling the question of how to secure peace, they discuss parity and security and safety and lose themselves in a morass of words. To expect progress in the cause of peace, so long as professional militarists are in the saddle, is one of the mental aberrations from which we must be delivered. The man in the street is sorely perplexed by the failure of these disarmament conferences, but this is no mystery to any one who knows that generals, and admirals and armament makers stand in the background, often silent but always mighty. These experts are not trying to banish war but simply to regulate it. They make new rules for it. They love to discuss the bores of guns and the tonnage of ships. The one vital question: How to secure a warless world, they stealily ignore.

"Security" Not Based Upon Armaments

/ ILITARY and naval budgets should be drastically reduced. Nothing is more deserving the scrutiny of the American people than the reports of our army and navy expenditures during the last fourteen years. They play with the word "security." They mesmerize the unthinking by the word "inadequate." Their argument is as plausible as it is simple. "Give us an adequate navy and army and your security will be assured." This is not true. Europe was armed to the teeth before 1914 and no nation was secure. Europe is now more heavily armed than before the World War, but no European nation is secure. There is no security for any nation in guns. It was once thought there was security in dreadnaughts. That myth was exploded. It was argued that security resided in submarines. That illusion was dispelled. It is now asserted that only in aircraft can a nation find safety, but this also is an idle fancy. There is no adequate army or navy. That is a will-of-the wisp. There is no security for nations except in friendships. These can be created by nations which feel their value. One of the supreme tasks of every nation is to keep its international friendships in repair. Nations should disarm. Otherwise there is no

solution for the world problem. There was a time when statesmen discussed the limitation of armaments. Later, they advocated the reduction of armaments. Today, the question at the front is the abolition of armaments. Armaments must go. This does not mean that all armed forces must be discarded. Every nation is in need of a police force. Law and order must be safeguarded against the thugs and rowdies. The world cannot go on without armed guards on land and sea.. There must be an international police force, and each nation must make its contribution to it. But the present armaments of the world are not for police purposes. They are for war. War is a duel. Armies and navies exist for fighting national duels. Duels are outgrown in private life. They must be cutlawed in the life of nations.

Let Us Cease All War Preparations

PREPARATIONS for war should cease. Governments have renounced war as an instrument of national policy. That was a great step; one of the greatest steps in history. We are now ready for the next step. The nations should renounce preparedness for war. It is not enough to renounce war. We should cease to prepare for it. If we prepare for it, it will come whether we have "renounced" it or not. It is futile to renounce it on paper if we prepare for it in our navy yards. The way of escape is easily seen. All war preparations should cease. That is what the spirit is saying to the churches and this is what the churches should say to the nations.

Peace Machinery Must Supplant Enginery of Force

WHILE the world is laying aside the weapons of war it should be putting on the armour of peace. Without peace machinery there is little likelihood of the nations giving up the enginery of force. There must be a progressive moral disarmament. We must cultivate the international mind not only in a few but in many. We must create the international heart not only in the elite but in the crowd. We must cultivate the international conscience not only in the classes but in

the masses. There must be a widespread spirit of good will. This friendly feeling will not come by chance. It will come only as a result of purpose ul effort. The effort must be pursued continuously through the years in our homes and schools and churches. We must practice good manners in speech and conduct. We must condemn with swift heat all boorishness in reference to our international neighbors. For every word that a congressman speaks in public concerning any foreign nation he should be held to account to the people. We must practice the art of cooperation. The policy of aloofness is immoral. We are members of a body-the body of humanity. If one member suffers, all suffer with it. We are dependent on one another. Our problem in the 18th century was independence but the problem of the 20th century is inter-dependence Isolation is impossible in a world of airplane and the radio. Aloofness from the affairs of mankind is stupid and unworthy of a high-minded nation.

There must be a World Court and the United States should be in it. Because of our size and power we are needed. It is only by courts that the disputes of men can be decided by reason. Violence will never be dethroned till law is exalted. There must be a federation of the world. Nations cannot live apart. For better or for worse they are joined forever. Without organization the world drifts inevitably toward chaos. There must be a League of Nations, and why should we not be in it? The present League is of course imperfect. It does not always function efficiently. If it is weak, it is chiefly because one of the strongest nations in the world, the United States, has thus far refused to join it. America's accession would enable it to function far more effectively. We owe it to ourselves and the human race to take our place at the council table of the world.

No Place for Selfishness in The Kingdom.

It is the duly of all religious men to keep their eyes steadily on governmental policy. It is by its foreign policy that a nation effectively helps or hinders the divine plan. The kingdoms of the world are to become the Kingdom of God. If they are to become the Kingdom of God, then diplomats

and statesmen must not block the way by unjust policies and selfish programs influenced by political jealousies and schemes for "spheres of influence" and by efforts to control raw materials and cheap labor. The tremendous pressure of economic competition moulded the policy of all the great powers and made the World War inevitable. An economic war set the stage for the war with guns. It was assumed that economic forces are omnipotent and cannot be directed and controlled. The assumption is false. Economic forces, like all other forces, can be directed to the well-being of mankind. Tariff barriers are thrown up by greed and not by spiritual insight or brotherly consideration. Tariff wars spring out of selfish hearts and do not come by chance. The Church should declare that God calls upon all men everywhere to change their mental habits and their political policies, for He is going to judge the nations by the standard of Him who is the brother of all men everywhere and who is the true "Prince of Peace."



Facing Facts

THE founders of CITIZENSHIP — THE AMERICAN CHALLENGE, believe that the present plight of our country, with its misery and discontent, is due primarily to the apathy of its citizens. "Eternal vigilance is the price of liberty," but we have slept at our posts, permitting great evil forces to get us in their power while we have been heedlessly drifting on the way to ruin.

In spite of our vast national resources, we find ourselves in a maelstrom of financial, moral and spiritual bankruptcy. We have over-emphasized the material things of life and neglected the cultivation of the fundamental factors of character. Integrity and righteousness are badly undermined. We have lived at the surface of things, unintelligently, without planned purpose or foresight. Arresting facts and startling realities have found us unprepared. The situation has developed a general state of fear, worry and indecision; of drifting, waiting, and vainly hoping that somehow conditions will right themselves.

There should be no need for this attitude of helplessness. To the degree that our troubles are due to wrong thinking, false ideals and low standards, the remedy for them must be sought in right thinking, sound ideals and high standards. To the degree that they are due to apathy and drifting, we must have worthy leadership and well-premised activity. Salvation lies in our own hands—in the proper exercise of the actual constitutional powers of our citizenship.

Challenging Our Citizens

WHAT is needed is a sound public opinion, and the determination to participate actively in expressing that opinion. Our Nation is People. Government is always responsive to the asserted will of its citizens. Sound opinion cannot be built impulsively. It must be evolved and developed. In our complicated society today, there are countless interrelations that go far beyond citizenship in any limited sense.

A healthy and vigorous citizenship is the only means we have of saving our country from failure as the first illustrious modern democracy.

We must restore that great respect for government-national, state and local-which existed during the early days of this nation, and work out earnestly and patriotically, as a united force, that formula declared by Lincoln—"A government of the People, for the People and by the People."

Government of the politicians, by the politicians and for the politicians, has ceased to satisfy any but politicians. American multitudes are protesting, but merely protesting will not do. We must be safeguarded from the pitfalls of dictatorship, the deadening level of communism, the mechanizations of Marx, the lethargy of Utopianism, the destructiveness of anarchism, and the frightfulness of regimented militarism. This can only be done by sane functioning of a people's sovereignty, healthily conceived and manfully executed. It is the voter who finally determines the life of the commonwealth for good or evil. The voter must be awakened to his full sense of duty and responsibility. It is the purpose of this magazine not only to place before him his obligations as a citizen

of this great nation, but also bring him to see that the welfare of himself, his family and his community depends primarily upon the wise and active use of his voting rights.

A Planned Procedure

AS an active force in shaping an enlightened public opinion, CITIZENSHIP—THE AMERICAN CHALLENGE is designed to promote intelligent adjustment to our changing conditions. Times and circumstances have altered greatly since our Constitution was framed. Speed has annihilated distance; intercommunication of thought has become instantaneous; industry and commerce have become international. American life is constantly evolving, expanding and developing. New conditions call for new treatments. We must preserve all the values that experience and tradition have given us, the while we adapt ourselves to the changing laws of progress and the enrichment of living.

There are certain tenets that we all hold:—that the production and distribution of the wealth of this country should be so planned and organized as to give to the family of every willing, honest and diligent worker the enjoyment of the essential conveniences that science and invention, the soil, the mine and the workshop, place at our disposal; that unsocial manipulation of wealth by great financial corporations and institutions shall be effectively ended; that excessive costs of government shall be lowered; that consumers of goods shall not be exploited; that a living wage shall mean not merely an amount necessary to keep body and soul together, but sufficient to cover every necessity required by our advanced American standards of living.

It is in this spirit that we present CITIZEN-SHIP—THE AMERICAN CHALLENGE, with a program of many diversified parts, each significant of itself, yet all interrelated to provide sustenance to the broadening interests of intelligent citizenship in its new and unlimited sense. Life to be lived as a whole must be seen as a whole, and all of its parts must be coordinated and made to function together in the desired direction. We must begin at the root by education of the citizen to a higher standard of political action that expresses itself, first, in citizenship morale, and second, in corrective action against evils that undermine our economic, civic and social order.

Those Who Would Live in a Better World Must Help Build It

RECOVERY cannot come from the top down. It must grow up from the people. It is only as the people advance to a better and happier status, that the country, which is the sum of its people, can realize for them the ideals of a true American democracy. American democracy is an experiment, now being severely tried, yet it is our country's unique and distinctive contribution to the nations

of the world, and we simply must make it to thrive and prosper. We must demonstrate that through the American system of democracy it is possible to create an order of society in which every man and woman can have the opportunity of rising to full stature and living the finest possible life of which he or she may be capable. This ideal can be realized only if our people function as true citizens. Today the challenge to every American is the challenge of citizenship, which we interpret as a state of being, a point of view, a moral obligation, an economic necessity, and a social privilege.

Unite - Support - Cooperate

CITIZENSHIP — THE AMERICAN CHAL-LENGE addresses itself to a class but a class not defined by locality, race, creed, color or economic status; nor by education, vocation or social position. It addresses itself to that great class of decent, honest, hard-working and right-thinking men and women throughout our land, who believe in themselves and their country, and who form the backbone of our national commonwealth, who prize the old virtues, and who value the good in the new; who want for themselves and their families what is rightly theirs; and want their neighbors to enjoy what rightly belongs to them; who, while they believe that the State exists for the individual rather than the individual for the State, are ready to give of their material wealth, their lives and their service for the development of the common good, not only in the unusual emergencies of war, but in the daily practices of peace. To these principles of healthy individualism and civic righteousness, this magazine dedicates itself.

Dear Dr. Silver:

In <u>Spinoza</u> and <u>Buddha</u> by 3. M. Melamed — advance sheets of which are being sent you separately — is a new interpretation of Spinoza which shows him not as a western philosopher but as an eastern religionist. This series is based not so much on historical and philological presumptions but on logical and psychological ones.

We should very much appreciate having your opinion of this new book -- of Melamed's theory, as well as of the consequences to be drawn therefrom in regard to (1) the kindling point of ethics: (2) the classification of all religious into the redemptive and the legalistic; (3) the division of all metaphysical thought into two main streams -- one born of cosmic meditations and the other of anthropocentric considerations.

You will gather from a perusal of Spinoza and Buddha that it is not entirely a presentation of Spinozism, but a new attempt at the philosophy of history exemplified by Spinozism and its background.

We should also be very much obliged to you for your specific opinion on the origin of Christianity, as described in this book. If it is a purely eastern product, as Mr. Melamed thinks, we shall certainly have to reorient ourselves both theologically and historically.



To all Workers, Farmers, Veterans, Unemployed and Your Organizations:

To all Opponents of War-Men, Women and Youth: We Call You to the United States Congress Against War.

We welcome the step taken by Sherwood Anderson, Theodore Dreiser and Upton Sinclair in their call for a united Congress Against War to be held in New York City, September 2nd, 3rd and 4th.

We are united in the belief that the peoples of the world must arouse themselves to take immediate action against the wars now going on in the Far East and in South America, against the increasing preparations for war, and against the growing danger of a new world war. We appeal to all organizations, all workers, farmers, youth and professional groups to support this Congress against our common enemy.

The Governments Arm

After ten years of futile preparations and promises, the World Disarmament Conference has met only to adjourn itself with more promises and with all the imperialist governments continuing to prepare for war more intensively than ever. The 4-Power Pact, the latest imperialist gesture to avoid concrete disarmament measures, has solved nothing. The rise of fascism among the Western imperialist nations and the continued aggressive policy of Japanese militarism has increased the dangers of war involving the Soviet Union. The World Economic Conference in London has revealed only too clearly the inability and the unwillingness of the Great Powers to solve the basic international problems which are steadily driving us towards war preparations and war.

Fascism Breeds War

The recent rapid spread of fascism brings before us another serious problem, one which is closely related to war. It means forced labor, militarization, lower standards of living, and the accentuation of national hatreds and chauvinistic attitudes. It sets the people in one country against the people in another country, and even exploits the internal racial groups within each country, instead of uniting them for joint action to solve their common problems.

U. S. Prepares For War

We emphasize that the declarations of peaceful intentions on the part of the United States Government cannot be relied on to keep this country out of war. In spite of repeated statements of peaceful intentions all governments continue to arm, to train, to prepare. In the United States the Roosevelt administration has systematically aided and furthered preparations for war; the concentration of the entire fleet in the Pacific Ocean, the continued maintenance of armed forces in China, give the lie to the peaceful declarations of our own government.

Under the guise of public works, the National Industrial Recovery Act has become the vehicle for launching the building of a vastly larger navy along the lines demanded by the Big Navy jingos; the widespread unemployment of youth has been utilized to concentrate them in so-called reforestation camps, directly under the administration of the War Department, where

semi-militarized conditions prevail; the military training of youth in the colleges continues; and more and more, national holidays become excuses for glorifying the armed forces and stimulating war hatreds. Throughout the country, hundreds of firms are busy shipping munitions and basic war materials to the warring countries in South America and the Far East. With all this, the Rooosevelt administration has developed centralized control along the lines of the War Industries Board of 1917. We must organize and act to save ourselves from these war preparations and war forces certain to culminate in suicidal international war.

We Must Act Against War

It is to accomplish this task that we unite in support of this Congress. It is to formulate a program of concrete struggle against these conditions that we appeal for the widest possible participation by the workers, farmers, youth, and by all opponents of war throughout the nation.

We call every organization to form a united front and we appeal to every individual sincerely opposed to war to begin immediately the work of building this mighty rampart against the forces of war!

Start Local Activity in Preparation for the Congress:

- Set up a city-wide committee with representatives from all the locals of the organizations signing this
 call plus as many other local groups, clubs, unions, and other organizations as possible; special attention
 should be paid to securing the support of labor organizations and workers' groups in factories, docks,
 war materials industries, transportation industries, Civil Conservation Camps, C. M. T. C., etc. This
 Committee should immediately communicate with the National Organizing Committee for the U. S.
 Congress Against War.
- See that this Call is distributed and given wide publicity wherever groups of workers, farmers, unemployed, youth, war veterans, professionals, white collar workers and peace advocates meet. Get local publicity in the press and in your organizational publications.
- 3. In every city the organizations must begin to campaign for funds to pay the expenses of the delegates. Funds must also be raised for the national preparations for the Congress and for the holding of the Congress. Hundreds of thousands of leaflets must be sent out. Expenses for delegates from other countries to the U.S. Congress must be provided. This Congress must be the beginning of a nation-wide movement in opposition to war. National Collection Lists should be secured from your organizations or from the Treasurer of the National Organizing Committee.
- Give publicity to all war preparations in your city through leaflets, letters to the press, meetings; send such information to the National Organizing Committee for national use.
- Sell "U. S. Congress Against War" buttons; order these from the National Organizing Committee or from your own organization. Funds to help finance delegates can be raised through saie of these buttons, as well as popularization and support of the Congress.

ELECTION OF DELEGATES

Delegates should be elected from all local groups and organizations opposed to war. Every organized group is entitled to one delegate for its organization, plus an additional delegate for every 250 members or major fraction thereof.

National, state, county and city bodies shall each be entitled to two delegates.

Dear Dr. Silver:

Now that the fall holidays are nearly over, may I write to you concerning the following:

The American Jewish Committee, as you probably know, has given up its statistical department which I directed for eleven years, and I am now directing the Jewish Statistical Bureau. The change took place while you were abroad, and I had no occasion to write to you until now.

In my opinion more and better work is being done now than before. The Bureau issues the following publications:

- Digest of Events of Jewish Interest, weekly, a continuation, in a way, of the Summary of Events of Jewish Interest which I issued during 1922-1927.
- (2) Hasid's Index to Periodicals and Booklist, monthly, a bibliographical journal which enters new books, articles appearing in Jewish periodicals, and articles appearing in the general periodical literature, provided these deal with subjects pertaining to Judaism and the Jewish people.
- (3) Jewish Library of Facts, a series of momographs, one of which has been issued (Jewish Migration 1920-1930).
- (4) Statistics of Jews, a statistical annual to be issued in December or January.

I am enclosing herewith the latest issue of the weekly Digest and of the monthly Index, and complete sets of these publications have been put aside for you should you care to have them. These publications are sent to subscribers, a selected number of Rabbis and communal leaders, Jewish educational and social welfare organizations, and the Jewish press; to a selected number of prominent non-Jews, the statistical offices of the principal governments of the world, bibliographical institutes, and educational organizations; and The Index is sent to every library in the United States having 25,000 volumes or over - city and county public libraries, federal and state reference libraries, teachers' training school libraries, and college libraries - and the principal libraries abroad.

The Bureau is the only American Jewish office exclusively devoted to the collection and dissemination of accurate data of Jews in this country and abroad. It is also the only Jewish office in the world which maintains a Jewish bibliographical service. May I add that it has been found that the librarians use The Index both as a bibliographical reference tool and as a guide to the purchase of books. The Index in this way tends to promote the circulation of meritorious literature about Jews and to exclude or limit the spread of biased and anti-Semitic writings (I am enclosing herewith a sheet of excerpts from letters by librarians on the use of The Index).

I am anxious to have your interest in the work of the Bureau, and I shall deeply appreciate if you will join the Committee of Sponsors. I need your cooperation. I am enclosing herewith a slip for your signature. It is understood that by so doing you do not commit yourself to any financial support.

World Jewry Welcomes Chanukah Tonight

Before sundown tonight, just a few minutes before the Sabbath cardles are lighted, the first Chanukah candles will be kindled.

With this quaint ceremony the Festival of Chanukah will be welcomed in countless numbers of Jewish homes throughout the world. This will be the signal for a week of celebrations wherever Jews assemble—here in the United

States as well as in the remotest parts of the globe. Everywhere the spirit of Chanukah brings joy and faith and hope. Everywhere it brings back the spirit of loyalty and devotion which has been so dear to the heart of the Jewish people throughout the ages.

In this country celebrations take place in private homes, in religious schools, in community

centres, in Y.M.H.A.'s, among Young Judaea groups, as well as in many other places where Jews assemble. At these celebrations the story of Chanukah so rich in romance and in heroism, is retold and reacted. The week also serves to stress the unity of the Jewish people and the duty which the Jew owes to his gast and to his future.


The two largest public celebrations this year will take place in New York City and in Chicago—the two largest Jewish communities in America. In New York City wite Festival will take place at Madison Square Gazelen tomorrow (Saturday

evening). The affair will be in the nature of a Maccabeean Festival and it is expected that it will be attended by many thousands of people. The program of the evening will include singing and dancing. Several dramatic sketches and a number of magnificent choral pageants have been prepared. One of the most impressive events of the evening will be the chanting of the

> prayer over the Chanukah lights. A prominent Cantor, assisted by a picked choir of 25 voices will bless the candles. Some of New York's leading Jewish citizens will act as patrons.

> What is expected to be the greatest spectacle in the history of the Jewish community of Chicago will take place on Sunday evening, the second day

of Chanukah. On that evening it is expected that more than twenty-five thousand Jews will gather at the Stadium for a Chanukah concert and ball. Here too, a program of unusual interest appropriate for the occasion has been prepared. An outstanding feature of the evening will be a mixed choir of five hundred voices which, together with all the Canters of Chicago, will take part in the blessing of the candles and in singing Jewish music. Both in New York City and in Chicago these evenings are arranged by the Zionist Organization of America.

HILLEL ZLATOPOLSKY, NOTED PALESTINE LEADER, DEAD

Hillel Zlatopolsky, a well known figure in Palestine activity and a leading sugar merchant, died in Paris last week from wounds received when he was shot by one of his employees.

Zlatopolsky, who was in his 62nd year, played an important part in Russian Jewish life before the Russian Revolution. Though engaged in big business he still found a great deal of time to devote to Palestine and to Jewish education. He was among the first to urge the establishment of the Keren Hayesod—the fund through which the Jewish people all over the world have been making their contributions for Palestine upbuilding. This was in 1920. Since then millions of dollars for Palestine development have been raised through the Keren Hayesod. He was an authority on the sugar industry. For his work in this direction the French Covernment decorated him with the Order of the Legion of Honor.

His sudden death was mourned by Jews throughout the world and especially in Palestine, where impressive memorial services were held.

NEW RULING BRINGS HARDSHIPS TO JEWS IN RUSSIA

Thousands of Jewish families in Russia will suffer as a result of a new ruling which was put into effect last week. This ruling forbids buying and selling of food products and other articles at a profit. A punishment of five years imprisonment is announced for those who will be caught breaking this rule. In the past a large number of Jews, especially those residing in small towns and villages, earned their livelihood in this way.

Our Book Shelf

WITHEN THE PALACE GATES: By Anna Pier-

Mary books of fiction have been written with biblical characters as their heroes. Through these books the reader is given a better understanding of the period in which the characters lived. "Within the Palace Gates" by Anna Pierpont Siviter, is one of these books. Here the reader is introduced to the interesting story of Nehemiah, once cupbearer to Artaxerxes, King of Persia.

The tale opens at Susa, where Hanani, brether of the Lord Nehe, or Nehemiah, comes to ask the King for permission to rebuild the walls of Jerusalem. As children Hanani and Nehe had lived with their father and mother in a small town just outside of Jerusalem. One day a party of Samaritans, headed by Sanballat, swept down upon the town. Nehe, his father, Hachaliah, and his mother, Sarai, were carried off, but Hanani was saved by a faithful servant. Hachaliah besame head gardener to the Persian King, while Sarai was ludy-in-waiting to the Queen, Damaspia, and Nehe finally became the King's cup-bearer and stood high in the royal favor. Hanani believed them dead. He himself was befriended by a goldsmith, who later gave him his only daughter, Hannah, in marriage. Two sons were born, but Arabs captured Hannah and her elder son. The story begins with the joyful reunion of Hanani, his mother and brother, and closes with the no less joyful reunion of Hanani and his wife,

There is plenty of action and quite a number of interesting incidents throwing light upon this period in Jewish history. You will do well to read this book.

AVUKAH ANNUAL

A volume of unusual interest is the Avakah Annual which has just been published by Avakah—the American student's Zionist Federation. This annual, dedicated to Justice Louis D. Brandeis, is a book of over eight hundred pages dealing with almost every form of Zionist activity. Among its contributors are some of the foremost Jewish writers and thinkers, throughout the world. The book should be found on the bookshelf of every student of Jewish affairs.

Chanukah-Them and Now

Chanukah has been observed by our people for over two thousand rears now. Year after year Jews have celebrated the holiday with kindling of lights, with prayers and chants, with special games and foods and with other kinds of festivity. Each generation interpreted and celebrated the Festival of Lights in its own way.

The very first Chanukah must have been most festive and picturesque of all. It was celebrated

immediately after the Jews of Palestine, under the leadership of Judas Maccabeus and his brothers, had won a great victory over the Symans and had taken possession of Jerusalem. To our ancestors it was a two-fold victory, since they were fighting for national and religious lindependence. The rule of the Syrians threatened the existence of the Jewish nation and also the existence of the Jewish religion and culture.

For some generations the Greek religion and Greek way of life were spreading in Palestine. The Greek language was taking the place of Hebrew. Greek games and sports were seriously interfering with the study of Torah and with the observance of

Jewish customs. Antiochus, although himself a Syrian, was a champion of Greek civilization. He was determined to conquer the Jewish nation, and he knew that only by destroying Judaism could he accomplish this.

The first Chanukah, then, must have been a The streets of Jerusalem very festive occasion. were crowded with thousands upon thousands of men, women and chil-Iren, many of them carrying palms and torches. The Temple square was crowded to capacity. We can imagine the enthusiasm when the beloved Judas Maccabeus and his brothers ascended the platform and the ceremonies began. The Levites chanted psalms of victory and thanksgiving. The "Ner Tamid". the perpetual light of the Temple, was rekindled. The new High Priest offered a sacrifice on the new altar. And Judas spoke to the people bidding

them to be courageous and steadfast, for the struggle was not yet over. To them it was truly a festival of dedication. Since that eventful day Jews have celebrated 2,097 Chanukahs.

As centuries passed and Jews came to live far from the scene of victory, the heroism of the Maccabews became only stories of long ago. What meaning could a war for independence have to our forefathers in the Ghettoes. The legend about

the jug of oil seemed 10 them more important. Text they could understand, forgers not the survival of the Ewish people after centuries of wandering and persecution the greatest miracle of all? However, the Jews of the Middle Ages added new washed observing the festival. invented the "dreidel" with its four Hebrew letters which stand for "Nes gadol hayah sham" and which means a great miracle happened there. They also thought of giving Chanukah Gelt (gifts) to children, and eating "latkes" (pancakes). All these served to make the eight days of Chanukah meaningful and enjovable days in the Jewish calendar.



Judas Maccabeus

In our own day, Chanukah has come back into its own and has taken on new meaning. We today, particularly in America, understand a little better what it means to enjoy independence and freedom and what it is to have heroes and heroines. We also appreciate, even more than our fathers, what it means to have among us Jews who care not whether Israel survives or not. These people show no concern about our language and literature, our customs and ideals, our institutions and problems. Like the defenders of the faith in the days of the Maccabees, we are waging a peaceful battle for improving and beautifying Jewish life.

And then there is another reason why Chanukah has become more important in recent years. It is the rebuilding of Palestine. To our great-grandparents the rebuilding of Zion was just a hope,

something to pray for. To us it is becoming a reality, a thing going on before our very eyes. We are the generation privileged to lay the foundations of the Jewish National Homeland. In our times Palestine is once more becoming the center of the Jewish people as it was in the days of the first Chanukah.

As in ancient times, Chanukah has a two-fold meaning to us. The lights we kindle each of the eight days are reminders of the great miracle—the survival of the Jewish people. The heroic stories we read in the Books of the Maccabees encourage us to labor with love and devotion for our own community, for the rebuilding of Palestine and for the strengthening and beautifying of Jewish life in every land.

LEAVE FOR SOUTH AMERICA

One hundred and twenty persons, mostly women and children, left Poland last week for Argentine, Brazil and Uruguay. These went to join their relatives who left Poland sometime ago in order to establish themselves in these South American republics.

The group was accompanied to the boat by a special representative of the Jewish Emigrant Aid Society. This Society, which is known in this country as HIAS—the Hebrew Immigrant Aid and Sheltering Society—has for its purpose to give advice and to guide Jewish people who must wander from one land to another. HIAS was established more than thirty years ago and has helped thousands upon thousands of Jews who were compelled to go from one country to another in order to make their homes there.

JEWS OF SPAIN ARE SADDENED BY DEATH OF DON ANGEL PULIDO

Don Angel Pulido, the Spanish physician who died last week in Madrid, was a most interesting person. Himself a descendant of an old Spanish family (not Jewish) he wanted his country to make amends to the Jewish people for the wrong done them in 1492 when they were expelled from the land. It was his thought that Spain should invite the descendants of those who were exiled to return and to enjoy the privileges the country has to offer. In this way, he thought, the stain would be removed from the history of his country.

There are about four thousand Jews in Spain living mostly in Madrid, Seville and Barcellona. Most of the Jews in Seville are from Spanish Morocco. A little over a year ago the three communities formed a Federation for carrying on religious, educational and other Jewish activities. This was the first time since the terrible days of 1492 that the Spanish government gave permission to establish a Jewish communal organization.

The descendants of the Jews who were expelled are known as "Sephardim," or Spanish Jews. There are large settlements of Sephardim in the countries of Northern Africa, in Bulgaria, Greece and Turkey.

Since Spain became a Republic new laws were made which give equal rights to all Spanish citizens no matter what their religion is.

Don Angel Pulido was very popular among the Jews of Spain and the entire Jewish population was saddened by his death.

PINCHOT HONORARY CHAIRMAN PALESTINE FOREST COMMITTEE

Governor Gifford Pinchot has accepted the Honorary Chairman hip of the Pennsylvania Committee on the George Washington Forest to be established in Parestine commemorating the 200th anniversary of the birth of the first President. This Forest is now being established by the Jewish National Fund.

In accepting the Honorary Chairmanship of the Pennsylvania Committee, Governor Pinchot, who is one of America's ourstanding foresters, explained that he believes in the program of the afforestation of Palestine and is eager to help in this work.

Kamillo Schiller, famous authority on trade and economic questions, especially tariff problems, was appointed permanent Austrian representative to the League of Nations with the title of Minister and Delegate Extraordinary.

JEWISH EDUCATION ASSOCIATION HAS CHANUKAH DINNER

The Jewish Education Association of New York City held their eleventh annual Chanakah dinner last Sunday evening. Several hundred

men and women who are devoting a great deal of their time to Jewish education attended this dinner and listened to reports showing how much was done for Jewish education among the Jewish youth of New York City during the past year.

Some of the speakers at this dinner told how the Jewish Education Association was organized for the purpose of interesting Jewish parents and children in Jewish education. Every year this Association

gives many prizes to children in Jewish schools for attendance and for good work.

In order to reach the mothers the Association organized a women's division called "Iv iah." The "Ivriah" arranges entertainment for Jewish children, brings them into Jewish schools and provides the mothers with useful information about Jewish affairs.

RARE BOOKS AND MANUSCRIPTS GIVEN TO SEMINARY LIBRARY

The library of the Jewish Theological Seminary of America in New York City received a gift of 1,130 Hebrew and Arabic manuscripts from a person whose name was not disclosed. This collection, gathered from all parts of the Orient, is considered of great importance.

The collection includes the Bible with various explanations; Mishna, Talmud, Midrash, philosophy, cabala and science. These manuscripts were gathered in Fez, Mequinez, Agadir, Oran, Algiers, Jerba and elsewhere in Africa. Some of them come from Asiatic communities, and also from Palestine.

Of especial interest are the manuscripts that come from Yemen. These include three private libraries of three prominent rabbis. Some of the Spanish manuscripts were found in Tokat, Anatolia, where Spanish exiles had taken them in 1492.

Other donations to the library were announced. These included books and newspaper clippings of historical value.

MARSHALL MEMORIAL BUILDING USED FOR FIRST TIME

The new Louis Marshall Memorial Science Building of the New York State College of Forestry at Syracuse University was used for the first time at the opening of the First Annual Forest Nursecy Conference.

The new building will be completed and officially dedicated sometime in February or March of next year when leading figures, such as the Governor of New York State, Secretary of Agriculture, Chief Forester of the United States and other leading personalities will take part in the ceremony.

Mr. Marshall was one of the foremost Jews of this country, having devoted the greater pant of his life to worthwhile Jewish causes. He was particularly active in helping to raise monies for Foreign Relief and was one of the founders of the Jewish Agency for Palestine. He died in 1929 and was mourned by Israel the world over.

WELFARE BOARD STRESSES NEED OF JEWISH EDUCATION

The importance of strengthening youth organizations devoting themselves to Jewish activities was stressed at the 15th annual meeting of the National Council of the Jewish Welfare Board, held in New York City, las: Sunday. The hard times through which a large number of people are now passing, it was pointed cut, should not be permitted to weaken those institutions which are now devoting themselves to Jewish educational and cultural activities. On the contrary, these should be encouraged to increase their work so as to reach greater numbers of young people.

About three hundred delegates, coming from various parts of the country, attended this annual meeting and a large number of them took part in a discussion of the general topic: "The Jewish Youth of America."

The Jewish Welfare Board was established in 1917. This was at the time the United States entered the World War. The purpose of the Jewish Welfare Board was to help the Jewish men in the United States Army and Navy by providing for them religious services, concerts, lectures and other forms of entertainment. Since the War, this organization has been active in social work among the Jewish youth of America. It publishes a magazine called "The Jewish Centre," and helps to raise money for Y.M.H.A.'s and Y.W.H.A.'s, as well as for Jewish Community Centres throughout the country.

EDUARD BERNSTEIN, NOTED SOCIALIST, DEAD

Eduard Bernstein, one of the foremost Socialist thinkers and writers of Europe, died last Saturday, in Berlin, at the age of 83. Because of his sincerity and his fine mind, he was held in high esteem throughout the world and his writings were read with deep in erest.

Although born a Jew, Eduard Bernstein took little interest in Jewish affairs in his early life. More recently, however, he realized his mistake and told his friends that if he had his life to live over again, he would not remain distant from his people. Following this change of mind, he interested himsel: in Palestine and on a number of occasions urged the Jewish people to take an active part in the development of that ancient country as their National Homeland.

BILL DESIGNED TO HELP BLIND

Clevelander's Plan Calls for Stands in U. S. Buildings.

bill aiming to make thousands of sightless men and women in the United States self-supporting by



means of candy and tobacco stores placed in federal buildings, has been drawn up by Attorney Leonard A. Robinson of Cleveland for introduction in Congress in January.

Attorney Robinson's partici-pation in the move springs primarily from

sity degrees, he is sightless.

The bill, sponsored by Congressman Matthew A. Dunn of Pitts-burgh, who also is blind, has the backing of a number of influential legislators, including Congressman Martin L. Sweeney of Cleveland. It provides for the organization

a bureau within the postoffice of department, to be known as the bureau of welfare of the blind, to aid sightless persons in various

ways and specifically to issue licenses for such vending stands in federal and other buildings. Primarily, such stands would be for the sale of newspapers, maga-zines, candies and tobacco, but the bill provides that the vendors may be authorized to sell other com-modities at the discretion of the director of the welfare bureau.

Robinson has conferred with President Roosevelt on the matter and the President favors the meas-

ure, he said.

Enclosed you will find a pregram for the National Conference on Subsistence Homesteading which is to be held in Dayton, Ohio, December 8, 9 and 10.

In holding this conference, Dayton is responding to a nation-wide and insistent demand for enlightenment as to the meaning and methods of homesteading. This program speaks for itself, and in addition, those who come to the conference will have an epportunity to visit the First Homostead Unit and see what has actually happened in that quarter. The conditions under which loans for homesteading may be secured will also be discussed.

It has been thought wise to call the attention of certain outstanding leaders in religious thinking to this conference, because the ideals of homesteading are so fundamentally consistent with high religious practice, and since the homesteeds will furnish such an ideal environment for the growth of vital religion.

In addition to this, it would seem that many churches or combinations of churches might do more for some of their members by facilitating their establishment on a homestead unit than in any other way. This set-up certainly provides an interesting opporturity to experiment with really religious communities, where moral judgements are not continually blurred by fear, and choap expedients for real living.

A special conference of religious leaders i: being called to consider the relationship between homesteading and organized religion as wel as the more indirect bearing they may have on each other.

All of this being the case, you are garnest ly invited to come to this conference, make a study of the whole proposition, and in turn let us have the benefit of any suggestions you may

Cronenberger comments on a report of an address of mine which appeared in your paper in which I am quoted as saying that "there are no landlords in Palestine." The statement which I made had reference to the colonies which wer established in Palestine since the War on the land of the Jewish National Fund. This Fund which was established in 1901 purchases land in Palestine with the voluntary contributions of Jews throughout the world and administers it as the common property of the Jewish people. This Rund now owns nearly three hundred thousand dumams. It is upon this land that the newer types of settlements in Palestine, the "Moshav," the small holder's settlement and the "Kvuza," the commune, are established. There are of course no landlords in these. The Jewish National Fund has also established five urban quarters for workers in Tel Aviv, Jerusalem, Haifa and Tiberius in which there is no private ownership in land. Very sincerely yours. AHS: BK

Dear Dr. Silver:

Last Spring the Julius Rosenwald Essay Contest Committee rendered the decision which was, as follows: That none of the essays should receive the prize of \$10,000, but that the sum of \$6,000 should be set aside to be awarded to the authors of the three best essays for the labor and effort they had put into their work. These awards were to be as follows: \$3,500 to the author of essay \$1, which was considered the best; \$1,500 for essay \$7, which was considered next in quality of work; and \$1,000 for essay \$3. The judges also recommended to the executive committee that the committee would not in any way be responsible for the publication of opinions expressed in these essays and that no public announcement be hade of the avards.

The committee carried out these recommendations in such a manner that even the judges were not incommed of the names of those who received these awards.

In the meantime, as we have been returning the essays to those who were not successful, we have been troubled by people who insisted that they must know who did get the money. Furthermore, the three people who did get the money evidently made the fact known to their friends and here and there the news must have spread.

Therefore, the executive committee discussed the matter again and lecided that while we would not make any public announcement of the fact whenever such a request is made information should be provided.

In view of this, I think that you as a member of the executive committee ought to be informed first. May I, therefore, inform you that the award of \$3,500 was given to Dr. Mordecai M. Kaplan, head of the Teachers Institute of the Jawish Theological Seminary, who was the author of essay #1. The award of \$1,500 was given to Dr. Lee J. Levinger, author of essay #7. Dr. Levinger has been in charge of the Hillel Foundation work at the University of Chio for a number of years and is the author of several books. The award of \$1,000 was given to Rabbi Eugene Kohn, of Payonne, N. J., who was author of essay #3.

In reply to your inquiry of December 19, I am writing to say that, so far as I know, the only Christian denomination which went formally on record as recommending the recognition of Russia by the United States was the Congregational-Christian. At the biennial council of this body in 1931, it took the following action:

"Be it resolved That the General Council of Congregational and Christian Churches respectfully urge upon our Government the recognition of the Soviet Union of Russia."

There were some whereases which preceded this statement which I can secure for you if you would like to have them.

The Federal Council of the Churches has taken no action upon the subject but has from time to time printed in Information Service various materials which we thought would help our readers to understand what was happening there. We never felt that there was sufficient unity within our constituency, even among the well informed groups of our constituency, to make it possible for us to make an official declaration of jucgment.

When one's days grow crowded with competing interests and duties, he soon finds an easy-going life impossible. Each hour brings a series of new choices and decisions and every one of them entails some risk. One has to order his life and take its risks according to some standard or code of values, otherwise it would become a confusion of problems, issues and crises in which he would hopelessly lose his way. Call this set of values on which a man bets his life day by day his faith, if you will, but faith is tougher staff than we often credit it with being. The boy in Sunday School who defined faith as "believin' what you know ain't so" had the wrong idea. Believing something in spite of the evidence is credulity, not faith. / Personally, I like the definition that faith is living out a conviction in spite of the apparent consequences.\

My observation has been that men of science are usually men of faith. Science deals with facts which we get through our senses, through what we see, hear, feel, taste or smell. These facts help us to understand ourselves and the universe about us, and to turn the forces of nature into our servants. Without the facts of science, civilization would be impossible, but no man can live by facts alone. What is a man worth? What regard do you owe to yourself and what consideration to the other fellow? Science does not answer these questions; itdeals with facts, not values. The chemist can describe man as a complex arrangement of elements, of raw materials which might be bought at a drug store for less than a dollar. The physicist can picture him as a power plant and a motor with narvellous automatic controls but hardly powerful enough to keep the kitchen refrigerator running. The biologist con classify him as a primate, the product of millions of years of evolution, a first cousin to the chimpanzee. The psychologist may speak of him as a bundle of reactions, habits, feelings and instincts. The astronomer may reduce him to an animated mite, lost in limitless space on a speck of cosmic dust.) But none of them can tell you what he is worth and what destiny, if any, hangs on his existence. Science alone has no design for living.

What is man worth? When man meets man, each treats the other according to his code of human values. Primitive man trusts to his instinct for survival, to tooth and claw. In a rude civilization the rule is an eye for an eye, a tooth for a tooth. A more mature and tolerant code is to live and let live, and there is a still higher code idealized in the golden rule. Where prudent self-interest ends, religion enters. My own faith begins with the belief in an ongoing value in human personality, that in every man who has struggled, suffered, loved, sacrificed, fallen, repented and tried again there is something too valuable for death to destroy. That our conscious selves survive death I am far from sure, nor do I think it makes a great difference in our daily living. But whether we look on a man as something to exploit or something of potential beauty and worth in itself makes all the difference in the world.

Because I believe in the on-going values of human personality, I should like to see chery child well born and reared in a home of harmony and love, with a wholeseme discipline of body, mind and character in his years of dependence and a deliberate training for independence in his years of adolescence. Education ought to give him every chance to discover and develop his distinctive abilities, free him from conceit and self-consciousness, and adapt him to the team-work of life without destroying his individuality. A belief in the enduring value of personality makes of sex more than a series of casual advertures; rather, it invests the life-long devotion of one man and one woman with the greatest possibilities of happiness. This belief denies to man and woman equally

the right to dominate the other, but creates the possibility of achieving in some measure a merged personality as the richest fruit of married life.

In the economic world, I am for whatever system will produce the finest type of persons. Uniformity I dislike, on the principle that I would rather listen to a symphony orchestra than a hundred violins. I prize the scope which democracy and capitalism have given to individuality, despite their injustices, and would need to be convinced that any form of fascism or communism will produce a finer human product. I want to see the experiment tried, however. I hope Russia may go on until she has come abreast of the Western world in her material life. Until then she can teach us very little about the relative merits of communism and democracy.

Between social radicals and conservatives I find it hard to take sides; possibly I am too much of an opportunist. In the long run the conservative is fairly certain to be wrong and there is always at least a chance that the radical may be right. The only sure thingin the social order seems to be change.

"Our little systems have their day They have their day and cease to be,"

and I suppose it may be so in due time with democracy, capitalism and most of the framework of modern society. War may turn into an anachronism. In times of peace I incline to pacifism, but there is no telling how my adrenal glands would respond if we actually found ourselves at war.

According to my faith, sin is any act which tends to degrade one's own integrity or that of other men. To exploit men for selfish ends rather than making their development an end in itself is probably the most widespread evil in human society. Having tried both the industrial and the educational world, I find the latter more congenial to this faith in personal values. The educator, perhaps more than all others, can be free from the temptation to exploit. In the choice of a career, I find myself envying no other man. I know of no more absorbing task than the leadership of a college, with its manifold outreaches into the social and intellectual life of a great community.

Happy men, as a rule, have a strong sense of vocation which resolves their inner conflicts, spurs them to work with zest and abandon and produces a budyant cometack from periods of fatigue. Nork is not exhausting when it is backed by a strong emotional drive, when we get a kick out of it. Some wise psychologist ought to write a book for busy men on how to keep emotionally fit. I surmise that he would dwell on our need for alternating stimulation and relaxation. Nothing is more stimulating than the taste of success. That is what every young person who is failing in study or work needs above all else. For imaginative stimulation I turn instinctively to music, especially symphony and opera. Humor and sport to ease the tensions, the beauties of nature as an aid to inner peace and worship as an integrator of personality, are in my experience all parts of an emotional hygiene as needful as sleep, bathing and eating.

If my faith begins with man and his enduring worth, it ends in God and his enduring love and truth. Experience has led me to an intellectual distruct of the claims of revealed religion on the one hand, and yet on the other to a growin affection and respect for those who find in it the mainspring of their lives. I find myself craving the spiritual fellowship of Catholic, Jew and Protestant alike Religious faith is to me an adventure and not a dogma, a quest rather than a bequest. Two great facts of experience deeply stir my sense of awe. One is utterly selfless devotion to human needs; the other the adventure of the human mind into the mysteries of the atom and of cosmic space. The one suggests the kinship of

human nature to a divine nature beyond the limits of self; the other the kinship of the human intellect to the great enveloping order of the universe. Call it hereditary kinship, if you will, and think of man as the child of God. Surely, science can not deny this right. Beyond the realm of sense and sight is the realm of insight, where poets are more likely to be right than scientists. If this is mysticism, count me among the lesser mystics.

Radicals Plan Fight on War

Pacifists Seek United Front-Women's International League Will Meet with F. O. R.-Atheists Need Cash

(Correspondence from New York)

NEW YORK, Aug. 12 .- About fifty radical and liberal organizations are planning a "congress against war" to be held in this city on Labor day weekend, September 1-4. The call to this congress points out that the present administration has furthered preparations for war by concentrating our entire fleet in the Pacific ocean and by its jingoistic navy policy has shown the hypocritical nature of its peace talk. It had been hoped that this congress might show real united action against war with both communists and socialists participating. Apparently, however, it is not working out that way, for the Daily Worker, the communist organ, did not lose any time in attacking the socialists. The inevitable result was that the socialists withdrew.

P. O. R. Conference

Among the organizations which plan to participate in the anti-war congress mentioned above is the Fellowship of Reconcilation, well known Christian - pacifist group. This does not mean, however, that the F. O. R. will not hold its own regular fall conference. Plans are already complete for this and the place chosen is Swarthmore college in Pennsylvania. The Women's International League for peace and freedom has been invited to cooperate with the F. O. R. in the holding of this conference. The subject to be considered will be "Pacifism in the World Crisis." The conference will give special attention to the meaning of pacifism in the class struggle. The speakers upon this problem will be Reinhold Niebuhr, John Haynes Holmes and Arthur L. Swift. Another subject of deep interest to many will be discussed, namely, the spiritual resources available to the fighter for social righteousness. Among the speakers on this theme will be Roger Baldwin, well known for his stand during the war and his years of courageous battling for civil liferties. More detailed information about the conference may be obtained by writing to the F. O. R. office at 2929 Broadway, this city.

"Toward a United Front"

As stated above it is exceedingly difficult to get various groups opposed to the war mongers and other advocates of things as they are to work together. The omnipresent question is, why in this time of industrial hardship and mass suffering hasn't economic radicalism made any real progress in the United States? Leon Samson, a brilliant and courageous fighter for social change, who has been in the radical 1065

movement ever since the onslaught of the world war, has been devoting the last three or four years to an intensive study of that question. He believes he has found the answer. He has stated that answer in a book published this week called, "Toward a United Front." He thesis is that in "Americanism" the American has a kind of inoculation against socialism. This "Americanism" is a substitutive concept for Marxism which must always appear to the American as something foreign and divorced from his life.

Christians Aiding Jewish Pageant

The Jews of New York city are to give a musical and dramatic pageant of Jewish history at the Polo Grounds on September 14. The funds to be raised from this are to be used to assist German Jews to emigrate to Palestine. To help in this project a Christian committee is being formed under the chairmanship of Charles H. Tuttle. Governor Lehman is honorary chairman of all the sponsors.

Atheists Have Financial Troubles

The other night at Columbus Circle the Association for the Advancement of Atheism held forth a bit longer than usual as
the communists graciously gave them
most of their time. Mr. Charles Smith,
president of the atheistic society, told of
the financial straits of his organization.
He said that unless funds were raised
they would have to give up. Apparently
neither belief in God nor denial of him
makes one immune to the depression.
Many of us like the colorfulness of this
atheistic society and would be sorry to see
them pass out. Your correspondent expects
to debate with them in their headquarters
tomorrow night on the perennial question
of the existence of God.

The Rev. Bob Shuler Here

The Rev. Robert Pierce Shuler, famous evangelist of Los Angeles, is conducting services in Brooklyn. Mr. Shuler has come under the auspices of the American Protestant defense league. Mr. Shuler has received considerable publicity at the hands of our local press. In commenting to the reporters on the closing of his radio station the evangelist was in no sense downcast. He pointed out that this action helped him more than it harmed him as he can now buy his time on the air for less money and get just as good results.

Dry Enforcement Staff Reduced

The personnel of the prohibition enforcement unit for this district was reduced this week from 232 to 122. And yet Postmaster General Farley just said (we suppose with tongue in cheek): "The prohibition law is in the statutes of the United States . . . As long as it is there, the law will be and should be enforced."

Municipal Graft Stirs Glasgow

An Appeal to Parliament-Expensive Trial is Relatively Futile-Racing Tracks Become Menace

(Correspondence from Scotland)

Glascow, July 29.—Scandals in municipal government are comparatively rare in present-day Britain, but occasionally cases of corruption are discovered and the newspapers are then as full of the sordid details as they would be in any other part of the English-speaking world. Glasgow came into this ugly limelight not so long ago when two bailies (town-councilors, who also serve as judges in the police court) were accused of accepting bribes. On the eve of the trial in the high court, the case against one bailie was dropped while the second bailie pleaded guilty so that no evidence was heard at all. It was just stated by the crown attorney that the guilty bailie had demanded a £50 bribe from an appsicant for a stall in the meat market on the plea, "I have a subcommittee of nine. I can get five of these who will vote with me. Now it is up to yourself whether you get this good position." The applicant notified he police, and the most difficult kind of evidence to procureon the actual passing off a bribe-was witnessed by plain clothesmen in a restaurant. The bailie received the very mild sentence of a 450 fine, deposition from the town council, and debarment from holding public office for three years.

Parliament Appoints Graft Tribunal

The public and the town-councilors were very much perturbed by what had occurred. Was bribery such as this a common occurrence? An investigation was demanded which would either lay bare the unpleasant facts or else vindicate the good name of Glasgow. Parliament was appealed to. A graft tribunal having been authorized by the government, advertisements were repeatedly placed in the public press calling upon witnesses to come forward and promising them immunity in case their evidence should incriminate themselves. But it was all in vain. Hardly anyone came forward. The rumors and whisperings were not sub-stantiated. The court sat for three days, heard details about the case already discovered, listened to evidence from the lord provost (mayor), the whief of police, and other public officials, and then issued its report-all at a cost to the city of £4361.

The report comfortingly informed us that the general allegations of bribery had not been substantiated—nor had they been disproved. The tribunal evidently suspects that there is underhand practice on a considerable scale in the letting of municipal houses (the city now owns 39,000) and of market stances, in the granting of licenses to public-houses, and perhaps in the matter of approval of goods purchased and work done for the city. The report suggests to the town council as remedy—a slight different procedure in the letting of houses and stalls! All of which goes to show that there is no guarantee of good government until civic honors become an unbreakable standard of the common man.

Tote-Clubs Illegal

The law courts have helped Scotland in another sphere, however. The court of appeal in Edinburgh has decided, by a majority of five judges to two, that the use of the totalisator on dog-racing grounds and in what are known as "tote" cluis is illegal. This judgment brings Scottish gractice into line with the English. It does not stop the gambling of course, and it merely brings back the bookmaker, and it merely brings back the bookmaker, but it is a real brake to the process by which betting was becoming more widespread and more respectable. The bookmaker, after all, is usually a vulgar individual who may cheke you, or may prove a "welcher." A pari-matual machine, as the greyhound racing people themselves have always maintained, in the fairest method of investment?"

Racing Tracks A Menace

The rapid increase of greyhound racing tracks and of "tote" clubs has become a real social menace. One of the Glasgow tracks has been giving a matinee performance on the day when the dole is paid out and the unemployed have streamed into the grounds in considerable numbers. Music is provided in some grounds to while away the tedium between races. The matter of admitting children to dog-race meetings was brought up at Glasgow town council. It was discovered on investigation that three out of the five race courses did admit children, and that at one of these a nursery was also provided where infants could be left under the care of nurses in order that the mothers might not be distracted at their gambling! The average child attendance per night at the nursery course was 15, and 120 at the other two tracks combined. The magistrates being informed of these facts, it was unanimously decided by them to forbid the admission any longer of children of the school age or less.

Mr. Brown warns: "The machinery for peace is new and ill contrived and creaky in its joints. But what can be said for the old way? Why is disapproval cast upon an effort which is still in its infancy and approval given to a method which has failed a thousand times in every century? The theory that nations which are ready to fight need never take up arms has been blasted in the lifetime of every generation since man first found flint and made himself a war club."

Chicago Fair Breaks Record

Religion Has Conspicuous Place—Pastors
Assemble at University—Catholic
Alumni Urge Social Progress

(Correspondence from Chicago)

Chieroso, Aug. 14.—"Is it true that attendance at the World's Fair is disappointing?" I have been asked that question during the past month in places as widely separated as Los Angeles, Cal., Vancouver, B. C., and Torcnto, Ont. One wonders who can be spreading such rumors. The answer is that the attendance is not disappointing, but, on the contrary, must be very gratifying to the management of the exposition. Nearly two weeks ago the attendance passed the total attendance for the same date at the World's Columbian exposition, although the opening date of the present fair was almost a month later than that of the previous exhibition. Before this letter appears in print over 10,000,000 persons will have passed through the gates. And in spite of hard times people are spending money; more is being spent per person than at any previous world's fair. Moreover, people are getting their money's worth. The things that are most worth seeing cost nothing more than the fifty cents admission. at the gates. I have been there half a dozen times and have not been "gypped" yet.

Religion at

The Hall of Religion, excellent and interesting as it is, does not contain all the expressions of religion at the Fair. Church choirs have contributed notably to the musical programs. Thursday evening I listened to a wonderful program of Negrospirituals by the massed choirs of Chicago colored churches in the Court of States. Naturally there were religious elements in the great celebration of Jewish day. The great pageant in Soldiers Field, "The Epic of a Race," which was the central feature of Negro day, last Saturday, was pro-coundly religious; indeed, "De Lawd" of the Green Pastures was present and, reviewing Negro progress in America, said that it was good. And "Festival week" the present week) opened with a great Chicagoland Church Night in Soldiers Field which brought together practically all Protestant denominations in a reverent and lovely vesper service last evening. Thousands are visiting the Hall of Religion; indeed, one is amazed at the throngs that pass through and linger at the various exhibits. Visitors to the exposition ought to plan their itineraries so as to include the Christian Century forum in the assembly hall of the Hall of Religion on Friday, from 4 to 5 p. m.

Pastors' Institute Draws From Wide Area

Two hundred and thirty-three persons representing twenty-one Protestant denominations and coming from twenty-eight states, the District of Columbia, the territory of Hawaii, and two Canadian prov-

inces, were in attendance at the Pastors' institute conducted joint y by the Divinity school of the University of Chicago and the Chicago theologica seminary, July 31 to August 6. The denominational and geographical spread was extraordinary. The Disciples contributed the largest number of any one communion, with 51 registered; Methodists, Presbyterians, Congregationalists and Baptists following them in the order named. Pastors were present from points as widely separated as Rhode Island and British Coumbia, northern Wisconsin, Texas and Louisiana. But it was the quality of the men that was most impressive. There were pastors, indeed, of churches large and small, but more than one instructor remarked :hat he had never had the privilege of acdressing a more alert and able body of men. The faculty included Dr. C. C. Morrison of The Christian Century (his course on "Preaching the Social Gospel" certainly shook up the brethren. More than one man was heard to remark at the close of a class session, "Well, that ruined a half dozen of my sermons. I'll never be able to preach them again!"); Professor H. F. Rall of Garrett; President Albert W. Palmer, Professor S. C. Kinchelce and Dr. James Mullenbach of Chicago theological seminary; and Professors A. G. Baker, E. C. Colwell, and W. C. Bower of the Divinity school. Vice-President Woodward and Dean Houghton, both members of the Laymen's Inquiry commission, assisted Professor Baker in "Rethinking Missions." had the privilege of cellaborating with Professor E. S. Conklin of the University of Oregon in a course on 'Mental Hygiene and Pastoral Care." And Dr. (Mrs. H. N.) Westcott-Wieman conducted a course in "personal counseling" for pastors' wives. In the open forum of the institute, conducted on the closing cay, the pastors' wives insisted that if Mrs. Wieman could be secured for next year's institute, their husbands also be given an opportunity to

A rich program of guided tours about the city and to the Century of Progress, of fellowship lunches and round tables (Dr. W. E. Garrison's round table on "The Minister's Reading" was very profitable), and the Haskell lectures in the evening, by Mr. K. Naturajan, editor of the Indian Social Reformer, on "Social Movements in Modern India," rounded out a pleasant and profitable week.

And So Forth

The fight to compel the board of education to rescind its "eco-tomy" program, which threatens to cripple public education in Chicago, continues rigorously. The board offers stubborn missance to all pressure, however.

Chicago is middle west headquarters of the National Catholic alumni federation which has begun a vigorous campaign to enlist college graduates, both of secular and church schools, in a campaign of social justice based on the principles set forth in the encyclicals on that subject of Popes Leo XIII and Pius XI.

A "recovery council" which already has enlisted 200 local groups, has been set up in Chicago to aid President Roosevelt's program.

WHY?

IS IT BECAUSE THERE IS NO MONEY? In the past year the Roosevelt government has spent one billion dollars for war purposes alone. Several billion dollars have been given to banks and corporations in the form of "loans". Thus there is plenty of money for the war-nongers and the bankers—but not for education.

And yet, for two days the N. E. A. has deliberately evaded the growing crisis in American education in its discussions. Prayers, the bankrupt NRA and "new methods in education" are the answers of the 1934 program of the N.E.A.

The "radical" Teachers College faction of Columbia University, led by Prof. Harold Rugg, proposes a "revolution"—government control of banks, basic industries and public utilities. They deliberately cover up the fact that the fascists governments of Germany and Italy also control the banks and industries, yet both the governments and the industries of these countries remain in the hands of the capitalists. Government "control" with private ownership can only mean fascism. These "progressives" and "liberals" speak a "radical" language—so did Hitler!—but their program is reactionary in essence. By guaranteeing profits to stockholders at the expense of the masses of the people, government control with private ownership plays directly into the hands of finance capital.

The crisis in education is part of the crisis of the capitalist system itself. The program of the N. E. A. will not solve a single problem of this crisis and only helps to prepare the ground for fascism.

Only a realistic program can meet the crisis in education. If the N. E. A. seriously wishes to take steps to meet this crisis, let it adopt and fight for the following program:

- 1. \$500,000,000 immediate Federal aid for the schools. Divert the billions spent for war to the schools.

Friends of the League of Nations:

Our generation has witnessed the attempt to build a new instrument of social control, a new type of collective machinery, based on the belief that in a world economically and politically interdependent old ideas of isolation must give way to a realistic method of international consultation and teamwork.

In this moment of nationalist reaction we need to be reminded that it takes faith and patience to develop a community of the nations of the world. No new social institution is ever born to its maximum strength or has gone forward without eccasional threats of a return to the old order. The cause of the League of Nations today is more vital than at any time since its founding. As President Roosevelt so clearly pointed out in a recent speech, "the old policies, alliances, combinations and balances of power have proved themselves inadequate for the preservation of world peace." We believe that the alternative to such a procedure is the League machinery.

At the present moment there are two currents of public opinion making for closer American relationship with the League of Nations. Since it is a definite policy of our Government to give open cooperation to the League, many citizens wish that this relationship could be regularized and increased by the appointment of an offical diplomatic representative.

Also, there is increasing discussion as to the terms on which the United States might become a full member of the League. This discussion has been given impetus by the movement throughout the world for a revision of the Covenant. If such revision were to be undertaken in the light of the fifteen years history and with the idea of preserving rather than destroying the democracy of the League, the United States might well participate.

The League of Nations Association hopes to demonstrate the strength of these viewpoints in the United States. After you have added your signature to this petition and secured those of your friends, will you return it promptly?

Anxious to avoid war and organize peace in which prosperity can thrive,

Believing that the collective system of the world community which includes the Kellogg-Briand Pact (Pact of Paris) to which the United States is a party, and the League of Nations, can best prevent war,

Mindful of the fact that the United States is participating in many activities of the League of Nations,

Aware that without the privilege of membership in the League the United States is placed at a disadvantage, and the moral integrity of the world community is weakened,
