I read the statement on the Immigrants Loyalty League very carefully. My reaction to the proposal is quite negative. I do not believe that the immigrant group in the United States should be put on the defensive, and that the situation calls even for a modified form of a self-imposed Vigilante organization. I am persuaded that our Department of Justice can fully handle the cases of Fifth Columnists or saboteurs who may be found in the ranks of immigrants.

On October 11th twelve hundred Y.M.C.A.'s in the United States will celebrate the birth of Sir George Williams, who at nineteen organized the first Y.M.C.A. in London. The occasion will be observed with dinners and special programs extending over a period of several days.


The Y.M.C.A. is such a complex organization that most people today are not aware of its many different branches of service and types of activities. They do not realize that it has in the United States 1,316,000 enrolled members 65% of whom are under 25 years of age, and another million or more participants in its program; that the "Y" works among men of the service, railroad men, merchant seamen, Negroes, students, youth in rural areas, industrial workers...boys in slum sections of big cities, boys in small towns, boys seeking an education, boys in camps, boys in high school....

We are asking leading citizens to express their opinion at this time as to the value of the Young Men's Christian Association to American youth and their communities. We plan to use these statements in connection with Founder's Week programs and publicity. Will you be so kind as to set down in words -- a 50 to 100 word statement -- your convictions as to what the Y.M.C.A. means to youth and the American community at this particular time of world crisis.

May I refer to two examples of how the "Y" is working with youth today. The enclosed folder, "Y.M.C.A. DAY at the World's Fair," illustrates some of our many services and activities. The "Citizenship and Public Affairs" outline shows how Y.M.C.A.'s get discussion and shape opinion on public affairs. If you have a few moments to glance through these, I believe you will find they illustrate how alert the Y.M.C.A. is to the current needs of youth.

We will be grateful for a statement from you, and I hope you can conveniently send it to reach us by Monday, September 23rd.



Dear Rabbi:

As rabbi and leader of a community you no doubt have long felt the necessity of a responsible central body to act on behalf of the numerous religious educational and charitable institutions of Palestine, which have heretofore appealed for funds in this country, or which are now in need of aid from abroad.

For obvious reasons these institutions are entirely independent of the Zionist Organization and receive nothing out of the funds for Palestine raised throughout the world by the various Zionist Funds. Being disorganized and with limited means at their disposal, the institutions were compelled to apply primitive methods for fund-raising, which were subject to criticism and much of confusion.

While conditions were more or less normal the institutions might have been content to continue the way they started many years ago. In recent years, however, their financial conditions grew from bad to worse; first, they suffered from the crisis caused by the prolonged terrorism in Palestine, then when the European war spread they lost all their income from the European countries, as well as from England and South Africa. In recent months, due to the disruption of mail connections between America and Palestine, they also lost their income from individual donors of this country, who used to send their donations directly to Palestine. Consequently, all the religious educational and welfare institutions in Palestine face catastrophe.

In order to avert the ruination of these institutions and the many thousands of dear souls who depend on them, the heads of the institutions, together with the leading rabbis of Palestine, have come to realize that the formation of a central body in this country was most essential at this time. As a result

of their urgent plea, you will surely be glad to learn, the "Federated Council of Palestine Institutions" was formed recently, sponsored by the Central Relief Committee and the Union of Orthodox Rabbis of the U.S.A. and Canada.

Thus far, 121 institutions throughout Palestine were included in the program of our Council. As enumerated on the back of this letter, they comprise hospitals, orphanages, homes for the Aged, Yeshivoh, Talmud Torahs, and various relief institutions -- some of whom are functioning for a century or so, and as a whole form a very important part of the Jewish community in Palestine.

Our Council is about to start an emergency campaign on behalf of these independent institutions. The success of our undertaking depends entirely on the cooperation that we hope to get from those rabbis and communal leaders who realize the importance of our concentrated efforts.

Hoping that you will be one of the first to enlist your cooperation in our effort, may we ask you to: a) kindly advise your community during the approaching High Holy Days of the formation of our Council, and b) please advise us what can be done in your community for the rescue of the religious element in Palestine and its independent institutions.




In recent years there has been a rapidly developing interest in American art, yet in spite of this increased interest in art in our country the majority of our artists and skilled craftsmen are still engaged in what must be called a marginal occupation. It is evident that we must find ways of translating our interest in American creative expression into active popular support expressed in terms of purchase.

President Roosevelt has appointed Mr. Francis Henry Taylor, Director of The Metropolitan Museum of Art, as Chairman of a National Committee, on which I have the honor to be included. The week of November 25 to December 1 has been selected as "Art Week," during which time it is hoped to dramatize the artist and to bring to the attention of the people of America the all-important service which this group renders in many creative fields. Throughout the nation exhibitions, auction sales, and other meetings will be held at this time without cost to the artist, to stimulate these events.

As Chairman of the Committee for Art Week for the State of Ohio, and Chairman of the Cleveland Committee which includes Mrs. B. P. Bole, Mr. Ernest J. Bohn, Mr. Henry Hunt Clark, Mr. Kalman Kubinyi, Mrs. Malcolm L. McBride, Mr. O. F. Liebner, Mrs. C. G. Allenbach, Mr. Wray Manning (these three representing the three major art clubs of Cleveland), Mr. Henry Sayles Francis and Miss Louise H. Burchfield, I have the honor to ask you to serve as a member of an Honorary Committee to give as broad a civic backing as possible for the success of this enterprise.

I should be greatly pleased if you will let me know at your earliest convenience if we may include your name on that committee.

STATEMENT OF PURPOSE AND PROGRAM

Adopted October 22, 1940.

I

THE NEIGHBORHOOD — THE BASIC UNIT OF THE DEMOCRATIC STATE

American Democracy was built and still rests on local units and local representation. The faith in democracy so clearly expressed by Jefferson was rooted in the belief in a small unit of government, something like the town meeting. But the industrial revolution and growth in population have brought larger associations which have destroyed much of the life and effectiveness of the simpler face-to-face relationships—the neighborly association and practice. There is great need for the rebuilding of these smaller democracies, for re-creating that power and understanding which can come only from personal relationships and a sense of the interdependence of neighbors.

Without the integrating force of a conviction of neighborhood responsibility we see the differences among people as to nationality, race, religion, social and economic class giving rise to bitter antagonisms that are destructive of culture and that will ultimately destroy the larger democracy if they are not checked.

Because we believe that the roots of a culture are in the life and associations of relatively small neighborhood groups, we advocate the local Good Neighbor Committee as a workable form of community organization that will exert a substantial influence in the enrichment and the defense of democracy.

THE CONCEPT OF THE GOOD NEIGHBOR COMMITTEE — A PRACTICAL IDEA

The original Good Neighbor Committee was formed in New York City in October 1938 to promote the establishment of neighborhood organizations. Its purpose is to bring together the leaders and active workers in local churches, schools, settlements, social agencies and other civic groups to undertake united action in the interests of the whole neighborhood.

The concept of the Good Neighbor Committee is a practical idea. It is that in every neighborhood there are things that need to be done, such as securing better housing and better schools, establishing adequate health programs and recreation facilities, initiating movements for the reconciliation of antagonistic elements, and fostering better relations between native and foreign-born residents, to name only a few. The need for projects of this sort in every neighborhood is sufficiently specific so that the effort to achieve them can serve as the common task for all groups in the community. In fact, without the united effort of the community, little or no progress can be realized.

Consequently, in bringing to a community the suggestion that a Good Neighbor Committee be formed, it is our view that the committee should be organized around a specific project and that the original membership should be drawn from the leadership of organized groups that are interested in, or can be persuaded to take an interest in, the project at hand. Thus the Good Neighbor Committee is basically an organization for getting united effort in recognized common tasks. By establishing a basis for working together on common tasks, neighborhood groups which may differ as to race, religion, politics, social and economic status will find in a joint effort to solve their mutual problems the roots of a community culture and the bulwark of the small local democracy.

III

WHAT THE ORIGINAL GOOD NEIGHBOR COMMITTEE HAS DONE

The original Good Neighbor Committee in New York City was organized to get more effective work done with the refugees in that city. The work with refugees was undertaken not only because it represents an acute local problem, but also for the reason that it is a symbol of the forces of distrust, misunderstanding and prejudice that are the chief menaces to peace and social organization today. Many groups were already working in this field, but there was no general understanding of what was being done, nor of the facts of the situation. There was considerable difference of opinion as to what ought to be done. Some groups that should have been active were not yet aroused. The public at large was under some misapprehension as to the nature and extent of the refugee problem. There was a growing prejudice against refugees, and there was evidence that this was fanning the flames of intolerance.

The original Good Neighbor Committee recognizes that it has made only a slight beginning in dealing with these problems, but it believes that a firm foundation has been laid upon which a substantial structure may be built. The committee's specific accomplishments in the first two years of its existence include the following:

(1) Two important conferences have been held, which were attended by more than 1200 persons, at which the manifold problems of the refugee were stated and discussed under the leadership of experts in this field. These conferences were originally intended to serve interested organizations and individuals in New York City and its environs, but actually they drew their attendance from many communities in New England, the Atlantic Coast States, and even the Middle West. Every possible effort was made to give them practical meaning, and the comments received since they were held

give reason for the belief that they were immensely useful to great numbers of agencies and individuals.

(2) A considerable volume of authentic information about the refugee problem has been collected and disseminated to correct the misunderstanding which false propaganda has created.

(3) Valuable research projects have been undertaken. An exhaustive bibliography, "The American Way"—designed to orient newcomers to the American way of thinking and living—has been compiled and widely circulated. A manual entitled "What You and Your Group Can Do to Aid in the Adjustment of the Emigre in the Community," has been prepared and published; this also has had widespread circulation.

(4) Speakers and discussion group leaders have been furnished to many local groups seeking information on the refugee problem.

(5) Two local Good Neighbor Committees have been organized, one in Brooklyn and one in the Park West district of New York City; the latter district has been surveyed, and the results of this survey have been published. A third city neighborhood (the Washington Heights district of New York City) has also been surveyed, the results of the survey published, and the first steps taken toward the formation of a local Good Neighbor Committee. In the two latter instances, the local councils of social agencies have actively shared in the committee's efforts, a fact for which we are profoundly grateful. A fourth New York City neighborhood (the West Bronx) is now being surveyed and in the immediate future the results of this survey will be published and an effort made to form a local Good Neighbor Committee there. In a fifth city neighborhood, where religious and racial conflicts are especially bitter, an effort is under way to organize its social forces for the purpose of fostering good will and thus to offset the aggressive efforts of the anti-social forces now at work there.

(6) Interest in the work of the Committee has

been aroused in many parts of the country. From points as widely separated as Boston, Chicago, Philadelphia, New Orleans, San Francisco, Milwaukee, Cincinnati, and Portland, Oregon, to name only a few, have come requests for information and cooperation.

As a result of all this, there is a general belief that the Good Neighbor Committee has benefitted both the refugees now here and those agencies which are endeavoring to serve them, and that it has helped to create a better understanding of the whole refugee situation. But whatever gains may have resulted from these efforts, they are not the most important outcome of nearly two years of life of the original Good Neighbor Committee. The committee's outstanding achievement is that it has enabled organized groups of divergent aims and beliefs to come together to do a common task. They know each other better now, and they know that they can work together effectively on a common task and yet retain the full scope of their initiative within their respective organizations. Formerly they did not know one another, and there was a considerable reserve if not distrust between some of them. This achievement in principal marks a measurable advance in the solidifying of community relationships in those neighborhoods where the committee has operated or where its influence has been felt.

IV

WHAT THE LOCAL GOOD NEIGHBOR COMMITTEE MAY DO.

The Good Neighbor Committee of a local neighborhood, in its membership and general purposes, is similar to existing organizations, yet in its specific program it is distinctly different. The following points indicate briefly the basis of its program:

- (1) As an organization the local committee will continually seek for those practical and feasible things to be done that will serve the common good.

(2) It will seek to organize local community leadership into an autonomous group, the basis of the affiliation being a common program of social action.

(3) It will endeavor to keep the whole neighborhood and its needs alive in the minds of the leadership of the community by continually dramatizing the common task in which all groups should participate.

(4) It will promote educational programs by such means as reading and study groups, discussion groups, forums and conferences, and other recognized devices designed to foster the growth of the good neighbor idea.

(5) It will initiate or foster such service projects as shall be required by the needs of the neighborhood.

V

THE ORIGINAL GOOD NEIGHBOR COMMITTEE LOOKS AHEAD

The original Good Neighbor Committee, for its part, undertakes to foster the formation of local Good Neighbor Committees wherever possible, and to serve as a clearing-house of information and a source of guidance for them at all stages of their development. The Committee foresees a need for continuing the services it has rendered in the past, and it stands ready, within the limit of its resources, to provide other practical helps such as:

(1) The preparation or the assembling of program material for local use such as outlines of successful social, educational, vocational, cultural and other programs or projects conducted by local groups.

(2) Assistance in the enlistment and training of skilled volunteer leadership for specific tasks.

(3) Preparation and distribution of original or other texts for use by local discussion, reading or

study groups. Among the texts for which there appears to be a great need, now partly or wholly unmet, are the following, to mention only a few: (1) a course designed to dramatize for young people, refugees or non-refugees, the careers of those men and women who have devoted their lives to the perpetuation of the democratic idea; (2) a course designed to bring to life the early American pioneers for young people; (3) a course for foreign-born parents to guide them in their effort to acquaint themselves and their children with the American way of life and thought; and (4) a course for general use portraying the part played by foreign-born Americans in the upbuilding of the United States.

VI

THE GOOD NEIGHBOR IS MEASURED BY HIS SERVICE TO HIS NEIGHBOR

Because it provides a meeting ground for fundamentally different groups that have found a common basis for action, the Good Neighbor Committee has only one objective, that is to promote the idea of the Good Neighbor. There is no formula that defines the Good Neighbor; he is, of the moment, measured in terms of the needs of his neighbor and the resoluteness and courage with which he endeavors to serve those needs.

John Galsworthy once said, in an address to an American audience, "The measure of democracy is the measure of the freedom and sense of individual responsibility in its humblest citizens." Just so is the measure of the local Good Neighbor Committee the measure of its willingness, motivated by a keen sense of its responsibility to its neighborhood, to act as free men and women in service to the community.

It is expected that the active local Good Neighbor Committee will, within the sphere of its influence, have a positive effect upon the life of its community. The fears and hatreds and conflicts that beset many communities reflect the absence

of a feeling of neighborliness that can be realized only by working together. However difficult it may be to break down the barriers to common social action, it is the firm belief of those who advocate the Good Neighbor Committee that unless this is done, adequate social stability cannot be achieved nor can the democratic ideal become a living dynamic reality.

In closing, we believe that there is too much truth for comfort in the assertion made by many enemies of the democratic idea that in practice it has become soft and impotent. It is our earnest desire that all local Good Neighbor Committees will so function that this charge may be disproved. The original Committee hereby undertakes to do its full part in making our movement a positive and a potent force—a working democracy with good will to all men.

Dear Friend:



Last summer it housed 224 children, 30% of whom were accommodated free of all charge, the others pay a nominal fee.

A distinguished gathering of about eight hundred persons, composed of scholars, clergy and laymen, weathered a severe snow storm on Monday night, January 27, to honor the noted Orientalist and Biblical scholar, Professor Abraham S. E. Yahuda of London, and to listen to a lecture by him on "The Accuracy of the Bible in the Light of Egyptian Antiquity," at the Community House of Temple Emanu-El in New York.

The function was held under the auspices of a reception committee composed of fifty-two scholars and prominent leaders of the Protestant, Catholic, and Jewish Faith, of which Professor Albert Einstein was Chairman.

Rev. Dr. Samuel H. Goldenson, Rabbi of Temple Emanu-El, presided. Professor Einstein addressed the meeting from Princeton over the telephone and loud speakers, having been prevented by the weather from attending in person. Among those who introduced Professor Yahuda were Rev. Dr. Moses Hyamson, Professor Emeritus of the Jewish Theological Seminary and former Senior Judge of the Jewish Ecclesiastical Court of the British Empire; Dr. Fernando de los Rios, Professor at the University in Exile, former Spanish Ambassador to the United States and former President of Madrid University; Professor Chaim Tchernowitz of the Jewish Institute of Religion; and Dr. William Rosenau of Baltimore, Professor Emeritus of Johns Hopkins University.

All the speakers praised Yahuda's works in the fields of Hebrew and Arabic literature and biblical research. Messages of greetings from Governor Lehman, Mayor La Guardia, Thomas Mann, and others, were presented by Mr. Arthur Meyerowitz, a member and secretary of the reception committee.

A collation followed the reception.

It is a great joy to me that the life's work of my old friend Yahuda is receiving deserved recognition through this function, and through the interest of so many outstanding personalities.

Unfortunately I cannot attend this reception. However, I find consolation in the fact that Yahuda's thoughts - as far as they are intelligible to a layman - are quite familiar to me.

It is my conviction that the scientific research of the Bible from the historic-linguistic point of view is of particular importance in our time, when the authority of the highest moral principles are endangered. I hope that Yahuda's convincing arguments and lucid presentation will contribute to strengthen and to revive the influence of the moral contents of the Bible, the greatest creation of the people of Israel.

"I wish to express my thanks to the distinguished members of the Reception-Committee and to its Chairman, Professor Albert Einstein, of whom it may be said that he is "as great as a genius of thought as he is grand in his love of humanity and of ethical strictness."

Since I came to the United States, I realized that here democracy is not merely an ideological theory, but a true reality - so much so that Americans rather prefer to risk that un-American elements should abuse the hospitality and generosity of this country, than give up one iota of individual liberty and constitutional privileges imbibed by Americans since their childhood.

I also realize how closely the Democratic Constitution of America is connected with the ideas and ideals of the Bible; how deeply American institutions of social justice and individual rights are rooted in the Bible, which has been the most precious heritage of the English-speaking world.

This reason alone would be sufficient to justify the upholding of the authority of the Bible and the strengthening of the belief in the permanent value of its religious and ethical principles.

Although my object to prove the accuracy of the Bible was never apologetical or polemical, I never felt it more necessary to make the results of my researches and findings known, not alone to scientific circles as I did hitherto, but also to a larger public, than I feel now, when the highest principles of justice, liberty and brotherhood are trodden upon and the revival of racialism and paganism in their most barbaric forms are spreading everywhere demoralization and destruction based on a new 'kultur' of violence, cruelty and hatred.

Since I began to study the methods of Higher Criticism of the Bible, some 45 years ago, I observed with increasing amazement and anxiety how much the undermining of the authority

of the Bible contributed towards a weakening of religious and social morals; not only in Germany - the cradle of modern Biblical Criticism - but also in other countries, where the Bible was for generations a source of religious edification, of ethical education and a spiritual guide to hundreds of millions. Thus I thought that to prove the accuracy of the Bible was now-a-days not only a scientific concern, but also a moral duty in order to help those who cherish the Bible as a precious treasure, to prevent that destructive theories of Higher Criticism should contribute also in this country of Biblical traditions to the spreading of those disruptive ideas which, to a large extent, paved the way in Germany to that 'Kultur' of racialism, paganism and self-deification as in the darkest ages of human history.

I am therefore glad to address such a gathering which comprises illustrious scholars and notable laymen; and though I could not expect that all of them would agree with my conclusions, I hope that they will approve of my efforts to find the way to the truth about the Bible.

When speaking of Biblical Criticism, I do not mean the text criticism within reasonable limits, but that pseudo-science called Higher Criticism which laid the axe at the very roots of the Biblical Records, denying the truth of its historical information; distorting the facts about the religious development in Ancient Israel, and interpreting the text to accord it with pre-conceived theories. There is hardly one chapter in which the text has not been altered or disfigured beyond recognition of the original form.

Coming closer to the subject of my lecture, I say that the most important problems which occupied Old Testament scholars during the last century, was whether the 5 Books of Moses were written by one man, and in the time of the Exodus from Egypt, 12th or more centuries B. C. Now, according to the Modern School of Higher Critics, the Pentateuch is nothing else but a composite of many sources, emanating from various epochs beginning in the 9th century B. C., i.e., 4-6 centuries after the Exodus, and ending in the Babylonian Exile in the 6th century B. C.

The controversy between the Critics and the conservative scholars, who believe in the unity and antiquity of the Pentateuch, could however, not be brought to a definite decision, because while the critics based their theories on speculative methods, the latter challenged them by arguments derived from a belief in tradition. Thus both schools only pitted arguments against arguments.

After long years of study, I became convinced that a solution of the problem could only be reached, if it would be possible to establish beyond doubt, the date and environment in which Hebrew began to be used as a literary language. For

this purpose I studied all the languages and cultures of Israel's neighboring countries. But it was only when I acquired the knowledge of the Egyptian language and could penetrate deeper in its spirit and construction, that I could come to a definite conclusion.

The close relationship which I discovered between Hebrew and Egyptian made it clear to me, that the development and growth of Hebrew from a primitive Canaanite dialect to a perfect literary language, could only have taken place in a time and an environment when, and where the Hebrews lived in the most intimate contact with the Egyptians. This I illustrated by quoting a number of Egyptian loanwords and typically Egyptian phrases from the Pentateuch. Proofs were so cumulative, that there could be no doubt that the Pentateuch could not have been written at any other time than the time of the Exodus. This implies that the Hebrew language was a genuine creation of the Hebrews during their stay in Egypt; developed by them under the influence of the Egyptian language from the Canaanite dialect which they spoke when they immigrated into Egypt; and that it was Moses who brought Hebrew to that high degree of perfection in which the Pentateuch is written.

I wish to point out that the establishment of this fact is of far-reaching importance. By applying the combined method of comparative philology and archaeology, based on the monuments excavated not only in Egypt but also in Palestine, Syria and Mesopotamia, the antiquity of the Pentateuch, as well as the accuracy of the Biblical records can be proved.

Among the most important questions with which I will deal in my forthcoming lectures and publications, will be to establish the Unity of the Pentateuch on linguistic foundations; to prove that the view held by Egyptologists and supported by some Old Testament scholars that Pharaoh Akhenaton (Amenophis IV, died 1375 B.C.) was the founder of Monotheism, is a sheer fallacy; that Jehovah and not Jahveh is the true and linguistically and grammatically the only possible pronunciation of the Hebrew name of God; and that the alleged existence of Jahveh-idols in Ancient Israel is without any tenable foundation. A great number of words, phrases, customs and manners alluded to in the Pentateuch, can only be explained from the Egyptian and from the time of the Exodus.

Every new excavation has only confirmed the Bible and confused the critics. As a matter of fact, many of them are already beginning to revise their views. Also with regard to my own findings, some Egyptologists and Old Testament scholars are now beginning to see the light."





My dear Rabbi Silver:

I want to express my personal appreciation for your part in our meeting last Tuesday. I hope you feel, as I do, that the movement to help individuals, groups, and communities to help themselves is one of the utmost importance. We do, indeed, need to pull ourselves together decisively or we may fall apart disastrously.

The temporary executive committee of five, named last Tuesday, met on Wednesday and decided on the name - Commission for Democracy - and suggested a list of twenty-five for the Governor's appointment. That list reduces the representation from Columbus to give more recognition to the State-at-large, and reduces the number of professional workers to make room for more laymen and more women.

We are inviting all those who attended last Tuesday's meeting to meet again, Thursday, February 13, at the Neil House, at 3 p.m., and to participate as much as possible in the Ohio Valley Conference on Education, the Community, and the National Defense, which opens that evening. Any of you whose names may be omitted on the Governor's Commission will, I know, understand the limitations under which we worked. We propose to include those names in an Advisory Council whose work and connections will be so thoroughly associated with the Commission as to be equally important.

The meeting will be listed on the bulletin board at the Neil House on Thursday as Citizens Committee for Democracy.

Dear Dr. Silver:

I have read your pamphlet, "The Rights of Minorities and the Next War." It is a very brave attempt to give a picture of so complicated a problem in the small space of 13 pages.

Unfortunately, some small errors have crept into the text of your writings:

1) You write on page 3 -- "They insisted....., that there be written into the fundamental law of each of these states provisions for full rights of citizenship, absolute equality before the law and cultural autonomy for all racial, religious and linguistic minorities."

May I draw your attention to the fact that the provisions of the treaty are to be recognized by Poland as fundamental law, but it was not necessary to have these same provisions written into the fundamental law of Poland. The same was the case with all other treaties.

2) The provisions of the minorities treaties did not contain, as a rule, any special provisions about cultural autonomy. There are some exceptional cases, for instance, the case of the Szekler in Rumania.

3) Is it correct to translate "Drang nach Osten" as "thrust towards the Near East?" In German, "Drang nach Osten" means "thrust towards Eastern Europe" and not Oriental Europe. The English Near East or Middle Europe is translated into the German by the word "Orient" but not "Osten."

4) On page 10 you say -- "They will seek to undermine the governments which oppress them and in the long run they will succeed, even as they succeeded in Czarist Russia."

I doubt whether the reference to Czarist Russia is historically absolutely true. On the other hand, I am not sure that it is very appropriate to make such statements.

I have your letter of yesterday's date in reply to my suggestion that you have recorded the central portion of your Washington address which dealt with the necessity of democratizing American Jewish life.

You say that you have been asked to make a short recording for the U. P. A. campaign and that therefore you will not, because of limitations of the record which must deal more with Palestine itself, be able to say much about this theme. May I remind you that at this stage and at this critical hour of Jewish life, particularly in this country, we Zionists have an additional sacred obligation, to go "lifnim mishuras ha-din"; that is to say, ^{we} must act qua democratic Jews and not merely as democratic Zionists.

The time has come when we must strike with full strength and root out the constricting forces of petty Jewish fascism in this country, - these little men who try to do big things in a small way, - they who together with their to them unknown local emulators poison Jewish life at its source in the synagogue and in communal endeavor.

You have the opportunity as a recognized, gifted and strategically placed leader to give voice to this everlasting mass May to money-headed and self-important and self-righteous individuals and groups who negate Jewish life and Jewish ideals and the Jewish future. To miss this opportunity would be tragic. Your message, as Abba Hillel Silver, must reach every minyan of Jews throughout the land. You must assist those men not so well known, - who are on the firing line and who are manning the bastions of local Jewish life. Surely we Zionists are not now such kabtzonim and such batlonim that we can't afford a recording, which even some Sunday Schools can afford!

I assure you that if I were a nationally known and recognized leader, I would not be importuning you so. I'D GO OUT AND DO IT!

Alarming appeals reach us from Palestine calling for aid before it is too late. Owing to their desperate fight for existence, the independent religious educational and charitable institutions of Palestine are looking for substantial aid from America, the only country they can depend upon after the collapse of the European Jewish communities.

We enclose herein a statement from our venerable guest, the Chief Rabbi of Palestine, Dr. I. Herzog, pointing to the plight of the religious institutions in Palestine, which owing to the war most of their sources of income have ceased, and this at a time when the continued stream of immigration overburdens the current expense of the various institutions - Yeshivoh, Talmud Torahs, Hospitals, Orphanages and various relief institutions,

May we, therefore, ask you to kindly call to the attention of your congregation the sacred duty that lies upon each of us to liberally assist the independent religious institutions in Palestine at this time of distress. Contributions should be sent either through the American offices of the various institutions or through the Federated Council. In either case, the funds will be cabled to the respective institutions in Palestine.



My dear Rabbi Silver:

When I talked with you by telephone last Thursday, I had in mind reporting to you in some detail regarding the developments in the Ohio Council of Churches and Religious Education and to seek your advice and counsel. Since your organization was so good as to contribute \$1,000.00 last fall and to include in your spring drive \$2,000.00 for the coming year, I wanted to keep you advised from time to time as to what is being done. I shall make it a point to call on you the first time I am in Cleveland and have opportunity.

I am sure you will be glad to know that our program is developing satisfactorily to carry the spirit of goodwill between Jews and Christians into the educational program with children and young people where it will be most effective. I have always been of the opinion that the place to create goodwill is among the younger folks so they will grow up without religious prejudices. It is far easier to develop people without prejudices than it is to cure the prejudices after they have developed.

This summer we bring together at Camp Indianola the leaders of Youth activities of the churches from all over Ohio for a training conference for 16 days. We have engaged a Jewish rabbi to spend the entire 16 days with these Youth leaders to not only help create goodwill in their own minds and hearts but to coach them on going back to their respective counties to create goodwill among Youth there.

Similarly we had quite recently a meeting of the teachers of Weekday Schools of Religion throughout Ohio. The purpose was not only to train them in doing better teaching of Religion but to carry into their schools the spirit of goodwill between Jews and Christians and to train the children in their classes in that spirit.

We sincerely believe that as this program develops, and it should develop very significantly in the next few years, that it should be shot through and through with the spirit of Inter-religious goodwill and should be very definitely designed to cultivate that spirit in children and youth on a state-wide basis.

We are indeed grateful to you and our other friends in your group in Cleveland for the help already given and the help promised in making possible the enlargement, perfection and extension of this very imperative program.

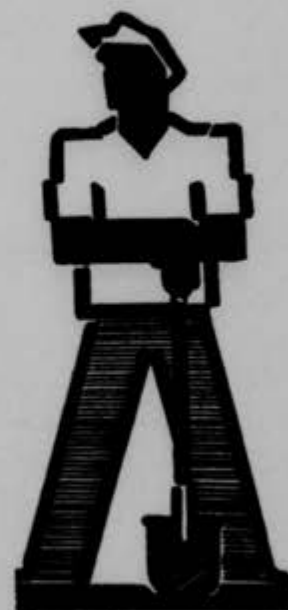



SOME BIOGRAPHICAL NOTES

ON

Professor Abraham Shalom Ezekiel Yahuda

Dr. Abraham S. E. Yahuda, well known Orientalist and Biblical scholar, was born in Jerusalem, from British born parents, June 18, 1877. He received his education in Palestine, England and in Germany at the Universities of Heidelberg and Strasbourg.

From 1905 to 1914 he was Professor of Biblical Exegesis and Semitic Philology at the "Hochschule fuer die Wissenschaft des Judentums" in Berlin and was also appointed as a lecturer for Arabic at the Orientalische Seminar of the University of Berlin. From 1915 to 1922 he was Professor of Hebrew Literature of the Jewish Spanish Epoch at the University of Madrid and of Semitic Philology at the Centro de Estudios Historicos in Madrid. After that Dr. Yahuda lectured at many universities and colleges, chiefly in England, at King's College, University College, The Royal Asiatic Society of London, in Oxford, Cambridge, in Cairo, Jerusalem, etc., and lately at Lisbon.

The field of Dr. Yahuda's studies covers Oriental languages, Semitic Philology, Arabic Culture and Islam, Moorish Civilization in Spain, particularly the History and Literature of the Jews in Spain, and Biblical relationships to all neighboring countries and languages.

Among Yahuda's publications are:

- Pre-Islamic History of the Arabs (In Hebrew) 1893-4.
- Arabic Poetry of the Jews in Spain (Hebrew) 1895.
- Hebrew Translations of Pre-Islamic Arabic Poetry 1896, and 1903.
- Hapax Legomena in the Old Testament (German) 1902.
- The Biblical Exegesis in its Relation to Semitic Philology (German) 1906.
- Bagdad Proverbs (German) 1906.
- Jemenite Proverbs (German) 1911.
- "Critical Edition of the Arabic Original Text of the Hoboth-Hallebaboth Bahya Ibn Joseph Pakuda" 1912.
- Contribucion al Estudio del Judeo-Espanol, 1915.
- The Religious Poetry of Gabirol and Halevi (Spanish), 1915.
- The Language of the Pentateuch in its Relation to Egyptian (in German, Berlin, 1929, and in English, Oxford, 1933).
- The Accuracy of the Bible (London, 1934, New York, 1935, etc., etc.).

Among the several Jewish scholars who have come to our shores in recent years, there is none as colorful a personality as Dr. Yahuda. He represents the happiest blending of the ancient wisdom of the Orient with the modern methods of scientific research. Dr. Yahuda is an Orientalist in the true sense of the word, for he is the undisputed master of the languages and literatures of the Hebrews, Arabs, Egyptians, Assyrians, Babylonians, etc. As Arabist, Dr. Yahuda may well be considered the greatest living student of the vast classic literatures and civilizations of the Arabs since pre-Mohammedan days, covering all countries inhabited by Moslems and civilized by Islam.

The descendant of an illustrious Hispano-Jewish family, whose members for centuries lived and flourished in Bagdad, Bassora, Calcutta and Jerusalem, Dr. Yahuda traces his family tree as far back as the Gaonim of Babylon on one side, and on the other side to Spanish ancestry as far back as the 12th century.

The Bible constitutes his most favorite study from his early childhood in the Holy City of Jerusalem. Hardly a lad of ten, he translated the book of Daniel from the

Aramaic original into Biblical Hebrew. At the age of 16 he published a book on the History of the Arabs before Mohammed, which has seen two editions. His mastery of languages is phenomenal. Dr. Yahuda has lectured in Hebrew, Arabic, Spanish, German, English, French, etc. What Dr. Max Nordau described in the Jewish Chronicle of London as Dr. Yahuda's "triumph," was his appointment by King Alphonso XIII of Spain in 1915, through a special royal decree, as Professor of Hebrew literature, especially of the Spanish-Jewish period, at the University of Madrid. Not since the days of Abraham Zacuta, the famous Jewish Mathematician and Astronomer, and Professor at the University of Salamanca, whose works were used by Columbus on his first voyage of discovery of the new world, had a Jew occupied a Professorship at a public institution of learning in Spain.

Among his numerous works, Dr. Yahuda's Magnum Opus is the first publication of the Arabic text of the "Hoboth Hallebaboth," of the great medieval religious philosopher Bahya Ibn Pakuda, together with an exhaustive study on its relations to Arabic philosophy and Moslem Mysticism.

Dr. Yahuda's studies on the Bible, the results of his researches on the language of the Koran, etc., have engaged the attention of Biblical and Oriental scholars the world over.

One of the most important aims of Dr. Yahuda's life's work was to establish, whether the so-called school of higher Biblical Criticism, which has its strongest supporters and most radical protagonists among German Old Testament scholars, was right, in pretending that the five books of Moses were not authentic, but a conglomerate of texts composed by different authors in different epochs, many centuries after Moses: or whether the traditional Jewish view was correct, namely that the Pentateuch was written by Moses, and consequently is a genuine product of the time of the Exodus of the children of Israel from Egypt in the fifteenth century B. C. Long before Dr. Yahuda left Madrid in 1921, he devoted most of his energy and studies to uncover the languages and archaeology of neighboring countries and peoples of the Land of Israel in Biblical times, particularly those of Aramea, Assyria and Babylonia and of the peoples of the Arabic peninsula. But it was only when he specialized in the study of Hieroglyphics of ancient Egypt that Dr. Yahuda came nearer to the end of his investigations. These studies led him to the discovery of the close relationship between the Egyptian and Hebrew languages, and through these studies he was able to challenge the theories of the so-called Biblical critics. In his book, "The Language of Pentateuch in its Relation to Egyptian," published by the Oxford University Press in 1933, and in his more popular book, "The Accuracy of the Bible," published in 1935, Dr. Yahuda succeeded in proving through linguistic and archaeological evidence from Assyrian, Babylonian and Egyptian monuments, that the literary language of the Pentateuch was a creation of the Hebrews during their sojourn in Egypt and that the Pentateuch could not have been written in another time than that of the Exodus in the fifteenth century B. C. Dr. Yahuda's discoveries have since been enhanced and confirmed by recent excavations, particularly those at Jericho, and the results of his investigations are now being accepted and considered fundamental, not only for the language of the Bible, but also in general for the archaeological problems of Oriental antiquity.

Dr. Yahuda is not merely a scholar but also takes a keen and active interest in world and Jewish affairs. While in Madrid during the World War, through his influence with the King, and the Government of Spain, Dr. Yahuda was able to assist many Jewish communities in the Near East and countless refugees from countries involved in the great war, and to prevent the total evacuation of the Jews from Palestine in 1917.

During his sojourn in the United States, Dr. Yahuda will lecture at various American universities, colleges, and before scientific bodies and different organizations.
