
Dear Rabbi Silver:

Dear Sir:

During the week-end following the recent riots in Detroit, an emergency conference of fourteen national organizations met in Washington, D. C. to outline a constructive program for preventing the recurrence of such racial violence.

The Washington conference was called by the National Lawyers Guild. The conference considered and approved the idea of an American Conference for Racial and National Unity. It has been decided to hold such a conference in Chicago, Illinois, in October. William Rose Benet, Associate Editor of the Saturday Review of Literature, Mrs. Mary McLeod Bethune, President of the National Council of Negro Women, Bishop Dwight J. Bradley, Director of the Council for Social Action, Mrs. Pearl S. Buck, well known author, Professor Arthur Upham Pope, Chairman of the Committee for National Morale, The Reverend Edwin McNeill Poteat, of Cleveland, Carey McWilliams, well known authority on minority problems, the Reverend Guy Emery Shipler, Editor of the Churchman and R. J. Thomas, President of the United Automobile Workers, have joined with me as initiators of the Chicago conference. We are inviting a number of American leaders in various walks of life to join with us in issuing an invitation to a cross section of church, civic, labor, industrial and minority group leaders to sponsor and participate in this event.

It is our hope and request that you will join with us in initiating this important activity. Since time is very short, will you please wire me, collect, that you will join this initiating committee.

I am enclosing a copy of the aims and objectives of the American Conference for Racial and National Unity and a copy of the letter which we are asking the initiators to sign.

STATEMENT OF AIMS AND OBJECTIVES OF THE AMERICAN CONFERENCE
ON NATIONAL AND RACIAL UNITY

1. To demonstrate the traditional American spirit of inter-racial harmony, justice for all, and cooperation among all races and creeds in building our democratic society as an answer to those who believe racial prejudice indigenous and ineradicable in the United States.
2. To take from the grasp of our enemies, the fascists, the destructive weapon of internal dissension among our varied races, which hampers production for war, weakens the spirit of our fighting forces, injures unity of the United Nations.
3. To place our nation on the alert against the subtle propaganda of groups whose programs divide races, creeds and nationalities on the basis of false theories of superiority --- propaganda which is put to use by Axis agents, seeking a fertile soil for their seeds of disunity.
4. To plan the means of achieving for all people, including our racial minorities, adequate housing, education, recreation, and work consistent with the American standard of living, and conducive to the development of self-respecting citizenship among all people.
5. To initiate a constructive program of training in dynamic Americanism --- the ideal of cooperation, freedom, justice and work for the common good --- developed through our churches and schools, labor, business, youth organizations and social institutions.

Dear Sir:

The anti-Negro riots in Mobile, Beaumont, Detroit and the anti-Mexican riots in Los Angeles are danger signals that none of us dares to ignore. Undermining the national unity and interrupting the production essential to our victory, they also diminished our moral prestige throughout the world and gave aid and comfort to our enemies.

These ugly and violent outbreaks challenge the faith by which this nation lives and fights.

We are confident that you feel as keenly as we do the need to answer this challenge. The American people, standing four-square behind the United Nations' policy of unconditional surrender, are alarmed by the harm done the home front and ashamed of these manifestations of Nazi racism in our midst. They are waiting for leaders who will help them find the road back to unity. And they will respond to leadership as they have always done, reaffirming that this land of many races, creeds and colors is one nation, indivisible.

We ask you to share in giving this leadership, to join with us in sponsoring an American Conference for Racial and National Unity, to be held in Chicago in September.

The most representative national organizations in the fields of religion, education, labor, minority groups, farm, youth, etc. will be asked to send one delegate each. We shall also invite first-hand reports from the cities in which riots have already occurred and from those where effective citizens' committees have adopted preventive measures.

Because of war-time travel problems, we shall keep the conference small in numbers, while making it as broadly representative as possible. Through the exchange of experience and ideas we hope to arrive at a program on which all of us can agree and on which will contribute to victory.



Dear Dr. Silver:

On Monday, August 30, I was in New York on a twenty-four hour leave and dropped in at the Conference for a short period. I hoped very much that I might be able to see you. Unfortunately, you were busy in committee meetings.

I have just returned to New York, being assigned to duty here until further notice. I would, therefore, like to take this opportunity to congratulate you on the most magnificent addresses I heard you made at the Conference and the part I know you played in bringing about the excellent achievements of the gathering, especially with respect to Palestine which I have been so vitally interested in.

I hope you will forgive me for troubling you. As Mr. Itzhak Norman may have already indicated to you in the brief moment he spoke with you, we have appealed to the Los Angeles Welfare Fund for a very modest sum. Our impression was that if the campaign were successful we would be included. The campaign, as you know, has been very successful. I understand that most of the leaders are in favor of our being included with the exception of Charles Brown. Judge Levinthal told Itzhak Norman at the Conference that he had recently spoken with Charles Brown, and Charles Brown indicated that he was not in favor of an allocation to the American Fund. Judge Levinthal's report of Mr. Brown's statements merely corroborated what Mr. Brown had said to Mr. Itzhak Norman in the Spring. I am worried about this; he is the Chairman of the Campaign and one of the most vigorous leaders in the Welfare Fund.

I understand that one of Charles Brown's chief objections to our organization is the fact that we have non-Zionists on our Board. There may be other reasons underlying the point of view he takes, or he may be influenced by some individuals.

I believe that not only in the spirit of that unity which you so nobly helped to achieve at the Conference, but also because you are a member of our Board of Trustees, I can call on you for your cooperation in recommending to Brown the inclusion of our Fund. I understand that your recommendation will bear fruit with him.

I beg of you to wire Mr. Brown because decisions are being made now. I hope you will do this - if not for me, personally, for the organization and for our beneficiaries which I know are close to your heart.






My dear Rabbi Silver:

CATHOLIC, JEWISH AND PROTESTANT
DECLARATION ON WORLD PEACE

1. The moral law must govern world society. The organization of a just peace depends upon practical recognition of the fact that not only individuals but nations, states, and international society are subject to the will of God as embodied in the moral law.
2. The rights of the individual must be assured. The dignity of the human person as the image of God must be set forth in all its essential implications in an international declaration of rights, and be vindicated by the positive action of national governments and international organization. States as well as individuals must repudiate racial, religious, or other discrimination in violation of those rights.
3. The rights of weak, oppressed or colonial peoples must be protected. The rights of all peoples, large and small, subject to the good of the organized world community, must be safeguarded within the framework of collective security. The progress of undeveloped and colonial or oppressed peoples toward political responsibility must be the object of international concern.
4. The rights of minorities must be secured. National governments and international organization must respect and guarantee the rights of ethnic, religious, and cultural minorities to economic livelihood, to equal opportunity for educational and cultural development, and to political equality.
5. International machinery to maintain peace with justice must be organized. An enduring peace requires the organization of international institutions which will (a) develop a body of international law (b) guarantee the faithful fulfillment of international obligations, and revise them when necessary (c) assure collective security by drastic limitation and continuing control of armaments, compulsory arbitration and adjudication of controversies, and the use when necessary of adequate sanctions to enforce the law.
6. International economic cooperation must be developed. International economic collaboration to assist all states to provide an adequate standard of living for their citizens must replace the present economic monopoly and exploitation of natural resources by privileged groups and states.
7. A just social order within each state must be achieved. Since the harmony and well-being of the world community are intimately bound up with the internal equilibrium and social order of the individual states, steps must be taken to provide for the security of the family, the collaboration of all groups and classes in the interest of the common good, a standard of living adequate for self-development and family life, decent conditions of work, and participation by labor in decisions affecting its welfare.


Dear Rabbi Silver:


Dear Rabbi:

I wonder if you could help me in suggesting name or names of a person who could most ably present the lectures, before our Lectureship on Judaism at Oberlin College, on the subject of "History of Jewish Music." 



Dear Doctor Silver:

It was indeed a great pleasure to see you and speak to you on Wednesday when we met. As a result of our conversation, my own thinking on the subject has been considerably clarified. I still feel very strongly that we must find some expression for Jewish aspirations in Palestine which will not seem to anyone to commit us to any kind of deviation from the principle of equality of all individuals and all groups before the law. 





NATIONAL COMMITTEE ON WAR AIMS

Throughout the course of the present war, those who have understood its essential character have urged for a clear statement of the specific aims of the United Nations.

The generalized contents of the Atlantic Charter which was adopted during the most critical period of the war, dramatically established the ideals for which the United Nations are fighting. It did not succeed in answering the question in the hearts of three quarters of the earth's humanity: "Victory for whom and for what?"

While the fortunes of the United Nations continued to be adverse, there were made from time to time, by ranking leaders of the United Nations, sincere and eloquent efforts to answer that question.

Mr. Wallace's promise of the coming century of the common man and of the pint of milk for every baby, was the first authoritative expression of specific aims; but even these were hardly more than poetic symbols. No one, who spoke with authority, offered any kind of program of political, economic and social proposals which might be accepted as the blueprint of the brave new world to come.

The slow march toward victory which was begun by the United Nations during recent months has in no way brought about a clarification of the positive objectives of the Allied Nations. On the contrary, as the fortunes of the Allied Nations took a more favorable turn, there was clearly discernible a departure in thinking and in speech from the original idealism of the Atlantic Charter. Leaders of the Allied Nations have shown a great reticence and caution on the question of war aims. In the face of the Indian crisis and the emergent independence of the Far East, for instance,

Winston Churchill asserted, with notable candor, that he was not chosen to be Prime Minister for the purpose of liquidating the British Empire.

Especially in the United States, however, is there manifest a dangerous and growing tendency away from the idealism of the Atlantic Charter--in fact, away from the war aims of the United Nations as they must be felt and sensed and uttered by thinking and honest people throughout the world. The results of the recent elections indicated that in many parts of the country there was an indifference, if not utter ignorance, as to why we are fighting and a marked renewal of the intellectual and spiritual isolationism of the pre-Pearl Harbor days.

Equally distressing, especially to those whose hope for an enduring peace is based upon the world leadership of the United States, is the decline in popularity of President Roosevelt and Mr. Wendell Willkie. In his own party, there is an evident planned movement on the part of powerful forces to rebel against the President's leadership. Similarly, Mr. Willkie has fallen into political disrepute among a large section of his own party as witness the election as Chairman of the National Republican Committee of a man who does not only fail to understand Mr. Willkie's viewpoint, but who holds that viewpoint in disdain. In both major parties the movement away from post-war international cooperation and from international responsibility is ascendant.

Thus, as the war, in its military aspects, has entered a decisive stage in which the United Nations can for the first time anticipate the military future with genuine hope of victory, in its political aspects the war has retrogressed. At the very point at which the military fortunes of the United Nations have taken a decisive change for the better, the political fortunes of the United Nations have reached their lowest ebb. The political and social aims of the United Nations are now more indefinite than they ever

were since the war began. Clearly, it is a very real possibility that we may win the war and lose the peace. If we do, history will indeed declare one day that all of the death and suffering were vain sacrifices between wars.

In order that the war may be won finally, irrevocably and completely, it must not only be fought against the military power of the Axis, but for a world new order based upon the declarations in the Atlantic Charter.

It has therefore become the solemn duty of every one to whom this mighty war represents a majestic effort of men and women to reach out into the future and to build upon the ruins of the present, a world order of enduring peace, security and freedom, to work together and think together so that such a world will one day come to pass. Thus, while the battles on land and sea are fought, the battles of words and ideas must also be fought. The military might of the Axis must and will be crushed. After the victory, there must be no relapse into the old order which produced this war.

It is proposed, therefore, that we organize a National Committee on War Aims, the purpose of which shall be:

- 1) To encourage thought and speech and public discussion on the question of United Nations war aims;
- 2) To agitate and exert pressure, by all legitimate means, upon the leaders of the United Nations for a clear, precise and specific declaration in favor of solving the problems of all peoples in terms of the idealism of the Atlantic Charter;
- 3) To disseminate facts and information concerning the war aims of the United Nations for the purpose of making those aims the stuff of the daily lives of our people;
- 4) To educate the people of America as to our need of assuming the responsibility of world leadership and to arouse an awareness of this responsibility among the members of both Houses of the Congress;

5) To develop leadership and direction to actualize the four freedoms and the tenets of the Atlantic Charter in the coming peace.

A successful and extensive propaganda devoted to the above purposes will have an immediate and far-reaching effect upon the morale and fighting spirit of all the peoples of the United Nations.

Against the background of popular understanding of what our war aims really are, the shock of civilian sacrifices and inconveniences, of military casualties, of the uncertainties of battle, will be more easily absorbed.

A successful campaign based upon the premises as set forth above will in fact make our war aims weapons of victory.

POSTSCRIPT

As soon as the Committee is effectively organized it should issue an invitation to the leading Universities, Labor Organizations, Industrial and Agricultural groups etc. to send delegates to a national Congress on War Aims to be held at an appointed time in a city to be agreed upon. It would be the purpose of this Congress to formulate a list of War Aims representative of the views of the rank and file of the American people.

RESOLUTION

We feel an intense pride in Judaism for priceless religious contributions to the followers of Judaism and to all mankind. Faith and belief in a moral and universal God; the Bible; the Ten Commandments; the moral and ethical concepts inherent in a truly religious way of life-- -- all these stand as living evidence of the spiritual mission of Israel. This is our Judaism which we would perpetuate.

American Reform Judaism did not "just happen". It represents clear and careful thinking. It was created to express the firm conviction that our mission is solely that of a religion; a most wonderful religion. It was designed to retain those traditional rites and customs which significantly illuminate the principles of our faith.

We answer in clear and simple manner the fundamental question: What do we want to be? We have chosen America as our nation and want no other national designation, either in whole or in any degree. We are Jews because we have chosen Judaism as our religion. Being a part of Jewry, we do not wish the concept or status of Jewry entangled with national affiliations or implications deriving from a fictitious Jewish nationhood. We wish our religion and nationality to remain entirely separate and distinct. We define our Jewishness as our religion; purely, simply and solely. The only national homeland we recognize is the national homeland we share with our fellow Americans of all faiths.

In confused and troubled times it is easy to stop thinking and forget fundamentals. Yet such is the very time when fundamentals are needed most. We revere American Reform Judaism. We deem it wholesome and essential to ever keep in mind its fundamental principles. If we remain true to our ideals-- --if we perpetuate our spiritual mission-- --we will not only enrich our own lives, but, in concert with the great brotherhood of religions, will continue to add to the blessings of all humanity. We will also help our children to enjoy the way of life which has made us happy and will make them happy in the land we love.

To these ends, and in consonance with the expression of all members of our congregation, we reaffirm the basic principles of our faith.

PRINCIPLE NO. 1

We believe in the mission of Israel which is to witness to the Unity of God throughout the world and to pray and work for the establishment of the kingdom of truth, justice and peace among all men. Our watchword is "Hear, O Israel, the Lord our God, the Lord is One." We accept it as our sacred duty to worship and to serve Him through prayer, righteous conduct and the study of our Holy Scriptures and glorious history.

PRINCIPLE NO. 2

We are Jews by virtue of our acceptance of Judaism. We are not a nation. We are solely a religion. We stand for the continuation of Judaism solely as a religion; and not as a national group, either in whole or in part. We stand unequivocally for the separation of Church and State. Our religion is Judaism. Our nation is the United States of America. Our nationality is American. Our

flag is the Stars and Stripes. We look upon Palestine not as a Jewish nation, but as one of the places where those who are oppressed may find a haven of refuge. We consider it our sacred privilege to promote the spiritual, cultural and social welfare of our co-religionists there and elsewhere.

PRINCIPLE NO. 3

We hope for the coming of a Messianic Age and not a personal Messiah. We recognize that it is our hallowed duty to speed the coming of the Brotherhood of Man under the Fatherhood of God, which is the Messianic ideal for which the righteous of all people work and pray; and we believe that only in such universal, moral evolution in man will Israel find the answer to its historic and tragic problems.

PRINCIPLE NO. 4

We accept as binding only the moral laws of Mosaic legislation and Prophetic teaching. While respecting the convictions of our Orthodox and Conservative brethren concerning the rabbinical and Mosaic laws which regulate diet, priestly purity, dress and similar laws, we, however, as an American Reform Congregation, do not regard these as being religiously obligatory. We shall continue to maintain and use in connection with our religious services only such ritual and ceremonies as may be approved by the congregation from time to time and which may symbolize, in effective and beautiful form, the principles of our faith, and which are adapted to the progressive and liberal spirit of our times.

PRINCIPLE NO. 5

We recognize the complete religious equality of woman with man.

PRINCIPLE NO. 6

Many treasures of Divine revelation were recorded in Hebrew and in such language are preserved immortal remains of a literature that influences all people. As a reminder of its religious significance we use in our ritual a limited number of expressions having particular beauty. Except for this we conduct our services in the English language.

PRINCIPLE NO. 7

The basis of brotherhood among the Jews throughout the world is Religion. Hence, it is our duty to help our co-religionists whenever and wherever the need may arise, even as we must help all mankind that may be in need, in accordance with the principles of our faith.

We realize that no principles endure except in the hearts and souls of human beings who believe in them. Unless we require that new members believe in the fundamentals upon which our institution rests, we shall have thought only of today and forgotten tomorrow. We have defined Judaism as a matter of belief, rather than birth or nationality. By the same token we look to the beliefs of those who seek admission as American Reform Jews. We therefore provide: All new members shall subscribe to the basic principles of our faith.

We are firmly convinced that the destiny of American Reform Judaism depends upon steadfast adherence to the fundamental principles of our faith. We regretfully record our feeling that the Central Conference of American Rabbis has abandoned them in large part; that the Union of American Hebrew Congregations has neutralized them; and that the Hebrew Union College has failed to adequately teach them.

We fear that there has been worshiping of the idol of "unity". It is desirable to have as much unity as may be consistent with principle. Whenever unity is placed above principle the result is eventual loss of both unity and principle.

We respectfully urge that while there is still time the Union of American Hebrew Congregations, Central Conference of American Rabbis and Hebrew Union College give to their programs vigorous and thorough analysis, reconstruction and action.

We are sending you herewith a copy of the Synagogue Council communication to the President of the Welfare Fund of your community requesting an allocation of \$5000 for the work of the Council.


As you are in a special position to appreciate the work of the Synagogue Council, may we turn to you to urge your community fund leaders that they act favorably upon our application.

Dear Rabbi Silver:

Rabbi Samuel Wohl urged that I write you on a vital matter, stating that no time should be lost in getting it to your attention. I do not know whether you will recall who I am. During your visit to Los Angeles a few years ago I enjoyed several intimate and scholarly conversations with you. At that time I was editor of the California Jewish Voice - a fighting Zionist publication.

A little less than a year ago I was made editor of the B'nai B'rith Messenger (no connection with the B'nai B'rith organization). During the past few months the Messenger decided to go all out for the American Council for Judaism. The chairman of the board is one Armin H. Wittenberg, a wealthy manufacturer of hosiery. Mr. Wittenberg not only is ignorant of Jewish life, purposes and aspirations, but he is opposed to the United Jewish Appeal, the democratically organized Los Angeles Jewish Community Council, the American Jewish Conference, and a bitter foe of Zionism. Of course it is not surprising that this man of intense self-hatred, fear and frustration should be the co-chairman of the local American Council for Judaism.

As editor of the Messenger I not only blocked their nefarious plans to promote confusion and distrust in the ranks of Southern California Jewry, but, against the wishes and will of the chairman and ^{of} the publisher, Joseph J. Cummins (who is in debt, financially to Wittenberg) I developed the paper into an interesting and forceful Jewish and Zionist weekly. The increase of over a thousand subscribers testify to that. Obviously, this

type of Anglo-Jewish newspaper was anathema to the Wittenbergs and Lessing Rosenwalds...Last Saturday afternoon they fired me. That I expected, Dr. Silver. I knew that it was inevitable. But they didn't know it, thinking that I could be made "to see the light" or perhaps be squelched through pressure and power.

The enclosed lead front page story which appeared in yesterday's (March 3) issue of the Jewish Voice helps clarify and emphasize the issue.....The editorial which appeared in the Messenger (March 3) the week immediately following my ouster, also clarifies the issue. It's viciousness is obvious to all Zionist ^{unaffiliated} leaders. But to the great bulk of [^]American Jewry, and to too great a percentage of Jews who should know better, that maliciously connived editorial (of which I am enclosing a copy to you, rabbi) "makes sense."


Taking advantage of the fact that so many Jews are frightened and befuddled today, the Am. Council for Judaism, in their national campaign (double truck in the Nation Feb. 26), and their ~~the~~ local committee in following their lead, will enlist many Jews to their yellow banners unless something concrete and ~~meaningful~~ meaningful be done about it. The "capturing" of the Beth Israel Temple in Houston, the exploitation of their dastardly plans thru the Messenger, their testimony in Washington before the House Foreign Affairs Committee, are all parts of a national plan, as you, of course have always been aware. Los Angeles and Houston ~~in~~ will not be the exception. Other communities will fall, too, unless a determined fearless war be waged against immediately against those who would capitulate to fascism.

I have written this letter not only to inform you, Rabbi Silver, but to be guided by your advise. I want, more than anything

else, to be in the front ranks in this fight, placing my abilities and efforts at the disposal of a national body, organized for that purpose. I realize full well that in these most climactic days of world history, the strengthening of our Zionist position is a positive answer to the 'American' Council.

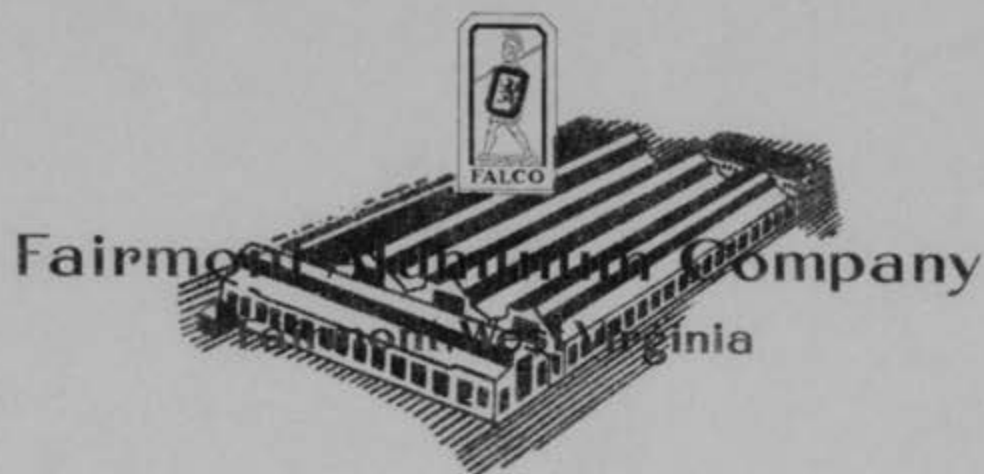

Gentlemen:

Referring to your invitation to attend the Tri-State Luncheon Conference at the William Penn Hotel, Sunday, March 26, 1944, I am not interested in attending this luncheon or any other conference arranged in this District by the United Jewish Appeal.

Before receipt of this invitation I had written a letter to Rabbi Abba Hillel Silver under the impression that he was still one of the national chairmen of the United Jewish Appeal, copy of which letter is enclosed herewith.

I notice from your invitation that an Arrangement Committee is named which you say in a footnote: "Comprised of 1943 Campaign Chairmen of the various communities." I happen to have been a chairman with Mr. Harry N. Pollock for Fairmont in the 1943 campaign, although I was not consulted with reference to any arrangements for this Tri-State Luncheon and if Mr. Pollock was consulted, he did not confer with me.

This is incidental and inconsequential since if I had been consulted I would not have let my name to this Arrangement Committee.

You have chosen again this year to deliberately offer an insult to the Tri-State Jewish Welfare Council. You have again absolutely ignored them and have acted in a high-handed, arrogant and arbitrary manner.

Because of your neat handling of the Arrangement Committee membership from Fairmont, I am inclined to believe that the antagonism of the

United Jewish Appeal is toward me personally and not perhaps toward the Tri-State Jewish Welfare Council.

Since you do not wish my cooperation or my support of the UJA, I will see that you do not get it and furthermore, in order not to embarrass the 90 or more communities in the Tri-State Jewish Welfare Council who comprise the membership of the Council, and in order not to embarrass the Tri-State Jewish Welfare Council itself, I shall resign the presidency at its next meeting, after giving them a full accounting of my personal experience as the president of the Council with the United Jewish Appeal. The attitude of the UJA has been such that for me to attempt a relationship with it either personally or in behalf of the Tri-State Jewish Welfare Council, would be to countenance and overlook a most insulting and impossible attitude on the part of the UJA. Since one of the major functions of the Tri-State Jewish Welfare Council is to cooperate with the UJA and since the UJA has determined not to cooperate, I have decided not to attempt to continue.

I want you to understand, however, that I want no further association with you in any way. You apparently feel that you cannot only dominate the communities who make it possible for your agency to exist, but you have now gone further and apparently delegate to yourselves the right to name the chairmen of the drives in the various communities. My only regret is that the cause that you represent has to suffer because of puny and irresponsible management in your field service.





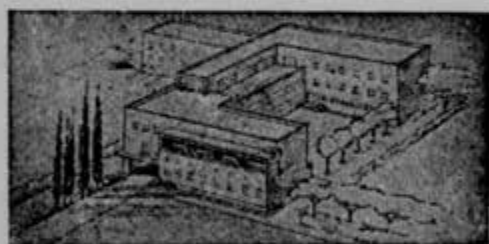

Once again we write to ask you, as one of the foremost Zionist leaders in America, to send us a word of greeting to be read at our Annual Spring Luncheon scheduled for Tuesday, April 25th, at the Hotel Astor, with an expected attendance of a thousand members and friends of the Women's League.

The tragic plight of our people in Europe has served only to strengthen our determination to do everything possible to provide much-needed shelter and vocational training for the thousands of young rescued girls and children who will be brought to Palestine. We know you will welcome the news that the Luncheon will initiate an intensive campaign to raise funds for the erection of the third story of our newest Home in Jerusalem. Thus we will be helping to fill the need for housing hundreds of new arrivals in Palestine.

Great numbers of young women at our Jerusalem Center are today receiving occupational training in dressmaking and other skilled trades to enable them to earn their own livelihoods. In the humane atmosphere of our three Homes young women who have suffered unparalleled tragedy in Europe are restored to mental and physical well-being. The Home is a favorite community center for all types of social events, concerts and lectures. As you probably know, immediately after its opening, last March, the Home served as reception center for 200 Polish-Jewish children who arrived via Teheran after a harassing three-and-a-half year journey over half of Europe and Asia.




our centers in Haifa and Tel Aviv have been geared to the war effort. Many of our graduates trained in dietetics and technical fields have joined the PATS as skilled workers and have made the Homes their recreational headquarters when on leave. Wives and mothers of Jewish soldiers, in desperate plight because very inadequate income was provided them, are taught war trades to make them self-supporting. 3,000 meals are served daily to children in the Tel Aviv Home which also maintains a nursery where 60 small children of soldiers spend their pre-school and after-school hours.

At home as well as abroad our members are contributing notably to the war effort. Their splendid response to the United States War Loan Drives has made possible the purchasing of a Flying Fortress and the erection of three 1,000-bed field hospitals in the United States and Near East in the name of the W.L.P.

In the trying months ahead, we stand ready to redouble our efforts for Victory. We know that a message from you would do much to inspire us to further achievements in rebuilding the shattered lives of rescued women and children in Palestine.

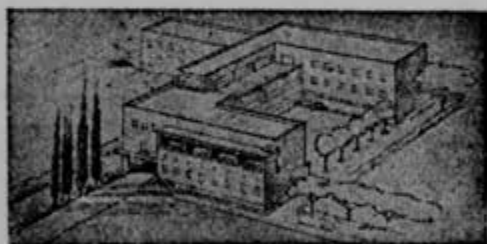

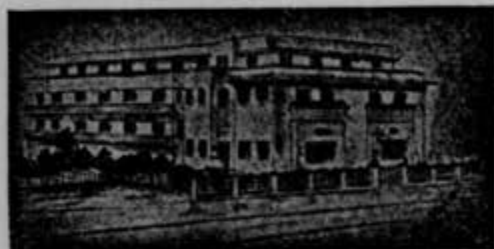

I AM AN AMERICAN DAY, 1944

BY THE PRESIDENT OF THE UNITED STATES OF AMERICA

A P R O C L A M A T I O N

WHEREAS Public Resolution 67, approved May 3, 1940 (54 Stat. 178), provides in part:

"That the third Sunday in May each year be, and hereby is, set aside as Citizenship Day and that the President of the United States is hereby authorized and requested to issue annually a proclamation setting aside that day as a public occasion for the recognition of all who, by coming of age or naturalization, have attained the status of citizenship, and the day shall be designated as 'I Am An American Day'.

"That the civil and educational authorities of States, counties, cities, and towns be, and they are hereby, urged to make plans for the proper observance of this day and for the full instruction of future citizens in their responsibilities and opportunities as citizens of the United States and of the States and localities in which they reside."

WHEREAS our nation has been enriched, both spiritually and materially, by the naturalization of many thousands of foreign-born men and women, and by the coming of age of great numbers of our youth, who have thereby achieved the full stature of citizenship; and

WHEREAS these citizens have strengthened our country by their services at home and on the battlefield:

NOW, THEREFORE, I, FRANKLIN D. ROOSEVELT, President of the United States of America, pursuant to the aforesaid public resolution, do hereby designate Sunday, May 21, 1944, as "I Am An American Day", and do set that day aside as a public occasion for the honoring of American citizenship by giving special recognition to all of our citizens who have attained their majority or have been naturalized during the past year; and I call upon Federal, State, and local officials, and patriotic, civic, and educational organizations to plan and hold, on or about May 21, exercises designed to assist our citizens, both native-born and naturalized, to understand more fully the great privileges and responsibilities of citizenship in our democracy.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the United States of America to be affixed.

DONE at the city of Washington this 6th day of March, in the year of our Lord
nineteen hundred and forty-four and of
the Independence of the United States
(SEAL) of America the one hundred
and sixty-eighth.

Dear Abba:

I know what a nuisance it often is to receive letters asking for advice. However, a matter of great importance has been laid before me which merits the wisest consideration. Since its implications go far beyond The Rockdale Avenue Temple or the Jewish Community of Cincinnati, I would be grateful for your counsel in this matter.

Two days ago, Dr. Heller and myself were invited to meet with four of the leading Protestant clergy of Cincinnati. We were both quite unprepared for the proposal they wished us to explore with them. Their spokesman, Dr. John Versteeg, the President of the Council of Churches of Greater Cincinnati, a warm and personal friend of us both, wanted to know the possibilities of our affiliating with the Council of Churches. He was thinking, he said, of the grave dangers of anti-Jewish reaction in the post-war days ahead. Such a fellowship with the Council, he thought, might be a bulwark of defense.

I have no doubt that in Dr. Versteeg's heart there is no subtle conversionist craving. I am certain that the invitation as it comes from him is prompted by the noblest ideals of the Fatherhood of God and the Brotherhood of Man.

The invitation to join the Council of Churches is not merely a personal one to the rabbis. It extends further to our congregations, and would include, if acceptable, the Conservative and Orthodox groups.

The Constitution of the Council of Churches states its present "Purpose" in these words:

"The Council exists to give united expression to, and provide united action for, Protestantism in this community; to provide for, and develop, cooperation among the churches; and to foster the spirit of fellowship in, and with, the civic, social, moral and spiritual agencies in the community.

I am wondering whether you think this invitation too fraught with dangers of misunderstanding to receive any consideration?

Would such a proposal be acceptable if the Council of Churches were to change its name to a "Council of Churches and Synagogues"? In our first conversation, when that suggestion was tentatively made, Dr. Versteeg seemed to doubt whether the Council could consider it favorably.


Would the addition of the following, or some similar statement to the "Purposes" of the Council be the part of wisdom?

"The Council welcomes to its wider fellowship all religious bodies that accept the cardinal principles of the Fatherhood of God and the Brotherhood of Man. Such participation in the Council is rooted in the democratic faith that all high spiritual aspiration leads Godward. It is clearly understood that participation in those portions of the Council's program that we can conscientiously share in no way diminishes the separate historic traditions of the Churches, Temples or Synagogues that compose its membership. This maximum fellowship is founded upon mutual respect and reverence one for another and upon the sovereign rights of conscience and freedom of religious worship to build in faith and in truth the Kingdom of God upon earth."

This is a longer letter than I had hoped necessary to write. Will you give it your earnest thought and if possible, let me hear from you before May 12th?



My dear Victor:

You pose an interesting question in your letter of May 4. If the Council of Churches of Cincinnati is prepared to change its name and its constitution to enable Jewish congregations to join the Council without ambiguity and without the danger of causing misunderstanding on the part of Jews or Christians, I see no reason why you should not accept the invitation. It is highly desirable for churches and synagogues to work together today for common objectives. I doubt, however, whether the Council will be prepared to change its name, or even to revise its fundamental statement of purposes. Our experience in the past has been that the representatives of the more orthodox groups among the Protestant churches register strong objections and defeat the good intentions of the more liberal elements.

I think you ought to be careful not to make any recommendations touching change of name or revision of purposes. Such recommendations should come from the non-Jews. You should only call attention to the difficulties involved. Let the recommendations come from them because if you make the recommendations and they are voted down by their group, you as the representatives of the Jewish communities will have suffered a defeat and a rebuke.




Dear Dr. Silver:





I am enclosing herewith an abstract of the address which I delivered on Wednesday before the National Association of Social Welfare, the National Association of Jewish Center Workers, and the National Council for Jewish Education, in Cleveland. We very much appreciated your writing as you did about our gross error in the use of the word Hagana in our April 3 issue. Your letter went the rounds of several editorial desks, and I am dismayed to find that it has only now reached me for reply.

As you will understand, I am sure, we are all particularly distressed that this slipped through because so much credit and honor is due the Hagana. As it happened, a cable (which we now see was ambiguous) came through to us very late that week-end and very close to press time. Nonetheless we checked. However, it was Sunday and though we reached what we had considered an authoritative source, it failed us this time.

You may be certain that all our editors are now pretty thoroughly conversant with the difference between the Hagana - which is respected by Jews, British, and Arabs alike - and the Irgun Zvai Leumi, whose offshoot, the Stern group, was responsible for the violence we reported.

We offer our apologies and our thanks to you for writing.

Dear Abba:

I should, before this, have written to thank you for your invaluable assistance in the problem which I laid upon your lap. I can hardly tell you of what incalculable help your counsel was. The conversations still continue and at this time I can only say that we have, from the Jewish side, agreed not to accept a subordinate role in the Council. I should tell you that at our first meeting with the Council representatives, Rabbi Heller made the following proposal:

"ARTICLE III

Membership

Sec. 1. The Council shall be composed of Protestant churches at work in this community.

Sec. 2. (a) Other churches and synagogues, desiring to further the cause of religious fellowship, may become Associate Members of this Council, and may cooperate in those activities of the Council in which they desire to participate.


(To be complete, this should also mean provision for representation on the Executive Committee, but not the right to hold office, as provided in Articles V, VI, VII, and VIII.) "

However, I dissented from this judgement. At a subsequent meeting, at which only the officers of the two Temples, as well as Mr. Adolph Rosenberg and Mr. Herbert Bloch, were present in addition to the four Rabbis, the proposal of Rabbi Heller's suggested Article III, was regarded as unwise by all those present, with the exception of Dr. Heller.

We are now continuing to explore such possibilities for cooperation as we can accept without diminishing the dignity of our Jewish tradition.

Again may I thank you for your helpfulness. Your letter was read at our meeting and undoubtedly exerted a tremendous influence in helping us to think straight on this vital subject.







My dear Mr. Feigin:

Let me thank you for your note of June 11 and for sending me a copy of your new publication, "The Student Zionist," which I read with interest.

The article of Mr. Sol Gordon on "Behind the Palestine Resolutions" needs some careful editing. The Palestine Resolutions were not "tabled" in Congress. No action whatsoever has as yet been taken on the Resolution in the Senate, and the House voted to defer action for the time being, not to "table" it. There is a sharp difference. We hope that action on the Resolutions will take place some time in August or in September.

The article also assumes that the Zionists did not sufficiently arouse American public opinion in connection with the Resolutions, and that they relied entirely on diplomacy. "If diplomacy can't do it, perhaps the people can!" Mr. Gordon should know that seldom has a resolution in Congress been attended by as much of a public response as the Palestine Resolution. Tens of thousands of letters, telegrams, resolutions poured in upon Washington from all parts of the country. Hardly a community in the United States and an important civic cultural labor or church organization but what was heard from by the legislators in Washington. The American Zionist Emergency Council has just published a volume of the editorial comments on the Palestine Resolution which appeared in hundreds of American newspapers. The Jewish press of course, Yiddish and Anglo-Jewish, went all-out for the Resolutions. Numerous delegations from many parts of the country came to Washington especially to interview their Congressmen and Senators. Mr. Gordon should know all this. He should also know that all this is not the result of spontaneous combustion, but must be planned, prepared for and organized by responsible leaders who understand the importance of public opinion as the principal source of strength for our cause.

My dear Rabbi Silver:

The National Organization for Public Health Nursing, as you perhaps know, has joined with five national welfare agencies in order to help overcrowded war-industry communities initiate urgently needed health and welfare services--such as public health nursing service for people sick at home, more and better recreational facilities for teen-age girls, and counselling for families of war workers.

The project is known as American War-Community Services and has as other participating agencies, Child Welfare League of America, Family Welfare Association of America, National Institute for Immigrant Welfare, National Urban League and National Board, Y.W.C.A. Each has its own particular project connected with war-created needs, which you will notice, represent three primary divisions of social welfare--health, social case work and group work--plus two areas of nationwide concern--race relations and the foreign-born.

Work began on the project last January, so far as limited funds would permit. It has been so successful, both in interest aroused and in actual services developed, that American War-Community Services with the help of Community Chests and Councils is planning to seek additional funds in 1945 from war chests all over the country.

To lend weight to this undertaking American War-Community Services needs a sponsoring committee selected from people interested in the work of one or more of the six participating national organizations. The position is an active one, with many active duties except possibly through interpretation in the sponsor's own community. For your information concerning details of American War-Community Services we are enclosing a printed folder.

As a member of the NOPHN Advisory Council, the AWCS would like to use your name on their Sponsoring Committee. If you are willing, will you please ask your secretary to wire the NOPHN, collect, giving your consent?





Dear Friends:

We are happy to advise you of the formation of a new congregation dedicated to the true fundamentals of American Reform Judaism.

At meetings of the congregation and board of directors on July 28 a resolution was unanimously adopted which contains a complete set of basic principles. Enclosed is a copy of the resolution. The articles of incorporation themselves, filed in April, also give positive support to these principles.

It is of utmost importance that the fundamentals of our faith shall survive. American Reform Judaism expresses a way of living which has brought great happiness to all of us. Today, however, we stand at the cross-roads. Repeated compromise and appeasement have shaken the very foundations upon which Reform was created. One need only re-examine the writings and utterances of Rabbi Isaac Mayer Wise and our other revered pioneering fathers to realize how sadly we have drifted from our course.

You will be interested in the results of the action we have taken in Lincoln. First and foremost, there has been a religious enthusiasm which is almost beyond description. Acting in complete accord with one's innermost beliefs is a truly invigorating experience. Although our congregation is not large in numbers, the spirit is remarkable in the extreme. Attendance of the various members has been almost one hundred percent each Friday evening. There have been no absences except for definitely unavoidable causes. The children, as well as the adults, have taken a keen interest. Every member of the group has remarked about experiencing a very warm and close feeling toward his faith -- far more personal and vital than any feeling which had ever existed before.

Another encouraging reaction is from the general public. Since the news stories of the formation of our congregation ap-

peared in local papers we have had a series of strong responses. These have included important public officials, professional men, business men, ministers and all other elements of the public. The typical reaction has been, first, amazement that there are Jews who do not believe in these principles; and, second, a decided feeling that general understanding of these fundamentals would greatly retard anti-semitism and that nationalism will increase it.

"Reform Judaism" is something more than just a name. The time has come for those who believe in its basic fundamentals to do more than maintain silence and watch the lights dim out. A vigorous movement is springing up throughout the land to reaffirm and revitalize these principles of American Reform Judaism which are so indispensable to the welfare of ourselves and our children. Our house can yet be set in order; but prompt and effective action is essential.

The initial burden must be largely carried by laymen. Here we find a parallel to the very origin of the American Reform movement; for such was also true during the first decade of Reform.


