





#### OBJECTIVES OF VISIT TO U.S.A.

Mr. Gotthelf is not only a labor leader but one of the leading newspaper commentators in international affairs and government. He is interested in discussing international labor affairs with top officials of the AFL-CIO. The role of government in labor affairs will be discussed when he meets with representatives of the Departments of State and Labor and the U.S. Congressional Committees on labor and foreign affairs. Mr. Gotthelf has indicated that he wishes to discuss with leading newspaper commentators the recent developments in international labor affairs and the position of Israel in international relations. He is interested in the cooperative movement, discussing techniques and trends in cooperatives, and in visiting selected cooperatives. Mr. Gotthelf has indicated a desire to discuss and review the role of the university in the development of schools of industrial relations. Observe the various irrigation projects in California and tour T.V.A.

Mr. Gotthelf will be interested in interviewing selected labor leaders in the United States and their views on labor relations and related subjects for a series of articles for the DAVAR, the daily newspaper of Histadrut.

Mr. Gotthelf's program will give him a balanced picture of the general economic, social and cultural scene in the United States.

I know you want to know the mood of the various congregations on the matter of rabbinical placement. This is in no sense an official letter, although the Board of Rodef Shalom Temple knows that I am writing it. There were suggestions raised at our Board that we should inform other congregations of our absolute opposition to the entire placement plan. I would not want Rodef Shalom to follow in the footsteps of other temples in previous years and organize an "opposition." So I asked them not to do that, but told them that I would privately let you know how we feel about the matter. Our Board is completely opposed to any compulsory placement plan. I need not give you their reasons; you can easily imagine them. The Board instructed our delegates to vote against the entire plan. I managed to get them to be willing, in case they see that they will lose, to accept the plan after certain amendments are passed. These are the amendments which would lead them, reluctantly, to accept the plan: 1. That any rabbi in any congregation may be permitted, independently, to give advice or respond to a request for advice from a congregation. 2. That when a congregation suggests the names of rabbis to be added to the Placement Committee's slate of candidates, that the Placement Committee must add those names; that they shall have no discretion on this matter. The congregation, of course, pledges itself to interview the entire slate. I hope things are going well with you, and that you are getting along now with increasing strength. 



#### Dear Colleague:

We are now in the midst of our 1964 UJA campaign. As in previous years there is a continuing blackout on publicity with respect to the statistics and countries of origin of Jewish migration to Israel and elsewhere. In view of this serious handicap the UJA in 1964 must rely upon the verbal presentation of the story to the American Jewish community. In this endeavor the American Rabbinate can make a significant contribution towards creating a climate of opinion favorable to the attainment of the objectives of the United Jewish Appeal.

We are, therefore, enclosing five items for your use in any manner you deem worthwhile and effective in your community. (1) A Proclamation issued by the Rabbinical Advisory Council which sets the tone for the 1964 campaign; (2) a UJA Sabbath Sermon by Rabbi Manuel Laderman; (3) the official statement of the UJA Rabbinical Advisory Council entitled "GUIDE TO SABBATH CONFERENCE PROGRAMMING"; (4) an address delivered by Arthur J. Goldberg, Associate Justice of the Supreme Court of the United States, to the National Inaugural Conference of the United Jewish Appeal in Washington, D. C.; (5) a memorandum (NOT FOR PUBLICATION) on "ISRAEL'S SHARE IN THE ABSORPTION OF IMMIGRANTS". It is a brief exposition on the question of responsibility in the effort to rehabilitate the hundreds of thousands of our brethren who were brought to Israel through the UJA.

I trust that the enclosed items will be helpful in your personal efforts to stimulate increased giving to the UJA in 1964. I would deeply appreciate your comments and ideas on how the Rabbinical Advisory Council can be of further service to the United Jewish Appeal.

#### PROCLAMATION

The United Jewish Appeal has for more than twenty-five years symbolized humane compassion and concern as well as Jewish mutuality and responsibility. In a world often darkened by inhumanity and indifference it has held high a beacon of light of the brotherliness which makes us kin to all who are in need. It has strengthened our common bond as Jews by inspiring us with a large responsibility and calling us to a sacred task.

We the representatives of the American Rabbinate - embracing all the branches of religious life - call upon our brethren to rally once again to this year's summons to duty issued by the UJA and in helping their brethren in Israel and elsewhere, enrich their own lives here.

May the G-d of our faith bless us and all mankind with peace and lead forth all who are now oppressed into the sunlight of freedom.

#### THE VIRTUE OF GIVING

One of the most interesting words in the vocabulary of a Jew is Mitzvah. Originally it stems from the Hebrew root of command, and is a reflection of our sense of being a people under Divine commandment. We are obligated, we are required, we are under the compulsion of fulfilling the Divine behest, as expressed to us in the Torah. In the course of time the word Mitzvah took on a less forbidding aspect. It came to mean, in folk language, a good deed, something which one felt it virtuous to do, and was moved to do by inner compulsion, and love and emotional prompting.

Not every Divine command had this fortunate evolution. Some remained in the category of obligations which one carries out only because of the sense of requirement, without inward impulse. Of all the Mitzvot the one of giving to charity has taken on a special hue of Jewish virtue. We are renowned for our readiness to give for the help of others.

Charity has many forms, and all its manifestations have desirable qualities. Because charity can be of different kinds our sages recognized degrees of charity. The best known of these catalogues is that of Maimonides who settled on eight degrees of charity, each of a higher character than the other. In the words of the great codifier the highest degree of all was this one:

"THE HIGHEST DEGREE IS TO AID A MAN IN WANT BY OFFERING HIM A GIFT OR A LOAN, BY ENTERING INTO PARTNERSHIP WITH HIM, OR BY PROVIDING WORK FOR HIM SO THAT HE MAY BECOME SELF-SUPPORTING, FOR OF SUCH IT IS SAID, "AND THOU SHALT HOLD FAST IN HIM SO THAT HE SHALL LIVE WITH THEE," (Lewiticus 25:35) meaning "AND THOU SHALT HOLD HIM SO THAT HE SHALL NEVER FALL AGAIN AND BE IN NEED."

Of all the many expressions of this high degree of charity the United Jewish Appeal offers every contributor a very wholesome opportunity. We who are fortunate enough to live in a free part of the world can never fail to be aware of the desperation and straitened circumstances of our fellow Jews in other parts of the world. Through the United Jewish Appeal we are able to focus upon the people of Israel the attention that they require, and can spread wide our range of concern to include a world circumference. Wherever Jews are in need, the United Jewish Appeal is an agency of mercy. Through the Joint Distribution Committee it gives succor and support to people in the lands where they live. Through the Jewish Agency for Israel it helps to bring them to the shores of the Holy Land where they can find that kind of new life which the Prophet spoke of when he said:

"AND I WILL APPOINT A PLACE FOR MY PEOPLE ISRAEL, AND WILL PLANT THEM, THAT THEY MAY DWELL IN THEIR OWN PLACE, AND BE DISQUIETED NO MORE; NEITHER SHALL THE CHILDREN OF WICKEDNESS AFFLICT THEM ANYMORE, AS AT THE FIRST."

(Second Samuel 7:10)

Each year as Israel grows in numbers and strength it radiates a sense of security to the Jew in every other part of the world. Conversely as we assist with generous gifts and bring to the shores of Israel those who cannot find freedom for themselves elsewhere, and enable them to create a new life for themselves where they will no longer be in need, and wards of charity, we are fulfilling one of our greatest commandments.

Everyone who has been privileged to visit Israel comes back with a sense of pride in the new spirit of the people who have been settled there. He has seen with his own eyes the fulfillment of the ancient prophecy:

"FOR I WILL TAKE YOU FROM AMONG THE NATIONS, AND GATHER YOU OUT OF ALL THE COUNTRIES, AND WILL BRING YOU INTO YOUR OWN LAND .... A NEW HEART ALSO WILL I GIVE YOU, AND A NEW SPIRIT WILL I PUT WITHIN YOU." (Ezekiel 36:24,26)

Frequently one hears the complaint about continued requests for giving to the United Jewish Appeal, "How long will we be asked to give?" No one is a Prophet in our day wise enough to reply. Anyone of us however can surely say that there has been a full return for the gifts which have hitherto been made in the vitality and exuberance of Israel's people, and the light which they have shed on many other newly emerged nations. Fortunate is our generation that we have seen this accomplishment. Privileged are we to have a share in its achievement. Blessed are we that we can give for a purpose which is not temporizing with fate. All too often in the past we have known what that meant. Many have been the appeals that were answered generously by prosperous Jewish communities for their less fortunate brethren, which were only palliatives, and did not offer any permanent solution. The United Jewish Appeal is an opportunity for solutions which under G-d's Grace will provide permanent help and dignified living for those who are its recipients. For our generation the UJA offers some of the feeling of the promise which is contained in the last verse of the prophecy of Amos:

"AND I WILL PLANT THEM UPON THEIR LAND, AND THEY SHALL NO MORE BE PLUCKED UP OUT OF THEIR LAND WHICH I HAVE GIVEN THEM, SAITH THE LORD THY G-D."

Let us give with a sense of carrying out a Divine commandment. Let us give generously out of gratitude for our own fortunate condition. Let us give with an open hand with the knowledge that we are helping a world-wide movement to find an ultimate solution of its problems. Let us give with happiness in our hearts that we are privileged to help world Jewry find a vital new life in a secure home.

#### UNITED JEWISH APPEAL RABBINICAL ADVISORY COUNCIL

#### GUIDE TO SABBATH CONFERENCE PROGRAMMING

The question of UJA Sabbath Conference programming was fully considered at a recent well attended meeting of the Rabbinical Advisory Council of the United Jewish Appeal held in New York on December 9, 1963. All branches of American-Jewish religious life were represented in this Council. The consensus was that every attempt should be made to conduct UJA regional and national conferences on weekdays. Alternatives to the scheduling of such conferences on days that include the Sabbath were explored. The Advisory Council was told that numerous attempts have been made to hold these conferences on weekdays, and all have uniformly failed.

It must be borne in mind that the success of the UJA efforts requires that regional and national gatherings of lay leaders be held. To these meetings are brought outstanding personalities from the State of Israel as well as from our own country to present authoritatively and vividly the problems, the concerns, the needs which the UJA is called upon to deal with and meet. The intensive impact upon the minds and hearts of these key people is essential to the UJA campaign that will subsequently be conducted in their communities and regions.

These gatherings are significant in educating the laity in the contemporary problems and challenges of world Jewry; in fostering their involvement and emotional identification; in fortifying mutuality and deepening the sense of Jewish responsibility. This should not be minimized for these are motivations of high spiritual quality.

It was, therefore, resolved that if there is no alternative and the Sabbath is included in a three-day week-end conference, the principle of Sabbath sanctity will be upheld and safeguarded by adhering to the following practices which the UJA has undertaken to carry out with diligence and consistence:

- 1. No meetings of a business nature which require the writing of minutes or the recording of votes will be held on the Sabbath.
- 2. The agenda of a gathering or seminar or meeting held on the Sabbath will contain background informational material which will focus on the spiritual and cultural aspects of the UJA.
- 3. The nature of any entertainment or dramatic program will be consonant with the spirit of the Sabbath and will not be accompanied by instrumental music.
- 4. At all conferences, a directory of local Synagogues and a schedule of their Sabbath Services will be posted and included in the printed program so that those delegates who wish to attend Services may know where to go. If, because of the location of the hotel, it is inadvisable to refer the delegates to local Synagogues, the conference will conduct religious services on the Sabbath. In this instance, the UJA will follow the policy adopted by the Council of Jewish Federations and Welfare Funds of inviting a military chaplain to conduct a military service, using the National Jewish Welfare Board prayerbook prepared for Jewish personnel in the Armed Forces.
- 5. There will be no programs other than services before noon on the Sabbath day.
- 6. At gatherings scheduled for Friday night or Saturday afternoon, members of the UJA staff will cooperate in every way to help maintain the traditional spirit of the Sabbath. Delegates in attendance will be asked to refrain from smoking.

Appropriate signs to this effect will be prominently displayed in rooms in which meetings are held. In addition, the printed program of the Conference will include a paragraph asking the delegates to respect the sanctity of the Sabbath and to avoid its public desecration.

- 7. Dinner served on Friday night under the auspices of the Conference will begin with the chanting of Kiddush; dinner served on Saturday night will follow a Havdala service, wherever possible.
- 8. All meals arranged by the UJA will be Kosher and will respect the sensibilities of observant Jews.

We are deeply cognizant of the role which the UJA has played and is playing in unifying American Jewry for the monumental task of saving, rehabilitating and resettling three million of our brethren during the first twenty-five years of its existence. The Conference experience, as many of us who have shared in it can testify, is of inestimable spiritual value to the men and women who attend, and who bring back to their local communities the inspiration, guidance and information which they receive at these meetings.

It is, therefore, essential that the UJA staff and conference delegates uphold the dignity of the Sabbath at all gatherings and, in keeping with Jewish tradition, utilize the Sabbath to enhance the sacred work of the UJA.



#### MEMORANDUM

SUBJECT: ISRAEL'S SHARE IN THE ABSORPTION OF IMMIGRANTS

FROM: UNITED JEWISH APPEAL

In our publicity material we state that Israelis provide two dollars for every dollar that American Jews give for immigration and absorption. It is important to understand the basis for this commonly used ratio. It is rooted in facts and statistics and is, to say the least, a conservative estimate. The basis for this conclusion is as follows: Using the statistics for the year 1960, which are available in greater detail than any year hence, we selected those items of the budget of the Israel Government which directly benefit immigrants. This includes such items as agriculture (irrigation), housing, health, education, and welfare.

In the year 1960, the Government of Israel expended the equivalent of 133.8 million dollars on social services including education, welfare and health. Of the 86,324 persons who applied for welfare aid, some 70,088 or 81% of the total were immigrants who came to Israel after 1948. In 1960, 40% of all pupils enrolled in Israeli schools were children of immigrants who arrived after 1948.

During the same year expenditures on housing totaled the equivalent of 84.7 million dollars; on agriculture, primarily irrigation, the budget figure is 74.7 million dollars. In adding up the items that benefit the post 1948 immigrants mainly, although not exclusively, we arrive at a total of 293.2 million dollars for the year 1960.

Let us assume that no more than one-half of these expenditures should be allocated to post '48 immigrant absorption; yet, even on the basis of this calculation we arrive at a rather impressive amount of 146.6 million dollars. During that same twelve-month period the UJA cash allotment for immigration to, and absorption in, Israel was no more than \$52,951,000 broken down as follows: Through the United Israel Appeal - \$30,802,000 in the Regular Fund and \$12,149,000 in the Special Fund; through the JDC for its programs in Israel - \$10,000,000. The UJA total, when compared to the budgetary items of the Israeli Government is slightly more than one-third. To put it another way, we find that a community of two million Jews in Israel spends approximately 146 million dollars on immigrant absorption as compared to the 53 million dollars contributed through UJA by the American community of five million Jews. In this connection it is important to note that more than half of the Jewish taxable households in Israel have an annual income the equivalent of \$1,800 or less. The well-to-do with a yearly income of the equivalent of \$5,000 do not constitute more than one percent of all taxpayers in Israel.

It should also be borne in mind that the ratio of two to one has risen since the year 1960 because immigration to Israel from European countries and North Africa has increased from 24,000 in 1960 to 64,000 in 1963. In addition, the dollar cost per person rescued is constantly increasing. During the same period the annual UJA cash allotments to the Jewish Agency and the JDC have failed to keep pace with the enlarged immigration. If anything, the contrary is true. In 1962 the total UJA allocation to the Jewish Agency and the JDC for work in Israel did not exceed 48 million dollars. In other words the Jewish community in the United States, while making a significant contribution to the solution of some of the problems confronting our people in Israel, have been no more than junior partners in this historic enterprise.

It is true that Israel is making steady progress towards the ultimate goal of economic independence. At the same time we must realize that the Government of

Israel and the Jewish Agency are confronted with a serious absorption crisis. One out of five immigrants in Israel is still under-housed, under-educated and under-employed. There are still twenty thousand Jews living in temporary dwellings. There are close to two hundred thousand men, women and children who are confined to 1 to  $1\frac{1}{2}$  rooms per family.

You can very well imagine that this situation creates serious social problems for the teen-agers who must spend most of the day and night out in the street for lack of anything to do, or any place to go. If there are no funds for improved housing, there are absolutely no resources available to provide these new immigrants, especially the children and teen-agers -- with clubrooms, social facilities, not to speak of tuition free high schools, which do not exist in the State of Israel.

Needless to say Israel must continue to expend tremendous sums to maintain its military strength in the face of surrounding hostile nations. On the basis of these facts it cannot be denied that the Israeli citizen is doing more than his share for the new immigrants. The American Jewish community must, therefore, reverse the trend in 1964 and seek to adjust the present two to one ratio. If we are, indeed, equal partners in this humanitarian endeavor it behooves us to strive for an equal share of responsibility. This can be accomplished only by increased giving on the part of American Jewry to the regular and special funds of the United Jewish Appeal.

# "THEIR LIBERATION IS IN YOUR HANDS"

# ARTHUR J. GOLDBERG

I AM GLAD TO JOIN in this important Conference of the United Jewish Appeal inaugurating its 1964 campaign. It affords me an overdue opportunity to pay deserved tribute to the indispensable and important role which the United Jewish Appeal has performed for the Jewish people throughout the world and throughout the years. In a very real sense, it is difficult to conceive how Jewish life and the Jewish spirit would have prevailed and endured in recent years of tragic memory without the work and contributions of the UJA.

#### A Proud Burden

This work has borne great fruits — a part in building the democratic State of Israel — the rescue and resettling of 1,500,000 Jews who survived Hitler's savagery and the world's neglect — the thriving cultural and spiritual Jewish life in this country and throughout the free world. These are the most notable of the many contributions of this great voluntary effort.

The burden of the UJA is a heavy but proud one. Year after year it must discharge the neverending task of mobilizing the generosity of Jews and non-Jews in support of these essential efforts. I am sure that the leaders of this campaign would like to promise you relief, at least in part, from this burden – the sight of an end to this responsibility. They would be ill-advised to do so.

Although Israel's self-reliance increases day by day, its people will need support for many years to come. Millions of Jews still live behind an iron curtain of anti-Semitism and oppression. Their liberation is in your hands—their emigration to Israel and the few other countries who will admit them their only salvation. Jewish institutions here and elsewhere need increasing aid and assistance if Jewish communities are to fulfill their proud tradition of maintaining Jewish spiritual and cultural life and of taking care of their own.

#### For All-Liberty

Jewish fundamental law for more than 3,000 years has proclaimed the blessings of liberty—teachings reflected in our American Declaration of Independence and Constitution. Jews in this country, therefore, must be doubly mindful of the admonition of Tom Paine, that "those who expect to reap the blessings of freedom must undergo the fatigue of supporting it."

Without impugning the motives or good will of anyone, I must frankly state that I do not understand the reasoning of those who question the support which the UJA extends to Israel's people and the aid it gives to resettle oppressed Jews in other countries who voluntary wish to emigrate there. In rescuing Jews from anti-Semitism and discrimination, and in enabling them to breathe the free air of Israel, the UJA is acknowledging the most ancient of Judaic-Christian teachings: that each man is truly his brother's keeper.

#### The UJA's Role

In this role, the UJA is responding to the ancient command: "If there be among you a needy man...within any of your gates...you shall not harden your heart nor shut your hand from your needy brother, but you shall surely lend him sufficient for his need....For the poor shall never cease out of the land. Therefore I [G-d] command you, saying, "You shall surely open your hand unto your poor and needy brother in your land."

—Deuteronomy 15:7-8, 11

#### Test of an American

In helping to maintain the life, creativity and vitality of Jewish institutions, the UJA is making an important contribution to the cultural and creative diversity of American life. To me, the supreme test of an American's citizenship is this: that he is one who does not conceal but affirms his origin, who is proud of whatever it may be, and who recognizes that in the plurality of American life is our strength and the source of the freedom that we so proudly profess in the world.

#### Our Nation's Ideals

The genius of American life is that in this free and tolerant land there is room here for men of any race, religion and ancestry. Our strength is in this diversity of cultures and traditions freely honored and cherished—not in an enforced uniformity. The only uniformity or merger of identity which America has the right to and should expect of its citizens is that politically they are solely American citizens. There is no room at the polls for Protestant-Americans, Catholic-Americans or Jewish-Americans. But there is every need in our national

life for the spiritual ideals of both the Old and New Testaments and every room for both the wearing of the shamrock on St. Patrick's Day and the celebration of Columbus Day; for both President Kennedy's and Senator Javits' sentimental journeys to their ancestral homes.

In helping the people of Israel to help themselves to economic self-sufficiency, the UJA implements American foreign policy. American foreign policy in the post-war period is one of enlarging freedom. Through the Marshall Plan, the Point Four and Foreign Aid Programs and the Alliance for Progress, we have indicated our open support for all nations seeking freedom. Our sympathies are manifestly with those nations standing for liberty and seeking the end to injustice, tyranny and oppression.

#### Let Freedom Survive

On this, our policy was well expressed by President Kennedy: "Let every nation know whether it wishes us well or ill, that we shall pay any price, bear any burden, meet any hardship, support any friend, oppose any foe to assure the survival and success of liberty. We stand for freedom. That is our conviction for ourselves—that is our only commitment to others."

Israel is a democratic nation sharing American ideals of freedom, liberty, equality and social justice. America and Israel are heirs of the same legacy and associates in the same historic endeavor to preserve freedom for their people and for all, everywhere, who wish it. Both America and Israel pursue common ideals, with sturdy peoples and with traditions of individual liberty that are in

themselves the highest product of man's existence.

#### A Common Cause

Israel's goal is our goal – peace in freedom. We are allies in this common cause. The leaders of Israel on every occasion have proclaimed their earnest desire to negotiate a just and lasting peace with their Arabic neighbors and a willingness to cooperate with them in the development of the resources of the area for the benefit of all its inhabitants. Israel arms only in self defense against neighbors who openly proclaim their hostile intentions and designs. Israel seeks in the words of Isaiah (32:17-18) to dwell "in a peaceful habitation" and "in secure dwellings." It extends a helping and brotherly hand, as we do, to newly-developing countries in Africa and Asia which are benefiting from Israel's unique experience in its own hardwon development. It seeks to live in peace and freedom. These are Israel's goals and these are America's goals.

#### "A Better Man . . ."

It is for such humane reasons that every Jew who, through the UJA and otherwise, aids in advancing Israel is a better man and a better American for doing so. It is for this reason that no American need be restrained from reaffirming the traditional American policy of support for the integrity of Israel and for its peaceful development—support which America, in equal measure, offers to every other country in the Middle East.

I conclude, therefore, by wishing you well in this new campaign and by expressing the hope for its successful outcome. The Jewish Theological Seminary of America in cooperation with
