Following a talk with your secretary, Iam sending you this set of money issued for and used by the inmates of the largest concentration camp in the Protectorate of Bohemia during the Nazi regime. It is a complete set. The money is signed by Jacob Edelstein whose title, apparently, was "The Oldest of the Jews". Theresienstadt was a large camp where not only Jews but others were sent. However, the majority were Jews.

I thought that from the historical point of view your museum may want the notes, even though it brings back sad memories. In case you are not interested, please send them back to me. If they are of any

value to your museum, keep the set.

AMERICAN JEWISH CONCRESS WOMEN'S DIVISION CONVENTION NOVEMBER, 1959

### NUCLEAR TESTS OD DIS RMANTETT

The Women's Division of the AJCongress holds it to be a solemn obligation of the United States to intensify its efforts along with the other Great Powers to the steps to halt the armaments race and to concert measures which by a controlled and progressive scheme of disarmament will deliver makind from the lurden of fear. We share to the full, the deep anxiety with which all mankind is afflicted in the knowledge that nuclear armaments is capable of destroying humanity.

We urge that decisions be then under conditions which will safeguard the security of all nations, to bring about the cessation of nuclear tests.

We believe that the cossation of tests is an important first step in an international effort to secure the halting of the manufacture of nuclear arms, and thereafter their abolition within the framework of a balanced and massive disarmament, on which a new structure of international relations can be built.

We urge that the AJCongress undertake a program of education and action to achieve this end.

We are planning an exhibit entitled "Story of American Judaism," which will open in our Klutznick Exhibit Hall around November 15. We are now in the process of borrowing from various museums, historical societies and private collectors, a representative group of ceremonial objects, books, mementoes and manuscripts which will tell the story of the development of Judaism in America over three centuries.

While at Hebrew Union College several weeks ago, Dr. Marcus told me of your unusual collection and suggested that I get in touch with you. I would appreciate your letting me know what sort of material you have that is of American origin or usage, and what would fit into our exhibit.

If you are willing to lend us suitable material, I would appreciate your listing some of the items you have available. I will then arrange for the loan of items we can use.

Our Exhibit Hall is protected by a uniformed guard during open hours and an electronic burglar alarm during closed hours. All of our exhibit cases are fireproof and tamperproof. We insure borrowed material portal to portal.

Dear Mr. Shosteck: Dr. Silver has turned over to me your letter of September 28th. We do have a large display here at The Temple of Jewish ritual and sacred art. Most of it is drawn from Near Eastern and European centers and includes valuable Sephardic Torah cases. silver genizah marriage contracts, Eastern European scrolls, Megillahs etc. etc. I am somewhat puzzled, however, in the area of Americana. We have such archival material as the early Board minutes of The Temple, photographs of the first several Temple structures dating back to the 1850s, etc. There is available in Cleveland, and we have displayed, some material relating to Jewish participation in the Civil War -- Officer Brevets, letters from the front, etc. We have also a copy of a film showing Dr. Silver's speech at the United Nations in May of 1948, proclaiming the establishment of the State of Israel. Dear\_:

... you may want to join in a <u>mitzvah</u>, in which I myself am engaged—since I know that it is this kind of <u>gemilut hesed</u> to which you always respond.

As you can very well imagine, my week, like yours, is punctuated by visitors who have all kinds of projects and who are in need of help in areas beyond my ken and ability. I have had to learn to try to limit my own response to those crucial, strikingly important projects which, at least in my opinion, if they go unrealized will be a loss to the community at large.

One such effort is now engaging me vary actively. It is a study of the Middle East on an historical basis but carrying very significant and vital overtones for the contemporary scene, since it demonstrates quite conclusively the kind of permanently strained relations which must exist between Syria and Egypt. I say this is an historical study, and that is its great strength, although I want to underscore that this critical study of the above trends in Syrian-Egyptian thought and action will indicate clearly why Syria always reacted forcefully and resisted Egyptian occupation despite the great measure of identity, culture, religion, language and so forth, of both countries. The implications of this study are abundantly clear. Much of our unrealistic international action has been based on just the opposite kind of thinking. I believe that when this book will be produced, many vague and unsupported theories will be dissipated, indeed as they should be. If we can bring about such a reformulation in political circles, as a result of a scholarly work, I believe we will have a perfect example of the relationship of thought and action.

The man who is engaged in this work is a struggling scholar. I want to keep his name anonymous, although I know that he will play a very important role once the book is published. I have undertaken to help him to conclude his studies in such a way that the book can be forthcoming within two or three years, although it need not necessarily take that long. This scholar, an Israeli, is now resident in London, where he is digging up all kinds of new material at the British Museum and elsewhere. In order for him to be able to continue these next two years, he will need a research sum of some \$3,000 each year. I have undertaken to try to help him raise as much of that sum as possible.

Do you want to join? I am writing to a few people, hopeful that I can get them to cover the sum. There will be a tax exemption on this contribution. I have arranged with a Foundation in New York that is set up for this purpose and that will transfer the funds. On the other hand, if you feel that this is not necessary, in terms of the monies available to you, you can arrange to have a check made out to me, and I, of course, will acknowledge it upon arrival.

I know that you most certainly do not mind my asking you to participate, just as I will fully understand if, for any good reason, you decide that you cannot join and help.

If you do choose to respond positively, I want to stress that the matter is of great urgency, and whatever you can do in an immediate way, will be doubly appreciated....


