My dear Joe:

I acknowledge at once the receipt of your good letter of the 28th of August, enclosing as it does the letter of the 24th of August from Mr. Lessing J. Rosenwald (which latter letter contained as enclosures (1). "A Tentative Statement of The American Council for Judaism, Inc." and (2) a reprint of Mr. Rosenwald's article in the magazine LIFE. I also acknowledge in connection with this, your reply to Mr. Rosenwald of the 28th, and I am, of course, flattered by your reference to me, and because you refer to me as your "collaborator", and because you believe that my "reaction" would be yours, I am at once charged with the responsibility of giving you that reaction which, may I say parenthetically, I think would be yours, even though you didn't hear my views on the subject.

Let's ahalyze for a moment. What is this "American Council for Judaism", and who are the men who esponse its cause? Unfortunately, Joe, there remain in Jewish life a remnant, who (because they still live among the flesh-pots) would sacrifice all of those things that contain in them the eternal values, that their position continue to be maintained. They are men, by and large, of wealth, and they are men who just won't read the handwriting on the wall (there are always those who with their eyes open are blind, and those whose ears hear not). They are men who can't even interpret current history, and they are men who take refuge in the hebulous hope that that which happened elsewhere (i.e., Germany, Austria, France, later Holland, and now Denmark) can't happen here. There are men like these in Germany. Peculiarly enough, the remnant that are here are the descendants of those men of Germany who sought to escape their Judaism via the media of Reform, assimilation, intermarriage, and apostatism, and I point to the tragic fact that when Fascism and Hitlerism raised its bugly head, the escape that thos; men sought availed them naught, and they were caught in the maelstrom of the victousness of that hate of Fascism and Hitl-rism, and were indeed the first to feel the effect of that hate. Unfortunately, men like Rosenwald can't or won't interpret what has happened as having any possible reference to what might happen here. Unfortunately, their Judaism is what Heinrich Heine once called it when he said, "das Julenthum ist nicht ein religion - es ise ein umglick", but whatever it is they seek to justify it and justify it in minimizing it to the abstract.

Now, my dear Joe, while you were here at the hostpinal, you read "THE WORLD OF SHOLOM ALEICHEM", and then I brought you, if you will recall, Styfan Zweig's "THE WORLD OF YESTERDAY". Mudge for yourself, my dear Joe, which world had men of the substantive in its men who had in

Wasn't it the world of your father and father's fathers? Wasn't it the world of East European Jewry? I remind you that we Jews had excesses even before the rise of Hitlerism. We had our pogroms (Kishinov - Bialystok). True, as Abe Sacher so well puts it in his foreword to the Hillel edition to "THE WORLD OF SHOLOM ALEICHEM":

"The contemporary world has devised so many new weapons and techniques of hate that the reaction and the brutality of the last generation appear, by contrast, as almost affectionate fratricide."

But nonetheless there were pogroms and fear of pogroms; there was poverty and insecurity, but the world of Sholom Aleichem could take its poverty and insecurity. It could go to its death when that need be, with a "shma-yieroael" on its lips, but the world of Stefan Zveig and the world of those German Jews of which the Lessing J. Rosenwalds are the American successors, gave nothing to the Jew in the mature of support, and the only surcease was the surcease of suicide (you recall, of course, that Mr. Zweig ended his life in Brazil last year).

Now, the right of suicide is a personal right, but the philosophy (God save the mark) of Rosenwalds contemplates race suicide, and I reserve the right as a Jew to hope for the continuance of my people, the American Council for Judaism, Inc., to the contrary notwithstanding. Mr. Rosenwald fears Zionism and Palestine. Mr. Rosenwald and that little coterie of rabbis, whose gilded temples the Rosenwalds support (but rarely attend) are fortunately in the minority, though they make themselves felt by the twin power of wealth and place. This is not the first time in Jewish history that we have "protest rabbiner". They prototype the "protest rabbiner" Theodore Hertzel met in Germany when he announced his conversion to Zionism, and published his famous "Judenstaadt". Whenever, Joe, the masses of our people sought relief and escape from the inhibitions and prohibitions of the times and places in which they lived, whenever the masses sought home and homeland and place in the sun, those Philistines always supported by their paid rabbinate - protested. Peculiarly enough, the type is common in history - always the well placed, always the wealthy, always those who feel that they are the historic exception, and that when atti-Judaism and anti-Semitism become rampant, they will not feel the scourge, forgetting that the anti-Semite doesn't make the very fine distinctions they would make.

Joe, the American Council for Judaism is a misnomer. Who is God's name are they to speak in the name of Judaism? Since when are they the keeper of the scroll? Since when have they, and they alone, kept aloft the eternal light? If anything, they would give it up - all of it; yes, all of it, if they could be accepted by the Cabots and the Lodges, and they have no right, and I, as a self-respecting Jew, refuse to give them the right to interpret Judaism for me.

A better answer than that which I give you now was made to Mr. Rosenwald by Chaim Greenberg, the editor of the "JEWISH FRONTIER". That really was magnificent, and I am having a copy of that sent to you through my friend, Er. Cruso. Read it. Joe. and then you tell me what the answer to Mr. Lessing J. Rosenwald should be on your part.

Yes, this man is the son of the late Julius Rosenwald. It was Julius Rosenwald, you remember, who in his lifetime gave millions for YMCA's for colored boys, but didn't give to Palestine. It was Rosenwald who lived through the halcyon era of the turn of the century, but who didn't live long enough to see that that security which he thought was permanent (as built up through Sears Roebuck) stands today on the sheerest of quick-sands if America is to repeat Germany's experience in relation to its Jews.

A Judaism so colorless, so osteopathic, so meaningless, so void of any of the values that make up my Judaism, as is contained in the rather shabby purpose of the American Council for Judaism, is one of which no man with respect for his tradition, will subscribe to.

I think I have made answer as I see it. It may be strong, but I feel strongly. You can temper it to suit your purpose, but I know that by and large, you must feel about it as I do, and that your reply to Mr. Rosenwald will be in keeping with those feelings.

Joe made reply to Mr. Rosenwald under date of August 28th, as follows:

However I have for many years been a Zionist and still am. I do not think I can subscribe to all of the principles set forth in your digest. However, my chief collaborator on subjects of this nature has been my very close and dear friend, Mr. Robert A. Hees of Milwaukee. I am sending to him your letter together with the enclosures for his reaction to the same. I am quite certain that my views will coincide with his, and when I hear from him I will again communicate with you.

Gross, an outstanding citizen here and a member of The Temple, was used in connection with the meeting held here by the Council for Judaism last Monday. I wrote to Mr. Gross, and I am sending you the enclosed correspondence. It is very revealing. I am inclined to believe that quite a number among the hundred whose names were used were drawn in under similar false pretenses. It might be well to consider the drafting of a letter to be sent to the hundred whose names appeared in the New York Times. plus the report of the meeting of the american Jewish Conference, where the Council was denounced, an account of which appeared in the New York Times, as well as the statement of the 900 Rabbis which was previously published by the Emergency Committee. My guess is that quite a number of these people will resign as did Mr. Gross. I would suggest that you draft such a letter before you come to Cleveland so that we can discuss it. Dear Dr. Silver:

- (1) Judge Samuel I. Rosenman will see you at the White House on Tuesday, October 12, at three o'clock p.m. This is part of the series of engagements being made for you when you are in Washington on October 11 and 12.
- (2) Dr. Israel Goldstein. during a lengthy discussion with me of certain matters affecting the Emergency Committee, told me that Judge Rothenberg has agreed to head the JNF. This would eliminate him from the UPA picture. The more I think about the alternatives we discussed, the more I feel it will be received very well in the country.
- (3) I should like to make a further observation with respect to the lady who you think ought to be substituted for the name originally suggested as Chairman of the Research Committee. I imagine that pressure may be brought to bear on you with respect to this particular woman, as, undoubtedly, with respect to everybody else seeking appointments, or for whom appointments are being sought.

A professional research worker, with competence, as in the case of Dr. Berkson, realizes that research is part of a machinery. The Chairman of the Committee is the one who is supposed to establish policy. The woman whose name you now suggest has been constantly identified with the opposition to the Jewish Commonwealth. It may create difficulties. She has also been identified with the present administration within her organization, which, I understand, is shortly to be replaced by a more militant Zionist point of view.

- (4) In accordance with your request, Arthur Lourie is arranging for a meeting of the Executive Committee of the Emergency Committee on Tuesday, October 5, at four o'clock p.m. I hope that by that time the back of the Allotment Committee situation will have been broken.
- (5) As a result of our conversation in Cleveland, I called Dr. Goldstein with reference to his letter to you to say that you were planning to name Joel Bross as Chairman of the

Dr. Abba Hillel Silver Page 2 September 29, 1943 Committee on Community Contacts, and Rabbi Milton Steinberg as Chairman of the Committee for Intellectual Mobilization. Dr. Goldstein, who has had very limited contact with Joel Gross, if any at all, seems terribly anxious that Mr. Gross should not be appointed to that post. I cannot tell whether it is because Dr. Goldstein personally does not like Mr. Gross, or whether he is trying to get him for a specific ZOA task. He asked that I see him further in regard to this matter. I do not share Dr. Goldstein's view at all, and told him so. With kindest regards, I am Cordially yours. Dear Dr. Silver:

I have tried to the largest extent possible to disengage myself from the work of the U.P.A. and the U.J.A., although the transition is not as easy it might sound because there were many activities which I was carrying on which will take time to explain to one person, perhaps even to more. Insofar as the Emergency Council is concerned, these represent some of my activities:

- (1) I spent approximately four hours with Charles Rosenbloom on Wednesday, October 6th, going over the entire budget with him. The position that we took was that we were trying to establish the general limits of a budget with the understanding that each functioning committee will fix a budget within this general framework. It was thought desirable to draw general lines, financially, as to what was possible. There are a number of items which were considered and cast aside for the time being to be taken up later on if there should be sufficient pressure from circumstances. The budget was in the neighborhood of \$550,000. I am now trying to arrange the first meeting of the Finance Committee, since my talks with Mr. Rosenbloom were personal in character, for next Wednesday, October 13th. The letters signed by Mr. Rosenbloom and yourself have gone off to Dr. Goldstein and Judge Rosenblatt. They will be followed up.
- (2) I spoke to Mrs. Jacobs about the Research Committee. She felt that she would have to see you first, as she had indicated at the Emergency Council meeting, before taking the position. I said that I knew what was in your mini; that you were terribly busy; that you would be in Washington next week; and that I would be glad to discuss the problem with her and why you had made the several remarks that you did as to the position of the Research Committee in relation to the political program of the Emergency Council. I am meeting with her tomorrow morning. Tomorrow I am also meeting with Dr. I. B. Berkson. I asked Mrs. Jacobs how she felt about Dr. Berkson. She approved heartily. This seems to have been the attitude of everybody to whom I have mentioned Dr. Berkson's name.

October 7, 1943

Mrs. Jacobs advises me that he is now receiving \$7,500 from the Esco Foundation. That is the basis on which I will proceed.

- (3) Joel Gross is tied up with law business and will not be free for a meeting with me to discuss community relations until next Wednesday afternoon.
- (4) I have had a long preliminary talk with Herman Shulmar about the American Palestine Committee. A letter announcing the appointment of members of his committee is going out. A copy of it was sent to you. The name of Mrs. Halprin had also been removed and the name of Mrs. Epstein substituted. The other name which you eliminated had also been eliminated by us. The names of Henry Monsky and Judge Ralph Hertz of Cleveland are being added. I am meeting again with Mr. Shulman tomorrow to discuss two events in particular: (a) the Christian Conference in New York and (b) a large function of the American Palestine Committee in Washington.
- (5) The most serious problem facing the Emergency Council is that of staff. The present staff is completely inadequate. By that I do not mean that the members of it are unsatisfactory, but merely that there is not enough, by far, personnel to handle the widely expanded job that we are now planning. Interviews for this purpose take a great deal of time. Sometimes I get the feeling that I am getting nowhere because so much time is wasted on these trivial matters. I recognize, however, that two or three weeks must elapse before the machine, as such, can be set up, if not necessarily perfected. We are actually creating from the ground up.
- (6) The problem of space is extremely serious. As you know, one could not possibly fit the staff that we are acquiring within the limited space now held by the Emergency Committee. I have discussed the question of enlarging this space so that it would run from 43rd Street down to 42nd Street on the long, narrow strip which the Emergency Committee now occupies on the 11th floor. But even if we were to acquire the total space, which would cost approximately \$9,000, it would not be fully adequate to meet our needs. Far more important, however, than the amount of space is the type of space now occupied by the Emergency Committee. With the exception of two or three rooms, the entire area is dark. Lights must be used constantly. The impression is one of dreariness. To people who come to an office to attend meetings once a week, this may not seem significant. But it has an important psychological effect on people who work in an office, whether they be stenographers or executives. It is my thought that the efficiency of the Emergency Committee is 50% less than it might be with even the same people because of the dismal atmosphere in which the people work. I am, therefore, scouting around for quarters that would be within a stone's throw of the present building. There ic a possibility, for example, of space in the building in which the U.J.A. has offices. I am hoping to have this problem disposed of within the next few days. It is the most serious problem we face from a technical point of view, since all plans for acquiring equipment, making shifts, etc., are dependent on the physical place we are to occupy.
- (7) I have had a long talk with Weisgal, who I believe will be one of the most useful assets of the Emergency Council. I propose to send him a memorandum of the things which he is expected to do. My thought is to utilize every single one of the fine contacts he has made. A service which he has rendered which is of inestimable value is the publication in LIFE

Dr. Abba Hillel Silver -3-October 7, 1943 in tomorrow's issue of the nine-page layout on Palestine. It is due to him, and to him alone, that this appears. It is probably the finest piece of pro-Zionist material that has appeared in a national publication of the importance of LIFE. His effectiveness on this score, as well as in many other directions, will be integrated by me into our program. (8) I have not yet been able to manage the time for a meeting with Mr. Lipsky on the subject of publication. This will undoubtedly take place within the next day or two. For the moment, the basic items will be: (a) a Confidential Bulletin, which is described in the attached memorandum which I have sent to Mr. Lourie. It is extremely important that we maintain contact with our people all over the country and give them a sense of the confidence we repose in them; (b) the publication intended for circulation among some 10,000 people of a lay character, whether Christian or Jews--most of them. of course, will be Christians. The exact scope of this is still to be defined. The plans up to this time are, I am afraid, quite incheate. (9) Joel Gross tells me that he is writing to you about Rosenman, so there is no need for me to add anything on that subject. I am terribly regretful that you could not manage to see the Treasurer. I am informed that he is the most important personality in the city which you are visiting next week, insofar as our interests are concerned. He has done many things and is said to be the greatest friend of our work who actually does something about it. I am suggesting that the attached letter be sent by you from Cleveland. My dear Mr. Montor:

I read the "Confidential Bulletin" and I approve of it.
I would sug est that you keep in mind the following things:

- 1) The Bulletins should be sent to a very restricted and reliable group of people.
- 2) I am not sure that the name "Confidential Bulletin" is the happiest one. The idea of its being confidential ought not to be in the title.
- Palestine Administration. As far as possible use the term "Palestine Administration" or "Colonial Office" rather than "England" or "Great Britain". We will have to appeal to England as well as to our own country to repeal the White Paper. Our position is that the historic line of Great Britain on Palestine has been detoured by the bureaucracies both in the Colonial Office and im Palestine.
- 4) It is not always wise to suggest the people whom we contacted in Washington. The opposition will probably come into possession of these bulletins and may proceed at once to contact the same people in order to counteract our influence.

This will acknowledge your letter of Movember 1st, with those items I shall deal seriatim.

May I use this letter to confirm your schedule in Washington on Monday, November 8th, when you will meet with Mr. Morgenthau at 11 a.m., and with Lord Halifax at the British Embassy at 12 noon. It is of course a very crowded schedule, but I thought it desirable not to miss this opportunity with the British Ambassador in view of what hinges upon your conclusions as a result of that meeting. I have no doubt that Mr. Morgenthau would find it possible to meet with you again in the afternoon. I have also put in motion the effort to get either Mr. Hopkins or Mr. Baruch. You will hear from me probably even before this letter reaches you. Mr. Lourie called W. D. Hayter to arrange the Halifax appointment.

The meetings have been scheduled as you suggest. That is, for November 15th there is a meeting of the Executive Committee in the afternoon, and the full Committee in the evening. A further meeting is to be held on November 29th of the Executive Committee, and on December 20th there will be a meeting of the Executive Committee in the afternoon and of the full Committee in the evening. I am wondering whether the large gap between the last two meetings may not give rise to criticism.

We are looking into the matter of getting housing accommodations. I shall report to you as quickly as possible. In any event, it would be desirable to have this space for yourself first, and we can utilize the rooms for other friends who may come to town as part of our hospitality program. It is certainly an impossible situation for you to have to come to town and sit around all day waiting for the elementary housing accommodations.

With respect to the question of overlapping membership on the several committees. I do not know how we can solve the particular situation. The mere fact that there are a large number of members on the Emergency Committee as not mean; a) that all of them are equally equipped to do certain types of work; and b), that each of them is available when called upon to do the work of a certain committee. Several of them have many other responsibilities, either in the Zionist field of Professionally. We would handicap ourselves very gravely if we were to rely on legislated committees. I happen to feel that Mr. Lipsky's idea of a working committee is spand, because he has selected people who are interested in the particular type of work he is doing who might be expected to attend meetings. We have had some rather despatrous experiences in the last two weeks of meetings being called and a very poor standance resulting. The best attendance that I have seen thus far in any of these meetings was recorded at the Finance and Personnel Committee which met for breakfast at the Sherry-Netherland last Monday, when nine people were actually present.

I shall be sending to you within the next two or three days as complete a list as is available at the present time of all the functioning committees. Several of them have not yet created their full committees, as the Research Committee and the Contact with Postwar Groups and the Labor Relations Committee. I have not even had an opportunity of meeting with Mr. Max Zaritsky. However, I have been after Mr. David Wertheim who has been our very helpful contact with him and as you will have heard before this, the C.I.O. at its Convention in Philadelphia adopted a resolution on the White Paper and the Commonwealth; copies should go forward to you within the next day or so when the text reaches me.

He feels that research must be a pigeonhole all by itself with no contact with the sordid world of everyday affairs. That is not my idea at all of the usefulness to which a research department can be put. I have hesitated long before coming to this conclusion because I confess that I stand in awe of scholarship, and particularly since Dr. Berkson was so highly recommended by everyone concerned. I am meeting with Dr. Kohanski tomorrow and shall then make up my mind about going forward with him.

Mr. Weisgal did not attend the meeting of the Executive Committee of the American Jewish Conference last Sunday. It happened that the day befor Max Reinhardt went into his last death agony and Weisgal was called to the bedside by Mrs. Reinhardt. He stayed there for almost three days in succession as a friend of family helping out in all the arrangements, including finally the funeral. I am informed however that the Executive Committee was very poorly attended. Mr. Monsky himself did not attend. No real action was taken. The only decision was to convene a meeting of the interim committee this coming Sunday. Presumably, you will not be able to attend. I shall try to make it my business to attend that meeting although I do not like to barge into places where I am not expected and not invited. However, I feel that the Emergency Council has a stake in the decisions to be made. Another difficulty with regard to my attendance this coming Sunday is that as a result of a discussion between Joel Gross, Leon Feuer, Simon Shetzer and myself, the fieldmen of the Zionist Organization are being called in this coming Sunday for a meeting to begin at 2 o'clock. At that time, we shall give these fieldmen who are out in the communities an idea of what the Emergency program is all about and try to utilize the best of them for quick visits to the communities so that proper emergency committees may be set up.

Insofar as the American Palestine Committee campaign for membership is concerned, the details have all been worked out. The final action has awaited Mr. Shulman's visit to Washington. This has been delayed because of business he has had to attend to here. He went to Washington yesterday and will be there to ay slso. He carried with him a series of letters, some to be signed by Senator Wagner, and some which I hope will be signed by Will Fogers, Jr. as Secretary of the American Falestine Committee. Mr. Shulman has made an appointment with Mr. Rogers in the hope of getting him to take the latter post. He would certainly be a great asset. As soon as these approvals are given we shall go forward at once.

1.00 Dr. Abba Hillel Silver -3-November 4, 1943 The telegram prepared by Joshua Leibman was circulated among the alumni of the Hebrew Union College. Apparently, Rabbi Leibman issued the text of his telegram from Boston for I saw the story in the Jewish Morning Journal yesterday on the frontpage. I have not seen a copy of the actual taxt as issued from Boston. A wire was sent to Liebman asking that he send the list of Rabbis who actually signed. The thought in suggesting that the telegram be issued from Boston was that it would secure better publicity than if it were part of a long series of statements from New York publicity channels. One's hopes do not always work out however. The publication, Palestine is in the stage of what is called dummying-up. Mr. Lipsky does not always agree with the editorial ideas of Miss Schwartz and myself. On several occasions. I am afraid, that Mr. Lipsky's ideas do not comport with my conception of what the communities need and what the average laymind stand. Mr. Lipsky lives a rarified atmosphere of great intellectual precision. He feels, for example, that Palestine should not contain any articles of emotional value, whether these are by men like Louis Bromfield or by other authors of outstanding note. He thinks that Palestine should be on the plane of a philosophical or scientific magazine. It is because there are these disagreements, at this early stage at least, that we are delayed. I hope that Mr. Lipsky will forgive me if, after a while, the decision is made that it is better to get the material out than to have it argued about for weeks and months on end at New York. One of the great tragedies has been that these things took such long debates with the result, as you put it at the last meeting of the Emergency Council, the group "talked itself into inactivity". I note that you have written to Mr. Riegelman, suggesting a meeting with the N.R.S. and J.D.C. on November 15th and 16th. I shall be looking forward most eagerly to word of the reply which you receive from Mr. Riegelman. I have not heard from Mr. Joseph Hyman since I last spoke to him on Friday. He had said at that time he would scout around among his people to let me know when it would be possible to arrange another date since he could not seem to arrange a meeting to coincide with the several dates that I suggested to him. I note in the letter from Mr. Farb of Houston together with the statement of principles of his Congregation. I hope you do not mind that I turned this over to the Jewish Press Service, with which since I took over in the Emergency Council I have had very little contact because of the overwhelming nature of my present task. I not this afternoon with Lee Wood, Executive Editor of the World Telegram, for the purpose of asking that the Scripps-Howard newspapers launch a nation-wide campaign against the White Paper. I gave him the full background of our situation, during which he inquired why it was that the President hadn't expressed himself in the matter.

During our discussion the following points were made:

- (1) He will personally endorse a policy involving the Scripps-Howard national chain participation in attacks on the White Paper. He will submit the matter to Mr. Roy Howard, the head of the chain, and to Mr. Parker, editor-in-chief of the Scripps-Howard newspapers.
- (2. He suggested that prior to his meeting with these people, which he said he would be prepared to do as soon as necessary, that a series of three articles be written, giving the story of the White Paper. He remarked that the people of America knew nothing about the White Paper, and felt that the Zionists had been derelict in not bringing the matter to the attention of the American public.

When I suggested the names of the signatories to the articles, which he suggested be some 600 words in length, he indicated instead that I write the articles and that my name be used, on the ground that people liked to feel that the articles had actually been written by the people themselves, instead of having been ghosted.

He said that these three articles should be so written that the editorial writers of the Scripps-Howard newspapers would have material on which to base their editorials in the coming months.

(3) I raised the question of advertising to tell our story. He recommended advertising. He said that the American people knew nothing of the situation, and that advertising, if it were done intelligently, would be the best means of reaching a maximum number of people. He emphasized the need of using advertising not for the splurge, but to present facts which readers could digest very quickly.

A crisis has arisen in the affairs of the Publications Committee. You asked me some time ago how the publications were going. I told you there were delays, but they are not delays for which this office is responsible.

Attached hereto is the dummy of the publication's first issue. It really is ready to go out, but Mr. Lipsky is holding up the issue. He wrote a piece which he insists should be the lead editorial. I realize that he is Chairman of the Publications Committee and has authority in the matter, but I take my responsibilities sufficiently seriously as to feel that nothing ought to go out about which there is serious cuestion as to policy. Mr. Lipsky's editorial piece, of which I enclose a copy, has an approach which I think is quite undesirable. It is a harangue against the United States lovernment for its failure to take "moral leadership" in the period mince the last war. I know that this is an attitude which Mr. Lipsky has expressed on quite a few occasions from the platform. I do not believe it fits into the first issue and into the editorial policy of that first issue of a publication intended to go to a great many assorted Christians who would undoubtedly resent an approach to them based on a castigation of the United States Government and its relationship to international problems.

I would appreciate it greatly if you would telephone me upon receipt of this material, since the publication is being held up.

I assume that since your letter of November 9th addressed to Mr. Arthur Hays Sulzberger is marked "Copy", an original letter actually went to him.

I regard your answer as the finest statement of the case against the Times that I have ever read. It is cogent; it is documented; it is persuasive.

It would seem to me that the letter could be most useful. I think we must make our minds up that Mr. Sulsberger will continue to be ever more venemous in his expression of anti-Zionism. In view of the fact that the New York Times occupies such an important place in the eyes of official Washington as of many other influential citizens and inasmuch as the Times' columns are being filled every day with all kinds of stories which are designed to undermine the Zionist movement, it is essential to begin attacking the New York Times itself.

My recommendation is this: that we engage a full page in the New York Times, or if that is not available, in the New York Herald Tribune, for the publication in full of your letter of November 9th to Mr. Sulzberger. I think that your letter can do more to discredit the New York Times and to establish the basis of Zionist policy than all the cliches which are usually the substance of pro-Palestine arguments. I do wish that you would give this consideration.

My suggestions would be (1) that Dean Alfange and Sigrii Undset be seen immediately to be told that a statement of condemnation of this malpractice is to be issued; (2) that the American Jewish Conference take special note of this telegram and undertake to send a telegram of criticism to every Welfare Fund in the country, since the latter are being approached for funds.

I think you will be interested in seeing this "MEMORANDUM" by Prof. Carl Freidrich, Professor of Government at Harvard University. This is the document with respect to which Mr. Neumann is supposed to have been working for a long time.

The document gives the impression of being hastily done. It shows an ignorance of the basic sources and a biased interpretation of those sources evailable to the writer. Some of the language is that of a high school senior and not of an academic person. It is completely useless, in my judgment, not because it betrays conclusions hostile to our work but because it reveals lack of scholarship and bias in research. Basically, the writer (I can hardly believe that it was actually written by a Professor at Harvard) has confused two facts. It is a fact that ever since the war the United States Government had no consistent foreign policy, if it had any at all. That absence of policy was reflected in the attitude to all countries. But the writer concludes that in the case of Palestine and the Jewish National Home this absence of policy was a studied policy of indifference, if not hostility. It is a non-sequitur, which completely forgets the nature of American foreign policy for a generation.

He thought that the Emergency Council can presently appropriate the sum of \$15,000 to a maximum of \$20,000 for this work. 2) Dr. Silver also suggested that at a later time the Council may be able to spare additional funds for this work. That would depend on circumstances, including, of course, the state of the exchequer. 3) In our discussion I had pointed out to Dr. Silver that in the opinion of the members of the Committee with whom I had discussed the question of budget, the sum of \$15,000 or even \$20,000 would be inadequate since a program of the nature contemplated would require \$50,000 or \$60,000. The solution envisaged by Dr. Silver was twofold: (a) That the work be done through or in conjunction with some agency other than the Emergency Council itself, which is engaged in this type of work or which is prepared to go into it; (b) that the sum provided by the Council should be made available in the form of a grant or contribution and that it be supplemented by funds which may be secured from other sources, preferably from private individuals who may be interested. 4) I was agreed that I canvass the situation further, consult my Committee, sound other groups and individuals before a final decision is made. I am in the process of doing so now. 5) One arrangement which I am tentatively considering is to have the Commission on Palestine Surveys established by the Jewish Agency with the formal approval of the Emergency Committee, broaden its scope so as to include the wider program of Economic Studies and Planning. This possibility would depend on the agreement of the members of the Commission and Dr. Weizmann, as well as upon the availability of the necessary funds, partly from the Emergency Council and partly from other sources. Under such an arrangement, if it can be effected, the Council, through its Sut-Committee on Economic Studies and Planning, may place the sum of \$15,000 cr \$20,000 at the disposal of the Commission, with the understanding that this sum would be used to finance certain studies



Your letter must have crossed a shipment from me of copies of the Silver letter. An additional twelve copies are being sent you under separate cover. I am sending one to Mr. Jacob Billikopf, in accordance with your suggestion.

You will recall my earlier observation that I regarded your letter to Mr. Sulzberger as one of the finest pieces of Zionist propaganda that has been written. I even felt that it was sufficiently good to be used as the text for a full page advertisement. If we are to succeed in neutralizing the New York Times we must blast the New York Times as a focus of anti-Zionist agitation. Otherwise the Times will continue to be regarded as a neutral organ, and as a paper which must obviously be fair to Jewish things because it is owned by a Jew. I certainly heartily approve publication in full in the New Palestine. Would you want me to carry this forward with the editor, or will you communicate directly with him?

I am giving instructions to Mr. Manson, our new publicity director who was formerly the assistant to Mr. Eenen, to go forward
with a large-scale publicity campaign on the enlarged American Palestine Committee. Under separate cover I am sending you a plan of
advertising which would use the American Falestine Committee as its
source. This would tie in with your own thinking as to the need for
large-scale publicity on this aspect of our work.

The transcript of Dr. Goldmann's conversation with Wallace Murray on November 19 was handed to you in the folder at the last meeting of the Emergency Council. Apparently you did not have an opportunity to read it. A copy thereof is going to you herewith.

Mrs. Shepard of our Speakers! Bureau will check on the availability of Pierre van Paassen or someone equally good for the meeting of the Cleveland Zionist Society, and will wire promptly.

Elihu Stone has written to me from Washington to urge that the Palestine Resolution be introduced promptly so that there can be a basis on which to approach Senators and Representatives.

He has also suggested the text of a Resolution as he would like to see it drawn up. I have suggested to him that he draft such a Resolution which could be submitted to you.

He feels that there are certain passages in the Rotienberg-Shulman Resolution which are not appropriate for Congressional action.

Is it your view that:

A. A Resolution can be introduced before January 10th when Congress reconvenes, or

B. That such a Resolution must await a meeting with the President.

The introduction of a Resolution would undoubtedly give to all the work of the Emergency Council a focus which would galvamize the activities of its followers throughout the country.

Dear Dr. Silver:

This will acknowledge your letter of December 19th referring to the Independent Jewish Press Service. Following the meeting at Columbus, to which you refer, I dropped any editorial participation in the Independent Jewish Press Service. I could not carry that and my other work as well. The personal relationship that I had with the Independent Jewish Press Service through the editorial supervision given by Miss Neumark was severed many months ago. Mr. J. L. Teller, who was for many years one of the star reporters of the Jewish Morning Journal, assumed complete editorial direction and management.

I have not always had time to read the Jewish Press Service material as rapidly and as regularly as I would have liked, but from time to time I have seen items which have displeased me greatly. The series of articles by Mr. Lipton is a case in point. When I learned that the several articles that had appeared were merely the beginning of a long series, I called Mr. Teller and gave him my views on the subject. Healso discussed the matter with Dr. Goldstein, I understand. Mr. Teller informs me that some seven or eight articles which he had had in his till from Mr. Lipton and which were/discuss the Zionist movement in the same terms will not appear, although they had been officially scheduled. There have been several other instances of this kind. I know that they do not represent any malice on the part of Mr. Teller, who is a very good Posle Zionist. But you are probably correct in assuming that an editor's reverence for the word "independent" may sometimes lead to injudiciousness. I believe that the several talks that I have had with Mr. Tellar should prove helpful.

Mr. Teller is one of the coming younger journalists and I think should be encouraged in the proper way. In fact, I should like for him to have a special interview with you when you are next in New York. It is this kind of personal treatment which has wonfor the Emergency Committee people some of their most enthusiastic press friends. I am certain that your capacity to win such friends is incomparably greater. During your interview with Mr. Teller you could drop some hints or observations which would go far to strengthen what has already been said to him.

As to the attack on the Emergency Committee to Save the Jewish People, I am trying, rightly or wrongly, to take into account that

Whatever may be their methods, the Emergency Committee people have fastened themselves upon the imagination or the admiration of great numbers of people-Jews as well as non-Jews. It has been my thought that activity on the part of the American Jewish Conference and the Emergency Council would go far toward eliminating the effectiveness of the Emergency Committee to Save the Jewish People as a nuisance. Incidentally, Mr. Kenen showed to me yesterday the statement that had been drafted for release by the American Jewish Conference. I found it temperate and very well written. I do not think that soberminded people could object to that kind of statement. One of the qualms that I have had with respect to the Emergency Committee arises out of the fact that many months ago, after we had discussed the matter, I met with Mr. Bergson. I was in no position to do anything but conduct an exploratory conversation. I could not commit anybody to anything. However, a suggestion was made that we consider further the possibility of a consultative arrangement whereby we would be mutually advised of each other's activities, with the thought in mind of controlling the Emergency Committee actions. You will recall that no further action was taken in this matter. Others who had dealt more intimately and for a longer period with Mr. Bergson feel that I was naive in assuming that any sound results could come out of such collaboration. In any event, I feel that some responsibility may attach to me for failure to carry through on our original conversation. Insofar as the Independent Jewish Press Service is concerned, I have determined that the severance of my editorial relationship shall continue permanently. Some of my friends feel that it is still terribly important to maintain an effective interest in it to guide it a little more strongly and to use it for its countervailing value. Perhaps you might even consider the advisability of your becoming President of the corporation. I mention the above in answer to your question as to whether any attitude I may have with respect to the tactics to be observed concerning the Emergency Committee will be reflected in the Press Service. It cannot be. At the time of the meeting at the Biltmore Hotel between Dr. Wise, Dr. Goldman, Mr. Lipsky and yourself, it was agreed that the sum of \$2,500 for a six-month period should be granted to the Jewish Telegraphic Agency and a similar sum to the Jewish Press Service. As you know, the check for \$2,500 has already been forward to the JTA. The check for the Jewish Press Service has not yet gone forward.
