My dear Mr. Cooperman:

Thank you for your kind letter of May 5th and for your invitation to prepare an article for the New Palestine. I wish I were free at this moment to write one. Unfortunately I am occupied with so many matters that it will be some time before I can sit down and write an article.

The conversation which I had with Dr. Goldstein a few days ago was not to elicit an invitation to contribute an article to the New Palestine. Rather I tried to suggest to him that the New Palestine should give far more space and attention to the work of the Zionist Emergency Council than it has heretofore. The Zionist Emergency Council is not a parallel or a competing body of the ZOA. It is the political arm of the ZOA and of the other Zionist groupings. Inasmuch as political rather than organizational questions are of supreme importance at the moment in the Zionist world, it is the political activities of the Emergency Council which should find their proper reflection in the columns not alone of the New Palestine, but of all Zionist periodicals.
