MEMORANDUM

To Chairmen of Emergency Committees

Date December 29, 1943

From Herman Shulman, Chairman, American Palestine Committee of the American Zionist Emergency Council

> The American Falestine Committee, cf which Senator Robert F. Wagner of New York and Senator Charles L. McNary cf Oregon are co-chairmen, is a committee composed almost entirely of prominent non-Jews. It was organized in 1941 for the purpose of winning the sympathy, good will and support of Christian America for our movement to reestablish the Jewish National Home in Falestine. Its present membership includes approximately two-thirds of the members of the United States Senate, over one hundred members of the House of Representatives, many Governors, Mayors, Judges and other public officials, as well as hundreds of important clergymen, educators, writers, commentators, publishers, civic, industrial and labor leaders.

On February 17, 1944, under the spensorship of the American Palestine Committee, there will be held in Washington an important national conference for the purpose of mobilizing non-Jewish public opinion in this country in support of our cause. It is anticipated that a number of important mational organizations will participate in this conference through their duly appointed representatives. It is also desirable that as many communities as possible throughout the country be represented at this conference through representatives selected by the local members of the American Palestine Committee. You can render a tremendous service to our movement if you will undertake to see to it that your community selects such a representative to attend this conference. You can readily appreciate that the larger the representation of local communities at this conference the more effective will be the instrument created.

There is attached to this memorandum a list of the members of the American Palestine Committee. For your convenience these names have been arranged in geographical order.

Will you, at the earliest possible moment, contact one of the prominent members of the American Falestine Committee in your community and urge him to call a meeting of all the members of the American Falistine Committee in your community for the purpose of discussing this conference and selecting one or two persons from your community to attend the conference in Washington on February 17th. It is important that such a meeting be called as soon as possible and that you advise us without delay what action was taken at your meeting.

You may suggest to the leader of the American Palestine Committee in your community, whenever in your good judgment you deem it advisable to do so, that the American Palestine Committee is planning to pay or assume the expenses incurred by the attending delegates.

The conference will be a working conference. It will last the entire day and evening and will be addressed by a number of nationally prominent speakers. Special subjects, particularly those which are raised most. frequently by non-Jews interested in our cause, will be dealt with. Among these subjects will be (1) the illegality of the Chamberlain 1939 White Paper; (2) the absorptive capacity of Palestine; (3) Arab-Jewish relations; (4) the imperative need for opening wide the doors of Palestine to large scale Jewish immigration; (5) the case in favor of re-establishing the Jewish commonwealth in Palestine.

At the conclusion of the conference it is hoped that appropriate resolutions in support of our program will be adopted and that a representative committee will be designated by the conference to make appropriate representations on behalf of the conference to the proper governmental officials.

We must all work together to make this conference a tremendous success. I am sure that I can count on your cooperation.

Please write us promptly if you desire any additional information or data and let us hear from you as soon as possible concerning the progress you are making.



Dear Rabbi Silver:

It is my belief that you should immediately write to the British Ambassador, Lord Halifax, and indicate to him that there are other Jewish people in America interested in Palestine, other than Judge Proskauer and the American Jewish Committee.

The A.J.C.'s going to Halifax should be criticised by independent writers in the Anglo-Jewish press, if we can secure such, on two grounds:

1. They should be condemned for their milateral action during this critical period.

2. They should be criticised for adding to their memorandum and to their statement; "this memorandum is wholly unrelated to any plan for the organization of a Palestine State."

Whatever you should wish me to do with reference to the above, please let me know immediately.

Today I had a conference with Meyer Weisgal. He has just returned to New York and I wanted him to go to work immediately on the issuing of the Lowdermilk book and a few other matters. He told me that he would like to get together with you so that you would define the area of interest of the committee of which he is the chairman -- the "Special Services and Events Committee". I hope that when you come to New York next week (that is, if you do come to New York next week) that you will let me know in advance so that I may make an arrangement for this meeting with him.

Yesterday I wired you with respect to sending Mr. Gerald Frank to Palestine. It was my impression that he is to do a Public Relations job for the Zionist movement with the American and British correspondents in the Near East. Henry Montor has indicated to me that the decision with respect to this has been made by the Council Rabbi Abba Hillel Silver

but I did not want to move in this matter unless I heard from you. It seems that the plan is to have Mr. Frank go to Palestine as a press representative of the Palcor News Agency and the New York Post. Before we can do anything with respect to this, we need to make application to the State Department in order to get a permit for Frank to do this work.

May I hear from you at your very earliest convenience with reference to the above?

My dear Mr. Shapiro:

I am returning, herewith, the program of the Christian Council on Palestine, revised as of January, 1944.

I am very much dissatisfied with it. I believe that Dr. Bernstein, if he is still functioning as Chairman of the Committee on Christian Clergy, should sit down with Dr. Voss and Dr. Atkinson and think through a real program for this group. There are items on this program which do not come within the scope of the Christian Council on Palestine. On the other hand, there are other items such as the championing of the Jewish Commonwealth, which are not even mentioned.

I am enclosing the original statement of policy of the Christian Council on Palestine which had definite reference to the Jewish Commonwealth. In the latest program, the Jewish Commonwealth is completely forgotten.

This Council should also be asked, definitely, to get behind the Palestine Resolution introduced in the House. Otherwise, we will have to get another list of Christian Clergymen who will back up this Resolution. I suggest that you should lose no time about this matter. If Dr. Bernstein is not available for a conference with Dr. Voss and Dr. Atkinson, I suggest that Mr. Emanuel Neumann or Mr. Shulman meet with them.



Dear Dr. Silver:

I have received a copy of a letter which Mr. Louis Segal, General Secretary of the Jewish National Workers' Alliance of America, sent you yesterday.

When Mr. Tuvim received the call from Mr. Segal the work on getting statements from Congressmen, Senators, and Governors already had begun in our Publicity Department. We were evidently thinking along similar lines.

Mr. Segal has made the suggestion that messages be secured from the heads of the Democratic and Republican Parties, pledging themselves and their Parties in favor of the Resolution. I do not advise this because if we secure these pledges at the present time we shall not be able to play one Party against the other when that becomes necescary, and we would therefore lose a vital instrument for the battle which is to come.

As you know, we are doing everything possible to build up an overflow meeting for next Tuesday, and if the weather is in our favor the Garden will be filled to capacity and the streets surrounding the Garden will be black with people.

My dear Mr. Shapiro:

With reference to the telegrams sent to members of Congress, and for the sake of the record, I wish to say that the matter was first brought to my attention in a letter sent to me by Louis Segal dated March 14th which reached me on Wednesday, March 15th. By that time the telegrams had already been sent.

It was after I received Mr. Segal's letter that I spoke to Rabbi Feuer on Wednesday afternoon in order to ask his opinion about the advisability of sending such telegrams. He told me that he had already spoken about the sending of such telegrams and that he urged me to press for them. That same evening, Mr. Emanuel Neumann telephoned me and among other things, I suggested to him to sound out some of the members of our committee about the advisability of sending such telegrams. He said he would do it Thursday evening at the Wise banquet where most of our people would be present. Early this Morning (Friday) he told me that he had consulted quite a few, and that generally they were in favor of sending such a telegram. But a few hours later I received a telegram from iim saying that the telegrams had already been sent a few days ago.

I would suggest that in all matters of such great importance that you check back with me and get my approval before any action is taken regardless of who makes the suggestion. There must be some centralized guidance and responsibility in the matter. As it happens, in view of the circumstances which transpired (which of course no one could have foreseen) it would have been better if the telegrams had not been sent.

We have also sent copies of both letters to "New Palestine" with a recommendation that they be published there.

You have written that Senator Connolly has asked that the Rev. Goddard give his consent to having his letter read before the Foreign Relations Committee and that this consent has been given.

I should like to suggest that an effort be made to have this letter read into the Congressional Record. While it is not going to be easy for Rev. Goddard to make this request to Senator Connelly, might it not be possible for you to arrange that this be done through Dr. Buief In this way the letter will become a part of a permanent record and it will be possible for up to call it to the attention of the remainder of the Hembers of Congress.

The Hon. Tom Connally, U. S. Senator from Texas, Washington, D. C.

Dear Senator:

Enowing that you welcome letters from Texans expressing their views on the questions before the Sanate, I write you to suggest that no inconsiderable portion of the American people views with sincere regret the possibility of the abrogation of the Balfour Declaration which in 1917 pledged the Jews of the world a homeland in Palestine.

by own views on this question are colored by an editorial written in the March 3 issue of the Southern Churchman, a national weekly of the Episcopal Church, published in Richmond, Va. The editor pointed out that it was unfortunate in the midst of a war fought partly in defense of minorities, that the Allies should make a military necessity of rescinding a pledge which had made some provision for one of the minority races of the world.

I write you not only because you are my Senator but also because of your responsibility as chairman of the Foreign Affairs Committee of the Senate.

May I also state that I am for winning the war as quickly as possible, and I realize that there are spheres of our foreign affairs in which I am not qualified to pass judgement. In this particular question, one factor to be given proper consideration is the effect of any action on the Arabs and the winning of the war. I recognize this, and respectfully suggest that instead of rescinding the Balfour Declaration, the decision be postponed until after the war, when proper consideration might be given to the rights of the question.

It is true that military necessity sometimes provides the basis for actions of empediency. As a minister, I question the precedence sometimes given military necessity over principles and moral issues. If it was right to establish a homeland for the Jews in 1917, and Jews all over the world have since that day contributed their money in reliance upon the Balfour Pledge that they were to be protected in this homeland, I do not believe that even military necessity decrees that a pledged word be broken. Perhaps I am peculiar but to me this going back on one's word with regard to Falestine is similar to our own government's action a few years ago in breaking its promise about the redemption value of a dollar. The New Dealers justified that action on the ground of expediency. As a lawyer and a student of human relations, you know the chaos that will result as people loss confidence in their government and each other because promises and pledges and guarantees are broken. If I as a Jew had given one dollar to the Zionist Movement, I should feel that the change in policy to be effected, was a kind of Munich appeasement, with the Jews being sold down the river this time.

I am sure that you have had representations made to you on behalf of the Jews in this country who are opposed to the Zionist Movement. They have the privilege of expressing their views but I think that they go too far in trying to block the efforts of those other Jews who want a Jewish homeland. The limit of their opposition should be withholding support.

It is well to keep a sense of proportion in this matter. I do not think that it is any valid argument against the Zionist Movement to assert that the Jews themselves are not united in it. The opposition is only a negligible percentage of the Jews, and I cannot help but think in terms of Christians. On what subject are Christians unanimously united. Dr on what subject are even the members of one denomination united. It is the nature of religion ambraced emotionally as well as intellectually to cause differences of opinion. And I do not think the argument valid that the Jews themselves are not united.

What appeals to me is the humanitarian argument. Many Jews in the United States who have prospered and enjoyed freedom, have a sense of responsibility for their brethren in Europe who have mt fared so well, and want to provide a refuge for them in Palestine. They are providing the funds to take care of their less prosperous brethren. Our American Jews do not want to leave this country which they leve to eke out a living in a primitive country, even though that country is bound inseparably with their history and religion. They simply want to provide a haven for the persecuted Jews of Europe. That is why I believe the influence of our great democracy should be exerted on their side.

I realize that this is a delicate matter, and I am isolationist by nature and training, abhorring the idea of meddling in the internal affairs of Great Britain any more than is necessary to win the war. But the Balfour Declaration lifted this matter to an international plane. This was a solemn decree. And if there was any doubt about the nature of that pledge, surely it was removed by the subsequent action of 52 other nations in ratifying the pledge. To me this is analagous to the course of a contract. An offer was made. And that offer was accepted and acted upon. Great Britain accepted the action of those 52 signatories to the Palestine Mandate, and the subsequent settling of Jews in Palestine. It is today therefore our concern as well as Great Britain's.

I know that you are open-minded on great issues, and I have therefore written my views at some length. As a Christian minister I am very much in favor of the Zionist Movement, and in company with many other ministers would deeply regret any change in policy. And at the least, I hope that it will be possible for you to work out some procedure by which you will be able to postpone any change in policy. To end this experiment now would be a crushing blow to many American Jews who have tried to help their brathren in Europe.

As pastor of St. Joseph's Catholic Church in Marlin, my attention has been called to the plight of the suffering Jewish People in Europe. In my opinion, to bar them from entering Palestine after March 31, 1944, would be not only un-Christian, but even inhuman.

I can well understand why some people of Jewish extraction are not particularly concerned with building a Nation in Palestine. But most of them are concerned; and they are anxious to provide a homeland in the places so dear to their traditions, culture, and heritage.

I take this means, therefore, to call your attention to their plight; and to arge you to give your support to the Wagner-Taft Resolution. The Chamberlain White Paper of 1939, in my opinion, should be abrogated.

Terming the issue of Palestine the yardstick of the rights of small nations to security after the war, Senator Styles Bridges of New Hampshire called last night for a "clear enunciation by America of a just and workable foreign policy."

He was one of several prominent speakers at a dinner sponsored by the New Zionist Organization of America to commemorate the twentieth anniversary of the American-British Convention on Palestine. The dinner in the grand ballroom of the Hotel Commodore was attended by 1,000 persons.

Other speakers included Gov. J. Howard McGrath of Rhode Island: Hugh Gibson, former Ambassador to Belgium: William C. Bullitt, former Ambassador to Russia and France: Representative Clare Boothe Luce and Col. John H. Patterson, commander of the Jewish legions in World War I and honorary president of the New Zionist Organization. Senator Bridge's address was heard locally over radio station WQXR.

"The struggle for a Jewish Palestine," Senator Bridges said, "is a part of the world-wide crusade to achieve an international order in which there shall be security for small nations. We cannot close our eyes to the challenge of Palestine without doing outrage to the whole cause for which we fight in this war. If we make a moral surrender in Palestine we shall have weakened ourselves incalculably when we face the issue of other small nations at the peace table.

"In this instance, Palestine can well serve as a yardstick as to the treatment to be accorded to the other small nations."

Senator Bridges noted "with deep disquiet" what he termed an increasing disposition to blur the this policy was followed by the moral issues of the war.

PALESTINE TRACT **GIVEN AS REFUGE**

Colony for 600 Families, Now in Peril, Is Named by Donors for Massachusetts

Special to Tus New York TIMES. BOSTON, April 23-A tract of 6,000 donums, about 1,320 acres, has been acquired in Palestine through the Jewish National Fund of New England for the settlement. of 600 Jewish families now facing danger in Hurgary and Rumania.

The colony, bearing the name of "Commonwealth of Massachusetts." was dedicated tonight at a dinner in the presence of 1,300 persons who have contributed toward it.

Speakers appealed for the immediate cancellation of the British White Paper and urged that President Roosevelt and Prime Minister Churchill accelerate the entrance into Palestine of as many refugees as could be rescued from Hungary and Rumania.

The late Cardinal O'Connell was culogized as "a great prince of the church" and as "a lover of humanity and peace."

The principal speakers were Gov. Leverett Saltonstall, who is honorary governor of the colony; Mayor Maurice Tobin, its honorary Mayor: Senator Guy M. Gillette of Iowa, Judge Morris Rothenberg and Mendel N. Fish of New York, respectively national president and executive director of the

"The establishment of this colony is a manifestation of faith in the triumph of the cause of the United Nations and the future of Palestine," Governor Saltonstall said.

"It will serve to associate the democratic ideals of the founding fathers of the Commonwealth of Massachusetts with those of the Jewish pioneers laying the foundation of the Jevish Homeland upon the sacred soil of their fathers.



My dear Mr. Shapiro:

The following matters should be followed through without delay and I would suggest that you keep checking on them until they are disposed of;

1) Concerning the release of the statement of professors, college presidents, etc. — careful preparation should be made for proper publicity in connection with the release. The last time, it was a complete flop. Representatives of the AP and the UP should be seen. Above all, the Community Contact chairmen should receive, a week or ten days prior to the release, the names of the people who are signers to the statement. They should be asked to see their local newspapers to make sure that the story receives proper coverage. Perhaps the pictures of the signatories should be published along with the new story. You may succeed in getting some radio announcers to make mention of it.

2) The release of the statement by the American Palestine Committee to the Anglo-Jewish and Yiddish press, signed by Senator Wagner -- I know that he hesitates, but it is important to make him understand that the very existence of the American Palestine Committee will be endangered if there is not such a statement issued. If he is unwilling to sign it, then the statement should be issued under the name of the American Palestine Committee. Copies of it should be sent to all Community Contact chairmen, and articles on the subject should appear in all the Zionist periodicals, prominently displayed.

3) The statement of the lawyers which Mr. Lourie has been drafting should be issued without fail by May 17. The names of eight or ten prominent law firms should be procured as signatories to the statement and a release on the subject should be given to the press with a brief digest of the arguments and the names of the signatories.

We heard indirectly that your Mr. Hans Lamm is trying to make arrangements for the release and distribution of Zionist literature on the college campuses.

I must protest against this action very strongly.

On the occasion of our conference a couple of months ago about the essay prize-contest it was agreed that there would be no undertakings of the Emergency Council touching upon Youth work without prior consultation with the Youth Commission.

There is considerable background to the whole problem of Zionist activities on the campuses which is nearing a solution, and intervention by the Emergency Council in the situation would be most unfortunate.

The possession by the Emergency Council of funds and personnel does not endow it with license to exercise (much less to broaden) jurisdiction without regard to injury to the work and plans of the official youth agency of Hadassah and the Z.O.A.

I must respectfully insist that nothing be done with or through the Hillel Foundation before the matter is fully presented by you to the Youth Commission and a decision, on an informed basis and beneficial to the Zionist program is reached.

I have your letter of May 6 relative to the runor that the Emergency Council is "making arrangements for the release and distribution of Zionist literature on the college campuses." I am rather dismayed at the tone of your note which infers that the Emergency Council is an agree about to devour the regularly established Zionist agencies in this country.

As you know, the Maergency Council is the political arm of the major Zionist bedies in America and has not nor does not anticipate sponsoring any activity which is not political.

Let me say to you categorically that the Emergency Council has made no plans to distribute literature to students on college campuses. Our only activity with reference to the universities has been the circularization of a petition signed by members of college faculties, a copy of which is attached, which is directed to the President of the United States. This, incidentally, has been a very successful activity, as you will see by the releases attendent to the issuence of that petition scheduled for May 17.

Included in the more than 1,500 members of college familties who signed the petition are many presidents of universities and collages. These signatures were secured through local inergency Committees, friendly faculty members and directors of Hillel Foundations. It is my conviction that it is our duty to approach any person regardless of his affiliation for political work. This is the reason why we sought the help of the directors of the Hillel Foundations. We shall continue to do this so long as the contact is consistent with ashieving our political objectives.

For your information, the college petition was the brain-child of the Young Zionist Actions Committee of New York, and they have done a good job on the New York compuses.

I am taking the privilege of sending a copy of your letter and my reply to Dr. Abba Hillel Silver and Dr. Stephen 5. Wise, co-chairman of the Energency Council, so that they may be acquainted with this exchange of correspondence. A copy of my answer is also being sent to Dr. Goldstein and Mrs. Hostein so that their information of this correspondence will be complete.

A booklet published by Victor Golantz, London, England, and written by Dr. Norman Maclean, who at the time was Moderator of the Church of Scotland, General Assembly, and is now Chaplin to His Majesty the King. It will, of course, be a powerful weapon in presenting the case against the McDonald White Paper, which this book does most vigorously.

In reference to the publishing rights I have been advised that a small honorarium is required by the author. I feel that this book would be an invaluable educational force in view of its forceful style and the prominence of its author. If permission to print were not granted a review of the book could be brought out and given wide publicity through the press, or put in pamphlet form and mailed direct to the clergy, editors, aldermen, etc.

I am continuing to endeavour to have this book published here in Canada; in the meantime I hope that this suggestion will meet with your approval. I remain,

We find ourselves in a situation which makes it imperative for us to launch such a project in order to carry out the intensive educational program which is so essential at this time in connection with the Palestine Resolution pending in Congress.

I believe that our request is "within bounds" and in no sense violates the letter, or the spirit of the letter, which the U.P.A. is sending to the Welfare Funds.

In the event that local Mmergency Committees do not provide sufficient funds to supplement what the American Zionist Mmergency Council itself plans to spend on the radio program, we shall appeal to the organized mational Zionist bodies for their help.

I do hope the above is an adequate explanation of the step which we have taken.

I spent Saturday and Sunday in Boston organizing the New England division of the American Jewish Trade Union Committee for Palestine. I would like to add that the spirit of the meeting was nost encouraging. About thirty-five men were present, each of them a president, manager, or secretary of a trade unich. The work of our Committee and the necessary for its existence was put before them by both Goldberg and myself. The response of those in attendance was enthusiastic and unanimous. I have no doubt that within a short time most of the outstanding non-Jewish labor leaders in the New England area will be canvassed and brought into the Honorary Committee.

This is all preparatory to the job we most likely will have to do in a couple of months in connection with the resolutions before Congress and such other matters that may come up and that may require widespread lebor support.

You will be pleased to know that at a conference held in Dorchester, Massachusetts, Sunday, June 11, the New England division of the Amorican Jewish Trade Union Committee for Palestine was organized and a program of activity was prepared and adopted by the conference.

The "Declaration" of the American Jewish Trade Union Committee for Palestine was adopted in its original form, and those present voted unanimously to apply themselves fully to the program of our Committee.

Officers of the New England division include Jacob Blume, manager of the Boston Joint Board of the A.C.W.A., and Philip Kramer, manager of the Boston Joint Board of the HLGWU, as co-chairmen. An executive committee was also chosen, as were vice-presidents and other officers. These are fully representative of all of the unions attending the conference.

The conference was addressed by I. H. Goldberg, secretary of the American Jewish Trade Union Committee for Palestine, and vice-president of the United Hatters, Cap and Millinery Workers Union. Mr. Goldberg outlined the background of our Committee and stressed the need for the implementation of its program by labor groups all over the country. In outlining the work of our Committee he indicated the wide support it is receiving from important labor officials of both the A.F. of L. and the C.I.O.

The New England division adopted as a program for immediate action the broadening of its Committee to include all important labor officials of the cities and states making up that territory. Following this resolutions will be introduced in every city and state Central Body and Industrial Council. The resolutions will call for the withdrawal of the British White Paper of 1939 and will support the demand for a free and democratic Jewish commonwealth in Palestine.

The New England division of our Committee is the first such group established since the formation of our Committee. It is hoped that similar groups will be created shortly in other sections of the country.

I would like to call your attention to the fact that the American Jewish Trade Union Committee for Palestine is not considered one of the erganizations which, under the rules, are qualified for invitation to the American Jewish Conference scheduled for the early part of September in Chicago. Mr. Kenen advises me that our Committee was organized too late to qualify. The Committee was organized in March of this year.

I most strongly urge that some way be found to circumvent this rule. There is no bona fide Jewish labor voice connected with the Conference. The Jewish Labor Committee is a hodgepodge of various Jewish organizations, most of them non-Zionist or anti-Zionist, as has been confirmed time and again. The only pro-Zionist elements of any moment in the Committee are the trade unions which we have organized into our American Jewish Trade Union Committee for Palestine, but these represent a voting minority on all issues affecting the future of Palestine.

Then the Jewish Labor Committee delegation comes to Chicago to attend the Conference, it will be bound by the agreement which was reached by the labor forces and the other groups in the Jewish Labor Committee. This agreement provided a neutral attitude with regard to the commonwealth issue. The delegates to the Conference were instructed not to vote one way or the other. Should this issue or any similar issue arise at the Conference, the delegation of the Jewish Labor Committee will not participate.

Jewish labor should have a voice in the Conference. Jewish labor is definitely for the commonwealth, and one of the reasons for organizing the American Jewish Trade Union Committee for Palestine was to give Jewish labor that voice. It should be given an opportunity to make itself heard at the American Jewish Conference. It represents hundreds of thousands of organized Jewish workers.

I hope that you can find some way to bring about the inclusion of the American Jewish Trads Union Committee for Palestine in the American Jewish Conference.

Attached is a copy of the original list with radio quotas and comments of communities heard from thus far. In making the summary, I find that the picture is not a very good one. To inte we have \$19,515. pledger of which \$1,790. has been paid. We have heard from another 21 communities whose quotas total \$46,100., that they are taking up the matter and we would hear from them. The majority of communities have not replied to your requests. The approximate total of the quotas assigned to these latter communities is \$65,000.

To recapitulate:	Total pledged	19,515.

	Communities no response	65,000.

When I tried to reach Dr. Goldstein to request that they desist fundraising until after July 15th, I found that he was in Mexico. This will in all probability have to await the ZOA Administrative Committee mesting which is scheduled in Philadelphia on Sunday, July 9th. I sincerely hope that you will be able to be there and I will be there in case you can't make it.

When an activity is once initiated, I personally do not like to call a halt to it and therefore I am submitting the following way which I believe we can work out this problem:

The entire program, including radio time and program cost, will be approximately \$100,000.

Our fiscal year ends October 14th.

Should we begin our broadcasts approximately August 23rd, it would mean that 8 of the broadcasts would be completed by the end of the fiscal year and 5 would come during our next fiscal year. If we charge the first 8 to this year and the remaining 5 to next year, the proportionate charges would be:

This year \$ 61,539. Jext year . . . \$ 38,461

After the Emergency Souncil allocates \$25,000. for this year's radic appropriation, there will be needed approximately \$36,500. I believe that if we went after this aggressively, we could secure such an amount, particularly if you would make a few long-distance calls to some of our friends in the larger cities.

I personally do not believe that the ZDA competition, except in New England, has too much of a bearing on the results we are getting. Our appeal has come at a bad season of the year and our people are reluctant to develop local efforts at this time of the year. Though the amount needed above is not too great an amount, it will be necessary that I send some of our staff into the field to get this money.

In developing the new budget for the coming year, on which I am now working, we could put in the remaining amount of approximately \$36,500. for radio in that budget. In such a way I believe that we could carry on this activity.

Will you please consider the above very carefully and let me have your reaction?

The New Palestine - News Reporter - in its July issue contains no report of the activities of the Emergency Council. I assumed that that was an oversight on the part of the editor of the New Palestine. I found, however, that it was our fault. On Judge 2, Mr. Barabash requested that material be sent to him for inclusion in the New Palestine News Reporter before June 12. Mr. Barabash also sent a wire on June 14 requesting material. The material was not sent to him.

This is a serious lapse on our part. The New Palestine News Reporter is being mailed in 115,000 copies to all the Zionists of America and to many others. The ZOA is entitled to have in its official publication full reports of the activities of the Emergency Council, of which the ZOA is a member. The Emergency Council should regularly utilize such an important vehicle of information for the dissemination of news about its activities.

Please see to it that from now on there be sent to the New Palestine regularly not just the releases which we send to all other publications, but specially written articles covering the field of our activities.

The same should be done with the Hadassah News Letter and the publications of the Poale Zion and the Misrachi. I would appreciate it if copies of the articles sent to the editor of the New Palestine be also sent to me. As you know, I have in the past severely criticized the New Palestine for failing to treat the activities of the Emergency Council adequately in its columns. When the fault is ours, we should take quick action to correct it.

This is with reference to yours of July 17th re the organization of the community contacts groups in the Metropolitan Area.

Thus far we have devloped a Brooklyn Committee and a Bronx Committee. The Manhattan Committee has been formed and Judge Reit is the temporary chairman. There is an internal political problem in this committee because neither the Mizrachi nor the Poale Zion want Reit as the chairman and this will be corrected within a few days. Judge Reit, in his reply on the radio program, did not consult with his committee and Mr.Magida has taken the matter up with him for inclusion on the agenda of the next meeting. With reference to money-raising for our radio program, the Brooklyn and Bronx Committees are trying to raise their quotas.

Mr. Magida is presently engaged in assisting Dean LeSourd in launching his work for the American Palestine Committee. In the last two weeks he has been to St. Louis and Chicago in order to arrange regional meetings for the A.P.C. and yesterday he was in Scranton, Pa., meeting with Judge Maxey in connection with A.F.C. work in that region. Today he is meeting with Mr. Teller and Mr. Silverman in order to go ahead with the fund-raising of the Independent Jewish Press Service campaign. You can rest assured he is fully occupied.

It will not surprise you to learn that I am having difficulty with the Mutual Broadcasting System on accepting our program. Last week we submitted an outline -- Mr. Manson wrote it -- to Mutual of what would be involved in our dramatic presentations for the thirteen broadcasts. On the receipt of this outline, the broadcasting company said that they would reject our program, pending receipt of some finished scripts.

On Thursday, Allen Sloan - whom Hy Brown has secured to do the scripts -will return to New York from his vacation and will go to work on the scripts. We hope by the beginning of next week to submit at least two presentations. If they have objections to these, I believe it will be time for us to apply some pressure on Mutual. We can threaten a public outcry of denial of freedom of speech and we can bring pressure to bear on the Board of Directors of Mutual. The latter are scattered throughout the country, one very important man being in Cleveland: H.K. Carpenter of WHK.

In speaking with a number of officials at Mutual, I have come to the conclusion that our material does not have real political objections in the national sense, but there are on the Board of Mutual two anti-Zionists, one a member of the Strauss family (Macy's) and the other Lewis Allen Weiss of the Don Lee Broadcasting System on the Coast. It is possible that since they will have no trouble in selling the time, they would prefer to keep a Zionist program off the air.

At the moment I am still having trouble getting together the needed money for the broadcast. I have carried through on this matter by sending quite a number of wires to communities where we have had no response. By the end of the week I hope to be able to give you a clearer picture on the subject.

It seems that he wants to build up the house organ of the organization of which he has recently become the head, B'nai Zion.

I believe he has done a fine job with "Palestine", and at the rate he has been going in the last few issues this should become a very fine publication.

In order to avoid his giving up the chairmanship of the Publications Committee and the direct supervision of "Palestine", I feel it is necessary to begin to work on him immediately to keep him on the job.
