FEBRUARY 7, 1944

RESCLUTION ON PALESTINE HAS BEEN INTRODUCED IN THE HOUSE ENDORSED BY THE LEADERS OF BOTH PARTIES:

"WHEREAS THE SIXTY-SEVENTH CONGRESS OF THE UNITED STATES ON JUNESO, 1922, UMANIMOUSLY RESOLVED THAT THE UNITED STATES OF AMERICA FAVORS THE ESTABLISHMENT IN PALESTINE OF A NATIONAL HOME FOR THE JEWISH PROPLE, IT BEING CLEARLY UNDERSTOOD THAT NOTHING SHALL BE DONE WHICH MAY PROJUDICE THE CIVIL AND RELIGIOUS RIGHTS OF CHRISTIAN AND ALL OTHER NON-JEWISH COMMUNITIES IN PALESTINE SHALL BE ADEQUATELY PROTECTED; AND WHEREAS THE RUTHLESS PERSECUTION OF THE JEWISH PEOPLE IN EUROPE HAS CLEARLY DEMONSTRATED THE NEED FOR A JEWISH HOMELAND AS A HAVEN FOR THE LARGE NUMBERS WHO HAVE BECOME HOMELESS AS A RESULT OF THIS PERSECUTION; THEREFORE BE IT RESOLVED, THAT THE UNITED STATES SHALL USE ITS GOOD OFFICES AND TAKE APPROPRIATE MEASURES TO THE END THAT THE DOORS OF PALESTINE SHALL BE OFFICES AND TAKE APPROPRIATE MEASURES TO THE END THAT THE DOORS OF PALESTINE SHALL BE OFFICES AND DEMOCRATIC JEWISH COMMONWEALTH."

HEARINGS BEFORE THE FOREIGH AFFAIRS COMMITTEE WILL BEGIN TOMORROW TURSDAY PRERMARY EIGHTM.
THE AMERICAN JEWISH CONFERENCE AND THE ZIONIST MOVEMENT OF AMERICA WOULD PROFOUNDLY
APPRECIATE A WARM AFFIRMATIVE ENDORSEMENT FROM YOU OF THIS RESOLUTION. I WOULD PERSONALLY
BE EXTREMELY GRATEFUL TO YOU FOR THIS SERVICE TO OUR GREAT HISTORIC CAUSE AT THIS
CRITICAL HOUR. PLEASE WIRE. WARMEST PERSONAL REGARDS
