#### AMERICAN ZIONIST EMERGENCY COUNCIL

WHEREAS The American Zionist Emergency Council established as the political arm of the four major Zionist organizations, has during the past year under the leadership of Drs. Stephen Wise and Abba Hillel Silver effected such significant achievements and advanced our cause so notably toward the attainment of our objective - the establishment of Palestine as a free and democratic Jewish Commonwealth and

WHEREAS The political directives of the Emergency Council and the publications, and othervital materials issued by it, have been of constant enlighterment and service to Junior Hadassah.

BE IT RESOLVED That this 21st annual convention go on record as expressing itssincere appreciation to the AMERICAN ZIONIST EMERGENCY COUNCIL.

WHEREAS on January 3, 1945, the Executive Committee of the Brooklyn Zionist Region adopted resolutions calling upon theZ.O.A. administration to recall Dr. Abba Hillel Silver to Zionist political leadership, and

WHEREAS, it is a matter of public record that the action taken by the Executive Committee of the B.Z.R. was followed by similar action on the part of Zionist districts and Regions throughout the country, and

WHEREAS, the demands contained in the resolutions which clearly expressed the democratic will of the majority of American Zionists and constituted a clear mandate and directive to the leadership of the Z.O.A., were sofar not carried out by the Z.O.A. administration,

NOW, THEREFORE, we the delegates to the loth ennual convention of the B.Z.R., comprising upwards of 15,000 members of the Z.O.A., hold at Hotel St. George, on Sunday, June 24, 1945, being fully conscious of our responsibility at this critical juncture in Zionist affairs, and being fully convinced that the widdom and necessity of the course heretofore taken by us has been fully borne out by the events of the last six months, regretfully declare as follows:

1. That by its many acts of omission and commission; by its disregard of the demands and violation of the mandatos of the overwhelming majority of Zionists throughout the country; by its incapacity to act decisively and in a

spirit of constructive statesmanship in a moment of grave omergency for the Zionist cause; and by its failure, through delaying tactics and procrastination, to restore Dr. Abba Hillel Silver, whose militant politics were unanimously approved at the last National Zionist Convention, to active Zionist leadership, and thus restore unity and strength to our movement, the leadership of the Z.O.A. has created a gulf between itself and its constituents, has aroused their bitter resentment, and deprived itself of the confidence to which it is normally entitled.

2. That the present administration of the Z.O.A. has ceased to be truly representative of the Z.O.A. as to its course of action with respect to the American Zionist Emergency Council.

3. That the moment has, therefore, come for those Zionists who are deeply conscious of their historic responsibility to take such steps as are called for by this anomalous and intolerable situation, and we, therefore, voice the following domands:

> A. That the 2.0.A. administration forthwith recall Dr. Abba Hillel Silver to active political Zionist leadership and establish such cooperation with and give such support to him, in conformity with the resolution adopted at the last Mational Zionist Convention, as will make it possible to carry out Zionist political action with maximum offectiveness.

> B. That the 2.0.A. administration promptly take steps for a re-organization of the American Zionist Emergency Council so that the Z.O.A. representatives on the Emergency Council shall consist of able and experienced process pledged to support the policies and leddership of Dr. Abba Hillel Silver.

> C. That the administration of the 2.0.4. exert every possible effort to obtain permission to hold, in time, the next regular convention inorder to afford an opportunity to the entire 2.0.A. nembership to give expression to their Democratic Will during these critical times.

> D. That the incoming administration of the Brocklyn Zionist Region take the initiative in calling and arranging for the holding of the Joint Conference of the Regions of the Metropolitan Area, in furtherance of a program of vigorous action to effectuate the Democratic will of the American Zionists and in order to safeguard the vital interests of the Zionist movement now imperilled.

E. That this resolution shall be forwarded to all national officers of the Z.O.A., all members of the National Emergency Council and American Council and to the Presidents and Secretaries of all Zionist Districts and Regions in the United States. Dead Laurelton ZIONIST DISTRICT LAURELTON, L.I.

RESOLUTION PASSED AT MEETING OF BOARD OF DIRECTORS January 3, 1945

WHEREAS the resignation of RABBI ABBA HILLEL SILVER from his position as Co-Chairman has been accepted by the Zionist Emergency Council, following objections to his actions with respect to the recent vote of the House Foreign Affairs Committee on the PALESTINE Resolution.


BE IT RESOLVED that this Board advise the Long Island Zionist Region

- 1) That this Board recalls the several requests made upon this District by the ZIONIST ORGANIZATION of AMERICA and by the ZIONIST EMERGENCY COUNCIL to support the pending Palestine Resolution and to implement such support by action;
- 2) That the policy of appeasement has not proven effective and should be discontinued;
- 3) That this Board is of the opinion that the Palestine planks in the recent political platforms and the letter from the President to Senator Wagner read to the Convention should be considered honorable commitments by honorable men as they were undoubtedly intended to be;
- 4) That this Board acclaims the action of the House Committee on Foreign Relations as a proper and consistent corollary to the party planks;
- 5) That this Board regrets and is deeply concerned over the acceptance by the EMERGENCY COUNCIL of Doctor Silver's resignation;
- 6) That this Board urges that the EMERGENCY COUNCIL request Doctor Dilver to reconsider his resignation, so that the Emergency Council and all Zionists may continue to avail themselves of the militant spirit, the integrity and the zeal of Rabbi Silver which has so long served Jewry and Zionism and so that American Zionists may continue to march forward together.



## RESOLUTION UNANIMOUSLY ADOPTED BY THE MILWAUKEE ZIONIST EM RGENCY COUNCIL on Tuesday, January 9, 1945

"Whereas the magnificent achievements of the American Zionist Emergency Council have been aborted and halted by the unfortunate dissension which has arisen in the leadership of the Council, and since the primary objective of the Council is the welfare of Palestine, the Milwaukee Zionist Emergency Council feels it incumbent upon itself to express its alarm and condemnation of the unfortunate situation which has arisen in the ranks of the American Zionist Emergency Council.

We, of the local Emergency Council, under the leadership of Dr. Abba Hillel Silver, have been constantly motivated and stimulated in our action to greater and greater effort in fulfilling the mandates of the American Zionist Emergency Council. WE DEPLORE THE MANNER IN WHICH DR. SILVER WAS DEFRIVED OF HIS LEADERSHIP AS CO-CHAIRMAN OF THE COUNCIL AND CHAIRMAN OF THE EXECUTIVE COMMITTEE, AND FEEL THAT HIS ABSENCE AS CO-CHAIRMAN HAS SHAKEN OUR CONFIDENCE IN THE PROGRAM AND FUTURE OF THE AMERICAN ZIONIST EMERGENCY COUNCIL.

We view with apprehension and disfavor the present structure of the reorganized American Zionist Emergency Council, and we call for a further and farreaching reorganization, WHICH SHALL INCLUDE DR. SILVER IN A POSITION OF EXECUTIVE LEADERSHIP.

My dear Dr. Silver:

At a recent meeting of the Executive Committee of the Westchester Zionist Region, a full and rather spirited discussion of the events leading up to the reorganization of the American Zionist Emergency Council was had, following which, the following resolution was duly passed:

"The Executive Committee of the Westchester Region after discussion of the Emergency Council controversy regrets that a difference of opinion between leaders whom it respects, has been permitted to cause public dispute and dissension in Zionist ranks and calls upon our leaders to eliminate such dissension and achieve genuine harmony."

It was the sense of the meeting in passing this resolution that our allegiance to the administration of the Zionist Organization of America was not shaken, nor was there intended any criticism of the fine work undertaken by the Council. There was, however, a deep sense of regret and hurt at the acrimonious nature of the dispute, and particularly the fact that it was deemed necessary to make the dispute an issue for the public press.

By direction of the Executive Committee, a copy of this resolution is also being forwarded to Dr. Stephen S. Wise and Dr. Israel Goldstein.

> "We view with deep regret and concern the retirement of Dr. Abba Hillel Silver from the position he has occupied in the American Zionist Emergency Council and the breach in the leadership of American Zionism. At this critical time the Zionist movement can neither dispense with the services of a man of his abilities nor permit the dangerous breach to widen.

We convey to Dr. Silver our sincere affection and admiration for his work in the Zionist cause and affirm our confidence in the policy he has advocated.

With the best interests of the Zionist movement in mind, we call upon the national administration of the Zionist Organization of America to take immediate steps for the prompt recall of Dr. Silver to active political leadership and the early restoration of unity in the Zionist movement."

RESOLVED THAT: The St. Louis Zionist Emergency Council views with deep concern the retirement of Dr. Abba Hillel Silver from the position of Co-Chairman of the American Zionist Emergency Council and Chairman of its Executive Committee.

World Jewry in general and the Zionist movement in particular can ill afford at this critical time to suffer a breach between two such eminent leaders as Dr. Stephen S. Wise and Dr. Abba Hillel Silver, and obviously all efforts must be made to effectuate unity between these two great leaders without undue delay.

FURTHER, the St. Louis Zionist Emergency Council, without any attempt to pass upon the merits of the pending controversy, respectfully insists that the National Administration of the American Zionist Emergency Council forthwith invite Dr. Silver to resume his positions in the leadership of the American Zionist Emergency Council jointly with Dr. Wise to the end that harmony be restored in the ranks of American Political Zionism.

BE IT FURTHER RESOLVED that copies of this Resolution be forwarded to the National Administration of the American Zionist Emergency Council, to Dr. Stephen S. Wise, to Dr. Abba Hillel Silver, to all Chairmen of the local Zionist Emergency Councils throughout the country and also to the national heads of the four groups affiliated with the American Zionist Emergency Council.

The Board of the Zionist Organization of Detroit views with dismay and deep concern the existing rift in the leadership of the Zionist movement in America. The recent upset in the American Zionist Emergency Council and the emergence of the American Zionist Policy Committee have created chaos in Zionist circles to the detriment of the present moves to place the Jewish case upon the agenda of the San Francisco Conference. At a time when Zionist unity is imperative and when disunity is tragic, we believe the rank and file of the movement demands, above all else, that personal feelings and personal considerations shall be subordinate to the great Cause which binds us together.

Therefore, we, the Board of the Zionist District of Detroit, appeal to the American Zionist Emergency Council to explore every possible means of effecting a reassociation of the Council so as to reestablish an integrated leadership which shall include the best minds and the leading personalities of the Zionist movement. Without attempting to pass upon the merits of the recent controversy, we earnestly urge cooperation in the present and future struggles which lie ahead. We recall the effective and colorful leadership of Dr. Abba Hillel Silver and we note with regret his absence in the councils of the movement. During his tenure of office there was a great acceleration of Zionist effort. At the same time we are not unmindful that theZionist situation needs the combined thought and the best judgment of all our leaders if we are to gain our ends.

We therefore earnestly urgo this plea for renewed harmony and cooperation. We commend the efforts of those who are trying to bring this about and pledge our aid to this end. At the last meeting of the Lorain-Elyria Zionist District I was instructed to convey to you the following sentiments:

The Lorain-Elyria Zionist District views with deep concern the continued rift in the Zionist Organization of America.

Differences of opinion and disagreements concerning procedure are natural and are to be expected, but we can ill afford breaches in our organization, resulting from personal conflicts.

We recognize Dr. Stephen S. Wise's long and faithful service to Zionism and appreciate his readiness to continue in the service of our common cause; we are anxious to avail ourselves of his experience and wisdom. But we also recognize Dr. Silver's dynamic qualities and value the services he has rendered the cause of Zion in general, and the Emergency Committee particularly. We can not afford to dispense with his leadership. The present crisis in Zionism calls for the combined efforts of both men. This is no time to indulge in another division in Israel.

Therefore, Dr. Wise and Dr. Silver, we, Zicnists of the Lorain-Elyria Zionist District, urge you to compose your differences without the aid of any peace committee. Your loyalty to our people will show you the way towards that settlement. Resume your places of combined leadership. Lead and we shall follow!

#### RESOLUTIONS ADOPTED BY THE LONG ISLAND ZIONIST REGION

AT CONVENTION HELD

## June 24th, 1945

WHEREAS, our movement is today in grave danger at a time when our enemies are mobilizing their resources in a campaign to put an end to Zionist aspirations for all time; and

WHEREAS, American Zionist leadership is disunited at the very moment when they should unite behind a program of militant political action; and

WHEREAS, disunity in our ranks has been fostered by the forced resignation of Dr. Abba Hillel Silver from the co-chairmanship of the American Zionist Emergency Council and the chairmanship of its Executive Committee; and

WHEREAS, the American Zionist masses have ceaselessly demanded that the present National Administration of the Zionist Organization of America recall Dr. Abba Hillel Silver to the active political leadership of our movement, and

WHEREAS, the failure of the National Administration to respond to the expressed wishes of the membership has served only to widon the gulf between the Zionist membership and the National officers;

THEREFORE BE IT RESOLVED that the Long Island Zionist Region, consisting of 6700 mombors of the Zionist Organization of America, in Convention assembled on this 24th day of June, 1945, expresses its deep dissatisfaction with the dilatory actions pursued by the National Administration on this all-important question and calls upon the Prosident, the National Executive and the National Administrative Council of the ZOA and demands that Dr. Abba Hillel Silver be recalled for thwith to the political leadership of American Zionism, so that our movement may have the benefit of his effective and dynamic direction in this crucial hour of decision, and

BE IT FURTHER RESOLVED that we call upon the National Administration of the ZOA to designate such representatives to the American Zionist Emergency Council and take such other steps as will enable Dr. Silver to carry on Zionist political work with the greatest effectiveness, and

BE IT FURTHER RESOLVED that we authorize and direct the Executive of our Region to take whatever steps the situation domands, in cooperation with other Regions, to effectuate the purposes of this Resolution, and

BE IT FURTHER RESOLVED that copies of this Resolution be sent to the President and members of the Executive and Administrative Committee of the Zionist Organization of America, to the members of the American Zionist Emergency Council, to the Presidents of all Zionist Districts and Regions in the United States, and to the New Palestine for publication. WHEREAS, decisions affecting the future of Palestine and of the Zionist movement are being taken by leaders of the United Nations in their various conferences, and

WHEREAS, the concerted efforts and careful deliberation of our entire organization are immediately imperative, and

WHEREAS, the highest deliberative body of our organization is the Annual Convention of the Zionist Organization of America;

THEREFORE BE IT RESOLVED, that the Long Island Zionist Region calls upon the President of the Zionist Organization of America and the Zionist Executive to make every effort towards the securing of permission from the Office of Defense Transportation to hold a National Convention as speedily as possible; and

BE IT FURTHER RESOLVED that we call upon the President of the Zionist Organization of America to call such a Convention at the carliest moment, consistent with government regulations; and

BE IT FURTHER RESOLVED that, in view of the need for clarifying current issues, we instruct our representatives on the Metropolitan Inter-Regional Council to call and organize forthwith a Conference of all Regions in the Metropolitan Area to consider the all-important questions now confronting our movement; and

BE IT FURTHER RESOLVED that copies of this Resolution be sent to the members of the Executive and Administrative Committees of the Zionist Organization of America and to the Presidents of all Zionist Districts and Regions in the United States and to the New Palestine for publication.

WHEREAS, the fostering of an informed Zionist public opinion is a prerequisite for the health and growth of our movement, and

WHEREAS, in this crucial period the ZOA has a positive responsibility to make available to the American people and to Zionists all significant news, material and comment on Zionist activity, especially information on the all-important questions of Zionist program and policy, and

WHEREAS, we are deeply porturbed by the attitude domonstrated by the official publications of the ZOA in presenting only such comment as reflects the views of the present Administration of the Zionist Organization of America, and

WHEREAS, the opinions shared by tens of thousands of American Zionicae merit the consideration of the entire members of the ZOA,

THEREFORE BE IT RESOLVED that we call upon the National Administration of the Zionist Organization of America and the Editorial Board of the New Palestine and all other official Zionist publications to alter forthwith the policy which is being pursued by the New Palestine and to permit the inclusion in our official organ of comment on Zionist affairs which does not necessarily coincide with the view of the Administration. WHEREAS, the Long Island Zionist Region, comprising over 6700 members of the Zionist Organization of America, is desirous of seeing fulfilled the ancient prophecy of return to Zion; and

WHEREAS, we, as citizens of the United States of America, are cognizant of the promises of the major political parties of the United States, in their conventions assembled, to expedite the establishment of Palostine as a Jewish Commonwealth; and

WHEREAS, we are also cognizant of the fact that Great Britain is bound, by a treaty with the United States, not to change the rights of the Jewish people under the Mandate for the establishment of Palestine as a Jewish Commonwealth, or to interfere with the free and unrestricted immigration of Jews to Palestine, without the permission of the Congress of the United States; and

WHEREAS, the League of Nations and other investigating bodies have found that Great Britain has failed to abide by the terms of the Mandate of the League of Nations, and, therefore, has violated said treaty with the United States; among other things by issuing the infamous White Paper of 1939, which, without any permission from or even consultation with the United States, has caused cossation of unrostricted immigration of Jows to Palestine; and

WHEREAS, the inability on the part of the membership of the Zionist Organization of America to meet in national convention has resulted in the inability of the membership effectively to control the executive policies of the Zionist Organization of America, which has resulted in a semblance of disunity: and

WHEREAS, the membership of the Zionist Organization of America is in fact united in policy and program and would so affirm if given the opportunity to express their desires, and

WHEREAS, under conditions of crisis existing today, it is necessary that the executives of the Zionist Organization of America must record such desires of the membership and proceed accordingly.

NOW, THEREFORE, BE IT RESOLVED, that the Long Island Zionist Region in Convention assembled on the 24th day of June, 1945, expresses its disfavor of any policy of procrastination, of inaction and of delay in regard to the matters hereafter enumerated - and positive, continuous and militant conduct on the part of the Officers and the Executive Committee of the Zionist Organization of America toward the same, and

BE IT FURTHER RESOLVED that we domand that the officers and Executive Committee of the Zionist Organization of America immediately take action upon the following:

1. Petitioning the Congress of the United States on our behalf as citizens of the United States, immediately and without further delay, to require Great Britain to desist from the further breach of her treaty with the United States and to require Great Britain, immediately and without further delay, to abide by and perform her treaty obligations to the United States and to nullify and declare void immediately the White Paper of 1939; 2. Petitioning the Congress of the United States on our behalf as citizens of the United States, immediately and without further delay, to carry out the promises of the conventions of the major political parties of the United States, and embodied in their respective platforms to implement and make a fact the establishment of Palestine as a Jewish Commonwealth;

3. Declaring the policy of the Zionist Organization of America to be to the same effect and at once impress upon the President and the Congress of the United States and upon the leaders of the major political parties that we demand immediate and positive fulfillment by both major parties of the promises those political parties made in convention assembled; and

BE IT FURTHER RESOLVED that we call upon the executive efficers and the Executive Committee of the Zienist Organization of America and demand that they immediately initiate a referendum to determine the desires of the members of the Zienist Organization of America, and if possible, of all Jews in the United States, on the specific matters of demand hereinbofore enumerated, providing, however, that said referendum shall in no way delay the earliest possible assembling of the ZOA Convention.

BE IT FURTHER RESOLVED that each and every of the Regions and Districts throughout the United States be requested immediately to take like action on the foregoing; and

BE IT FURTHER RESOLVED that copies of this resolution be sent to the members of the Executive Committee and the Administrative Committee of the Zionist Organization of America, to the members of the American Zionist Emergency Council, to the Presidents of all Zionist Districts and Regions throughout the United States, and to the Jewish press of the United States, and that it be published forthwith in all publications of the Zionist Organization of America.

WE DEPLORE THE MANNER IN WHICH DR. SILVER WAS DEFRIVED OF HIS LEADERSHIP AS CO-CHAIRMAN OF THE COUNCIL AND CHAIRMAN OF THE EXECUTIVE COMMITTEE, AND FEEL THAT HIS ABSENCE AS CO-CHAIRMAN HAS SHAKEN OUR CONFIDENCE IN THE PROGRAM AND FUTURE OF THE AMERICAN ZIONIST EMERGENCY COUNCIL.
