



JEWS MAY JOIN PALESTINE TALKS

Great Britain may act as a go-between for Arab and Jewish groups meeting separately in London soon on the future of Palestine....

Jewish Agency Executive has refused to take part in the Conference under existing conditions. But Berl Locker, a member said last night: "The Agency was in almost continual contact with Great Britain and that there was no reason why the informal discussions and communications would not continue while the British and Arab representatives were conferring."

In this way despite any Jewish boycott of the Conference, Britain would carry back and forth any Jewish and Arab proposals and counter-proposals.

COPY CABLE RECEIVED FROM MANSON ORGANS AND OTHER PAPERS ALONG FOLLOWING LINE LATEST SUGGEST COMMENT OUR DEVELOPMENTS EXPRESSED BY SILVER, NEUMANN AT CONGRESS AND THEIR APPRAISAL LONDON CONFIRMATION VIEWS TALKS INITIATED IN A MANNER CONTRARY THEIR JUDGMENT BUT POLITICAL SITUATION. PRESENT OTHERS WHO STUL HOPED - POSITIVE RESULTS EMPHASIZE THAT INSISTED UPON BY SINCE ARRIVAL LONDON NEUMANN HAS ISSUED REPEATED WARNINGS AGAINST HOPEFUL FORECASTS AND EXAGGER ATED EXPECTATIONS. OF COURSE CONCEIVABLE CABINET SHIFT POSITION AGAINST BEVIN FAVOR JONES BUT THIS HIGHLY IMPROBABLE AT PRESENT. IN RECENT CONVERSATIONS EXECUTIVE EMBARRASSED HANDICAPPED BY UNFORTUNATE ACTION TAKEN LAST SUMMER WHICH MANEUVERED MOVEMENT INTO UNF AVOR ABLE POSITION. AS MIGHT HAVE BEEN EXPECTED GOVERNMENTNOW MADE FULL US OF FACT THAT AGENCY SUGGESTED PARTITION AND BEVIN REPRESENTED IT TO ARABS AND WORLD AS THE UNDOUBTEDLY PRESENT COALITION EXECUTIVE HAS BEEN HONESTLY ZIONIST SOLUTION. TRYING FRAMEWORK CONGRESS RESOLUTIONS BUT ALSO TRUE THAT COMPOSITION PURSUE POLICY WITHIN REFLECT NUMERICALLY PROPORTIONATE STRENGTH GROUPINGS BASLE. CONGRESS EXECUTIVE DOES NOT MAJORITY VIEW BEING REPRESENTED BY MINORITY IN EXECUTIVE. THIS ALSO REFLECTED IN LONDON WHERE CONGRESS MAJORITY REPRESENTED BY NEUMANN SNEH SHRAGAI AS AGAINST SIX REPRESENTATIVES WHILE UNDOUBTEDLY EFFORT MADE RECONCILE DIVERGENT OF CONGRESS MINORITY. VIEWPOINT IT IS FAIRLY EVIDENT RESULTANT LINE OF EXECUTIVE LONDON LARGELY DETERMINED BY ITS MAJORITY THOUGH STRONGLY INFLUENCED BY A MINORITY. BRITISH PROPOSAL SO THORBUGHLY BAD AS TO PRODUCE EFFECT STRONGLY CONSOLIDATING ALL ELEMENTS IN EXECUTIVE AND MOVEMENT IN UNITED FIRM NEGATIVE STAND

FOR YOU & WEINBERG PRESS FROM HARMON OR SPECIAL CORRESPONDENT FOLLOWING: MUCH COMMENT ZIONIST CIRCLES NEUMANN'S NON PARTICIPATION FORCED MEETING COLONIAL OFFICE YESTERDAY. HE DECLINED PUBLIC EXPLANATION BUT REPORTEDLY REFUSED GO BECAUSE PROPOSAL WAS COMPLETELY IMPOSSIBLE AS UNWARRANT DISCUSSION. HE THEREFORE PROPOSED NO FURTHER TALK AT LEAST NOT BEFORE DELIVERING WRITTEN CATEGORICAL REJECTION AND AVOID GETTING DRAWN INTO DISCUSSIONS EXECUTIVE HAVING CONSIDERABLE INFLUENCE CHECKING OTHER TRENDS. YESTERDAY'S TALK REPORTED STORMY GOVERNMENT SPOKESMEN INDIGNANTLY PROTESTING "DEFRAUT" (DEFRAUD) SCHEME REVERSION TO PRINCIPLES WHITE PAPER. AMERICAN EMBASSY CIRCLES REPORTED DEEPLY DISAPPOINTED NEW PLAN. GENERALLY FELT HERE LITTLE PROSPECT FAVORABLE PROGRESS NEGOTIATIONS EXCEPT INSOFAR GOVERNMENT FEELS URGENT NECESSITY EARLY SATISFACTORY SETTLEMENTS BECAUSE PRESENT TROUBLED CONDITIONS PALESTINE AND PRESSURE AMERICAN OPINION. EVERYONE ASKING WHETHER TRUMAN WILL NOW INTERVENE INSIST 100,000 THIS YEAR REGARDLESS OUTCOME NEGOTIATIONS.

> The publication date of Bartley C. Crum's new book, "BEHIND THE SILKEN CURTAIN" will be next Tuesday, April 8. The book is published by Simon and Schuster and is a fascinating and profoundly significant account of Mr. Crum's personal experience as a member of the Anglo-American Committee of Inquiry on Palestine. It reads like an exciting tale of adventure and it is my feeling that this book -- if widely circulated -will move thousands of Americans to actively support Zionist objectives.

It now seems fairly definite that there will be a special session of the United Nations General Assembly some time during the month of May in order to deal with the Palestine problem. If this is correct, the book can be of inestimable value to our cause provided, of course, it is widely read and becomes a "best seller." The book can achieve this status if there is a sufficient demand for it on the publication date or immediately thereafter. If a mass sales response by the buying public results in a sell-out of the first printing of "BEHIND THE SILKEN CURTAIN" the book is sure to become a "best seller."

We follow an old adage in the office of the American Zionist Emergency Council: "Nothing happens unless you make it happen!" The only way / that "BEHIND THE SILKEN CURTAIN" can become a "best seller" is for you and the members of your committee to take the bull by the horns and make it happen. Therefore, I would urge you to develop a program in your community whereby the book would be bought over the counter of your local bookstores and then placed in the hands of every important non-Jew in your community.

I will be deeply grateful to you if I could have a report of your committee's activities in the matter of: "BEHIND THE SILKEN CURTAIN."
