For a long time the members of the Research Department have felt the need for an organ on the Middle East which would advance our point of view. Meanwhile, about a year ago, the State Department in conjunction with the oil interests established the Middle East Institute which publishes the Middle East Journal, which by all implications is anti-Zionist. We feel, however, that there is still an opportunity to counteract the effect of this journal, and even surpass it in influence and authority, as indicated in the enclosed memoranda.

I would appreciate it very much if you could arrange to meet me so that I may discuss the plan with you.

December 8, 1947 Mr. Mark Sugarman South Coatesville, Pennsylvania. Dear Mr. Sugarman: James G. McDonald tells me in a letter that when he spent an evening with you recently at the house of Emanuel Neumann, you discussed the publication project which I have suggested. He further says that you expressed the desire to see me. As you will recall, both Dr. Silver and I wrote to you months ago on this subject. I realize of course that during the last few months all of us have been engrossed in the United Nations developments on Palestine to such an extent as to preclude any thoughts about a long-range Zionist program. However, that is over now, at least the first stage. Furthermore, in my judgment, the U.N. decision on a Jewish State in Palestine makes it even more important than ever to create in the United States a Middle East publication along the lines envisaged by me, which would offer a concentration point for all the progressive forces in the Middle East. I would very much welcome an opportunity to discuss this project at greater length with you at your earliest convenience. Sincerely yours, Eliahu Ben-Horin EBH/1b

Dear Dr. Neumann:

James McDonald was kind enough to inform me about the talk which he had with you and Mr. Sugarman about the project of a Middle East publication. Thus far, I haven't met Mr. Sugarman, despite his promise, months ago, to look me up, when he is in town. I wrote to him today, as per enclosed copy.

I do think that a Middle East Weekly along the lines suggested by me is now an urgent necessity. With the revemping and reorientation of Zionist activities in the Diaspora and in the United States, our political efforts in this country will have to be directed towards the development of a bloc of Middle Eastern interests capable of counteracting the Pan-Islamic Arab League. A weekly publication devoted to the Middle East, properly shaped and managed would be the natural center for such a bloc. I know how busy you are, but if you can find some time for thinking on the long-range program of Zionism in America, I feel sure that you will agree with me on the importance of such a publication.
