Are you afraid that Britain will seek to abort this outcome again? I know that some of her spokesmen have said the plan is "unfeasible". Apparently, all plans of salvation are!

Several days ago I addressed a note of congratulation to you, which probably you will find on your arrival.

Today comes your wire from the Queen. I am glad to have it, because it shows that a victory was won for honesty in the Palestine cause, in the winning of which I attribute a large part to you.

When you see Snyder, or the President, again I think it would be wise for you to tell him that the use of the message was effective to your position; it may prove equally effective for Truman.

I have written Snyder, and sent a message to the President. You may think it well to do the same thing, without making any final commitment.



I was pleased to hear that you had a talk with Mr. Hershel V. Johnson. His attitude has been giving us some concern. I am enclosing herewith a confidential report on a conversation which was held recently between Mr. Selim Sarper, Chief of the Turkish Delegation to the United Nations, and Mr. Johnson.

Secretary Marshall's reference to Palestine in his address on Sunday was very vague. I got the impression that unlike his address which was very straight-forward and clear, the reference to Palestine was designed to conceal rather than to reveal American policy. However, we shall know before long now where we really stand with our State Department.

Dear Dr. Silver:


When do you plan to be in New York again?

MEMORANDUM TO DR. ABBA HILLEL SILVER

Confirming my telephone message:

The Overseas News Agency and the Jewish Telegraphic Agency (with which I think I see an advantageous conjunction with the Zionist organization, about which I want to talk to you) will appear before the United Jewish Appeal allocation board tomorrow. The sum involved is comparatively small, but we want to be assured of its permanence.

We have, as part of the undertaking, withdrawn from the solicitation of funds, but it is essential that money come in to supply working capital.

I should like to have your support, or that of your representatives, in making the grant permanent.
