Dear Rabbi Silver:

I notice in today's Plain Dealer an announcement of the organization by Rabbi Novak of a synagog and religious school in the Coventry School in the Heights. At last we now have the transmutation of the old and detestable East Side institution of a "shule" or top of a stable into its modern form of a privately owned synagog housed in an American public school building.

Outside of the fact that there is no need either in Cleveland Heights or in the City of Cleveland for an additional synagog, and outside of the fact that the proposed congregation of a "cosmopolitan" nature is just bunk and a desecration of the Jewish name in Cleveland, I believe it is a dangerous precedent to allow synagogs and religious schools to be housed in public school buildings. You are, of course, aware of the disputes regarding this matter prevalent in this country during the last ten to fifteen years, most of which have been resolved in favor of the protagonists of the idea of keeping religion away from the public school.

Had there been an actual and sincere demand of an un-synagog group to organize an additional synagog, or were this proposed synagog of a nature as would add a new tinge to Jewish life, and were it not a purely private enterprise undertaken by Rabbi Novak for his own private aims and aided by a few "helpful" laymen, I should be inclined to forget about all the other items mentioned in the previous paragraphs. In view, however, of all of the circumstances in the matter, it would seem to me that something ought to be done to stop this kind of fiasco, even though it might hurt Rabbi Novak's possibilities to earn \$2500 a year. This thing can be stopped, I believe, without much difficulty upon the initiative of any individual or group of individuals living in the Heights. It seems to me, however, that this is one of the matters that should not be undertaken by any individual unless there is some community understanding on the subject. I should, therefore, appreciate your opinion to me, confidentially, either by letter or at lunch downtown some day next week at your convenience.



My dear Mr. Kluga:

Please pardon the delay in answering your letter. I have been away from the city a great deal of the time. I would very much like to have you come in to see me at The Temple some day when I can talk over in greater detail the matters which you mention in your communication to me. It was very thoughtful of you to take the trouble to write me about them. I want to call your attention, however, to a few principles which govern our organization and which may explain some of the actions which you criticize.

1. Up to a few years ago, The Temple admitted children of non-members. When the Bureau of Jewish Education was established and seven free Sunday Schools were opened for children whose parents were unable to join Temples, our Temple together with all others in the city, felt that they were discharging their obligations to those children by helping maintain these free Sabbath Schools. The members of our Temple contribute thousands of dollars to the Bureau of Education to help support these schools. The Temple and its constituent organizations contribute a thousand dollars annually to those schools. There is no reason why any child in Cleveland should not receive a Jewish education if he so desires. The schools are for them.

2. We have not barred from the Religious School the children of members who are in arrears of their dues. We have asked delinquent members whose children are attending the school to come in and talk the matter over with the secretary. The secretary was instructed to make

any arrangement with such members for the payment of their dues which they are able to make. If they are unable to pay now, The Temple is glad to carry them until better times. It is only in the cases of those members who have not even paid the Temple the courtesy of coming in to talk to the secretary, although we have repeatedly written to them and called them by telephone, that the Temple authorities felt they have no further responsibility toward them.

3. As far as admission to our holiday service is concerned, you realize, of course, that we are confronted with a very serious problem. We have a membership of over fifteen hundred and we must mail seats to each one for the High Holy Days. That is over three thousand seats. The total number of seats, both in The Temple and in Mahler Hall is much less than three thousand. Furthermore, we must provide seats for two to three hundred young men and young women of our Alumni Association and for the members of our High School whom we want to attend the High Holy Day Services. While it is true that all who receive admission cards do not attend the services, we are in no position to know who is coming and how many are coming and we cannot admit many visitors for fear that our own members will be crowded out. The empty seats that you refer to in The Temple, in most instances belong to Temple members and we have no right to assign them to anyone else. In spite of all, we do take care, and did this year take care of a number of out of town visitors who took the trouble to come into the Temple office a few hours before the service or a day or two ahead, and made themselves known to the secretary. Many of those whom you regard as out of town visitors are really local people who, on the High Holy Days, indulge in the pastime of "visiting around" the various Temples of the city.

I trust that I may have the opportunity some time of explaining this matter to you in person and in greater detail. With all good wishes for a happy new year, permit me to remain,


I have just returned from a visit to New York in the interest of my problem concerning the continuation of important, unfinished scientific work. In view of the announcement by Western Reserve University that funds would be sought by an appeal for individual contributions, I did not desire to permit the urgency for continuation of my work to hamper, in any way, the University's appeal. I, therefore, made an attempt to obtain some funds from sources outside of Cleveland. My needs could have been readily supplied in New York were it not for the large demands now being made in consequence of the German situation. However, I have the promise of assistance to the extent of \$1000.00 to \$1500.00 if I can obtain the balance locally. I feel that it should not be impossible to obtain in the neighborhood of \$2000.00 in Cleveland without interfering materially with any appeal that the University may make. This would enable me to continue the prosecution of the work in which I have invested a great deal of time, labor and money and which would be a great injustice to interrupt. As my labors are an essential function of the University, any support given to my work would, of course, constitute assistance rendered to the University from which funds for my work should normally be available. Further delay in this matter will render impossible the completion of my work now in progress. I, therefore, make this appeal to you to aid me by bringing the matter

as soon as possible to the attention of some of your friends whose aid might be enlisted. As I am asking nothing whatever for myself but only a moderate amount of assistance for the continuation of my service, I feel free to make the request and I shall be greatly indebted to you for whatever assistance you may be able to render in placing my request before those who are in a position to render a service to science and humanity. Since Mr. Eugene Wolf has extended me the courtesy of an interview, I am taking the liberty of forwarding to him a copy of this letter in the hope that he might cooperate in this matter with you.

My dear Dr. Silver:-

Well, it feels mighty good to be back upon one's own soil, and back in one's own work. We delayed our return to America by some weeks because I was forced to return to Spain and complete some work which my Spanish friends assured me would have been done months before. So that we thereupon took advantage of our situation and went to Belgium and London, where we met more, always more, of the refugees from Germany. What a sad and tragic tale. And we finally came back to America last month. I have wanted to write to you long before this, but my work at the University has kept my head under water since my return. I have read of your many activities, and I hope and trust that you will continue to lend your force and strength to these activities for many, many more years to come.

It was very kind of Mrs. Silver to write us. We hope that she is altogether herself, after the bitter tragedy. I use the editorial "we", although Gladys is with her folks at the moment, in Youngstown, almost a suburb of Cleveland. We were there for Rosh HaShanah together, but I had to return to the University, and she begged off a little while longer to stay with her folks. She has received orders to return, for I'm not so good at this kind of separation. I really expect her back in New York within a week.

Sometime this coming spring, we are hoping that you will pay Columbia University a long-delayed visit. Specifically, we are hoping that you can come and address the University under the auspices of the Jewish Students Society of Columbia College and the Menorah Society on April 23rd. We have been writing and inviting you for sometime, now, and I am hoping that the long-deferred pleasure will be ours at last. In any event, do let me know.

When you plan to be in New York, will you let me know, because we would very much want to see you again. Our last experiences were so delightful and pleasant.

Please remember both Mrs. Braunstein and me most cordially to Mrs. Silver. Our greetings and regards to you. May I expect to hear from you?



Dear Abba: Jerusalem Oct 31-1933

I know how anxious you must be to find out what we are doing and what the prospects are. Well - It is not an easy thing to decide especially now, with the new Government rules regarding tourists. If they are really sincere, then one has to think twice, before he makes any definite step.

My drug license was not accepted (the law was passed two years ago). I wrote to the Amer. University of Beirut and they replied that my request for admission has come in too late for them to consider it this year but that they would be glad to hear from me next fall. So - the question of the retail drug business cannot be entertained right now.

I have investigated the retail drug trade to a number of druggists, salesmen and others connected in the line and gathered that it is a very small and hard business and that the returns will not be enough to give a man a decent living. The Palestinian, whose standard of living is low, can probably get along nicely, but whether an American who cannot adapt himself very readily can do likewise is questionable.

It didn't take me very long to find out that any kind of a business here would require a good deal of money, because they deal in pounds here, as we

do in dollars. Rents had to be paid in advance, for at least six months. In the States, you can accomplish more with half the amount and if you want to reduce your standard of living a bit you can get along very well.

Do go into any other business is not the wisest thing to do, in my case. Things are inflated very badly now, with the German influx, and competition is very keen. It looks, as if I will have to go back to the States and start all over again. I believe, that this trip has opened my eyes and that I have learned a great deal. I know, that I will benefit by the wonderful experience and will always look upon it as one of the happiest adventures in my life. It is very unfortunate, that I am so "financially embarrassed" right now, but even that would not discourage me. I still have a lot of faith in America if am sure that the future holds some good for me.

Would like to have your opinion about the matter and would appreciate an early reply. Rose is reconciled and wouldn't mind my going back. Should I decide definitely, I would not like to lug him too long.

We are all well. The children are attending school and are quite happy. The folks are well and seem pleased with our visit. Look to Virginia and the children. — Jack.



It was then my intention to ask you to see me, and when I phoned you the second time, they had decided to fly. I wouldn't blame you, after listening to me over the phone, if you placed me in the same class of the dozens traveling about the country today saving our people.

I enclose herewith a letter which is self-explanatory. I have since realized that our leaders are hopelessly divided and that their respective organizations are at cross purposes, and further, that they are competitive. Then we have "leaders" who daily speak for all Jewry without any authority, creating liabilities, which will take us years to pay.

As an example, Mr. Untermyer has seen fit to inject a religious question into New York politics, and Mr. Deutsch, as President of the American Jewish Congress, is a candidate for a political office. Mr. Untermyer, as President of the Defense League has no right to inject the religious issue into politics, and Mr. Deutsch, as President of the Jewish Congress, should have resigned his office or remained out of politics.

There are two million Jews outside of New York to be considered, and I as one, will never subscribe to the theory that all the Jewish brains are located in New York. I have practically retired from my business, and at my own expense, I am discussing this problem with small groups in different cities. As I represent no organization or individuals, and as I do not seek any office, I have met with little resistance.

It isn't my purpose to destroy any organization, nor attack sincere leaders, but rather, if possible, to either cement our present organizations into one effective group that is all representative, or create a new acting body. Personally, I am hopeful that a new one will be unnecessary.

I recognize in you a Jewish leader with both feet on the ground, and I would deem it an honor and a privilege to work with you or receive your advice and counsel.

My dear Dr. Silver:

It was a great pleasure to hear from you and to know that you and your family are all well. I have had regards from my sister-in-law, whom you were so kind to entertain when she was in Cleveland. It was most gracious of Mrs. Silver and yourself to have asked her to dinner and to have given her the privilege of meeting and speaking with you. I am deeply appreciative of your kindness.

I want you to know how very sympathetic I am with the point of view you expressed in your editorial on the Good Bill movement in yesterday's Jewish Daily Bulletin. I long felt the futility of the method of approach employed at the National Conference of Jews and Christians. Once or twice I dared to express my opinion to Mr. Glasser, and I was very cordially rebuffed. This last meeting of the conference at Teachers College was, from the point of view of interest and numbers of people attending, sadly discouraging. I was supposed to have been chairman of a Round Table but I was sick in bed at the time and was not able to attend. I have reports, however, that the meeting was rather futile and a weak gesture. You have expressed the way I feel in your editorial in succinct and careful words. At least in this matter, we are in agreement.

I am wondering if I might not ask for a favor: this year my salary has been drastically reduced and I am forced to make it up by lecturing... I have already begun to lecture in and around New York. I have met with surprising success. Would it be possible for you to recommend me to groups with whom I may come into contact. I am prepared to speak on a number of things but I am most interested in lecturing on Jewish Life in Spain and the Life of the Secret Jews ~~and the Gypsies~~ of Majorca. The following themes will give you some idea of the scope of **themes** it would be my interest to lecture on:

- 1- Spain and Palestine: Jewish memory and hope.
- 2- The Awakening in the near east.

- 3- European Universities, old and new.  
4- Student life in Europe.  
5- Student life in the near east.  
6- Toledo: El Greco and Samuel haLevi  
7- New Spain  
8- Outcasts of the Mediterranean World.

Believe me, I shall be deeply grateful for the help I know that you may be able to give me.

You may expect to hear from me sometime in February, asking you to appear before the Jewish Groups in the University. I know you will come to New York often this year, and, as you have suggested in your letter, I am going to keep in constant connection with you so that the students here may have the pleasure of hearing you.

Mrs. Braunstein joins me in greetings and best wishes to Mrs. Silver and your two boys and yourself.




It is with sincere regret that my nephews and myself cannot, at present, make a larger contribution to the "War Chest for the Defense of Human Rights", especially when these rights are vitally affecting our brethren in various parts of the world. I trust that this is not only the war against the ferocious barbarities of Hitlerites that have destroyed the rights of our people and threaten the very existence of the Jews in Germany, a land that never tolerated genuine human freedom, but it is also the war for the defense of the rights of our people which are being viciously attacked at our very door steps. To win such a war, must be the ultimate aim of every lover of freedom, especially of the Jews, and of those who have a real interest in human progress.

But there is another war I am anxiously hoping to see realized, despite my peace loving propensities, and that is the war against the diseases, rather perversities, which affect many of our Jewish younger men. These children of parents who were bent with toil and crushed by want, and who have had no time, nor incentive, to look after their maturing offsprings, and because of this, and not because of inherent viciousness, and because of misdirected energies, many of these children grow up to become racketeers, gunmen, etc., to the harm of all Jewry. If a war of prevention could also be started, with all the forces of real interest by the leaders of our people, many slanderous, provocative and harmful propaganda against the Jews could be allayed, or entirely prevented so long as we still have many friendly and well meaning neighbours who have, so far, escaped the antisemitic contagion.

I know what I have just said may seem to have no bearing on the present plight of our disfranchised and persecuted brethren, but, on closer study, the soundness of inaugurating a real preventive war against gangdom in the rising generation will become apparent, especially in creating, at the same time, a stronger friendly feeling amongst Jews themselves—not only a brotherly feeling that is awakened in calamitous and troublous times against our Jewish people.—Such preventive warfare will go a long way to allay, if not to stamp out Judophobia, in this country at least.



# The Finger Prints of a Vanished Glory.

In looking through an old Photograph Album I came across a faded tintype which was like finding a pressed rose in the leaves of a long forgotten book.
